| <p><b>SOUTHERN VOGUE</b> (K Chowdoory) – Required farrier attention at the start after pulling a plate leaving the Birdcage. Slow away then commenced to over-race in the early stages being allowed to improve forward to sit outside the leader passing the 1200 metres.</p> <p><b>CHARRED</b> (M Cameron) – Removed from the barriers to undergo a veterinary inspection after becoming fractious being passed suitable to race.</p> <p><b>ETCH</b> (J Riddell) - Removed from the barriers to undergo a veterinary inspection after becoming fractious being declared a late scratching on veterinary advice at 12.59pm and is now required to barrier trial satisfactorily prior to racing again.</p> <p><b>ALTAR GIRL</b> (C Dell) – Lay outwards under pressure over the final 100 metres.</p> <p><b>S McKay</b> – Spoken to regarding his whip use prior to the 100 metres.</p> |                              |

| <p><b>FORGETZ</b> (J Riddell) – Restrained leaving the barriers.</p> <p><b>ON THE RIVET</b> (S Spratt) – Jumped away awkwardly. Raced three wide without cover.</p> <p><b>ENRICHMENT</b> (O Bosson) – Inconvenienced passing the 200 metres when REIKO shifted outwards.</p> <p><b>DONTGIVEADAM</b> (J Fawcett) – Lay outwards under pressure in the final straight.</p>   |  |
| <b>Race 3</b>  | <b>Tulloch Café 1200</b>                     |
| <p><b>COMBAT QUEEN</b> (S Weatherley) – Slow away.</p> <p><b>ALAGANT ANGEL</b> (R Scott) - Steadied when becoming awkwardly placed on heels shortly after the start.</p> <p><b>SILVERSTREAM</b> (T Yanagida) – Steadied off the heels of WHISTLING CLOUD passing the 800 metres.</p> <p><b>STAR OF BOMBAY</b> (O Bosson) – Made contact with ROCKIN ROBIN when attempting to obtain clear running approaching the 300 metres then again made contact with ROCKIN ROBIN when that runner lay in near the 250 metres unbalancing both runners.</p> <p><b>ROCKIN ROBIN</b> (C Grylls) – Contacted approaching the 300 metres then again near the 250 metres becoming unbalanced.</p>  |  |
| <b>Race 4</b>  | <b>Next Avondale Trials 13 November 1400</b> |
| <p><b>MAKABAR</b> (R Elliot) – Jumped away awkwardly losing ground. Had some difficulty obtaining clear running early in the final straight until shifting outwards near the 200 metres.</p> <p><b>R Smyth</b> – Spoken to regarding using her whip on consecutive strides prior to the 100 metres.</p>  |  |
| <b>Race 5</b>  | <b>Jan Skinner Birthday Celebration 1600</b> |
| <p><b>FORSEEABLE</b> (S Collett) – Slow away.</p> <p><b>MOET MOLLY</b> (T Thornton) – Had a tendency to over-race in the early to middle stages.</p>   |  |
| <b>Race 6</b>  | <b>Westbrook Wines 1400</b>                  |
| <p><b>SWORD OF FREEDOM</b> (O Bosson) – Shifting inwards abruptly after jumping from the number one barrier and when being corrected by its rider made contact with ZAWADI. Shifted outwards to avoid the heels of NAVEL AFFAIR near the 850 metres forcing MARBUZET into a three wide position.</p> <p><b>ZAWADI</b> (T Thornton) – Hampered when contacted shortly after leaving the barriers. Over-raced in the middle stages. Had difficulty obtaining clear running until shifting outwards across heels passing the 200 metres.</p> <p><b>MARBUZET</b> (M Cameron) – Forced outwards 850 metres then racing three wide without cover for the remainder of the race.</p> <p><b>FOODIE KING</b> (A Calder) – Steadied to obtain cover passing the 850 metres.</p> <p><b>MAKARAKA</b> (J Waddell) – Rider reported that the gelding had felt sore behind with a post-race veterinary inspection revealed 3/5 lameness with a veterinary clearance now required prior to racing again.</p> |  |

**MANAVGAT** (C Dell) – Briefly steadied when placed in restricted room passing the 400 metres.

**SEVEN AAJES** (S Weatherley) – Held up early in the final straight until near the 200 metres.

**POWER'S THAT BE** (R Elliot) – Began awkwardly then further hampered when crowded.

**RIP EM UP** (J Waddell) – Began awkwardly. Had difficulty obtaining clear running until shifting outwards near the 150 metres inconveniencing SYMPATHIQUE near the 100 metres.

**SYMPATHIQUE** (C Grylls) – Inconvenienced near the 100 metres.

**R Scott** – Spoken to regarding her use of the whip on consecutive strides prior to the 100 metres.
