Co-trainer M Pitman advised Stewards that OKAY PAL will have a brief freshen up and then resume its current preparation.

**Canterbury Jockey Club - Saturday 9 November 2019****Race 1 - CHRISTCHURCH CASINO PREMIER (2000m)**

Trainer A Schwarz advised Stewards that ROAD TO REDEMPTION has recovered well and will continue with its current preparation.

**RACE COMMENTS:****Race 1 FASTTRACK INSURANCE \$5K STAKE TOP UP (1600m)**

**TORMUND** (R Elliot) - Began awkwardly.

**SHOWMETHEBUBBLES** (L Hemi) - Crowded at the start losing ground, had to be steadied to avoid the heels of ROULLETTE when BI YING (S Wynne) shifted outwards to avoid the heels of DIVINEXCUSE near the 600 metres.

**BI YING** (S Wynne) - Contacted and lost ground at the start when bumped from the inside by LAVAGLO which was taken out by TORMUND which began awkwardly, held up having to be steadied after improving onto the heels of ITSONLYMONEY passing the 200 metres and continued to be held up hampering ONESTAR near the 125 metres.

**LAVAGLO** (M Dee) - Contacted start.

**SABOTEUR** (C Johnson) - Slow to begin then further hampered when ONESTAR shifted outwards abruptly at the start, crowded and checked near the 1300 metres.

**S Wynne** (BI YING) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear of SABOTEUR which was checked near the 1300 metres. After viewing films and hearing submissions the Judicial Committee suspended S Wynne's licence to ride at race meetings for 8 national days effective from the conclusion of racing on Saturday 16 November up to and including racing on Friday 29 November.

**HIBACHI** (M McNab) - Raced three wide without cover throughout, had a tendency to lay in under pressure in the final straight, inconvenienced near the 250 metres when TAKE THE DEEL shifted inwards.

**DIVINEXCUSE** (R Mudhoo) - Steadied away from the heels of ONE STAR near the 600 metres.

**ATAAHUALUVTHEDREAM** (S Collett) - Held up approaching the 200 metres.

**ONESTAR** (T Moseley) - Placed in restricted room passing the 125 metres and had to be steadied.

**S Shinde** (ITSONLYMONEY) - Issued with a warning for his whip use prior to the 100 metres.

**Race 2 CHAMPION FLOUR PREMIER (2000m)**

**LOCHAN ORA** (K Kwo) - Slow to begin.

**SHADOW KING** (M Dee) - Raced keenly when being restrained in the early to middle stages, forced wider on the track passing the 550 metres.

**KAHARAU** (R Mudhoo) - Shifted ground outwards passing the 550 metres to find clear racing room and in doing so forced SHADOW KING wider on the track.

**Race 3 ROMANO'S PIZZAS PREMIER (1200m)**

**GOLDEN HARVEST** (S Weatherley) - Struck a heel and blundered leaving the barriers when KHITAN WARRIOR jumped outwards, held up early in the straight until near the 250 metres.

**MACRON** (Z Bholah) - Slow to begin.

**QWERTY** (K Williams) - Slow to begin.

**LA CONSEILLE** (S Shinde) - Raced wide throughout.

**GRAND EXPRESS** (J Lowry) - Hung outwards throughout the race shifting outwards abruptly passing the 200 metres.

**OUR ROSETTE** (K Chowdhoo) - Held up early in the run home until near the 300 metres.

**ALONZO** (M McNab) - Steadied when placed in restricted room near the 300 metres. When questioned regarding performance rider was unable to offer any tangible excuse.

**THE SELECTION** (C Campbell) - Shifted inwards abruptly passing the 150 metres when struck with the whip and had to be straightened.

**TOUCHABEEL** (T Comignaghi) - When questioned regarding performance rider could offer no tangible excuse. A post race veterinary inspection did not reveal any obvious abnormality.

**Race 4 BIDFOOD BUTCHERY PREMIER (1600m)**

**THE SAINTLY ONE** (S Weatherley) - Declared a late scratching at 12.10 pm on veterinary advice.

**ALBARON** (D Hirini) - Slow to begin.

**ALWAYS** (A Mudhoo) - Bounded at the start losing ground, raced three wide without cover.

**RUMOUR HAS IT** (C Johnson) - Crowded at the start losing ground when OCEANS AWAY shifted outwards.

**S Shinde** (BLAIR FLIGHT) - Admitted a charge of careless riding in that he permitted his mount to shift inwards passing the 1300 metres when not sufficiently clear of DANNY GREEN which was forced inwards crowding RED LIGHT DISTRICT onto LEIGHTON WARRIOR which was checked. After viewing films and hearing submissions the Judicial Committee suspended S Shinde's licence to ride at race meetings for 7 national riding days effective from the conclusion of racing today Wednesday 13 November up to and including racing on Thursday 28 November.

**DANNY GREEN** (J Laking) - Hampered and forced inwards near the 1300 metres.

**RED LIGHT DISTRICT** (M Cameron) - Hampered when contacted near the 1300 metres.

**LEIGHTON WARRIOR** (S Wynne) - Checked when crowded near the 1300 metres.

**VINEYARD MCPHEE** (R Myers) - Got its head up for a distance passing the 1200 metres when being steadied away from heels.

**VOWS YOU MADE** (T Comignaghi) - Raced wide without cover throughout.

**MISS OAKS** (K Williams) - Raced wide throughout.

**BROTHER WILL** (S Toolooa) - Raced wide without cover from the 800 metres.

**AMPUIS** (R Elliot) - Held up when disappointed for a run near the 350 metres having to be steadied.

**HEY HAPPY** (K Asano) - Held up entering the final straight before obtaining clear running near the 350 metres.

**TUBTHUMPING** (S Collett) - Held up near the 350 metres, had some difficulty obtaining clear running over the final 150 metres.

**Race 5** | **NZB READY TO RUN SALE PREMIER (1400m)**

**SANCTIFY** (C Johnson) - Crowded at the start losing ground.

**VIVACE LADY** (M Cameron) - Slow to begin.

**EL GLADIADOR** (T Comignaghi) - Raced three wide without cover through the early to middle stages.

**LIVE DRAMA** (T Moseley) - Got its head up when over racing for a distance passing the 1100 metres, had some difficulty obtaining clear running through the middle stages of the run home.

**Race 6** | **VALACHI DOWNS CANTERBURY BREEDERS STAKES (1400m)**

**MONZA CIRCUITO** (R Mudhoo) - Began awkwardly then further hampered losing ground when crowded shortly after the start.

**LAKE CHALICE** (M Cameron) - Slow to begin.

**EMILY MARGARET** (R Hannam) - Raced four wide without cover throughout.

**BELLE FASCINO** (S Wynne) - Held up passing the 400 metres and when shifting outwards to obtain clear running made contact with MEARA MARY near the 250 metres. S Wynne was advised to exercise greater care.

**MEARA MARY** (S Weatherley) - Contacted near the 250 metres.

**BOUNDTOBEHONORED** (R Elliot) - Had some difficulty obtaining clear running in the final straight.

**ZABAY** (C Campbell) - Held up entering the final straight before shifting outwards to obtain clear running near the 300 metres.

**C Campbell** (ZABAY) - Admitted a charge of careless riding in that he directed his mount outwards near the 300 metres when not sufficiently clear of FEELIN THE LOVE and LAKE CHALICE which were both hampered. After viewing films and hearing submissions the Judicial Committee suspended C Campbell's licence to ride at race meetings for 6 national days effective from the conclusion of racing on Saturday 16 November up to and including racing on Wednesday 27 November.

**FEELIN THE LOVE** (T Comignaghi) - Hampered passing the 300 metres.

**LAKE CHALICE** (M Cameron) - Hampered passing the 300 metres.

**THE SPARKLE** (S Collett) - Unable to obtain clear running over the final 250 metres.

**S Wynne** (BELLE FASCINO) - Issued with a warning for her whip use prior to the 100 metres.

**R Hannam** (EMILY MARGARET) - Spoken to regarding his use of the whip in consecutive strides prior to the 100 metres.

**Race 7** | **HALLS REFRIGERATED TRANSPORT PREMIER (1400m)**

Trainer **P Harris** (TOP LAURELS) - Fined \$50 after failing to apply the notified shadow roll.

**STELLA DAZE** (R Mudhoo) - Began awkwardly losing ground.

**XCUSES XCUSES** (C Johnson) - Over raced through the early to middle stages.

**TORRE DEL GRECO** (K Asano) - Raced three wide without cover throughout.

**TOP LAURELS** (S Collett) - Raced wide without cover throughout.

**UPPERHAND** (J Lowry) - Made contact with CARSON RIVER when shifting outwards to obtain clear running passing the 400 metres.

**CARSON RIVER** (K Chowdhoo) - Contacted passing the 400 metres.

**MR TYPHON** (S Weatherley) - When questioned regarding performance rider was unable to offer any tangible excuse advising that the gelding had felt disinterested. A post race veterinary inspection did not reveal any obvious abnormality.

**Race 8** | **LINDAUER STEWARDS STAKES HANDICAP (1200m)**

**ENZO'S LAD** (M McNab) - Slow to begin. When questioned regarding performance rider was unable to offer any excuse. A post race veterinary inspection did not reveal any obvious abnormality other than a slower than normal rate of recovery.

**EXEMPLAR** (K Chowdhoo) - Slow to begin.

**JOHNNY JONES** (S Wynne) - Got its head up when over racing in the early stages and raced wide without cover throughout.

**SENSEI** (S Weatherley) - Had some difficulty obtaining clear racing room early in the run home until the 300 metres.

**SHEEZALLMINE** (M Dee) - Shifted ground outwards throughout the run home.

**PRINCE OZ** (T Moseley) - Held up entering the final straight before obtaining clear running near the 200 metres.

**MORWEKA** (L Allpress) - Went off-stride and dipped near the 150 metres then appeared to be uneven in its action for the remainder of the race. A post race veterinary inspection did not reveal any obvious abnormality.

**Race 9** | **WUHAN JOCKEY CLUB TROPHY PREMIER (2000m)**

**THE STYLE** (S Wynne) - Began awkwardly losing ground.

**IWO JIMA** (C Johnson) - Lay in throughout the run home crowding **RIPCORD** for some distance passing the 250 metres.

**BRIDGET TOWN** (C Campbell) - Held up early in the final straight.

**RIPCORD** (R Myers) - Placed in restricted room passing the 250 metres having to steady and shift ground to find clear racing room near the 150 metres.

**Race 10** | **15<sup>TH</sup> COUPLAND'S BAKERIES MILE (1600m)**

**WATCH THIS SPACE** (R Kozaki) - Bounded at the start, raced three wide without cover throughout.

**LINCOLN RAIDER** (M Dee) - Slow to begin.

**SIR NATE** (R Hannam) - Over raced in the middle stages.

**GALLANT BOY** (C Campbell) - Briefly held up on entering the home straight.

**CAMINO ROCOSO** (T Comignaghi) - Lay out in the run home and shifted out hampering **SON OF MAHER** passing the 250 metres before being corrected by its rider.

**SON OF MAHER** (S Wynne) - Hampered passing the 250 metres.

**S Collett** (VIGOR WINNER), **M Cameron** (TRUE ENOUGH) and **M Dee** (LINCOLN RAIDER) were issued with warnings for their whip use prior to the 100 metres.

**Race 11** | **AMICUS INSURANCE BROKERS PREMIER (2500m)**

Rider **M McNab** (JILDI JILDI) was examined by St John Paramedics and stood down from his remaining ride suffering from dehydration, being replaced by **R Kozaki**.

**VERSES** (R Mudhoo) - Began awkwardly, raced three wide without cover throughout.

**OUR ROYAL** (C Johnson) - Tended to over race when leading through the early to middle stages.

**LATASSO** (S Toolooa) - Over raced in the middle stages, lay out making the final turn awkwardly.

**MONDORANI** (K Asano) - Held up rounding the final turn and early in the straight.

Apprentices **K Chowdhoo** (LAST LETTER) and S Toolooa (LATASSO) were both spoken to regarding their whip use prior to the 100 metres.
