RACE COMMENTS:

Race 1	ISCL 1400
TUTTA LA CLASSE (T Yanagida) – Crowded shortly after the start having to be steadied.	

BEWITCHED (C Burdan) – Made the bend near the 1200 metres awkwardly, then commenced to over-race in the middle stages. Returned to the enclosure with blood present in both nostrils. Underwent a post-race veterinary examination which confirmed the mare to have bled. The connections were advised BEWITCHED would now be subject to a 2 month stand down from training, a 3 month stand down from racing and a veterinary clearance will be required prior to racing next. The connections advised Stewards that the mare would not be persevered with as a racing proposition.

SALT BAY (E McCall) – Improved on to the heels of the weakening BEWITCHED approaching the 400 metres having to be firmly restrained losing ground. Also hampered as a result was RICKY BAKER.

RICKY BAKER (J Fawcett) – Hampered passing the 400 metres.

Race 2	MACMILLAN ACCOUNTANTS 3YO

ALAMO (V Colgan) – Slow to begin. Held up for clear running around the final bend until near the 300 metres.

CAPTAIN NEWZEALAND (J Waddell) – Slow to begin.

TEE BONE BROWN (L Innes) – Raced 3 wide without cover throughout.

HUMBUCKER (O Bosson) – Shifted out near the 1200 metres when not fully clear of GRACEFUL WAY which had to steady and dictated BERGAMOT over extra ground. Jockey O Bosson was issued with a warning.

BERGAMOT (L Satherley) – Forced wider 1200 metres.

GRACEFUL WAY (M Coleman) – Steadied when awkwardly placed on heels near the 1200 metres.

PALM SPRINGS (M Coleman) – Slow to begin.

FREE THYME (J Waddell) – Ran off rounding the bend near the 700 metres and was not persevered with for the remainder of the race. The connections were advised the gelding would be required to barrier trial to the satisfaction of Stewards before racing next.

KIRRA LAD (S McKay) and **SHOW THE LOVE** – Made contact shortly after the start with **SHOW THE LOVE** becoming briefly unbalanced. Over-raced through the middle stages.

SHOW THE LOVE (C Lammas) – Contacted and unbalanced shortly after the start.

Race 4	ARAWA PARK FUNCTION ROOMS 1560

LETS ROC (C Burdan) – Crowded shortly after the start having to be steadied. Lay out under pressure in the final straight finishing wide on the track.

NAVEL AFFAIR (D Johnson) – Restrained from its wide barrier shortly after the start.

RAZOR (T Yanagida) – Raced keenly for a distance approaching the 1100 metres. Had difficulty obtaining clear running early in the final straight.

COMMANDING ANNIE (V Colgan) – Shifted away from the running rail abruptly passing the 750 metres hampering MOVINONBYE.

MOVINONBYE (A Calder) – Hampered 750 metres.

J Riddell (MONGOLIAN DYNASTY) – Issued with a Minor Infringement Notice for failing to make the declared weight on MONGOLIAN DYNASTY and was fined \$100.

Race 5	CAMPBELLS INFRASTRUCTURE 1215

CHALK (J Bassett) – Began awkwardly losing ground.

SAVAPPIEL (S Spratt) – Slow to begin.

MEKELLE (D Johnson) – Commenced to over-race passing the 1000 metres when being restrained off the heels of **EARL OF ORKNEY** (J Waddell) which shifted in when not fully clear. J Waddell was advised to exercise care when shifting ground. Shifted out making the bend awkwardly near the 850 metres forcing **OSO SHOCKING** wider. Continued to over-race through the middle stages making contact with **OSO SHOCKING** near the 700 metres.

OSO SHOCKING (T Thornton) – Forced wider passing the 850 metres then contacted near the 700 metres. Was not persevered with from near the 450 metres. A post-race veterinary examination found the mare to have suffered from cardiac arrhythmia and will require a veterinary clearance prior to racing next.

A Calder (SHOWAAN) – Reminded of his obligations over his use of the whip re consecutive strides prior to the 100 metres.

Race 6	POMARE ELECTRICAL 1215

TANGODANZER (J Kamaruddin) – Made firm contact with the front of its barrier stall forcing it to open slightly early, as a result then began very awkwardly losing ground. Commenced to over-race through the middle stages. **TANGODANZER** returned to the enclosure with blood present in both nostrils with the mare undergoing a veterinary examination which revealed minor lacerations in the nostrils consistent with making contact with the front gates of its starting stall. An information was filed to determine whether **TANGODANZER** had been denied a fair start under Rule 632(2). After viewing videos available and hearing submissions the Judicial Committee found that **TANGODANZER** was declared a runner.

OUTTALIGN I AM (S Collett) – Raced wide without cover throughout.

MYSTERY GIRL (N Alam) – Commenced to over-race passing the 800 metres having to be steadied when becoming awkwardly placed on the heels of **SLEEPY GEEG**.

The barrier stalls were re-tested prior to the running of the next race.

Race 7	HOLIDAY INN 1400

KOOLASCUZ (T Thornton) – Slow to begin.

ROSA FIORE (R Elliot) – Began awkwardly losing ground. Steadied over the concluding stages when placed in restricted room when runners either side shifted ground.

SARDONIA (D Johnson) – Slow to begin.

WESTERN GIRL (M Coleman) – Slow to begin.

KIA ORA KEITH (V Colgan) – Raced three wide without cover for the majority of the race.

<p>OCEANS EIGHT (O Bosson) – Held up for a distance passing the 400 metres, and near the 250 metres was denied a run to the outside of GIRLFROMTHENORTH which had lay out under pressure with OCEANS EIGHT then being angled to the inside of GIRLFROMTHENORTH and again being denied clear running. GIRLFROMTHENORTH shifted back inwards with OCEANS EIGHT then being unable to obtain clear running for the remainder of the race.</p>	
Race 8	LASER ELECTRICAL 1950
<p>BEAU ARCHERS ROSE (C Lammas) – Began awkwardly losing ground. Commenced to over-race passing the 1700 metres with the saddle shifting forward. Rider C Lammas advised that his saddle had continued to shift throughout the race placing him at a disadvantage. Raced wide without cover for the majority of the race.</p> <p>JONNY RUSS (T Thornton) – Slow to begin.</p>	
Race 9	ATKINSON DONALDSON PLUMBERS 1950
<p>J Waddell (VANNOSS) - Issued with a Minor Infringement Notice for failing to make the declared weight on VANNOSS and was fined \$100.</p> <p>CAPELLANI (R Elliot) – Slow to begin.</p> <p>DANCE CARD (L Innes) – Crowded shortly after the start having to be steadied.</p> <p>VANNOSS (C Lammas) – Crowded shortly after the start having to be steadied.</p> <p>ZAMAX (O Bosson) – Raced keenly in the early and middle stages. When questioned rider was unable to offer any reason for the gelding’s performance. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p>MALIK (J Riddell) – Held up for a distance passing the 400 metres.</p>
