| HALFASIXPENCE (Z Moki) - Slow away. |  |

| POST GRADUATE (B Ansell) - Awkwardly away. |  |

ROCCO VALENTI (S McKay) - Raced keenly for a distance near the 1000 metres making the bend near the 800 metres awkwardly.

AMAZING TEAM (M Singh) - Raced three wide without cover throughout.
UNIONHALL (C Burdan) - Raced wide without cover throughout.

SALTBUSH BILL (H Andrew) - Slow away. Had some difficulty obtaining clear running entering the home straight having to be angled outwards across heels to gain clear running approaching the 100 metres.

PLATINUM ROAD (K Asano) - Raced in restricted room for a distance near the 200 metres.

CRISTAL BUBBLE (E McCall) - Lay in under pressure in the home straight going to the line not fully tested.

Track upgraded to Good 3 retrospective to Race 1.

## Race 2 HIGGINS CONCRETE/BNZ PARTNERS 1300 (1300 Metres)

HOWZANGEL (R Goldsbury) - Slow away.

KELLYS INSPIRATION (R Elliot) - Slow away.

FLYING SURF (L Hemi) - Raced ungenerously in the early stages shifting inwards and went off stride approaching the 1000 metres. Continued to race greenly throughout.

RED RUFUS (J Parkes) - Lay inwards near the 850 metres tightening YEAH RIGHT. Dictated over extra ground 800 metres.

SHOUT (D Bradley) - Brushed the running rail when racing greenly near the 800 metres and over reacted, then when being corrected went back on to YEAH RIGHT which had to take evasive action to avoid that runners heels and shifted out dictating RED RUFUS over extra ground

YEAH RIGHT (M Singh) - Tightened near the 850 metres. Inconvenienced 800 metres.

D Turner (PODKAST) - Issued with a warning under Rule 638(1)(d) after allowing his mount to shift out over the final stages when not the required distance clear of MATT CAIN, which was dictated outwards and steadied

## Race 3 TEST ASSURED/AVENUE CONSTRUCTION LTD 1300 (1300 Metres)

LILIKOI (R Elliot) - Slow away.

TRIFOLUM (C Burdan) - Raced keenly in the early stages. Tightened near 800 metres.

SECOND SLIP (H Andrew) - Raced keenly in the early stages and when being restrained shifted in tightening TRIFOLIUM near the 800 metres.

SERENA (K Asano) - Made the bend awkwardly near the 800 metres then raced keenly for a distance, having to be restrained off heels passing the 600 metres.

POWER ‘ $N$ ’ PASSION (C O’Beirne) - Held up early in the home straight going to the line not fully tested.

LINCOLN'S KRUZ (L Allpress) - Disappointed for a marginal run early in the home straight before being angled
outwards to improve passing the 200 metres.

IMAREADY (D Turner) - Raced wide without cover throughout.

FREE TO SHINE (C Johnson) - Received a laceration to the left hind leg during the running which required veterinary attention.

## Race 4 SMART PHONE REPAIRS/TUI BACKING A WINNER SINCE 1889 HANDICAP (2200 Metres)

Trainer C Cole (VAINGLORY) - Fined \$50 for late declaration of rider.

OBRIGADO (S McKay) - Began awkwardly settling back.

ALL IN STITCHES (T Taiaroa) - Began awkwardly. Shifted in to avoid the heels of JOHNNY LINCOLN near the 100 metres and in doing so inconvenienced RUN LIKE BOO.

RUN LIKE BOO (B Ansell) - Inconvenienced 100 metres.

JOHNNY LINCOLN (R Elliot) - Held up near the 300 metres having to be restrained and angled outwards to gain clear running inside the final 100 metres.

CEAD MILE FAILTE (L Allpress) - Held up rounding the turn.

E McCall (VAINGLORY) - Was issued with a warning under Rule 636(1)(d) after noticeably relaxing her ride over the final stages, but holding second placing by a short margin. When questioned, E McCall, in the presence of the riding master, acknowledged her error and advised that she had misjudged the finish on this occasion.

## Race 5 HUNTING AND FISHING/FARMLANDS CO-OPERATIVE SOCIETY LTD 2200 ( $\mathbf{2 2 0 0}$ Metres)

MISS WOBURN (L Allpress) - Stood in its gate and was slow away (6L) and failed to make any discernible ground in the final straight. When questioned, LAllpress said that despite being slow away she could offer no tangible excuse. Connections have been advised that a warning has been placed on the barrier manners of MISS WOBURN.

SO IT WAS (R Goldsbury) - Restrained off heels near the 1400 metres.

REX ROYALE (R Elliot) - Lay in rounding the turn. Held up for a short distance passing the 200 metres.

HYPATIA (D Bradley) - Lay in under pressure in the home straight.

AKELA BELLE (K Asano) - Raced three wide in the early stages until being allowed to roll forward to sit outside the leader near the 1400 metres. K Asano was spoken to regarding the use of his elbow when PROLETARIAT lay in on his mount near the 750 metres.

PROLETARIAT (C O'Beirne) lay inwards from near the 1200 m and had to be straightened for some distance in the home straight.

ROCK WITH CHOUX (M Singh) - Became awkwardly placed on the heels REX ROYALE near the 600 metres, having to be restrained.

SAGUNTO (S McKay) - Badly checked near the 350 metres.

C O'Beirne (PROLETARIAT) - Admitted a breach of Rule 638(1)(d) in that she allowed her mount to shift in near the

350 metres resulting in SAGUNTO being checked. After deliberations C O'Beirne had her licence to ride in races suspended from the close of racing on Saturday, 30 November up to and including racing on Saturday, 14 December (10 days).

Race 6 MCVERRY CRAWFORD/HARRIS CONTRACTING 1200 (1200 Metres)
DRATINI (D Turner) - Awkwardly away settling back.

DANCE FOR MONEY (M Singh) - Raced ungenerously in the early stages.
DANGER DEE (L Hemi) - Became awkwardly placed on the heels of LA LANDONNE having to be steadied passing the 400 metres.

LA LANDONNE (R Elliot) - Hung outwards rounding the final turn.

## Race 7 <br> JOHN TURKINGTON FORESTRY LTD/WAI PINE BULLS COUNTRY CUP (1400 Metres)

HENI (L Allpress) - Slow away. Held up approaching the 250 metres then raced in restricted room for the remainder, having to be steadied over the final stages.

AWATANE (C Johnson) - Slow away.

BEEFEATER (J Parkes) - Restrained from a wide draw. The shadow roll became displaced in the home straight.

THE BANDITO (J Fawcett) - Steadied near the finish when HONNEUR NOIR lay in and away from HARTLEY.
HARTLEY (D Bradley) - Shifted in under pressure over the final stages, tightening HENI. D Bradley was advised he is expected to straighten his mounts sooner than he did on this occasion. Lost a plate during the running.

## Race 8 PROPERTY BROKERS 1400 (1400 Metres)

Trainer G Vile (MISS CONTESSA) - Issued with a warning under Rule 537(a) for late declaration of rider.

LANGKAWI (S McKay) - Tightened at the start settling back. Bumped and briefly unbalanced near the 400 metres when SINARAHMA (D Turner) attempted to improve to its inside. D Turner was advised to exercise greater care when shifting ground.

C O'Beirne (SUGAR RUSH) - Issued with a warning under Rule 638(1)(d) after allowing her mount to shift inwards approaching the 1000 metres when not fully clear of PROSECCO, ROLL THE GOLD and FLORAL BELT, which had to steady.

ROLL THE GOLD (J Fawcett) - Steadied 1000 metres.

FLORAL BELT (T Taiaroa) - Steadied 1000 metres.
SINARAHMA (D Turner) - Bumped 400 metres then had some difficulty obtaining clear running in the home straight.

PROSECCO (H Andrew) - Steadied 1000 metres, then raced three wide without cover.
MISS CONTESSA (J Parkes) - Held up for a short distance entering the home straight.

WEAPONRY (C Burdan) - Lay out over the final stages bumping LINCOLN HILLS near the finish.
LINCOLN HILLS (K Asano) - Tightened near the finish.

Race $9 \quad$ GLENN CARROLL TRANSPORT 1600 (1600 Metres)
PIMLICO (R Elliot) - Raced greenly across the junction on to the course proper.

YOSSARIAN (M Singh) - Raced keenly in the early stages.

VEUVE CLICQUOT (D Hirini) - Restrained off heels approaching the 800 metres.

MAGIC INCANTO (B Ansell) - Raced three wide without cover throughout.

TUIGIRL (S McKay) - Tailed the field throughout and was not persevered with when well out of contention. When questioned into performance rider considered something amiss in the run along the back straight so had not persevered with the mare. A post-race veterinary examination was clear. Co trainer G Lowry is to report the progress of TUIGIRL over coming days.

DASHPER (L Hemi) - Was not persevered with over the concluding stages when well out of contention. A post-race veterinary examination was clear.
