RAIL QUEEN (A Calder) - Began awkwardly losing ground. Had difficulty obtaining clear running early in the final straight before shifting out passing the 350 metres making contact with SON OF SASANOF.

HESAGOODBOY (E McCall) - Crowded soon after leaving the barrier and steadied. Could not obtain clear running until inside the final 100 metres.

SON OF SASANOF (S Collett) - Began awkwardly. Steadied near the 900 metres when awkwardly placed on heels. Contacted and inconvenienced passing the 350 metres.

MASAROVA (R Elliot) - Restrained soon after leaving a wide barrier.

REMARKABLE RILEY (L Satherley) - Raced keenly in the early to middle stages. Raced wide throughout.

WESTERN CHOICE (S Spratt) - Raced wide without cover for the majority of the race.

Race 2 RANDALL JUDD MEMORIAL 1200

STRIKING (S Collett) - Raced in restricted room shortly after leaving the barrier.

AMERICO (S McKay) - Contacted soon after leaving the barrier becoming unbalanced. Raced three wide without cover throughout.

RELIABLE LADY (T Thornton) - Restrained from a wide barrier.

ROBROCKS (T Yanagida) - Inconvenienced shortly after the start.

MABILIS (D Johnson) - Steadied when placed in restricted room passing the 100 metres to the inside of AMERICO which shifted in slightly. A post-race veterinary examination did not reveal any abnormality. Trainer advised that the filly would now be spelled.

AZAFRAN (R Elliot) – Lost a right hind plate during the running.

Race 3 REVITAL GROUP 1400

RED RUSHIN (J Fawcett) - Slow to begin.

MR BAZAMOUR (S Collett) - Began awkwardly.

STRATIUS (T Thornton) - Began awkwardly.

ON THE NIGHTTRAIN (C Grylls) - Had difficulty obtaining clear running until passing the 250 metres.

SHAM ON TOAST (A Calder) - Over raced in the early stages. Raced in restricted room for a distance approaching the 100 metres before shifting out passing the 75 metres to obtain clear running.

ITS ALL FAKE NEWS (M Coleman) - Raced three-wide without cover throughout.

PEACE TRAIN (L Satherley) - Had some difficulty obtaining clear running early in the final straight.

GOLDEN ABLE (L Innes) - Inconvenienced approaching the 50 metres after improving onto heels.

Race 4 MARSH RACING 1400

CERYS (A Calder) - Slow to begin. When questioned regarding performance rider A Calder advised that getting further back than intended, the mare had raced greenly then failed to run on in the final straight.

AMELIA GRACE (T Thornton) - Began awkwardly. Made the bend near the 900 metres awkwardly.

CHAMPAGNE PRINCESS (L Satherley) - Knuckled leaving the barrier. When questioned regarding the performance the rider advised that the mare had been unsuited to today's track conditions.

TORQUE STRAIGHT (J Riddell) - Raced three wide without cover throughout.

COCO BACI (C Grylls) - Lay out rounding the final bend then held up for a distance approaching the 150 metres before shifting in to obtain clear running. When questioned regarding his decision to improve inside of CICCIOLINA early in the final straight, when he had initially been racing outside of that mare, C Grylls explained that after CICCIOLINA had shifted out slightly in front of him a run had presented itself to the inside of that runner approaching the 200 metres however when ORIGINEEL shifted out, the run had closed with him then being held up and having to shift ground inward to obtain clear running. C Grylls's explanation was noted.

ORIGINEEL (L Innes) – Lost right hind plate during the running.

Race 5 PORRITT SAND 1600

SWORD OF FREEDOM (O Bosson) – Underwent a veterinary examination after arriving at the start with blood present in the left nostril and was declared a late scratching at 2:55pm. Underwent further veterinary examination on return to the stable area which found the blood to be from a minor laceration.

SHELOB (E McCall) – Slow to begin then hampered. Ran wide when making the bend near the 900 metres when racing ungenerously.

HEY SOUL SISTER (J Waddell) - Crowded start.

PAUL'S SUPER ARIKI (A Calder) - Raced wide without cover for the majority of the race.

Race 6 WENTWOOD GRANGE 1600

MATAWHERO (J Fawcett) - Began awkwardly.

AALAALUNE (R Elliot) - Steadied shortly after the start when in restricted room. Held up entering the final straight when shifting out to obtain clear running.

DAWNTING (J Riddell) - Contacted and forced wider passing the 400 metres by AALAALUNE which was shifting out in an attempt to find clear running.

XITLALLI (S Collett) - Had difficulty obtaining clear running early in the final straight after improving onto the heels of BOSCOLO which was weakening.

SEVEN SEAS (C Grylls) - Held up until passing the 200 metres.

BOSCOLO (L Satherley) - Lay out when placed under pressure in the final straight.

R Elliot (AALAALUNE) - Issued with a warning for allowing his mount to shift out when not sufficiently clear of DAWNTING which was contacted and unbalanced passing the 400 metres.

Race 7 COGSWELL SURVEYS 1600

BEACHED AS BRO (D Johnson) – Lost right front plate during the running.

RIPLEY (O Bosson) - When questioned regarding the performance the rider could offer no excuse.

ANNA CECELIA (S McKay) – Raced wide without cover for the majority of the race.

THE MIDNIGHT SHFIT (J Fawcett) – Raced in restricted room passing the 250 metres then was unable to obtain clear running until inside the 100 metres.

PONT ALMA (J Riddell) - Steadied passing the 100 metres when denied clear running.

PATSYS LASS (R Smyth) - Held up until shifting out to obtain clear running passing the 200 metres.

Race 8 ANDERSON ACCOUNTING FAST TRACK \$5k BONUS 1200

RISTRETTO (D Johnson) - Slow to begin.

WITCHERY (O Bosson) - Began awkwardly losing ground.

NEW YORK JAZZ (J Fawcett) - Crowded shortly after the start having to be steadied.

OUR WONDERLAND (T Thornton) - Crowded shortly after the start having to be steadied.

DRAIOCHTA (J Riddell) - When questioned regarding the performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

DIDI BAY (V Colgan) – Raced wide without cover. Eased down in the final straight by its rider and found to have had blood in both nostrils when returning to the enclosure. A veterinary examination confirmed the gelding to have bled. DIDI BAY is now subject to a three month stand down from racing and trialing and a two month stand down from track work with an appropriate veterinary clearance also being required prior to trialing or racing next.
