## **RACE COMMENTS:**

#### Race 1 DAVE HOSKIN CARRIERS MDN 1340

Stewards gave permission for **D Turner** to ride **LA MIA SIRENA** 1kg over its carded weight due to there being no suitable replacement. Both **D Turner** and his riding agent were addressed by Stewards and advised that **D Turner** is no longer permitted to accept rides under 56kg without prior consultation with the RIU.

SORRY I'M LATE (B Ansell) - Raced three-wide without cover throughout.

**EXPLOSIVE ROC (L Hemi)** - Began awkwardly contacting and briefly unbalancing **TRENDY BELT.** 

TRENDY BELT (T Taiaroa) - Contacted at the start.

**SOUL VACATION (K Asano)** – Slow away.

**FLIRTINI (R Goldsbury)** – Slow away.

**B** Ansell (SORRY I'M LATE) - Admitted a breach of Rule 638 (1) (d) in that she allowed her mount to shift inwards in the home straight near the 100 metres when not clear of **CARPE DIEM** which was checked. After deliberations **B** Ansell had her licence to ride in races suspended from the close of racing today (30 November) until the close of racing on Sunday, 8 December – 5 racing days.

**CARPE DIEM (C Johnson)** – Checked approaching the 100 metres.

LA MIA SIRENA (D Turner) - Raced in restricted room passing the 100 metres.

**HEIRLOOM (H Andrew)** - Held up for a distance entering the home straight having to be angled inwards to gain clear running approaching the 100 metres.

## Race 2 AME SOUND ELECTRICAL 1340

**EDWARDIAN LADY (T Taiaroa)** - Began awkwardly bumping **STAND TALL**.

**STAND TALL (D Bradley)** – Contact at the start.

**ARTURO (J Parkes)** - Raced keenly throughout.

**T TAIAROA (EDWARDIAN LADY)** - Was issued with a warning under Rule 638 (3) (b) (ii) with regard to her whip use prior to the 100 metres.

LA BELLA ROSA (C O'Beirne) - Raced three wide on the pace in the early stages before being restrained to obtain cover near the 800 metres.

## Race 3

**GAS & HEATING 1200** 

**CUIDADO CALIENTE (L Hemi)** - Slow away

KARIMA (M Singh) – Slow away

**GLAMOUR (C Burdan)** - Tightened going into the first turn when **PAINLESS**, which was racing greenly, shifted in and away from **SHOWBOAT**. Held up entering the home straight then continued to have difficulty obtaining clear running until passing the 150 metres. Raced greenly throughout and ran up onto heels over the final stages.

MISS SWEET PEE (R Hannam) - Raced three-wide on the pace throughout. When questioned into performance rider advised the filly had raced keenly when wide without cover.

FIANO (H Andrew) - Lay in under pressure over the final stages briefly tightening PAINLESS approaching the 100 metres.

PAINLESS (C O'Beirne) - Tightened 100 metres. Dictated final stages near the finish.

Race 4 PALAMOUNTAINS MUSCLE RECOVERY 2040

**CASINO EL JAY (L Hemi)** – Stood in the gates losing ground – 10L. Connections were advised that a warning has been placed against the mare's barrier manners.

AMORATA (C Johnson) - Raced keenly in the early and middle stages.

**FLYING MEG (C Burdan)** - Dictated inwards shortly after the start. Raced keenly in the early to middle stages being restrained off heels near the 1,400 metres and again near the 850 metres.

**ROSCHANA (M Singh)** - Raced keenly in the early stages having to be restrained off the heels of **LORD TURBO** approaching the 1,700 metres.

**LORD TURBO (C O'Beirne)** - Raced ungenerously near the 1,650 metres and when being restrained went back on to **COMMANDING PRINCE, ROSCHANA** and **FORESEEABLE** which were all dictated wider on the track.

C O'Beirne (LORD TURBO) – Was given a warning under Rule 638 (1) (d) for allowing her mount to shift in shortly after the start when not the required distance of **SUNBURST** (H Andrew) which had to steady. C O'Beirne was shown footage of her ride in the presence of the Riding Master.

**R Myers (STEVEN JAMES)** Was issued with a warning under Rule 638 (1) (d) after allowing her mount to shift ground shortly after the start dictating **FLYING MEG** inward when not clear.

**MYRTLE (R Goldsbury)** – R Goldsbury reported that the mare had lost its footing going into the back straight. The area was inspected by the RIU and ground staff which found a clod of earth had become displaced and remedial action was done.

**TRENDING (D Turner)** – D Turner was questioned into his ride and in particular his decision to hand up the lead when racing adjacent to the running rail near the 800 metres to **COMMANDING PRINCE** when challenged, then shift out and attempt to regain the lead one off the rail. D Turner advised that his riding instructions were to make sure the gelding was not crowded as it has a tendency to over react when in restricted room. Trainer B Newman was questioned and confirmed the instructions given to D Turner.

Race 5 WANGANUI MOTORS AND THE DYKE FAMILY 1600

ROCK ISLAND LINE (K Asano) - Raced keenly in the early and middle stages. Tightened near the 1,400 metres.

**SHADOW KING (C O'Beirne)** – Made the bend near the 1,400 metres awkwardly shifting out dictating **GUILLADA outwards** tightening **ROCK ISLAND LINE.** 

**GUILLADA (D Bradley)** - Steadied off the heels of **AWATANE** which shifted in near the 1,200 metres when not entirely clear. H Andrew was advised to exercise greater care.

**AWATANE (H Andrew)** – Was galloped on during the running and required veterinary attention following the race.

Race 6 LOADERS WANGANUI 1600

**HE NO OPILIO (H Andrew)** – Slow away. Ran up onto the heels of the retiring **KIT KAT** on the point of the home turn and had to be steadied.

**ALL IN MANA (T Taiaroa)** - Shifted out abruptly going into the first bend resulting in **CHARTWELL** and **CAPELYN** being heavily contacted and checked. T Taiaroa was questioned in the presence of the Riding Master and advised Stewards she had difficulty maintaining control of the gelding which had a tendency to race greenly and was unable to make the first bend correctly. Raced three-wide without cover throughout.

**OFF SHAW (D Turner)** – Made the first bend awkwardly. Lay in under pressure rounding the final turn and again in the home straight.

ROC LEGEND (M Singh) – Held up early in the home straight having to be angled outwards across heels to gain clear

running inside the final 200 metres. Lay in under pressure over the final stages becoming awkwardly placed on the heels of **PLATINUM WILD CARD** having to be straightened.

**CAPELYN (C Burdan)** – Heavily contacted and checked near the 1,400 metres. Not persevered with in the home straight. A subsequent veterinary examination revealed mild soreness in the left hind.

KIT KAT (J Bassett) - Made the first corner awkwardly and shifted out tightening HINEPARA.

# Race 7 STEELFORM ROOFING GROUP WANGANUI CUP

**Trainer F Auret** (PORTLAND JIMMY) - Issued with a warning under Rule 537 (a) after not declaring a rider by the required time.

**SAMPSON (J Parkes)** – Slow away

**OBSESSIVE (R Kozaki)** - Got its head down as the start was made and was slow away. Finished well back. R Kozaki was of the opinion the gelding is better suited to more rain-affected going. A subsequent veterinary inspection was clear.

**RED SIERRA (R Myers)** - Bumped near the 350 metres when **SENTIMENTAL MISS** improved into a narrow run to its inside.

M Singh (PORTLAND JIMMY) - Was spoken to regarding his whip use prior to the 100 metres.

**Darryl Bradley** (YATIMA) – Defended a charge of careless riding in that he allowed his mount to shift in shortly after the start dictating **OVERTHERIVER** in onto **PLATINUM INVADOR** with both those runners being bumped. Also affected was **OBSESSIVE** which had to take evasive action to avoid the heels of **PLATINUM INVADOR**. After deliberations the JCA found the charge proved and **D Bradley** had his licence to ride suspended from the close racing today (30 November) until the close of racing on Sunday, 8 December (inclusive) – 5 riding days.

# Race 8 A+ PLUMBING 1340

**DESTINY ONE (B Ansell)** – Tightened at the start settling back.

**SOMEWHERE MAN (C O'Beirne)** – Slow away

**RED ROBIN (D Bradley)** - Raced wide without cover throughout.

**TERRACOTTA WARRIOR (C Burdan)** - Restrained off heels near the 1,100 metres going back on to **HUNDYAMONTH** which had to be steadied for some distance. Tightened having to be restrained near the 700 metres when **POWERBALL** which was racing keenly shifted out, simultaneously as **BANGLES** shifted in with **TERRACOTTA WARRIOR** going back on to **HUNDYAMONTH** which was steadied. Lay inwards in the home straight.

**HUNDYAMONTH (M Singh)** - Restrained off heels near the 1,100 metres when the pace ahead eased. Accidentally struck over the head near the finish.
