RACE COMMENTS:

Race 1 CR GRACE/AWASSI NZ 2200 (2200 Metres)

BELINDABELLA (H Andrew) - Raced ungenerously for a short distance near the 1900 metres.

AJAY LINCOLN (R Hannam) - Made the turn near the 2000 metres awkwardly, dictating HOWZANGEL wider on the track. Shifted in under pressure approaching the 300 metres.

HOWZANGEL (D Hirini) - Dictated wide near the 2000 metres then raced three wide without cover.

ALTAR BOY (M Singh) - Contacted when HOWZANGEL lay in near the 900 metres. Tightened 100 metres.

TOUCH THE CLOUDS (J Fawcett) - Shifted in passing the 300 metres and had to be straightened.

J Fawcett (TOUCH THE CLOUDS) – Admitted a breach of Rule 638(3)(b)(ii) in that she used her whip excessively prior to the 100 metres and was fined \$300. J Fawcett was also issued with a warning under Rule 638(1)(d) after allowing her mount to shift in tightening ALTAR BOY inside the final 100 metres.

Prior to the authorisation of dividends an objection was lodged by the connections of the 2nd placed TAKE THAT (J Parkes) alleging interference by the winner BELINDABELLA (H Andrew) passing the 300 metres. After deliberations the JCA dismissed the protest. H Andrew was advised she is expected to straighten her mounts sooner than she did on this occasion. Stewards took into account inward movement from AJAY LINCOLN (R Hannam) when assessing the degree of interference.

Race 2 RURAL AIR WORK/ISAACS PLUMBING, PLUMPING & ELECTRICAL 1350 (1350 Metres)

FLYING SURF (L Hemi) - Jumped outwards at the start tightening BENNY LINCOLN, COLYTON SKY and FLORENCE O'REILLY. Inclined to lay inwards early in the home straight.

COLYTON SKY (C Johnson) – Tightened start.

BENNY LINCOLN (H Andrew) - Tightened start. Raced three wide without cover throughout.

FLORENCE O'REILLY (M Singh) – Tightened start. Lay in under pressure in the home straight having to be straightened.

SHOUT (J Parkes) - Began awkwardly settling back. When questioned into performance rider advised the gelding had raced greenly throughout.

R Hannam (KELLYS INSPIRATION) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and was fined \$300

Race 3 NZB INSURANCE PEARL SERIES RACE (1200 Metres)

The start of this event was delayed approximately 4 minutes after several runners proved difficult to load.

OHITI LASS (R Hannam) – Slow away.

L Hemi (TAMAHINE) - Issued with a warning under Rule 638(4) after checking the speed of her mount when crossing to the lead near the 700 metres, inconveniencing KISS AN ANGEL, which went back on to DISTANT FIRE, and

SHOWPIECE, which were dictated outwards.

KISS AN ANGEL (R Kozaki) – Inconvenienced 700 metres. Shifted out 250 metres having to be straightened.

DISTANT FIRE (Z Moki) – Dictated outwards 700 metres.

SHOWPIECE (J Parkes) – Dictated outwards 700 metres.

FABULOUS FLEET (M Singh) - Shifted inwards near the 250 metres becoming awkwardly placed on the heels of KISS AN ANGEL, which shifted out, having to be straightened.

Race 4 FARMERS TRANSPORT 1200 (1200 Metres)

TEKEELA CHARM (R Kozaki) – Late scratching at 2.31pm after proving difficult to load. Connections were advised the filly must trial to the satisfaction of Stewards prior to racing next.

RIBA MINE (D Hirini) - Slow away. Restrained off the heels of THUTMOSIS near the 800 metres, shifting out dictating ENDURING LOVE wider on the track.

ENDURING LOVE (J Parkes) – Dictated out 800 metres.

THUTMOSIS (Z Moki) - Made the bend awkwardly near the 800 metres.

RIO STAR (L Hemi) - Held up for a short distance rounding the turn, then again near the 250 metres, before being angled into a narrow run passing the 100 metres to gain clear running.

LINCOLN HANOVER (R Hannam) - Had to be angled outwards across heels to gain clear running inside the final 300 metres.

Race 5 AON INSURANCE BROKERS 1200 (1200 Metres)

LINCOLN'S GAL (R Hannam) - Slow away.

SUPER GIRL (M Singh) - Restrained from a wide draw.

SECOND SLIP (H Andrew) - Raced wide without cover throughout.

MAISON ROXANNE (L Hemi) – Raced keenly in the early stages. Held up rounding the turn and early in the final straight gaining clear running inside the final 300 metres.

Race 6 PGG WRIGHTSON/LEOPARD HOTEL XMAS CUP (2200 Metres)

LUMINOUS (J Parkes) - Began awkwardly.

AMORATA (C Johnson) - Raced keenly for a distance in the middle stages.

PEP TORQUE (M Singh) - Ran up on to the heels of VERY APPEALING near the 1800 metres and when being restrained shifted out dictating HANK MOODY.

HANK MOODY (H Andrew) - Dictated out 1800 metres.

Z Moki (VERY APPEALING) - Was spoken to regarding her whip use in the home straight.

Race 7 BALLANCE AGRI-NUTRIENTS MILE (1600 Metres)

CAPELLASSTAR (R Goldsbury) – Late scratching at 4.15pm on veterinary advice after dislodging the jockey after leaving the enclosure and jumping the outside fence. Connections were advised that CAPELLASSTAR will require a veterinary clearance prior to racing next.

OCEANIC (J Parkes) - Underwent a pre-race veterinary inspection after making contact with the outside fence on the way to the start.

COUNT CONTI (R Kozaki) – Slow away.

LOVE POTION (C Johnson) - Raced three wide in the early stages before being ridden forward to sit outside the leader near the 1000 metres.

EMIRATE (Z Moki) - Gave ground quickly approaching the 800 metres and was not persevered with in the final straight when well out of contention. When questioned, rider could offer no excuse. A subsequent veterinary inspection was clear.

FRIDAY (T Allan) – Hung outwards rounding the home turn.

Race 8 CARRFIELDS LIVESTOCK MILE (1600 Metres)

CHAMPAGNE BRIDE (H Andrew) – Awkwardly away. When questioned into performance rider could offer no tangible excuse.

HUNDYAMONTH (R Kozaki) – Slow away. Hung outwards over the final stages.

T Allan (UNCLE BRO) - Was spoken to regarding his whip use prior to the 100 metres.

UNCLE BRO (T Allan) – Rider dropped whip just short of the finish.
