| Race 2 - VERNON & VAZEY TRUCK PARTS PREMIER (1400 Metres) TIMES TICKING (J Waddell) – Trainer A MacGregor reported the gelding has come through the race well and it is now his intention to remove the blinkers from Times TIMES TICKING before his next start. |
| Race 3 - FASTTRACK INSURANCE \$5K 'CHALMERS HANDICAP' (2500 Metres) CEAD MILE FAILTE (L Allpress) – Co-trainer J Benner advised Stewards the mare may have jarred up slightly throughout the running of the race. J Benner is satisfied with CEAD MILE FAILTE post-race condition and it is his intention to carry on with her current preparation. |
| Race 6 - HIREMASTER PREMIER (2400 Metres) BRUNO STARS (L Allpress) – Trainer C Ivil advised the gelding pulled up lame in the shoulders and has now been sent for a spell. |

SWORDS DRAWN (S Weatherley) – Trainer S Ritchie advised Stewards that on Monday the gelding underwent an endoscopic examination and blood tests which found no abnormalities. S Ritchie also advised that SWORDS DRAWN will participate in an exhibition gallop at Ellerslie, Thursday 19 December and if connections are happy with the gelding's gallop will carry on with his current campaign.

Race 8 JR Webb & Son 2200

STAR KAREN (S Collett) – Co-trainer P Williams was satisfied with the post-race condition of STAR KAREN and will carry on with the mare's current preparation.

RACE COMMENTS:

Race 1

Evenflo 1400

THOUSANDKISSESDEEP (R Elliot) – Made contact with the front of the gate with its barrier opening slightly early and losing ground as a result.

VLADIVOSTOK (J Childs) – Began awkwardly. Shifted out to obtain clear running approaching the 300 metres making brief contact with AZAFRAN. Lay out when placed under pressure in the final straight.

MONLULA (T Yanagida) – Began awkwardly.

MY WORLD (S Weatherley) – Raced wide in the early stages being asked to improve forward to lead approaching the 1000 metres.

AZAFRAN (A Collett) – Briefly contacted 300 metres.

HUMBUCKER (L Innes) – Lay out making the final bend and early in the final straight when placed under pressure. Raced in restricted room over the concluding stages and was steadied.

Race 2

First Global Logistics – Asendia 2100

NOT USUAL DREAM (L Innes) – Began awkwardly losing ground. When questioned regarding the performance of NOT USUAL DREAM Rider L Innes advised that after beginning poorly the gelding had settled further back than intended and when placed under pressure had failed to respond. Underwent a post-race veterinary examination which could find no obvious abnormality.

VIVA VOLARE (T Yanagida) – Raced ungenerously when making the crossing near the 1600 metres and was hampered when awkwardly placed. Hampered 550 metres and then improved on to heels 400 metres.

SHOCKING PENNY (D Johnson) – Raced ungenerously in the early stages.

RAPIDZ (C Grylls) – Raced wide without cover for the majority of the race.

CLEVER APPROACH (S Weatherley) – Restrained away from heels passing the 900 metres.

JAKAMA KRYSTAL (S Spratt) – Crowded and checked near the 550 metres to the inside of YING RESOLUTE which shifted in and away from CHARRED which lay in despite the efforts of its rider. Hampered as a result was VIVA VOLARE.

PIGGY MALONE (J Childs) – Rider dropped his whip over the concluding stages.

| <p>BAYEUX (J Childs) – Slow to begin.</p> <p>MARBUZET (S Weatherley) – Began awkwardly losing ground.</p> <p>SARDONIA (T Yanagida) – Began awkwardly. Shifted out abruptly passing the 150 metres to obtain clear running.</p> <p>KIWIANNA (A Collett) – Raced wide without cover for the majority of the race.</p> <p>READY TO ROAR (D Johnson) – Steadied when hampered passing the 150 metres to avoid the heels of SARDONIA which shifted out abruptly.</p> <p>T Yanagida (SARDONIA) – Admitted a breach of careless riding in that he angled SARDONIA out near the 150 metres when insufficiently clear of READY TO ROAR which had to steady when hampered. After considering submissions the Judicial Committee suspended his license to ride in races from the conclusion of racing on Sunday 15 December 2019 up to and including racing on Friday 20 December 2019, 4 national riding days.</p> | |
| Race 4 | Dunstan Feeds 1500 Championship Qualifier 1400 |
| <p>ACUTUS (S Spratt) – Raced three wide without cover for the majority of the race.</p> <p>FIRODEN (L Innes) – Slow to begin.</p> <p>MEKELLE (S Weatherley) – Raced ungenerously passing the 1000 metres shifting out to avoid heels, becoming awkwardly placed for a distance passing the 800 metres.</p> <p>GIANT GEM (L Allpress) – Held up entering the final straight before shifting in to obtain clear running. Had to shift out passing the 200 metres to obtain clear running.</p> | |
| Race 5 | Barfoot & Thompson Twilight Cup (1500 metres) |
| <p>SACRE COEUR (A Collett) – Slow to begin.</p> <p>VERBALIZER (K Asano) – Restrained from a wide barrier draw.</p> <p>JIP JIP ROCK (R Elliot) – Restrained from a wide barrier draw.</p> <p>RIDING THE WAVE (J Childs) – Went off stride when in restricted room near the 1200 metres.</p> <p>S Spratt (ROYAL PRINCE) – Issued with a warning after permitting ROYAL PRINCE to shift in near the 1200 metres when insufficiently clear of IT’S DOABLE which was dictated inwards crowding MASTER PAINTON which then placed RIDING THE WAVE in restricted room which reacted poorly and was hampered.</p> <p>INCANTESIMO (L Innes) – Raced three wide without cover throughout.</p> <p>MASTER PAINTON (D Johnson) – Lost the off hind plate during the running.</p> | |
| Race 6 | Cardinal Logistics 1600 |
| <p>IAGO (A Collett) – Began awkwardly losing ground. Had difficulty obtaining clear running in the final straight before shifting in approaching the 300 metres.</p> <p>GREYVEE (L Innes) – Raced three wide without cover throughout.</p> | |

SINGLE MOMENT (S Spratt) – Raced ungenerously when being restrained in the early to middle stages. Inconvenienced passing the 400 metres when awkwardly placed near the heels of CHARLI ROSE which shifted out to obtain clear running. Had some difficulty obtaining clear running for the majority of the final straight.

ANJAMEME (T Yanagida) – Raced wide without cover until improving forward near the 1000 metres to race outside the leader. Hampered when weakening 300 metres.

CIVILISED (K Asano) – Shifted out to obtain clear running passing the 300 metres hampering ANJAMEME.

K Asano (CIVILISED) – Issued with a warning after permitting CIVILISED to shift out near the 300 metres when insufficiently clear of ANJAMEME which was hampered.

T Yanagida (ANJAMEME) – Issued with a warning for using his whip excessively on ANJAMEME prior to the 100 metres.

The connections of the 2nd placed horse **GREYVEE** (L Innes) viewed Stewards' footage contending interference by the 1st placed horse **CIVILISED** (K Asano) electing not to proceed with a protest.
