RACE COMMENTS:

Race 1	ICON SECURITY SYSTEMS 1600
CAUTIOUS APPROACH (J Waddell) – Slow away. Steadied when awkwardly placed to the inside of HAKUNA MATATA (D Danis) which shifted in passing the 1300 metres.	

MERSEY BEAT (T Thornton) – Slow away.

SAVEZAR (R Elliot) – Hampered leaving the barriers, then being steadied to obtain cover. Held up rounding the final bend, then had difficulty obtaining clear running until approaching the 100 metres.

HAKUNA MATATA (D Danis) – Jumped away awkwardly. Contacted and unbalanced approaching the 1500 metres.

SESTO (R Kozaki) – Briefly crowded approaching the 1500 metres. Held up until shifting out approaching the 100 metres to obtain clear running, then lay out when placed under pressure and raced greenly for the remainder of the race.

WORDSWORTH (A Calder) – Briefly crowded approaching the 1500 metres.

RANGER (V Colgan) – Made the bend awkwardly near the 900 metres when the pace steadied, then continued to race ungenerously for a distance.

V Colgan (RANGER) – Issued with a warning for allowing his mount to shift in approaching the 1500 metres when not sufficiently clear of WORDSWORTH which was crowded inwards on to SESTO and HAKUNA MATATA.

D Danis (HAKUNA MATATA) – Issued with a warning for allowing his mount to shift in when not sufficiently clear of CAUTIOUS APPROACH which was placed in restricted room having to be steadied passing the 1300 metres.

D Johnson (SNOWDEEL) – Was spoken to regarding her whip use prior to the 100 metres.

T Da Cruz (SESTO) – Trainer T Da Cruz was fined \$50 under the Minor Infringement Schedule after failing to declare an item of notified gear by the required time.

Race 2 | **ROB PINNY REALTYCOM 1400**

AILEEN GRACE (S Weatherley) – Contacted and unbalanced passing the 50 metres by SALT BAY which was crowded outwards when WEAPONRY shifted outwards abruptly.

SALT BAY (C Lammas) – Crowded and unbalanced passing the 50 metres.

WEAPONRY (C Burdan) – Shifted outwards abruptly passing the 50 metres. Apprentice C Burdan was shown the footage in the presence of the Riding Master.

Following the running of this race the connections of the fourth placed AILEEN GRACE viewed footage before electing not to proceed with a protest.

Race 3 | **SHOWTECHNIX 1200**

SON OF SASANOF (B R Jones) – Jumped away awkwardly. Held up for a distance passing the 350 metres before shifting out to obtain clear running.

MORE THAN ENOUGH (R Elliot) – Slow away. Lay out rounding the final bend.

SNIP (C Burdan) – Over-raced in the early and middle stages. Shifted out to obtain clear running passing the 400 metres making contact with CALL ME EVIE which was forced wider.

PONTIAC (J Waddell) – Crowded near the 1100 metres. Held up throughout the final straight.

CALL ME EVIE (J Fawcett) – Contacted and forced wider 400 metres.

LUCKY CENTURY (C Grylls) – Checked near the 1100 metres.

T Thornton (SHEEZNOTEASY) – Admitted a charge of careless riding in that she permitted her mount SHEEZNOTEASY to shift inwards when not sufficiently clear of PONTIAC which was dictated inwards crowding LUCKY CENTURY which was checked near the 1100 metres. After hearing all relevant evidence, the Judicial Committee suspended T Thornton's license to ride in races from the conclusion of racing on 18 December up to and including racing on 26 December, 5 national riding days.

Race 4 | **KIWI BUS BUILDERS 1200**

EL NYMPH (M Coleman) – Slow away.

RELIABLE HUNTER (S Weatherley) – Jumped away awkwardly.

RAIL QUEEN (A Calder) – Slow away. Held up rounding the final bend.

MAC'S EXPRESS (S McKay) – Raced wide without cover throughout. Lay out rounding the final bend.

AEROETTE (T Yanagida) – Held up until near the 150 metres.

RIVERFALLS (C Burdan) – Contacted and unbalanced on several occasions over the final 150 metres.

S Weatherley (RELIABLE HUNTER) – Admitted a charge of careless riding in that he allowed his mount RELIABLE HUNTER to shift outwards on a number of occasions inside the final 150 metres when continuing to ride his mount forward making contact with RIVERFALLS on several occasions. After hearing all relevant evidence, the Judicial Committee suspended S Weatherley's licence to ride in races from the conclusion of racing on 15 December up to and including racing on 27 December, 8 national riding days.

Race 5 | **YOUNG READ WOUDBERG CHARTERED ACCOUNTANTS 2100**

SECONDS OUT (M Hashizume) – Made the first bend awkwardly near the 1600 metres forcing WINKLEBELLE wider.

WINKLEBELLE (V Colgan) – Hampered and forced wider passing the 1600 metres.

OHTHOSERUSSIANS (T Thornton) – Had to be checked passing the 1400 metres when improving on to the heels of MOTUMAN (T Yanagida) which was being steadied. T Yanagida was advised that he must not steady his mount to a degree which puts other riders in difficulty. Held up rounding the final bend.

SEEMAX (C Grylls) – Contacted and unbalanced passing the 350 metres when MOTUMAN (T Yanagida) shifted out. Rider T Yanagida was advised to exercise care.

Race 6 | **JACKSON REEVES LAWYERS 1200**

QUANTUM (J Riddell) – Slow away.

DR HANK (T Thornton) – Slow away.

MAKABAR (R Beemud) – Slow away.

PUYSEGUR (C Grylls) – Blundered jumping away.

GLORIOUS OCEAN (D Johnson) – Jumped away awkwardly. Raced three wide without cover throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 7 | **REAL CHARTERED ACCOUNTANTS 1400**

CERYS (M Coleman) – Began awkwardly losing ground.

GEEJAYROC (J Fawcett) – Crowded shortly after the start having to be steadied.

BOUFFANT (V Colgan) – Crowded shortly after the start having to be steadied.

RELIABLE LADY (T Thornton) – Held up for a distance approaching the 250 metres. Lay out and away from **SWEET DREAMS** which shifted out approaching the 200 metres becoming awkwardly placed on the heels of **SOFT HEARTED** which was shifting in.

SWEET DREAMS (J Waddell) – Held up rounding the final bend.

Race 8 | **DON GRIFFITHS LIMITED DRILLING CONTRACTOR 1400**

OAK (A Calder) – Began awkwardly. Improved on to heels passing the 100 metres, then being held up for the remainder of the race.

MASTER OAKLEIGH (T Yanagida) – Crowded shortly after the start. Held up rounding the final bend.

HUNTER VILLAIN (D Johnson) – Crowded shortly after the start.

CRAIGIEVAR (S McKay) – Raced keenly when being restrained for a distance passing the 1000 metres.

OUR BEESKEES (L Satherley) – Raced in restricted room near the 100 metres when **HUNTER VILLAIN** and **AMASECOYA** both shifted ground slightly.

CEARDAI (M Coleman) – Lost the left hind plate during the running.
