GENERAL:

No issues to report.

RACE COMMENTS:

Race 1	WEBSITE ANGELS PREMIER (1400 metres)
KHORABELLA (D Danis) - Slow away being restrained early after jumping from the outside barrier. When reviewing films of the start it was apparent that the barrier gate for KHORABELLA had been slightly slow to open in comparison with the remainder of the field. With KHORABELLA having finished in third placing, under the provisions of Rule 632 the mare remained a runner. Held up rounding the final turn continuing to have some difficulty obtaining clear running until angling outwards across heels near the 150 metres.	

RIVER RUN (L Innes) - Jumped away awkwardly. Steadied near the 1200 metres.

RUSAVY (J Fawcett) - Shifted outwards abruptly shortly after jumping away hampering LEAF, TORQUE STRAIGHT, DANGER DEE, and inconveniencing SAINTLY WAY. Raced four wide without cover.

LEAF (J Riddell) - Hampered shortly after jumping away.

DANGER DEE (D Johnson) - Hampered shortly after jumping away. Held up early in the straight until near the 200 metres.

TORQUE STRAIGHT (C Grylls) - Hampered shortly after jumping away.

SAINTLY WAY (S Weatherley) - Inconvenienced shortly after jumping away.

TERRACOTA WARRIOR (C Burdan) - Raced three wide without cover.

EL COOLIO (T Thornton) - Steadied when placed in restricted room passing the 600 metres. Shifted away from GARADOS near the 250 metres then being steadied for a distance when placed in restricted room.

JEWEL OF PATCH (T Yanagida) - Held up early in the straight until the 250 metres.

PEACE TRAIN (L Satherley) - Had to be steadied to avoid the heels of SHOW DOWN near the 125 metres.

T Harris - Issued with a warning after permitting his mount to shift inwards near the 125 metres when not sufficiently clear of PEACE TRAIN which was crowded and briefly steadied.

Race 2	WENTWOOD GRANGE PREMIER (1200 metres)

Trainer **G Harvey** (BEAUNE) - Fined \$50 after failing to obtain permission for Pre-race Ear Covers by the required time.

TELLMESOMETHINGBOY (T Thornton) - Slow to begin then crowded.

O'CANADA (S Spratt) - Raced three wide without cover. When questioned regarding performance, rider advised that the colt had raced greenly and was still immature.

LIONIZE (J Waddell) - Hung out rounding the bend and continued to do so in the straight running off when proving a difficult ride losing its chance. Trainer S Marsh was advised that the gelding would be required to trial to the satisfaction of a Stipendiary Steward prior to racing again. Mr Marsh indicated that LIONIZE was likely to be sent for a spell. A post-race veterinary inspection did not reveal any obvious abnormality other than the gelding having lost the right hind plate.

JAMIESON'S TIPPLE (C Grylls) - Lay out rounding the final turn continuing to race greenly when placed under pressure in the straight inconveniencing TOKORANGI passing the 200 metres.

TOKORANGI (C Lammas) - Inconvenienced passing the 200 metres.

BEAUNE (A Calder) - A post race veterinary examination found the filly to have suffered from cardiac arrhythmia with the appropriate veterinary clearance now required prior to racing again.

Race 3	LOWE SCHOLLUM & JONES PREMIER (1200 metres)

FEELIN THE LOVE (C Burdan) - Jumped away very awkwardly losing ground then racing ungenerously for a distance losing further ground.

PRETTY TO SEA (L Innes) - Slow away (4L).

MONEY TRAIL (J Fawcett) - Raced three wide without cover.

CYBER ATTACK (J Waddell) - Checked when crowded passing the 250 metres and was not persevered with for the remainder of the race.

R Beemud - Admitted a charge of careless riding in that he permitted his mount MALAMBO to shift inwards when not sufficiently clear of CYBER ATTACK which was checked passing the 250 metres. After viewing films and hearing submissions the Judicial Committee suspended R Beemud's licence to ride at race meetings from the conclusion of racing on Saturday 14th December up to and including racing on Thursday 26 December 2019, 7 National riding days.

Race 4	DUNSTAN FEEDS PREMIER (2200 metres)

PRINCE ALBERT (J Waddell) - Slow to begin.

TAKE IT OUT (R Scott) - Began awkwardly.

UNACCEPTABLE (D Johnson) - Began awkwardly. When questioned regarding her ride, D Johnson advised that after beginning awkwardly the mare had been unable to take up a prominent position lacking early speed and had never travelled comfortably feeling a beaten runner entering the final straight. D Johnson added that in her opinion the mare would be better suited to some easing of the ground. A post race veterinary examination did not reveal any obvious abnormality.

CAPTIVE (S Spratt) - Raced three wide without cover from the 1400 metres. A post race veterinary examination found the mare to be 1/5 lame in the left fore-leg.

Race 5	J SWAP CONTRACTORS SPRINT (GROUP 3) (1400 metres)

SCOTT BASE (T Harris) - Began awkwardly.

WATCH THIS SPACE (S Weatherley) - Began awkwardly.

MONGOLIAN MARSHALL (J Riddell) - Restrained after jumping from a wide barrier.

PIERINA (D Johnson) - Restrained after jumping from a wide barrier. Crowded when improving into a run between SWEEPSTAKE and SCOTT BASE which both shifted ground approaching the 100 metres.

CAMPARI (C Grylls) - Held up passing the 400 metres.

Race 6	PATHWAYS - THE IMMIGRATION SPECIALISTS PREMIER (2400 metres)

CASINO EL JAY (M Coleman) - Began awkwardly losing ground.

MAZZURO (C Grylls) - Knuckled leaving the barriers losing ground.

LINCOLN KING (D Johnson) - Restrained after jumping from a wide barrier.

HATTIE BEE (R Smyth) - Raced wide without cover throughout.

OCEAN BILLY (J Fawcett) - Raced ungenerously when being restrained in the early stages. Had to shift ground to obtain clear running near the 350 metres.

FRANCIS DRAKE (C Lammas) - Raced ungenerously when being restrained in the early stages getting its head up.

LAKE SUPERIOR (J Riddell) - Raced wide from near the 900 metres.

VENCEDORA (J Waddell) - Checked when placed in restricted room to the inside of JOE'S LEGACY near the 500 metres when JOE'S LEGACY was improving to the inside of HATTIE BEE which had LAKE SUPERIOR improving to its outside with HATTIE BEE appearing to lay in away from LAKE SUPERIOR at that point. With film footage of the incident being inconclusive no further action was taken.

Race 7	SKY CITY HAMILTON WAIKATO CUP (GROUP 3) (2400 metres)

IN A TWINKLING (T Harris) - Knuckled leaving the barriers. Raced wide without cover from near the 1400 metres when hanging outwards running wide rounding the final turn losing its chance. T Harris advised that the gelding had commenced to hang shortly after the start getting progressively worse through the race. A post race veterinary examination did not reveal any obvious abnormality. Mr Richards advised that he would have the horse fully vetted on return to the stable before deciding on its future racing programme. Mr Richards was advised that the gelding must barrier trial to the satisfaction of a Stipendiary Steward prior to racing again.

STROLLING VAGABOND (D Johnson) - Slow to begin. When questioned regarding performance rider was of the opinion that the mare would appreciate some easing of the ground. A post race veterinary examination did not reveal any obvious abnormality.

ALL ROADS (M Coleman) - Restrained after jumping from a wide barrier. Held up entering the final straight and was unable to obtain clear running until near the 150 metres.

DEZELLA (C Grylls) - Raced ungenerously over the junction onto the course proper approaching the 2200 metres.

BLUE BREEZE (C Dell) - Rider reported that the gelding had lay out throughout and in his opinion is better suited to racing on right handed tracks.

Race 8	CAL ISUZU STAKES (GROUP 2) (1600 metres)

INSCRIPTION (S Weatherley) - Jumped away awkwardly losing ground. Trainer R McCarroll reported that the mare had pulled up sore with a post-race veterinary examination revealing the mare to be lame in the right foreleg. Mr McCarroll advised that INSCRIPTION would be subjected to further veterinary tests on return to his stables and any results reported to Stewards.

RED SKY AT NIGHT (A Calder) - Slow away. Had to shift ground to avoid the heels of THE REAL BEEL near the 300 metres then had difficulty obtaining clear running until near the 100 metres.

ATLANTA PEACH (M Coleman) - Slow away.

THE REAL BEEL (C Grylls) - Slow away. Held up early in the straight and when shifting outwards to obtain clear running near the 250 metres made contact with HINEGANGI which then lay in. Contributing was slight outward movement from CONTESSA VANESSA.

HINERANGI (D Johnson) - Contacted near the 250 metres.

NASHA RIVA (T Thornton) - Had difficulty obtaining clear running until near the 200 metres.

GUILLADA (D Bradley) - Raced three wide without cover. Hind quarters contacted passing the 250 metres.

YEARN (S Spratt) - Held up early in the straight and continued to have difficulty obtaining clear running until inside the final 100 metres.

LIVIN' ON A PRAYER (S McKay) - Inconvenienced over the final 100 metres.

C Lammas - Issued with a warning after allowing his mount to shift outwards under pressure over the final 100 metres inconveniencing LIVIN' ON A PRAYER.

Race 9	SVS HAMILTON PREMIER (1600 metres)

INTRIGUE - Application was made by connections to late scratch the mare due to the firm track conditions as they had anticipated some forecasted showers. With no material change in the track conditions which had been declared on race morning Stipendiary Stewards were not satisfied that there were circumstances warranting the mare to be scratched. A request for a ruling was filed with the Judicial Committee who also found that there were not circumstances which warranted INTRIGUE being scratched. INTRIGUE was then withdrawn by its connections without permission being fined \$350 by the Judicial Committee.

DAYTONA RED (S Weatherley) - Began awkwardly. Had difficulty obtaining clear running until near the 150 metres.

MONGOLIANCONQUEROR (C Burdan) - Began awkwardly. Restrained for a distance passing the 1200 metres when awkwardly placed on heels. Held up passing the 400 metres and could not obtain clear running until passing the 200 metres.

LANGKAWI (S McKay) - Raced ungenerously in the early stages shifting outwards abruptly when linking onto the course proper near the 1400 metres then continued to race ungenerously through the middle stages going back onto MONGOLIANCONQUEROR which had to be restrained for a distance passing the 1200 metres.

LA MIA STELLA (T Thornton) - Raced three wide without cover. Crowded when weakening between DAYTONA RED and MONGOLIANCONQUOR which both shifted ground slightly near the 150 metres.

JAKKALBOMB (C Lammas) - Had difficulty obtaining clear running throughout the final straight.

SASANOF'S HERO (T Yanagida) - Had difficulty obtain clear running throughout the final straight.

Stipendiary Stewards report as posted is provisional and subject to further review and amendment.
