Race 1 MILLS REEF WINERY HANDICAP (2100 metres)

**LADY SHABEEL** (S Weatherley) – Slow to begin. Unable to obtain clear running throughout the final straight.

FINAL SUGGESTION (C Burdan) – Held up until near the 100 metres.

**REDCAYENNE** (S Collett) - Taken three wide to improve forward from the 1600 metres to sit outside the leader passing the 1000 metres.

Race 2 ROGER AND LYNLEY HILLS HANDICAP (2100 metres)

**INITIATIVE** (S Weatherley) - Slow to begin. Briefly held up near the 450 metres shifting out across heels to obtain clear running.

**VOLER POUR MOI** (T Yanagida) - Began awkwardly losing ground.

**MODEL AYE** (S Collett) - Began awkwardly losing ground. Commenced to give ground passing the 600 metres and was not preserved with passing the 450 metres. Rider could not offer any explanation for the gelding's performance. A post-race veterinary examination found the gelding to have fibrillated and will require a veterinary clearance prior to racing next.

**OCEAN BILLY** (J Waddell) - Slow to begin. Raced three wide until improving forward to lead approaching the 1000 metres.

**SHENANIGANS** (R Elliot) - Slow to begin. Commenced to give ground passing the 600 metres and was not preserved with in the final straight. When questioned regarding performance, rider was unable to offer any reason for the gelding's performance. A post-race veterinary examination found the gelding to be 1/5th lame in the off hind leg and will require a veterinary clearance prior to racing again.

KORAKONUI (M Cameron) - Held up rounding the final bend.

**C Burdan** – Admitted a charge under Rule 649(1) in that she omitted a girth, surcingle and breastplate from her gear when weighing out. The Trainers were notified and returned the saddle to the weigh-in area where the rider was reweighed with the correct gear with C Burdan being fined the sum of \$150.

# MATAMATA VETERINARY SERVICES 2YO (1200 metres)

**LEESIDE** (C Lammas) - Began awkwardly then crowded shortly after having to be steadied and again having to be steadied near the 400 metres when becoming awkwardly placed on the heels of JACK OF HEARTS after making the bend awkwardly then steadied when placed in restricted room to the inside of JACK OF HEARTS which shifted in slightly.

Race 4 PHIL BUCKLAND MOTORS HANDICAP (1200 metres)

**R Elliot** MAKABAR - Was unable to make the handicap weight and after admitting the charge was fined the sum of \$200 being replaced by S Weatherley.

**ON DEMAND** (C Burdan) - Raced in restricted rom shortly after the start having to be steadied. Commenced to shift ground passing the 50 metres then shifted out abruptly over the concluding stages into the line of LAURANT which had to be firmly restrained off that runner's heels. Apprentice rider C Burdan was issued with a warning under Rule 638(1)(d).

MAKABAR (S Weatherley) - Began awkwardly.

**CENGHAR** (M Coleman) - Raced keenly for a distance passing the 1000 metres when being restrained and was then obliged to race three wide without cover for the remainder of the race. Commenced to give ground passing the 200 metres and was not preserved with.

**PUYSEGUR** (C Grylls) – Commenced to over race when being steadied for a distance passing the 1000 meters. A post-race veterinary examination revealed no abnormalities.

**LOOKSEASY** (J Waddell) – Commenced to give ground passing the 200 metres rider reported the mare was feeling the effects of the firmer track conditions with a post-race veterinary examination confirming that the mare was found to be short in its action when trotted up.

# Race 5 CROCKFORD REAL ESTATE OPEN HANDICAP (1400 metres)

**R Elliot** PASABACHE - Was unable to make the handicap weight and was replaced by S Weatherley.

**PASABACHE** (S Weatherley) - Slow to begin then crowded shortly after. Steadied for a short distance when placed in restricted room to the inside of SANTA MONICA which steadied and shifted in when awkwardly placed on the heels of LUCYINRIO which had to be restrained off the heels of SHADOW FOX near the 800 metres.

**LUCYINRIO** (D Johnson) - Raced keenly in the early to middle stages. Steadied off heels 800 metres. Had difficulty obtaining clear running early in the final straight.

MALO BIK (S Collett) - Raced three wide without cover throughout. Forced wider in the final straight.

SHADOW FOX (C Burdan) - Lay out entering the final straight forcing MALO BIK wider.

SANTA MONICA (T Thornton) - Steadied and shifted in 800 metres.

# THE BREEZE BREAKFAST HANDICAP (1400 metres)

Rider C Burdan (UP 'N' GONE) was dislodged during the preliminary and was immediately attended to by the St John's Paramedics and was then taken to Hospital for further evaluation. Another ambulance was called and the race was delayed approximately 20 minutes with this race then starting at 4.05pm.

**CALL ME EVIE** (T Yanagida) - Underwent a pre-race veterinary examination after being fractious in the birdcage and was declared fit to start.

O'GUY (S Spratt) - Slow to begin. Raced ungenerously for a distance passing the 1000 metres.

**FLOMILINE** (R Oliver) – Slow to begin. Raced in restricted room to the inside of BIT LIPPY and commenced to over race for a distance. Crowded passing the 1200 metres.

ACUTUS (J Riddell) - Raced three wide without over throughout.

**QUANTUM** (S Collett) - Crowded passing the 1200 meters. Crowded and checked passing the 1000 metres to the inside of FLOMILINE which lay in and away from BIT LIPPY when racing keenly despite the efforts of its rider.

**R Kozaki** BIT LIPPY - Issued with a warning for allowing his mount to shift in passing the 1200 metres crowding FLOMILINE and QUANTUM for a distance.

# Race 7 SEL NEAL BUILDERS HANDICAP (1600 metres)

This race was re-scheduled to run at 4.40pm at the request of Raceday Control.

NASHA RIVA (M McNab) - Began awkwardly. Held up early in the final straight.

THE BUZZ (D Johnson) - Slow to begin.

VEE CECE (C Grylls) - Restrained from its wide barrier.

**LEAF** (J Riddell) - Held up rounding the final bend having to shift out across heels to obtain clear running passing the 300 metres.

THOMAS AQUINAS (S Collett) - Held up until near the 150 metres.

**OTATIA** (M Cameron) – Commenced to give ground passing the 200 metres then was not preserved with. When questioned, rider advised that the mare would derive some benefit out of the run as it had not raced or a trialed since 6<sup>th</sup> November 2019.

**MASTER PAINTON** (O Bosson) – Raced keenly through the middle stages running on fairly in the final straight. When questioned rider advised the gelding was unable to quicken when placed under pressure. A post race veterinary examination revealed no abnormalities.

# Race 8 C U AT THE GOOD LOCAL HANDICAP (1600 metres)

This race was re-scheduled to run at 5.15pm at the request of Raceday Control.

EN SOIE (S Collett) - Began awkwardly losing ground (5L).

**DESERT MIRAGE** (C Grylls) - Began awkwardly losing ground. Had difficulty obtaining clear running until approaching the 100 metres.

**VAN IRVING** (M Cameron) - Began awkwardly losing ground. Steadied when weakening passing the 100 metres to the inside of DESERT MIRAGE which shifted in to obtain clear running.

**MIGHTY ASLAN** (S Spratt) - Began awkwardly losing ground.

BRAVISSIMO (J Fawcett) - Raced three wide without cover throughout.

SHE'S FEARLESS (J Riddell) - Held up until passing the 100 metres.
