Race 3 - GO RACING PATERSON MEMORIAL (1600 Metres)
LINCOLN RAIDER (O Bosson) – Trainer L Latta advised Stewards the gelding has now been sent for a brief spell.

Race 8 - HARCOURTS THORNDON MILE (Group I) (1600 Metres)

LIVIN' ON A PRAYER (L Allpress) – Trainer W Hillis advised Stewards LIVIN' ON A PRAYER will now have a brief freshen up. W Hillis further advised that he will be removing the blinkers prior to the mare's next start.

Race 9 - NZ CAMPUS OF INNOVATION & SPORT WELLINGTON CUP (Group III) (3200 Metres)

JOHNNY LINCOLN (R Hannam) – Trainer L Latta advised Stewards the gelding has now been retired from racing.

Race 5 - LEGACY LODGE 1600

WORDSWORTH (J Waddell) – Trainer M Falconer advised that she was satisfied with the post-race condition of the gelding, however, has now been sent for a brief freshen up.

RACE COMMENTS:

Race 1 | Auckland Alarms 2200

M & K Murdoch (SHOCKING PENNY) – Issued with a warning after SHOCKING PENNY was presented to race without notified gear (pre-race ear covers).

SHOCKING PENNY (J Fawcett) – Began awkwardly and then was further crowded having to be steadied losing ground.

CLEVER APPROACH (M Cameron) – Slow away. Shifted out to avoid heels when the pace steadied approaching the 1500 metres then raced ungenerously for a distance.

CAPTAIN NEWZEALAND (L Innes) – Slow away.

FLYING (M Hashizume) – Raced wide without cover for the majority of the race.

MONLULA (R Elliot) – Held up rounding the final bend.

FOOGAYZEE (V Colgan) – Improved on to heels approaching the 300 metres.

L Innes (CAPTAIN NEWZEALAND) – Reminded of his obligations regarding his whip use.

Race 2 | Avondale Sunday Markets 1400

JELINA (R Elliot) – Restrained from its wide barrier draw.

JAYDEEAR (T Thornton) – Over-raced when being restrained for a distance approaching the 900 metres.

Race 3 | NZB Insurance Pearl Series Race 1400

GRACIES GOLD (S Spratt) – Began awkwardly with the rider becoming briefly unbalanced.

LADY YELRACM (R Elliot) – Slow away.

MELUSINA (M Cameron) – Briefly went off stride passing the 350 metres after the rider reported that the mare had been struck from behind. Steadied approaching the 200 metres when racing in restricted room. MELUSINA underwent a post-race veterinary examination which could find no obvious abnormalities.

JAKAMA KRYSTAL (J Riddell) – Held up until near the 250 metres.

ONE WAY STREET (J Fawcett) – Held up until near the 250 metres.

JAKAMA JILL (S Collett) – Had difficulty obtaining clear running early in the final straight.

Race 4

Tulloch Café 1200

SONORITY (S Spratt) – Began awkwardly. Hampered and forced wide 250 metres.

FORGETZ (A Goindasamy) – Slow away.

DRAGON RUN (V Colgan) – Held up early in the final straight before shifting out into a marginal run approaching the 200 metres and raced in restricted room for a distance.

SATIN RUBY (S Weatherley) – Held up early in the final straight before shifting out passing the 250 metres.

S Weatherley (SATIN RUBY) – Admitted a breach of careless riding in that he permitted SATIN RUBY to shift out near the 250 metres when insufficiently clear of SONORITY which was hampered and forced wider. After hearing submissions S Weatherley's license to ride in races was suspended from the conclusion of racing on 7 February 2020 up to and including racing on 15 February 2020, 5 national riding days.

REGAL DUCHESS (T Thornton) – Placed in restricted room approaching the 200 metres by DRAGON RUN which shifted out to obtain clear running, then further crowded when RAKUTEN shifted in with REGAL DUCHESS then being steadied losing ground.

V Colgan (DRAGON RUN) – Issued with a warning for permitting DRAGON RUN to shift out approaching the 200 metres placing REGAL DUCHESS in restricted room for a distance which was then steadied when further crowded by RAKUTEN which shifted in slightly.

Race 5

AJC.CO.NZ 1600

PUMBAAH (J Whiteside) – Began awkwardly losing ground (3L).

OCEAN SPIRIT (T Yanagida) – Slow away.

SAVEZAR (R Elliot) – Crowded and checked 1450 metres losing ground.

NIZONA (S Collett) – Crowded and checked 1400 metres.

O'SUSANA (S Spratt) – Crowded and checked 1350 metres when racing to the outside of EROS which ducked out despite the efforts of its rider.

D Danis (THE GARRISON) – Defended a breach of careless riding in that he permitted THE GARRISON to shift in from near the 1450 metres when insufficiently clear of NIZONA which was dictated in crowding SAVEZAR which was checked and continued to shift in crowding NIZONA which was also checked. After considering submissions the Judicial Committee found the charge proven and suspended his license to ride in races from the conclusion of racing on 27 January 2020 up to and including racing on 8 February 2020, 6 National riding days.

SASSEGO (J Fawcett) – Raced ungenerously passing the 1400 metres when leading on to the Course Proper losing ground.

ZAKALICIOUS (M Cameron) – Raced in restricted room approaching the 150 metres and then briefly crowded passing the 100 metres.

<p>WILLIAM TELL (O Helagi) – Began awkwardly. Raced wide without cover for the majority of the race.</p> <p>SHANQUEEN (L Innes) – Unable to obtain clear running throughout the final straight.</p> <p>SOCIALLY EXCITED (J Fawcett) – Crowded passing the 150 metres when weakening.</p>	
Race 7	Next Avondale Trials 25 February 1600
<p>HASABRO (T Yanagida) – Slow away.</p> <p>MY ZULU WARRIOR (S Collett) – Began awkwardly losing ground. Over-raced in the middle stages.</p> <p>SPELTERINI (T Thornton) – Slow away. Forced wide near the 1300 metres.</p> <p>SAHAR (M Cameron) – Over-raced 1300 metres and shifted out when becoming awkwardly placed on heels forcing SPELTERINI wider on the track.</p> <p>KAINUI ROSE (D Danis) – Shifted out to obtain clear running 400 metres. Rider reported the mare had hung outwards through out and had proven difficult to ride.</p> <p>LUCKY SHARK (O Bosson) – Shifted out near the 1300 metres when becoming awkwardly placed to avoid heels. Forced wide 400 metres. When questioned regarding the performance Rider O Bosson advised that the gelding had raced keenly in the early stages and then had hung out rounding the final bend before being forced wider near the 400 metres.</p> <p>D Danis (KAINUI ROSE) – Issued with a warning after allowing KAINUI ROSE to shift out passing the 400 metres when insufficiently clear of LUCKY SHARK which was forced wider on the track.</p> <p>HOLY LOCH (M Hashizume) – An inquiry was opened into the riding tactics adopted by Apprentice Rider M Hashizume.</p> <p>DAM RELIABLE (V Colgan) – Received veterinary attention following the race for a small laceration to the right hind leg.</p>
