SUPPLEMENTARY:

Levin RC, Friday 20 December 2019, Race 2 Ribbons Plus 1200 Z Moki admitted a breach of Rule 330(3)(c) in that she was unable to make the contracted weight for AMOR AMOR. After hearing submissions the JCA suspended her licence to ride in races from the close of racing on Friday, 27 December up to and including racing on Monday 30 December.

RACE COMMENTS:

Race 1	MAINFREIGHT PREMIER (1200 Metres)

RESURRECT (K Asano) - Began awkwardly.

ONE PRIZE ONE GOAL (M Singh) – Slow away.

EXCELLERATION (R Hannam) - Held up for some distance approaching the 200 metres.

SAIGNON (R Elliot) - Contacted and briefly unbalanced passing the 100 metres when GO JAMES lay inwards under pressure, bumping SALAMANCA.

SALAMANCA (J Bassett) – Bumped 100 metres and placed in restricted room.

T Taiaroa (GO JAMES) - Was shown footage of her ride in the presence of the riding master after allowing her mount to shift ground inwards over the final stages.

ARTURO – (J Parkes) – Bled. After undergoing a veterinary inspection, the gelding was confirmed to have bled. ARTURO is now unable to be in training for two months and is unable to trial or race for three months with a veterinary clearance required prior to racing or trialling next.

Race 2 | **OLIVER BRICKWORKS, SUPREME BUILD, GRAPHICS HQ PREMIER (1100 Metres)**

JUST BEN – J Parkes replaced D Turner (unable to make contracted weight).

D Turner admitted a breach of Rule 330(3)(c) being unable to make the contracted weight for his mounts JUST BEN and DE GAULLE (Race 4). After hearing submissions the JCA suspended D Turner’s licence to ride in races from the conclusion of racing on Friday, 27 December 2019 up to and including racing on Thursday, 2 January 2020. In addition the JCA imposed a fine of \$500.

PIAGGIO (L Allpress) – Late scratching at 1.22pm by the veterinary surgeon after becoming fractious in its gate, rearing, turning around and getting its front legs over the back of the gate. Connections were advised the colt must barrier trial prior to its next start.

LA DIVA (R Elliot) – Removed from the barriers, underwent and passed a pre-race veterinary examination as a precautionary measure being in the adjacent stall to PIAGGIO. Awkwardly away.

GENTLEMAN JACK (H Andrew) - Raced three wide without cover throughout. Lay inwards under pressure approaching the 100 metres.

PERFECT SCENARIO (R Myers) – Lay in having to be straightened approaching the 100 metres.

Race 3 | **RICH HILL STUD PREMIER 3YO (1400 Metres)**

MASCARPONE (R Elliot) – Was re-plated at the start after pulling a hind plate on the way to the barriers. Reared as the start was made, losing ground (3L). Shifted in abruptly over the final stages when racing greenly, hampering CALLSIGN MAV.

CALLSIGN MAV (C Grylls) – Hampered final stages.

SECOND SLIP (H Andrew) - Raced ungenerously in the early to middle stages, having to be heavily restrained off heels in the back straight.

Race 4 | **THE PAVEMASTERS PREMIER (1600 Metres)**

DE GAULLE – R Myers replaced D Turner.

HARTLEY (R Elliot) - Raced keenly in the early stages.

PROSECCO (D Johnson) - Raced keenly for a distance near the 1000 metres.

O Bosson (LINCOLN RAIDER) - Was spoken to regarding his whip use prior to the 100 metres.

BONNY EZRA (L Allpress) – When questioned into performance rider advised the gelding had not appreciated today's Slow (8) track conditions.

Race 5 ROAD LOGISTICS PREMIER (2300 Metres)

HE NO OPILIO (C Johnson) - Began awkwardly, tightening VANNOSS, which settled back and dictating SAVANNAH GEM, which had to steady. Hung outwards in the early stages then raced keenly in the middle stages.

REX ROYALE (J Parkes) - When questioned into performance rider advised the gelding was unsuited to today's Slow (8) track conditions. A subsequent veterinary examination was clear.

ZAC BROWN (D Turner) - Raced wide without cover throughout.

SPEED CALL (Z Moki) - Raced ungenerously in the early stages. Lay inwards in the home straight, having to be straightened passing the 200 metres. When questioned Z Moki said her instructions were to ride the gelding back in the field in order to get the gelding to settle

VANNOSS (S Collett) - Commenced to give ground rounding the home turn. When questioned into performance rider felt something may be amiss. A post-race veterinary examination revealed a slow recovery rate.

Race 6 ABERDEEN ON BROADWAY MANAWATU CUP (Group III) (2300 Metres)

COLLINSTREET (L Hemi) – Dropped its head as the start was made, losing ground.

HANK MOODY (K Asano) -Slow away.

AMORATA (S Collett) - Began awkwardly.

DEUCE COUPE (L Allpress) - Raced keenly in the early to middle stages.

JACKSSTAR (M Singh) - Raced keenly in the early stages.

HIGH QUALITY (C Grylls) - Steadied and checked near the 500 metres when racing between PLATINUM INVADOR (R Hannam), which was dictated outwards by YATIMA (D Johnson) and BALHAM (D Bradley) racing to its outside, which lay in. After questioning riders, C Grylls advised that after being placed in restricted room his mount had over-reacted when being steadied. Nevertheless, D Johnson was advised to exercise greater care when shifting ground.

Race 7 KAMADA PARK/MANAWATU CHALLENGE STAKES (Group II) (1400 Metres)

SECRET ALLURE(R Myers) - Began awkwardly, shifting out, contacting HENI.

HENI (D Turner) – Contacted start, then raced ungenerously for a short distance.

CHOCANTE (D Johnson) – Raced wide without cover throughout.

SHADOWS CAST (L Allpress) - Had some difficulty obtaining clear running early in the home straight.

Race 8 TOTALLY VETS PREMIER (1400 Metres)

PODKAST (D Turner) - Raced ungenerously for a distance passing the 1000 metres when being restrained.

ENRICHMENT (O Bosson) - When questioned into performance rider could offer no excuse. A post-race veterinary examination was clear.
