RACE COMMENTS:

Race 1	THE BEACON 1400
MONEY SHOT (D Johnson) – Slow to begin. When questioned regarding the performance of the mare, the rider could offer no excuse.	
CASTLE BLACK (M Cameron) – Began awkwardly losing ground.	
J Fawcett - Was reminded of her obligations and advised that she must ride her mounts out fully to the end of the race when circumstances permit.	
Race 2	NICHOLSON AUTOS 1400
OPERATOR (R Elliot) - Slow away.	
CALL ME EVIE (J Fawcett) – Began awkwardly. Lay in when placed under pressure in the final straight.	
RISING RANSOM (T Yanagida) – Began awkwardly losing ground.	
Race 3	NZ FULVIC 1200
POWER TYCOON (J Fawcett) – Slow away.	
VIKING (R Oliver) – Began awkwardly. Raced greenly when placed under pressure in the final straight.	
ROYAL CHARM (S Collett) – Began awkwardly losing ground. Improved onto heels having to be steadied passing the 550 metres.	
AROMATIC (T Yanagida) – Restrained from a wide barrier.	
SHOWCAT (M Coleman) – Had difficulty obtaining clear running early in the final straight.	
MIKE'S MISTAKE (A Calder) – Received veterinary attention post-race after suffering a suspected bout of colic.	
Race 4	HJ ASMUSS KAWERAU 1200
LONDON BANKER (M Coleman) – Restrained from a wide barrier. Contacted and forced wider entering the straight, then lay in when placed under pressure for the remainder of the race.	
IFFRAAJINATOR (S Collett) – Began awkwardly. Hampered having to be steadied passing the 350 metres.	
MASTER OAKLEIGH (R Oliver) – Slow to begin. Lay in when placed under pressure in the final straight.	
OHTHOSERUSSIANS (J Fawcett) – Lay out rounding the final bend making contact with IFFRAAJINATOR approaching the 400 metres which shifted outwards contacting LONDON BANKER which was forced wider. LONDON BANKER then lay in after being contacted shifting in abruptly passing the 350 metres hampering IFFRAAJINATOR which had to be steadied.	

YOU'RE WELCOME (M Cameron) – Contacted and steadied after being placed in restricted room approaching the 100 metres after LONDON BANKER (M Coleman) shifted in. M Coleman was advised to exercise greater care.

M Coleman (LONDON BANKER) – Issued with a warning and advised that he would be expected to make a greater effort to straighten his mount in similar circumstances after LONDON BANKER lay into the line of IFFRAAJINATOR which was hampered and steadied passing the 350 metres.

K Fursdon – Issued with a warning for presenting IFFRAAJINATOR to race without the notified blinkers.

CABALLERO (J Riddell) – Slow to begin.

DE KONING (L Satherley) – Knuckled after making the crossing near the 1600 metres.

STARRYBEEL (T Yanagida) – Had difficulty obtaining clear running early in the final straight.

Race 6 | **TEAM WELLEANS 1600**

SAVASTEP (R Oliver) - Slow away. When questioned regarding the performance the rider advised that the mare may benefit from some easing in the ground. Underwent a post-race veterinary examination which did not reveal any abnormality.

GARADOS (S Collett) - Slow away.

ZOULUMINOUS (C Lammas) - Slow away.

DECLARADA (M Cameron) – When questioned regarding the performance the rider advised that the mare may benefit from some easing in the ground.

Race 7 | **TRACKS CONCRETE LTD 1600**

SARCED CAGA – Declared a late scratching at 8:19am after connections were unable to engage a suitable rider.

RANGER (A Calder) - Raced three wide without cover throughout.

BRAWLER (T Yanagida) – Hampered passing the 300 metres after becoming awkwardly placed on the heels of BRAWLER.

M Kareem - Issued with a warning for allowing his mount OVERTHEMARK to shift out passing the 300 metres hampering BRAWLER.

Race 8 | **NEW WORLD WHAKATANE 2100**

OAK (C Lammas) – Slow away.

ELLE D'BERRY (M Cameron) – Slow away.

POWER'S THAT BE (R Oliver) – Began awkwardly losing ground.

ATOMIC KITTEN (S Collett) – Raced keenly in the early and middle stages. Shifted out abruptly when racing keenly approaching the 1400 metres to avoid heels.

YING RESOLUTE (J Riddell) – Raced three wide without cover until near the 1500 metres. Hampered passing the 400 metres having to shift inwards to avoid heels.

LUCKY CENTURY (D Johnson) – Raced keenly for a distance when being restrained passing the 1700 metres. When questioned regarding the performance the rider could offer no excuse.

I AM THE KNIGHT (R Elliot) – When questioned regarding the performance the rider could offer no excuse.

SOUTHERN VOGUE (M Hashizume) - Made the bend awkwardly passing the 400 metres hampering the trailing YING RESOLUTE. Rider dropped his whip passing the 150 metres.

HAKUNA MATATA (S Collett) – Had difficulty obtaining clear running early in the final straight.

L Satherley – Issued with a warning for her whip use prior to the 100 metres.
