GENERAL:

<p>Rider M Cameron advised Stewards that he was unable to ride today due to aggravating a knee injury. M Cameron is to provide a medical certificate to Stewards prior to riding next.</p> <p>M Blackie (BLOOD WARRIOR) – Trainer M Blackie admitted a breach of Rule 527 in that he entered BLOOD WARRIOR for the primary purpose of affecting the total number of horses entered and accepted for a race. After considering submissions the Judicial Committee imposed a fine of \$1,250.</p>

Race 3 – Barneswood Farm Eclipse Stakes

AMERICAN PRINCESS (D Johnson) – Co-trainer A Forsman reported the filly had undergone a further veterinary examination on return to the stable which included x-rays and was found to have fractured its left fore cannon bone, and is to undergo an operation on Monday with a positive prognosis.

RACE COMMENTS:

Race 1	GARTSHORE CONSTRUCTION 2100
<p>NOT USUAL HEAVEN (D Johnson) – Reared leaving the barrier. Raced keenly in the early to middle stages laying out. Continued to lay out making the final bend and running wide passing the 600 metres hampering CHARRED and ALTAR GIRL and forcing PIPING HOT wide on the track. Connections were advised that NOT USUAL HEAVEN would be required to barrier trial to the satisfaction of Stewards prior to racing next.</p> <p>CHARRED (S Collett) – Began awkwardly. Forced wide and hampered 600 metres.</p> <p>SHOCKING PENNY (J Fawcett) – Raced ungenerously when being steadied for a distance passing the 1700 metres.</p> <p>ALTAR GIRL (C Dell) – Forced wide and hampered 600 metres.</p> <p>PIPING HOT (O Bosson) – Forced wide approaching the 600 metres and for the remainder of the bend.</p> <p>A Calder (PRESTIGIOUS LAD) – Reminded of his obligations with regard to whip use.</p>	
Race 2	REAL CHARTERED ACCOUNTANTS 2100
<p>IFFRAAJINATOR (S Collett) – Began awkwardly losing ground.</p> <p>WINKLEBELLE (D Johnson) – Commenced to race keenly when the pace steadied approaching the 1600 metres shifting out off heels, forcing PATSYS LASS wider on the track with WINKLEBELLE continuing to over-race through the middle stages.</p>

<p>SAVETTE (C Dell) – Slow away.</p> <p>BYZANTINE (O Bosson) – Began awkwardly.</p> <p>SALT BAY (R Elliot) – Had difficulty obtaining clear running until shifting out passing the 150 metres.</p> <p>J Fawcett (ROLL THE GOLD) – Issued with a warning for excessive whip use prior to the 100 metres.</p>	
Race 4	STE INDUSTRIAL ELECTRICAL 1600
<p>J Pender (MODEL AYE) – Issued with a warning after MODEL AYE was presented to race without notified gear (side winkers).</p> <p>MODEL AYE (C Grylls) – Began awkwardly losing ground. Raced ungenerously in the early to middle stages.</p> <p>CARIBBEAN ROSE (O Bosson) – Began awkwardly making contact.</p> <p>IN FASHION (R Elliot) – Restrained from a wide barrier. Shifted out to obtain clear running passing the 300 metres.</p>	

CAMEAHOTFRIDAY (D Johnson) – Restrained from a wide barrier.

Race 5 | **NEW WORLD SUMMER CUP (1400 Metres)**

Nothing to report.

Race 6 | **BULK LINES LIMITED 1600**

MASTER OAKLEIGH (R Oliver) – Began awkwardly when being corrected by its rider, made contact with the hind quarters of HENLEY ROAD which became unbalanced.

HENLEY ROAD (S McKay) – Contacted and unbalanced soon after leaving the barrier.

ANGRY BIRD (A Jones) – Slow away.

ANHEDONIA (S Collett) – Raced wide without cover.

PAUL'S SUPER ARIKI (J Fawcett) – Held up early in the final straight and continued to have difficulty obtaining clear running until the 150 metres.

SOFT HEARTED (A Calder) – Held up 300 metres before shifting in abruptly passing the 275 metres to obtain clear running.

MERSEY BEAT (T Thornton) – Crowded and checked 275 metres.

CAUGHT THE EYE (D Johnson) – Crowded and checked 275 metres when weakening.

A Calder (SOFT HEARTED) – Defended a charge of reckless riding in that he angled and rode his mount SOFT HEARTED inwards when not sufficiently clear of MERSEY BEAT and CAUGHT THE EYE which were both checked near the 275 metres. After viewing films along with hearing submissions and evidence the Judicial Committee amended the charge to one of careless riding which they found to be proven. Following penalty submissions A Calder was suspended from the conclusion of racing on Saturday 4 January until the conclusion of racing on Friday 24 January, 15 riding days.

Race 7 | **OASIS BAR AND GRILL GREERTON 1400**

SON OF SASANOF (B R Jones) – Began awkwardly and steadied. Forced wider over the final 100 metres.

ONE WAY STREET (R Elliot) – Crowded soon after leaving the barriers and steadied.

JELINA (S Collett) – Raced ungenerously when being steadied for a distance passing the 900 metres.

REMEMBER O'REILLY (T Yanagida) – Raced wide without cover.

PUMBAAH (J Whiteside) – Briefly steadied passing the 200 metres when crowded.

CANDID CAMERA (S Spratt) - Shifted outwards under pressure from near the 150 metres.

WAR PATH (T Thornton) – Had difficulty obtaining clear running until shifting out approaching the 150 metres and then forced wider near the 75 metres, and steadied to avoid heels near the 50 metres.

S Spratt (CANDID CAMERA) – Issued with a warning after permitting her mount to shift outwards under pressure over the final 150 metres dictating DESERT MIRAGE wider on the track which was forced into the line of WAR PATH which had to steady near the 50 metres.

COMMOTION (S Weatherley) - Inconvenienced approaching the 150 metres having to change ground to obtain clear running.
