<b>Race 1</b>	<b>NORWOOD 1200 (1200 Metres)</b>
<b>SWEEPSTAKE</b> (J Parkes) – Slow away.	
<b>VINNIE'S VOLLEY</b> (S Weatherley) - Began awkwardly contact PRINCESS RIHANNA then settling back.	

**PRINCESS RIHANNA** (T Yanagida) - Contacted start.

**STUMPY** (L Allpress) - Raced keenly in the early and middle stages.

**EUKA LADY** (R Myers) - Returned to the enclosure with blood present in the nasal area. A subsequent veterinary examination revealed a cut consistent with the mare having hit the front of its gate.

Track upgraded to Dead (4) retrospective to Race 1.

<b>Race 2</b>	<b>SUPERIOR CHUNKY 1400 (1400 Metres)</b>

**SHADOW FOX** (R Hannam) – Began awkwardly bumping THE MITIGATOR.

**THE MITIGATOR** (S McKay) - Began awkwardly, contacted, then raced keenly in the early stages. When questioned rider S McKay advised the gelding was unsuited to the slow early pace in the race and failed to quicken when asked and in his opinion, was now looking for a longer distance. A subsequent veterinary inspection was clear.

**MARLO BIK** (T Taiaroa) - Began awkwardly. Lay inwards near the 750 metres, becoming awkwardly placed on the heels of POP STAR PRINCESS.

**BROTHER ONE** (L Allpress) - Raced keenly in the early stages.

**C Grylls** (CHOCANTE) - Was spoken to with regards to striking his mount in consecutive strides prior to the 100 metres.

<b>Race 3</b>	<b>SOUTHERN RANGITIKEI VETERINARY SERVICES 1400 (1400 Metres)</b>

**OZIL** (J Parkes) - Restrained from a wide draw.

**PROSECCO** (S Weatherley) – Began awkwardly. Inconvenienced near 100 metres.

**LADY RUDOLPH** (R Myers) - Raced keenly when being restrained in the early stages.

**SAIGNON** (R Elliot) – Tightened and dictated outwards when MISS CONTESSA (C O’Beirne) rolled out under pressure. Also inconveniencing PROSECCO. C O’Beirne was shown footage of her ride in the presence of the Riding Master and advised she is expected to exercise greater care when shifting ground.

<b>Race 4</b>	<b>PROPERTY BROKERS 3YO 1400 (1400 Metres)</b>

**PROBABEEL** (O Bosson) – Slow away.

**KICK START** (H Andrew) – Lay inwards near the 1200 metres, tightening POWER ‘N’ PASSION then raced three wide without cover throughout. Tightened 400 metres.

**POWER ‘N’ PASSION** (C O’Beirne) - Shifted out abruptly near the 1350 metres having to be steadied then tightened 1200 metres. Forced over extra ground 400 metres.

**BELLE PLAISIR** (J Parkes) - Lay inwards when racing greenly passing the 200 metres, having to be straightened.

**O Bosson** (PROBABEEL) – Issued with a warning under Rule 638(1)(d) after shifting out near the 400 metres tightening KICK START and forcing POWER ‘N’ PASSION over extra ground.

<b>Race 5</b>	<b>CENTRAL ITM 1600 (1600 Metres)</b>

**LINCOLN RAIDER** (J Riddell) – Slow away. Raced in restricted room passing the 200 metres before being angled

inwards across heels to gain clear running approaching the 100 metres.

**HARTLEY** (R Elliot) - Raced keenly in the early to middle stages. When questioned into performance rider reported the gelding may appreciate some easing in track conditions.

**CAVALLO VELOCE** (S McKay) - When questioned into performance rider could offer no excuse.

**PORTLAND JIMMY** (J Parkes) – When questioned into performance rider could offer no excuse.

**O Bosson** (WEAPONRY) – Was spoken to with regards his whip use prior to the 100 metres.

<b>Race 6</b>	<b>SPREADING RURAL BULK 1600 (1600 Metres)</b>

**SPONDULIX** (C Grylls) – Slow away.

**SHADY GREY** (J Parkes) – Raced keenly in the early stages when three wide without cover. Lay inwards under pressure approaching the 200 metres, having to be straightened.

**LADY VERAWOOD** (S McKay) - Raced wide without cover throughout.

**R Hannam** (ORIGINAL GANGSTER) - Spoken to regarding his whip use prior to the 100 metres.

<b>Race 7</b>	<b>JAPAC HOMES FASTTRACK \$5K MARTON CUP (2200 Metres)</b>

**SYLVESTER** (L Satherley) - Began awkwardly tightening JACKSSTAR with both runners settling back.

**JACKSSTAR** (T Thornton) - Tightened at start settling back.

**SOLESEIFEI** (K Asano) - Improved wide without cover approaching the 800 metres.

**DEZELLA** (R Myers) - When questioned into performance rider could offer no excuse. A subsequent veterinary inspection was clear.

**BEAUDEN** (R Elliot) Wide throughout

**S Weatherley** (SAMPSON) – Admitted a breach of Rule 638(3)(b)(ii) in that he used his whip excessively prior to the 100 metres and was fined \$400.

<b>Race 8</b>	<b>EVAN DIX MEMORIAL (2200 Metres)</b>

**CASINO EL JAY** (C Grylls) – Slow away.

**AKELA BELLE** (T Thornton) - Raced wide without cover throughout. When questioned into performance rider advised the mare may appreciate some easing in the track conditions. A subsequent veterinary inspection was clear.

**K Asano** (RED RIVER ROCK) – Issued with a warning under Rule 638(1)(d) after allowing his mount to shift out in the home straight when not fully clear of DEUCE COUPE, which was hampered near the 200 metres K Asano was spoken to regarding his whip use prior to the 100 metres.

**DEUCE COUPE** (S Weatherley) – Hampered 200 metres.
