Race 1	LINDAUER 2000
<p>WALK THE LINE (J Fawcett) - Tightened at the start. Raced keenly in the early stages making the bend at the 1800metres awkwardly shifting out inconveniencing BLIZZING AWAY (S McKay). Continued to hang throughout and was not persevered with in the home straight when well out of contention. Trainer C Isdale advised he would make gear adjustments prior to its next start. C Isdale was advised a warning has been placed against the mares racing manners.</p> <p>BLIZZING AWAY (S McKay) Inconvenienced 1800metres.</p>	

EAGLE FIFTY (R Elliot) - Slow away.

ROSA FIORE (L Allpress) - Lay inwards under pressure in the home straight.

Race 2	GISBORNE SCAFFOLDING 2000

VANOSS (S McKay) - Began awkwardly settling back.

KATIEM MARIE (S McNab) - Slow away.

YOU'RE WELCOME (J Parkes) - Hung throughout. When questioned into the performance, rider advised that the gelding had a tendency to hang throughout. A subsequent veterinary examination was clear.

DAM RELIABLE (D Johnson) - Shifted out near the 300metres simultaneously as CAPELLANI was improving to its outside dictating CAPELLANI outwards over extra ground. A short distance further CAPELLANI shifted in and contacted DAM RELIABLE which then shifted out under pressure and made contact with CAPELLANI over the final stages. Stewards took into account movement from both runners when assessing the interference.

CAPELLANI (R Elliot) - Dictated out near the 300 metres then shifted in under pressure approaching the 100metres bumping DAM RELIABLE. Dictated out over the final stages.

Following the running of this race a protest was lodged by the connections of 2nd place **CAPELLANI** against the winner **DAM RELIABLE** alleging interference in the home straight. After viewing footage and hearing submissions the protest was upheld by the JCA with the amended placings being 5,7,1,4.

POSTCODE ENVY (H Andrew) - Began awkwardly making contact with **MERYACE** settling back

MERYACE (R Elliot) - Contacted start settling back. Ran up onto the heels of the tiring POSTCODE ENVY having to be steadied near the 400 metres

CHATEAU DE ROQUE (S MacNab) - Began awkwardly settling back

ALL THE RAGE (A Goindasamy) - Raced wide without cover throughout

MASAROVA (R Beemud) dropped his whip near the 150 metres.

C Lammas (MOTLEY CRUE) was issued with a warning under Rule 638(3)(b)(ii) with regards his whip use prior to the 100m.

Race 4	BRONWYN KAY 1200

RISTRETTO (D Johnson) - Bounded at the start losing ground

VINO BELLA (C Burden) - Bumped at the start settling back. When questioned into the disappointing run, C Burdan could offer no tangible excuse but advised the filly would take natural improvement from the run.

MAKABAR (R Beemud) - Began awkwardly. Held up rounding the final turn. Continued to have some difficulty obtaining clear running early in the home straight

SIMONA (S McKay) - Raced keenly in the early stages. Tightened and steadied at the 200metres.

CHOSEN PEAK (S Macnab) - Held up approaching the 200metres prior to being angled across heels to improve tightening SIMONA which was steadied a short distance further. Rider S McNab was issued with a warning under Rule 638(1)(d) and

advised she is expected to exercise greater care when shifting ground.

BELLESGIRL (L Allpress) - Tightened at the start. Held up rounding the final turn.

KAPALKA (A Goindasamy) - Began awkwardly

AROMATIC (D Johnson) - Began awkwardly

NEW DAWN (H Andrew) - Raced keenly in the early stages

BORDER LEICESTER (C Lammas) slow away

PRODIGAL SON (R Elliot) had to be angled outwards to obtain clear running near the 200metres.

PLUSHENKO (J Fawcett) ran up onto heels of **BEAU GESTE** over the final stages and steadied.

LOCALLY SAUCED – T Newman admitted a breach of Rule 330 (3) (c). after being unable to claim her full allowance so was replaced by A Goindasamy and fined \$100 under the Minor Infringement schedule.

MORE WONDER (R Elliot) slow away

SATU LAGI (J Parkes) Began awkwardly making contact with the hind quarters of **ROLL THE GOLD**. Lay out under pressure in the home straight

ROLL THE GOLD (J Fawcett) Contacted and briefly unbalanced at the start

PASABACHE (S McKay) When questioned into the performance rider could offer no excuse.

Race 8	CRAIGS INVESTMENT PARTNERS MILE

NEDWIN (C Burdan) – Dislodged a plate during the preliminary which was replaced, with the start of the race being delayed by approximately 4 minutes. Steadied near the 200metres.

ROCKING ALONG (L Allpress) jumped outwards at the start dictating **PIPING HOT** which contacted **NEDWIN**

MISS FENDT (A Goindasamy) raced keenly in the early stages. Steadied near the 300m.

SWEET FIELDS (R Elliot) Lay in early in the home straight tightening **MISS FENDT** which was steadied. R Elliot was advised to exercise care.

BRAWLER (T Allan) Had be steadied approaching the 200m when **ROCKING ALONG** shifted in under pressure. L Allpress was advised to exercise care. T Allan was spoken to regarding striking his mount in consecutive strides prior to the 100metres.

COMMOTION (D Johnson) had some difficulty obtaining clear running in the home straight

H Andrew (VROOM) was issued with a warning under Rule 638(1)(d) after allowing her mount to shift out when not entirely clear of **NEDWIN** which had to be steadied near the 200 metres.
