<u>Matamata Racing Club - 11 March 2020</u> Race 3 TOKOROA COSMOPOLITAN CLUB (INC) & TREES TAVERN 1200 BO JACKSON (T Thornton) – A Herbert advised Stewards that upon return to the stable, the colt underwent a veterinary examination which confirmed BO JACKSON to be shin sore, and has now been sent for a spell.
<u>Wellington Racing Club - 14 March 2020</u> Race 8 Al Basti Equiworld Dubai New Zealand Oaks (Group 1) LOIRE (V Colgan) – Stable representative D Williams reported the stable was satisfied with the post-race condition of the filly, however, and has now been sent for a spell.
<u>Racing Tauranga – 14 March 2020</u> Race 4 Appliance Plus Panasonic 1600 KYA KHOOB LAGTI HO (C Burdan) – Stewards concluded an inquiry into the riding tactics adopted aboard the mare. In particular why she had not attempted to improve forward from the 600 metres when there had been an

opportunity to improve. C Burdan explained that after suffering tightening soon after leaving the barrier she had got further back than intended in a muddling run race. She had then elected to ride for luck, however, entering the straight no opportunity had presented itself she then shifted out in an attempt to obtain clear running, with the mare finishing the race in a reasonable fashion. C Burdan's explanation was noted with Stewards advising that she must not ride in a manner that is left open to question.

RACE COMMENTS:

Race 1	JOHN NEWTON MEMORIAL 2200
HATTIE BEE (C Lammas) - Slow to begin.	
LOCALLY SAUCED (A Goindasamy) – Raced keenly when being steadied for a distance passing the 1600 metres.	
CAPELLANI (R Elliot) – Had to shift out entering the final straight to obtain clear running.	
Race 2	CAMPBELLS INFRASTRUCTURE 1215
OPTIMUM SWEET (R Kozaki) – Made contact with the rail leaving the birdcage dislodging rider R Kozaki. The mare was then re-mounted and proceeded to the start undergoing a veterinary inspection and was cleared to race. Steadied when placed in restricted room passing the 1100 metres to the inside of CAN I GET AN AMEN which was forced inwards by SHE SPEEDS. Also contributing was slight outward movement from DAY DREAMER.	
TE ATATU PASH (S McKay) – Hampered on jumping away losing ground.	
D Johnson – Issued with a warning for permitting her mount SHE SPEEDS to shift in forcing CAN I GET AN AMEN inwards on to OPTIMUM SWEET which was crowded having to be steadied passing the 1100 metres.	
D Guy – Fined \$50 for presenting SEAFOLLY and DOHA to race without notified gear (ear covers).	
Race 3	RYDGES HOTEL ROTORUA 1400
MANHATTAN GIRL (L Allpress) – Slow away.	
SWEET MOLLY MALONE (M Coleman) – Lay out under pressure in the final straight and could not be fully ridden out	
Race 4	NZB INSURANCE PEARL SERIES RACE (1400 Metres)
STARRING ROLE (S Collett) – Slow away.	
HEART SHAPED BOX (C Lammas) – Crowded and steadied shortly after jumping away. Raced keenly through the early stages, then commenced to give ground passing the 600 metres and was not persevered with in the final straight. The filly underwent a post-race veterinary examination which did not reveal any abnormality. Connections were advised that a warning would be placed on the filly's record after being uncompetitive.	
Race 5	WAITOMO FUELS 1560
LUCETTA (J Riddell) – Began awkwardly with the rider making contact with the top of the barriers becoming briefly unbalanced losing ground. J Riddell was attended to by the on course ambulance paramedic following the race and was cleared of any injury.	
KOOLASCUZ (L Allpress) – Slow away. Had difficulty obtaining clear running for the majority of the final straight.	
LAGERTHA (A Goindasamy) – Slow away.	

BABY FACE (D Johnson) – Slow away.

PARISIAN (R Elliot) – Had to shift out passing the 250 metres to obtain clear running placing KAINUI ROSE in restricted room which had to be steadied. R Elliot was advised to exercise care.

KAINUI ROSE (R Kozaki) – Placed in restricted room having to be steadied passing the 250 metres.

MACMILLAN ACCOUNTANTS 1560

NEW ROCA (R Elliot) – Raced three wide until passing the 1200 metres.

MISS FENDT (T Thornton) – Over-raced in the early stages.

MONBEAU (C Lammas) – Had to be restrained passing the 1200 metres when becoming awkwardly placed on heels, then continued to over-race for a distance. Steadied near the 400 metres after improving onto heels.

SON OF SASANOF (S McKay) – Held up for a distance passing the 400 metres.
