## GENERAL:

**G Jogoo** did not attend the meeting being stood down for the required fourteen day period after being in contact with a person who had recently returned from overseas.

**K Williams** - Admitted a charge of Misconduct in regard to the manner in which she spoke to Raceday Officials at the point of entry to the racecourse, with the Judicial Committee imposing a fine of \$600.

## RACE COMMENTS:

<b>Race 1</b>	<b>COCHRANES FARM MACHINERY (1400m)</b>
<p><b>WHALE SONG</b> (K Chowdhoory) - Slow to begin.</p> <p><b>CLOONEY</b> (C Johnson) - Slow to begin.</p> <p><b>MANHATTAN FLAME</b> (K Williams) - Steadied when crowded near the 1100 metres after FINAL SAVINGS shifted outwards to avoid the heels of I GOT A ROCK simultaneously as WHALE SONG was shifting inwards.</p> <p><b>FINAL SAVINGS</b> (K Mudhoo) - Began awkwardly then had to be steadied away from the heels of I GOT A ROCK which was being steadied to take a trailing position, placed in restricted room and buffeted for a short distance passing the 1000 metres when racing tight to the inside of WHALE SONG (K Chowdhoory). Apprentice <b>K Chowdhoory</b> was reprimanded and advised that he must make a far greater attempt to provide sufficient room for runners to his inside.</p> <p><b>I GOT A ROCK</b> (S Wynne) - Placed in restricted room and buffeted for a short distance passing the 1000 metres when racing tight to the inside of FINAL SAVINGS which was receiving pressure from WHALE SONG, went off stride near the 900 metres, held up early in the straight.</p>	
<b>Race 2</b>	<b>SELWYN RAKAIA VET SERVICES (1400m)</b>
<p><b>FAR SITE</b> (T Moseley) - Jumped away awkwardly then made firm contact with VARDON ROAD which shifted inwards at the start with the rider briefly losing the inside iron.</p> <p><b>PAPAGENA</b> (S Toolooa) - Began awkwardly then blundered shortly after the start, over raced in the lead in the middle stages, rider dropped his whip near the 200 metres.</p> <p><b>VARDON ROAD</b> (C Johnson) - Contacted by FAR SITE as the start was made, forced inwards shortly after the start having to be steadied to avoid the heels of CHARLIE AWESOME passing the 1200 metres.</p> <p><b>K Chowdhoory</b> (ALL ABOUT MAGIC) - Admitted a charge of careless riding in that he directed his mount inwards shortly after the start forcing VARDON ROAD inwards having to be steadied to avoid the heels of CHARLIE AWESOME near the 1200 metres. After hearing submissions the Judicial Committee suspended K Chowdhoory's licence to ride at race meetings for 7 national riding days effective from the conclusion of racing on Monday 23 March up to and including Friday 3 April.</p> <p><b>ALL ABOUT MAGIC</b> (K Chowdhoory) - Raced keenly in the middle stages.</p> <p><b>CHARLIE AWESOME</b> (B Murray) - Required post race veterinary treatment being 4/5 lame in the left foreleg, with a veterinary clearance now required prior to racing next.</p> <p><b>SANCTIFY</b> (K Asano) - When questioned regarding performance rider was of the opinion that the filly was not concentrating fully and would benefit from a gear change.</p>	

<b>Race 3</b>	<b>PETERSENS JEWELLERS LADIES BRACELET (1000m)</b>
<p><b>SISTER SARAH</b> (S Toolooa) - Slow to begin.</p> <p><b>MISS PENVOSE</b> (B Murray) - Slow to begin.</p> <p><b>TAVILIGHT</b> (K Chowdhoory) - Raced wide without cover throughout, lay inwards throughout the run home having to be straightened on a number of occasions.</p>	
<b>Race 4</b>	<b>YALDHURST WOOLS &amp; NZWTA (2000m)</b>
<p><b>RAINMAN</b> (K Mudhoo) - Slow to begin, hampered shortly after the start, held up entering the final straight having to be angled outwards across heels to obtain clear running near the 300 metres, lay in throughout the run home,.</p> <p><b>BABY MENAKA</b> (C Johnson) - Raced ungenerously when being steadied shortly after the start losing ground hampering RAINMAN. When questioned regarding performance rider was unable to offer any excuse other than the mare wanting to lug inwards throughout. A post race veterinary inspection did not reveal any obvious abnormality.</p> <p><b>SHAZ THE BANK</b> (S Toolooa) - Steadied when negotiating the crossing near the 1800 metres, clipped a heel and blundered passing the 800 metres unbalancing the rider.</p> <p><b>CINTO BAY</b> (J Laking) - Raced three wide without cover throughout.</p> <p><b>HEAD OFFICE</b> (G Jogoo) - Raced in restricted room rounding the final turn before obtaining clear running near the 300 metres.</p>	
<b>Race 5</b>	<b>R REDPATH LTD (1800m)</b>
<p><b>LORD ZACFORD</b> (J Lowry) - Fractious in the barriers being removed to undergo a pre-race veterinary inspection before being declared a late scratching at 2.23 pm on veterinary advice.</p> <p><b>SMILING ASSASSIN</b> (W Papier) - Slow to begin.</p> <p><b>RUMOUR HAS IT</b> (K Asano) - Restrained to obtain cover after jumping from a wide barrier draw.</p> <p><b>SHOCK AND AWE</b> (S Wynne) - Bounded at the start beginning awkwardly and losing ground as a result, held up near the 450 metres and was unable to obtain clear running for the majority of the final straight until inside the final 50 metres.</p> <p><b>SCANDALOUS</b> (C Johnson) - Raced wide until improving forward to sit outside the leader near the 1000 metres.</p> <p><b>COUP DREAMWOOD</b> (K Chowdhoory) - Over raced in the middle stages, held up early in the straight until near the 300 metres, shifted outwards under pressure over the final 150 metres inconveniencing LARIPPA. K Chowdhoory was advised to exercise greater care.</p> <p><b>LARIPPA</b> (T Moseley) - Inconvenienced over the final 150 metres when COUP DREAMWOOD shifted outwards under pressure. Prior to the authorisation of dividends rider T Moseley viewed Stewards films before electing not to proceed with a protest. Lost the left front plate during the running.</p> <p><b>FINE BOUQUET</b> (K Williams) - Held up from the 150 metres until inside the final 50 metres.</p> <p><b>BB Hong</b> (MAMBA) - Fined \$300 after admitting a charge of using his whip excessively prior to the 100 metres.</p>	
<b>Race 6</b>	<b>SEATON FAMILY MEMORIAL HORORATA GOLD CUP (1800m)</b>

**CAMINO ROCOSO** (C Johnson) - Raced keenly whilst leading through the early to middle stages.

**WHO DARES WINS** (BB Hong) - Raced three wide without cover throughout.

**C Campbell** (DIORISSIMO) - Fined \$350 after admitting a charge of using his whip excessively prior to the 100 metres.

**S Wynne** (NEESON) and **J Lowry** (PATRICK ERIN) were spoken to regarding their whip use prior to the 100 metres.

<b>Race 7</b>	<b>SONIA &amp; GARRY THOMPSON (1200m)</b>

**DON CARLO** (K Williams) - Declared a late scratching behind the barriers at 3.33 pm on veterinary advice as it was found to be lame in the right hind leg. Connections were advised that a veterinary clearance will be required prior to racing next.

**TURNCOAT** (W Papier) - Lost its footing jumping away, had to be steadied near the 600 metres when placed in restricted room between WINDSOR which shifted outwards slightly when over racing and DYNAMIC (K Chowdhoo) which shifted inwards. K Chowdhoo was advised to exercise greater care. Held up for a distance entering the final straight.

**STRADIVARIUS** (S Wynne) - Began awkwardly losing ground. The rider reported that the gelding had been run off its feet and may be better suited by some easing of the ground.

**KHIMAR WAR** (C Campbell) - Blundered leaving the barriers.

**EL BEE DARCI** (R Mudhoo) - Was taken back from a wide draw shortly after the start.

**WINDSOR** (C Johnson) - Over raced badly in the early and middle stages. When questioned regarding performance rider reported that after over racing the gelding had been unable to finish the race off.

<b>Race 8</b>	<b>VALACHI DOWNS SOUTH ISLAND THOROUGHBRED BREEDERS (1600m)</b>

**BELLE FASCINO** (S Wynne) - Slow to begin.

**THE PRECIOUS ONE** (B Murray) - Blundered at the start.

**ZABAY** (C Campbell) - Bounded at the start then further hampered losing ground when MONRECOUR shifted outwards at the start.

**QUINTUPLE TWINS** (C Johnson) - Commenced to over race shortly after the start and when being restrained going into the bend near the 1100 metres lay in making contact with EXCELLERATION with both runners continuing to make contact for several strides when unbalanced.

**EXCELLERATION** (J Lowry) - Contacted and unbalanced for several strides near the 1100 metres.

**XCUSES XCUSES** (T Comignaghi) - Raced wide without cover through the early to middle stages.

**UPSCALE** (C Barnes) - Raced ungenerously when being steadied near the 1000 metres.

**BENEFICIAL** (J Laking) - Inconvenienced near the 800 metres when BELLE FASCINO lay out when being steadied, inconvenienced near the 500 metres when BELLE FASCINO shifted outwards, held up early in the run home only gaining clear racing room inside the final 250 metres.

**J Laking** (BENEFICIAL) - Admitted a charge of using his whip excessively prior to the 100 metres, with the Judicial Committee suspending his licence to ride at race meetings for 6 national riding days effective from the conclusion of racing on Monday 23 March up to and including 2 April and in addition imposing a fine of \$200.

**K Williams** (TICKET TO RIDE) - Fined \$450 after admitting a charge of using her whip excessively prior to the 100 metres.

**B Murray** (THE PRECIOUS ONE) - Fined \$450 after admitting a charge of using his whip excessively prior to the 100 metres.

<b>Race 9</b>	<b>PAT REARDON FAMILY &amp; HORORATA SUPPORTERS (1400m)</b>

The race was slightly delayed due to some debris being removed from the track.

**O'GUY** (K Asano) - Began awkwardly.

**MOREIRA** (BB Hong) - Slow to begin.

**OUTRAM** (J Lowry) - Slow to begin, had to be briefly steadied shortly after the start when crowded for room, raced three wide without cover for the majority of the race. Rider reported that the gelding would be better suited to rain affected conditions.

**ALONZO** (K Chowdhury) - Slow to begin, hampered losing ground when crowded by ADMIRAL ROUS which lay inwards shortly after the start.

**GRANT** (C Barnes) - Under pressure passing the 800 metres and tailed the field for the majority of the race finishing a distant last. Rider was unable to offer any excuse and a post-race veterinary inspection was clear.

**WANDERIN OVER** (J Laking) - Had a tendency to lay in when placed under pressure in the straight.

**S Wynne** (SEVERINE) - Issued with a warning for her whip use prior to the 100 metres.
