RACE COMMENTS:

Race 1 GARTSHORE CONSTRUCTION 1200

A Fuller – Issued with a warning for presenting HAPPY EGO to race without the notified nose band.

HAPPY EGO (A Goindasamy) – Raced keenly in the middle stages.

CRIMSON STAR (A Calder) – Raced in restricted room over the concluding stages after improving on to heels.

Race 2 TAURANGA CROSSING FASHIONS IN THE FIELDS NEXT SATURDAY 1400

JACK THE LASS (A Calder) – Reared over in the barriers becoming cast and after being removed underwent a veterinary examination being declared a late scratching at 12:30pm. Trainer C Wood was advised that the filly would be required to barrier trial to the satisfaction of Stipendiary Stewards prior to racing next.

ARATAI (R Oliver) – Was in the adjacent stall to JACK THE LASS and was removed and underwent a veterinary examination being declared a late scratching at 12:32pm.

METRO WINNER (C Lammas) – Slow away.

VOLITIVO (L Satherley) – Commenced to over-race in the early stages having to be firmly restrained off heels passing the 1000 metres. Contacted near the 350 metres.

MAC'S EXPRESS (D Danis) – Raced wide without cover. Had to be steadied when placed in restricted room passing the 450 metres.

GOLDCHI (A Goindasamy) – Steadied passing the 400 metres when placed in restricted room.

BLADE (J Fawcett) – Lay out rounding the final bend and shifted out near the 350 metres making contact with VOLITIVO.

L Satherley (VOLITIVO) – Issued with a warning for her whip use prior to the 100 metres.

Race 3 BETHLEHEM MOTOR INN 1200

S Marsh – Trainer S Marsh admitted a breach of Rule 614(2) in that he presented RAPOSA RAPIDA to race with the incorrect saddle cloth number and was fined \$50 by the Judicial Committee.

Race 4 APPLIANCE PLUS PANASONIC 1600

N Tiley – Issued with a warning for presenting BRUEGEL to race without the notified blinkers.

NASHA RIVA (D Danis) – Slow away. Raced keenly in the early stages before having to be firmly restrained off heels passing the 1200 metres when TWEEDLEDEE shifted in when not fully clear.

LE SABLIER (J Fawcett) – Slow away.

KYA KHOOB LAGTI HO (C Burdan) – Steadied when placed in restricted room shortly after the start.

IMELDA MARY (T Newman) – Raced in restricted room for a distance passing the 1100 metres.

BRUEGEL (S Spratt) – Steadied when placed in restricted room near the 1100 metres to the inside of IRON EAGLE (A Calder) which shifted in slightly. A Calder was advised to exercise care in similar circumstances. Then raced keenly for a distance having to be firmly restrained off the heels of IRON EAGLE which shifted in near the 900 metres. Lost the right hind plate during the running.

LE SABLIER (J Fawcett) – Held up until near the 300 metres.

M Hashizume – Issued with a warning for allowing his mount TWEEDLEDEE to shift in when not sufficiently clear of NASHA RIVA which had to be firmly restrained to avoid heels near the 1200 metres.

A Calder – Issued with a warning for allowing his mount IRON EAGLE to shift in when not sufficiently clear of BRUEGEL which had to be steadied passing the 900 metres.

Race 5 PACIFIC STONE KITCHEN AND VANITY BENCHTOPS 1400

LUMINOUS (R Kozaki) – Began awkwardly losing ground. Shifted in passing the 200 metres placing AILEEN GRACE, ARRAIGNMENT and TUTTA LA CLASSE in restricted room. R Kozaki was advised to exercise care.

UP 'N' GONE (J Fawcett) – Began awkwardly.

MONT VENTOUX (M Kareem) – Raced three wide without cover throughout.

AILEEN GRACE (A Goindasamy) – Placed in restricted room passing the 200 metres. Lost its front near plate during the running.

ARRAIGNMENT (L Satherley) – Placed in restricted room passing the 200 metres. Checked passing the 50 metres.

TUTTA LA CLASSE (M Hashizume) – Placed in restricted room passing the 200 metres. Steadied after becoming awkwardly placed on heels over the concluding stages.

A Goindasamy – Admitted a charge of careless riding in that he permitted his mount AILEEN GRACE to shift in when not sufficiently clear of ARRAIGNMENT which was checked near the 50 metres. After hearing submissions, the Judicial Committee suspended Mr Goindasamy's licence to ride in races from the conclusion of racing on 21 March up to and including racing on 28 March, 5 national riding days.

C Burdan – Admitted a charge of careless riding in that she allowed her mount GRIFFIN to shift out over the concluding stages when not sufficiently clear of TUTTA LA CLASSE which had to be steadied losing ground. After hearing submissions, the Judicial Committee suspended Miss Burdan's licence to ride in races from the conclusion of racing today 14 March up to and including racing on 22 March, 5 national riding days.

Race 6 GRACE TEAM ACCOUNTING 1400

MAGDALA (C Lammas) – Steadied when placed in restricted room shortly after the start. Shifted outwards abruptly passing the 100 metres crowding VICTORY GLORY outwards on to THE HELIX which became unbalanced which then shifted in further crowding VICTORY GLORY over the concluding stages.

THE HELIX (C Burdan) – Shifted in making contact with MAGDALA for a distance passing the 900 metres with THE HELIX then making the bend awkwardly, was then obliged to race wide without cover for the remainder of the race. Contacted and unbalanced passing the 100 metres.

VICTORY GLORY (D Danis) – Crowded passing the 100 metres and again over the concluding stages.

Race 7 SUPER LIQUOR GREERTON 1400

HYPNOS (C Lammas) - Slow away.

NEW YORK JAZZ (A Goindasamy) – Began awkwardly losing ground. Over-raced in the early stages.

POLLY GREY (J Fawcett) – Held up for a distance approaching the 100 metres, then had difficulty obtaining clear running over the concluding stages.

Race 8 ALL FROCKED UP GIRLS 1600

CLEVERCONVERSATION (J Fawcett) – Began awkwardly and then was further hampered losing ground. Held up until shifting out passing the 350 metres making contact with ROCKING ALONG which became unbalanced.

SON OF SASANOF (B R Jones) – Began awkwardly losing ground.

BEYOND SACRED (S Spratt) – Shifted out shortly after jumping away inconveniencing TARWYN.

TARWYN (D Danis) – Inconvenienced shortly after the start.

SPEEDY GEE (R Kozaki) – Crowded shortly after the start.

ROCKING ALONG (C Dell) – Contacted and unbalanced passing the 350 metres.

HENLEY ROAD (A Goindasamy) – Had difficulty obtaining clear running early in the final straight.

BARRY'S BOYO (L Satherley) – When questioned regarding the performance the rider advised that the gelding had got its tongue over the bit and had proved difficult to control, adding that in her opinion it would benefit from some easing of the ground.

JAKAMA KRYSTAL (C Burdan) – Lost the right front plate during the running.

Following the running of this race M Hashizume was stood down for medical reasons. M Hashizume is to provide a medical clearance to Stipendiary Stewards prior to riding next.

Race 9 ULTIMATE MAZDA JAPAN TROPHY NEXT SATURDAY 1200

RIVERFALLS (D Danis) – Began awkwardly losing ground. Had some difficulty obtaining clear running early in the final straight.

APPELLANT (R Oliver) – Began awkwardly. Raced keenly in the early stages, then was obliged to race three wide without cover throughout.

PHANTOM WITNESS (R Kozaki) - Began awkwardly. Lay out rounding the final bend.

Race 10 WORLDS END BAR AND RESTAURANT FRASER COVE 2100

NIZONA (C Burdan) – C Burdan was granted permission from Stewards to ride NIZONA 1 kg over her book weight as there was no other suitable claiming apprentice available. Began awkwardly losing ground.

YOU'RE WELCOME (R Kozaki) – Began awkwardly and then was further hampered when making contact with the hind quarters of GABRIEL then losing ground.

VITTACHI (C Lammas) – Raced wide in the early stages. Following the race the rider reported that the gelding had felt indifferent throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

HAKUNA MATATA (D Danis) – When questioned regarding performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.
