**POROTENE CHARM** (C Burdan) - T Keegan advised Stewards she was satisfied with the post-race condition of the filly, however, put the disappointing performance down to the holding track conditions. T Keegan further advised it is now her intention to carry on with POROTENE CHARM'S current preparation.

<b>Race 1</b>	<b>WAIKATO EQUINE VETERINARY CENTRE 2YO</b>
<p><b>ZOLTAN</b> (T Yanagida) - Hampered soon after leaving the barriers and steadied.</p> <p><b>JOHNNY CANUCK</b> (A Calder) - Began awkwardly.</p> <p><b>CHARMAINE'S DREAM</b> (D Johnson) - Began awkwardly then restrained.</p> <p><b>SHEZA JAKKAL</b> (J Fawcett) - Restrained from its wide barrier.</p> <p><b>PRINCESS ALICE</b> (L Satherley) - Restrained from its wide barrier.</p> <p><b>QUEEN OF THE PROM</b> (S Weatherley) - Raced wide without cover.</p> <p><b>FLASH WARRIOR</b> (S Spratt) - Held up when denied a run to the outside of LADY WOBURN passing the 350 metres having to be steadied and then shifted out passing the 200 metres to obtain clear running.</p> <p><b>LADY WOBURN</b> (C Grylls) - Improved onto heels near the 300 metres and steadied.</p> <p><b>CHILLAX</b> (M Cameron) - Inconvenienced near the 350 metres.</p> <p><b>R Elliot</b> (DE LA TERRE) – Stipendiary Stewards granted permission for A Goindasamy to replace R Elliot as there was no other suitable senior rider available. Issued with a minor infringement notice and fined \$100 for failing to make the contacted weight for DE LA TERRE and ANA ZORRA</p>	
<b>Race 2</b>	<b>TE RAPA EVENT CENTRE – OPEN AGAIN 1000</b>
<p><b>TURRET</b> (J Fawcett) - Slow to begin.</p> <p><b>SHAM ON TOAST</b> (S Collett) - Began awkwardly then contacted becoming unbalanced.</p> <p><b>CHUR CHING</b> (T Newman) - Crowded soon after leaving the barriers and restrained.</p> <p><b>KRYPTONITE</b> (C Grylls) - Restrained from its wide barrier.</p> <p><b>M Kareem</b> (ATOM ANT) - Reminded of his obligations in that he must ride his mounts out fully to the end of the race when circumstances permit.</p>	
<b>Race 3</b>	<b>NZB INSURANCE PEARL SERIES RACE</b>

**SCOTCH** (C Grylls) - Crowded soon after leaving the barriers being steadied. Had to be firmly restrained off heels passing the 700 metres.

**VINO BELLA** (J Kamaruddin) - Began awkwardly then was crowded shortly after. Steadied passing the 700 metres when in restricted room to the inside of **FERINDI** (R Elliot) dropping back onto **SCOTCH** which had to be firmly restrained off heels. R Elliot was advised to exercise care when in a similar circumstance. Held up for a distance passing the 400 metres.

**KEEP THE CASH** (S Weatherley) - Began awkwardly then steadied.

**QUALITY PREVAILS** (J Fawcett) - Restrained from a wide barrier.

**LADY LIRA** (M Cameron) - Had to be restrained off heels passing the 650 metres when racing keenly.

**HEZA LOOKER** (A Goindasamy) - Held up passing the 350 metres having to shift out to obtain clear running.

**ERIDANI** (D Johnson) - When questioned regarding the performance the rider advised that in her opinion the mare would now benefit from a step up in distance.

**ROC CHA** (B Rogerson) - Underwent a post-race veterinary examination which did not reveal any abnormality.

**B Rogerson** (ROC CHA) - Was spoken to regarding her whip use.

**T Yanagida** (PORSHABEELE) - Issued with a warning for raising his arm above shoulder height when using his whip.

<b>Race 4</b>	<b>DUNSTAN EQUINE FEEDS 1000</b>

**RONCHI** (M Hashizume) - Slow to begin.

**LONDON EXPRESS** (H Schofer) - Slow to begin. Steadied when placed in restricted room passing the 750 metres when racing between **RONCHI** and **WALKIN' BY** which made the bend awkwardly. M Hashizume was advised to exercise care in a similar circumstance.

**WALKIN' BY** (S Collett) - Began awkwardly.

**TAMMIE WYNETTE** (T Yanagida) - Began awkwardly, with the rider becoming briefly unbalanced. Steadied approaching the 200 metres when held up for clear running.

**MALAMBO** (R Elliot) - Had to be steadied then shift out passing the 350 metres after **IHU** shifted in when not fully clear.

**C Jones** (**IHU**) - Issued with a warning for allowing his mount to shift in when not clear of **MALAMBO** which had to be steadied passing the 350 metres.

Authorization of placings was withheld until Stewards were satisfied that **RONCHI** had received a fair start. After interviewing the starter and rider it was determined that the gelding had received a fair start and the geldings slow beginning was of his own accord.

<b>Race 5</b>	<b>GROUP ONE TURF BAR 1200</b>

**FORGETZ** (C Jones) - Began awkwardly then hampered.

**THE GRINDER** (H Schofer) - Slow to begin. Had difficulty obtaining clear running early in the final straight. Then steadied when placed in restricted room to the outside of WILD LIKE which shifted out approaching the 300 metres.

**CICCIOLINA** (D Montes de Oca) - Slow to begin.

**CANNSEA CLEARLY** (S Collett) - Crowded shortly after the start having to be steadied. Had difficulty obtaining clear running until passing the 200 metres.

**SNAKEYE** (E Nicholas) - Began awkwardly shifting out abruptly. Raced wide without cover throughout when laying out.

**RAPID RECALL** (A Calder) - Raced in restricted room for a distance entering the final straight.

**C Ormsby** (WILD LIKE) - Issued with a warning for allowing his mount to shift out approaching the 300 metres placing THE GRINDER in restricted room which had to be steadied.

<b>Race 6</b>	<b>WEBSITE ANGELS 1200</b>

**TUTTA LA CLASSE** (S Collett) - Refused to leave the barrier as the start was effected losing considerable ground. I Marks was advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing again.

**RHAPSODY IN BLUE** (D Johnson) - Began awkwardly becoming crowded. Lost both front plates during the running.

**HOT SPRING PROJECT** (L Innes) - Crowded soon after leaving the barriers then steadied.

**MAKABAR** (R Beemud) - Began awkwardly then restrained.

**GIGOLO GEORGE** (J Riddell) - Raced wide without cover.

**OSAKA** (J Waddell) - Raced ungenerously through the middle stages.

**ANA ZORRA** (L Satherley) - Held up early in the final straight.

**LITTLE SHIRLEY** (T Yanagida) - Lay out when placed under pressure rounding the bend and in the final straight.

**SWEET CLEMENTINE** (M Hashizume) - Had some difficulty obtaining clear running entering the final straight.

**R Beemud** (MAKABAR) - Issued with a warning for his whip use prior to the 100 metres.

<b>Race 7</b>	<b>LODGE RENTALS 1200</b>

**LIVVY LASS** (C Lammas) - Began awkwardly losing ground.

**BORN TO FIGHT** (R Elliot) - Began awkwardly losing ground.

**MONACO** (T Newman) - Began awkwardly. Hampered having to be steadied passing the 850 metres.

**TIA CELESTE** (L Satherley) - Began awkwardly. Hampered passing the 850 metres.

**LEAF** (J Riddell) - Steadied when placed in restricted room over the concluding stages.

**HARBOURSIDE** (S Spratt) - Dictated outwards inside the final 200 metres being contacted and forced wider passing the 100 metres and again prior to the winning post.

**THREADTHENEEDLE** (C Grylls) - Firmly restrained near the 850 metres when placed in restricted to the inside of TUSCAN WHISTLER which was forced inwards by HARBOURSIDE which shifted in and away from the heels of SAINT CROIX with HARBOURSIDE then being further crowded by LEAF which shifted in. As a result, TUSCAN WHISTLER and THREADTHENEEDLE were further hampered, also hampered was the trailing MEDALZA. Steadied passing the 200 metres after improving onto heels.

**MEDALZA** (S Collett) - Hampered passing the 850 metres shifting out placing TIA CELESTE in restricted room, which dropped back onto MONACO which had to be steadied.

**TUSCAN WHISTLER** (T Yanagida) - Steadied when placed in restricted room near the 850 metres then further hampered passing the 800 metres.

**S McKay** (SAINT CROIX) - Issued with a warning to allow his mount to shift in when not fully clear of HARBOURSIDE which shifted in and away crowding TUSCAN WHISTLER and THREADTHENEEDLE. Also hampered as a result was MEDALZA.

**J Riddell** (LEAF) - Issued with a warning for allowing his mount to shift in approaching the 800 metres when not fully clear of HARBOURSIDE which was hampered.

**A Goindasamy** (PALAMEDES) - Issued with a warning for his allowing his mount to shift out passing the 200 metres making contact with HARBOURSIDE near the 100 metres and again prior to the winning post.

<b>Race 8</b>	<b>NZB READY TO RUN SALE 1400</b>

**IRIDESSA** (S McKay) - Reared as the start was effected, losing ground.

**BLADE** (J Fawcett) - Slow to begin then hampered shortly after.

**ARICINA** (H Schofer) - Badly hampered soon after leaving the barriers, losing ground.

**DAY DREAMER** (E Nicholas) - Rider became unbalanced after beginning awkwardly with DAY DREAMER shifting out abruptly dictating TOUCH THE CLOUD outwards which forced CASSIO into the line of BLADE which was badly hampered.

**H Schofer** (ARICINA) - Admitted a charge in that she used her whip excessively when riding ARICINA prior to the 100 metres with the Judicial Committee issuing a fine of \$300.

<b>Race 9</b>	<b>BGP BATTLERS CUP</b>

**SWEET TREAT** (R Elliot) - Raced ungenerously in the early and middle stages. Held up until near the 350 metres.

**GALLANTE** (B Rogerson) - Hung out in the early and middle stages, running wider passing the 600 metres and was unable to be ridden out for the remainder of the race. Trainer G Rogerson was advised that a warning would be placed on the geldings racing manners.

**HATTIE BEE** (C Lammas) - Crowded having to be firmly restrained just prior to the winning post.

**VAINGLORY** (S Weatherley) - Contacted and unbalanced just prior to the winning post.

**VALANTE** (J Riddell) - Eased down passing the 550 metres, hampering JOCHEN RINDT, and was pulled up by his rider. Was immediately attended to by the on-course veterinarian and the horse ambulance. VALANTE was found to have fractured its lower right leg and was humanely euthanised.

**JOCHEN RINDT** (J Riddell) - Badly hampered after improving onto the heels of VALANTE near the 500 metres.

**T Yanagida** (ALI BABA) - Issued with a warning for allowing his mount to shift in, crowding HATTIE BEE onto the hind quarters of VAINGLORY which was unbalanced just prior to the winning post.

Following the race, the connections of the 2<sup>nd</sup> placed horse VAINGLORY lodged a protest against the 1<sup>st</sup> placed horse ALI BABA alleging interference in the final 50 metres. After considering submissions the Judicial Committee dismissed the protest.

<b>Race 10</b>	<b>LEGACY LODGE 1200</b>

**SAIGNON** (R Beemud) - Rider became unbalanced when leaving the barrier.

**CYBER ATTACK** (C Grylls) - Began awkwardly then crowded losing ground. Inconvenienced passing the 350 metres when denied a run to the outside of INCA WARRIOR which shifted out. Hampered near the 200 metres when improving onto the heels of CAMPARI which had shifted out and away from NEW YORK JAZZ despite the efforts of its rider.

**DIVINE BOY** (C Jones) - Began awkwardly then restrained shortly after. Raced keenly in the middle stages.

<b>Race 11</b>	<b>SUPER SETH @ WAIKATO STUD 1400</b>

**VERRY FLASH** (C Jones) - Slow to begin.

**RODOLFO** (R Beemud) - Began awkwardly then hampered.

**AZABOY** (A Calder) - Crowded leaving the barrier.

**COLLINSTREET** (H Schofer) - Began awkwardly.

**FLAUNTING** (C Lammas) - Began awkwardly. Raced keenly through the middle stages.

**OBSESSIVE** (A Goindasamy) - Began awkwardly. Raced ungenerously passing the 1000 metres, then made the bend awkwardly approaching the 700 metres forcing PACORUS wider on the track. When questioned regarding the performance the rider advised that the gelding had settled further back than intended and had over raced throughout, adding that in his opinion it would benefit from a step up in distance.

**PACORUS** (T Yanagida) - Crowded leaving the barrier. Forced wide passing the 700 metres.

**M Hashizume** (DEEJAY MAC) - Issued with a warning for his whip use prior to the 100 metres.

**R Beemud** (RODOLFO) - Referred to riding master N Harris regarding his whip use.

<b>Race 12</b>	<b>SVS 1400</b>

**MR INCREDIBULL** (S McKay) - Began awkwardly.

**PENELOPE CRUISE** (H Schofer) - Began awkwardly. Raced keenly for a distance approaching the 800 metres making the bend awkwardly.

**ZAMAX** (A Goindasamy) - Began awkwardly losing ground. Commenced to race keenly shortly after the start before improving onto the heels of LADYLAX passing the 1000 metres which was steadied when over racing having to be firmly restrained. Continued to over race through the middle stages.

**VITTACHI** (C Lammas) - Began awkwardly losing ground.

**JOHNNIE REDMOND** (T Newman) - Began awkwardly losing ground.

**LADYLAX** (M Cameron) - Raced ungenerously when being restrained passing the 1000 metres then continued to over race making the bend near the 800 metres awkwardly, shifting out crowding ZABDI.

**ZABDI** (M Hashizume) - Steadied when crowded passing the 850 metres.

**DRAKE BAY** (S Weatherley) - Held up entering the final straight before shifting out to obtain clear running.
