<b>Race 1</b>	<b>BONNY GLEN LANDFILL-MIDWEST DISPOSALS 1550 (1550 Metres)</b>
<b>THE GREAT GURU</b> (T Johnson) - Tightened at the start and got back. Had to steady when awkwardly placed on the heels of TINTINTINNIE near the 800 metres when that runner shifted out simultaneously as NO TIP shifted in.	
<b>ONEFORTHE DITCH</b> (S O'Malley) - Slow from its wide draw.	
<b>LOVETOKEEPHIM</b> (D Parker) - Raced three wide without cover throughout.	

**T Johnson** (THE GREAT GURU) – Spoken to regarding the use of his whip prior to the 100 metres.

**I Lupton** (DES DE JEU) – Spoken to regarding the use of his whip prior to the 100 metres.

<b>Race 2</b>	<b>J&amp;J WALTERS 1550 (1550 Metres)</b>

**C Thornton** the foreman for the J Richards stable admitted a breach of Rule 614(2) in that he presented their two runners (AL HARAM and RICHARD OF YORKE) in the birdcage with incorrect saddles and was fined \$300.

**RICHARD OF YORKE** (M Roustoby) - Tightened at the start and got back.

**MR FLYNN** (L Douglas) – Over-raced when being steadied in the early stages. Steadied when in restricted room near the 300 metres.

**SPEED CALL** (S O'Malley) – Got its head in the air when over-racing towards the end of the back straight.

**N Downs** (FINAL SAY) - Became unbalanced rounding the turn when shifting out to avoid the heels of the runner ahead.

**S O'Malley** (SPEED CALL) - Issued with a warning for the use of his whip prior to the 100 metres.

<b>Race 3</b>	<b>KELLY &amp; ASSOCIATES 1000 (1000 Metres)</b>

**GREYSTONE** (C Johnson) – Slow away. Finished some distance back. C Johnson reported the gelding was under pressure throughout. A subsequent veterinary examination was clear.

**THATZ TIGERLILY** (T Taiaroa) - Made the bend near the 700 metres awkwardly.

**KHALFANI** (K Asano) - Inclined to lug outwards in the home straight.

<b>Race 4</b>	<b>TREADWELL GORDON/RICHARDS CONSTRUCTION 1000 (1000 Metres)</b>

**QUATTRO KATIE** (C Burdan) –Made contact with front of its gate so was removed and passed a veterinary examination prior to being reloaded. When questioned, C Burdan advised the mare travelled well throughout and had no excuse. QUATTRO KATIE returned to the enclosure with blood present in the nasal area. A subsequent veterinary examination revealed a small cut to the nostril consistent with having hit the front of its gate.

**LADY KARTEL** (L Allpress) - Lay in and away from DESERT MAGIC at the start resulting in tightening to the following runners; THIS LADY ROCKS, THOUSANDKISSESDEEP, ATENARTIN, which was checked and got back, and TRENDY BELT.

**THIS LADY ROCKS** (K Asano) – Tightened at start.

**THOUSANDKISSESDEEP** (R Oliver) – Tightened at start

**ATENARTIN** (T Taiaroa) - Tightened at start

**TRENDY BELT** (T Thornton) Tightened at start.

**LALA LAND** (R Myers) - When questioned rider advised the gelding would take natural improvement with the run and would be better suited to more ground.

<b>Race 5</b>	<b>PROPERTY BROKERS 1200 (1200 Metres)</b>

**TIGERTIGER** (M Hudson) – Very slow away from its wide draw. Improved up on to heels approaching the home straight and was checked.

**TED CAN TOO** (T Thornton) - Bumped at the start.

**AIMEE'S JEWEL** (L Allpress) - Began awkwardly and was slow away.

**CATHAY NOVA** (R Myers) – Finished on only fairly. When questioned R Myers reported the filly had not appreciated today's Heavy 11 track conditions. A subsequent veterinary examination was clear.

<b>Race 6</b>	<b>ALLAN MCNEILL/EVANS HENDERSON/WOODBRIDGE BARISTERS &amp; SOLICITORS (1200 Metres)</b>

**SHANPARK** (R Myers) – Slow away.

**J Parkes** (FATTORE OTTO) - Issued with a warning regarding his whip use prior the 100 metres when marginally outside the guidelines.

<b>Race 7</b>	<b>CENTRAL ITM – MARTON &amp; FEILDING 1200 (1200 Metres)</b>

**SATIN BELT** (L Allpress) – Shifted in and away from THE BANDITO at the start, resulting in tightening to FACETIME, which lost ground. Bumped home straight.

**R Oliver** (THE BANDITO) – Was advised to exercise more care when shifting ground after allowing his mount to shift inwards shortly after the start when not fully clear of SATIN BELT.

**FACETIME** (S Macnab) – Tightened start, losing ground.

**PINK GRAFFITI** (D Bradley) - Bounded at the start and got back.

**ROCK ISLAND LINE** (K Asano) - Held up early in the home straight, shifted out bumping SATIN BELT. K Asano was advised to exercise greater care when shifting ground.

**HARRY HARRISON** (M Hudson) - Inclined to shift ground in the home straight.

**AWATANE** (T Thornton) – Returned to the enclosure with an injury to the off hind, which required veterinary attention.

<b>Race 8</b>	<b>NORWOOD 1400 (1400 Metres)</b>

**RED SIERRA** (R Myers) – Slow away.

**OBRIGADO** (L Hemi) – Slow away.

**HAPPY STAR** (L Allpress) – Over-raced in the early and middle stages.

**T Taiaroa** (PLATINUM RAPPER) – Was observed to relax her ride over the final stages but held third placing. T Taiaroa was shown footage of her ride in the presence of the riding master and advised that she is expected to ride her mounts out fully to the finish when circumstances permit.

<b>Race 9</b>	<b>NZB INSURANCE PEARL SERIES RACE (1400 Metres)</b>

**BONNY GLEN** (L Allpress) - Had to steady off heels shortly after the start.

**MANAWAPOU** (D Hirini) – Over-raced in the early and middle stages.

**TIRO** (C Johnson) – Over-raced early. Received an interrupted run rounding the home turn and had to change ground when attempting to improve approaching the 200 metres when GOLD WINNER shifted inwards.

**CAST IN BRONZE** (J Parkes) –When questioned J Parkes advised the mare had not handled today's Heavy 11 track conditions. Underwent a post-race veterinary examination which was clear.

**Race 10**

**BJW MOTORS/RAYNER BUILDING 1400 (1400 Metres)**

**BREATH OF FIRE** (M Hudson) - Shifted out abruptly on jumping away, tightening EM KAY POPS, which got back.

**EM KAY POPS** (J Parkes) – Tightened start, got back.

**SUPER FLASH** (M Sanson) - Shifted out under pressure over the final stages.

**RELDA** (A Mudhoo) – Shifted inwards near the 75 metres when not clear ofDOUBLE ACT which was checked.

Following the event, connections of the 4<sup>th</sup> placed DOUBLE ACT (C Johnson) lodged an objection against the 2<sup>nd</sup> placed RELDA (A Mudhoo) alleging interference near the 75 metres. After a JCA hearing the protest was dismissed.

**A Mudhoo** (RELDA) - Admitted a subsequent charge of careless riding and had his apprentice jockey's licence suspended from the conclusion of racing today, up to and including racing on Saturday, 11 July 2020 (2 riding days).
