Rider B Murray was directed to meet with the NZTR rider skills review panel to assist in rectifying issues with his riding in relation to his use of the whip.

Race 7 - Barneswood Farm Rating 93 Handicap (1200m)

ISHINKTAATLEDO - Co-trainer R Didham advised that ISHINKTAATLEDO had been vetted in subsequent days with no abnormality apparent but the decision was made to retire the mare from racing.

RACE COMMENTS:

Race 1 HYGAIN/MITAVITE MAIDEN 2YO&UP (1200m)

SHELBY DEVINE (T Jonker) - Fractious behind the barriers and reluctant to load which delayed the start. A warning was placed on the filly's barrier manners.

READY TO ROAR (K Chowdhoory) - Began awkwardly then crowded shortly after the start clipping a heel and blundering losing further ground.

JOLLY RODGER (K Ramsamy) - Slow to begin.

LA FORZA (K Asano) - Crowded on jumping.

TREKOLURE (L Callaway) - Had to be steadied when negotiating the crossing near the 650 metres when awkwardly placed to the inside of MOLLY MAGUIRE which lay in.

TURN YOUR EYES (T Comignaghi) - Had difficulty obtaining clear running until approaching the 100 metres.

MORE THAN ENOUGH (C Campbell) - Lay in under pressure over the concluding stages.

K Chowdhoory (READY TO ROAR) - Admitted a charge of excessive use of the whip prior to the 100 metres and was fined \$400 by the Judicial Committee.

C Campbell (MORE THAN ENOUGH) - Spoken to regarding his whip use prior to the 100 metres.

LIGHTNING RIDGE (C Barnes) - Trainer P Harris reported that the filly had lost both back plates during the running and had returned to the enclosure without its tongue tie.

Race 2 RICCARTON PARK FUNCTION CENTRE MAIDEN 2YO&UP (900m)

SUPER TAP (C Johnson) - Declared a late scratching at 11.06am after refusing to load. The connections were advised that the filly must barrier trial satisfactorily prior to racing next.

WALKTHISSWEY (S Macnab) - Fractious prior to the start with a warning placed against the filly's barrier record.

MISS IF FORMAX (K Chowdhoory) - Began awkwardly.

ROCK SENSATION (L Allpress) - Slow to begin.

COLLABORATOR (T Jonker) - Began awkwardly.

ATAAHUA DREAMTIME (R Cuneen) - Slow to begin.

SOVIET WONDER (R Mudhoo) - Had a tendency to lay inwards throughout the straight and could not be ridden out fully as a result. Rider reported that his saddle had shifted sideways during the running further inconveniencing him over the concluding stages.

B Murray (KNEAZLE) - Admitted a charge of excessive use of the whip prior to the 100 metres and was fined \$400 by the Judicial Committee.

OUR CLARRY (G Jogoo) - Lay inwards over the concluding stages.

Race 3 AVON CITY FORD MAIDEN (1600m)

ANDALE ANDALE (L Callaway) - Declared a late scratching at 10.35am after sustaining an injury when being transported to the race course.

FIGEAMEOUT (T Moseley) - Reared as the start was effected losing its chance. Payment of dividends was delayed while connections viewed Stewards films before electing not to proceed with a request for a ruling with regard to being denied a fair start. FIGEAMEOUT is now required to barrier trial satisfactorily prior to racing next.

AQUATTACK (K Chowdhoory) - Slow to begin.

RAMBO'S WAY (C Johnson) - Slow to begin, commenced to weaken from the 800 metres and was not persevered with. When questioned rider was unable to offer any excuse, with a post race veterinary inspection being clear. Trainer B Smith was advised that a warning would be placed against the gelding and it would be expected to be more competitive in future racing. Mr Smith advised that he would be having further veterinary tests conducted in ensuing days.

KIWI PRINCESS (T Comignaghi) - Over raced in the middle stages.

R Cuneen (KEEP QUIET) - Spoken to regarding his whip use prior to the 100 metres.

Race 4 COCA-COLA RATING 81 (2000m)

RIVIERA ROCK (B Murray) - The saddle shifted forwards near the 1000 metres disadvantaging its rider for the remainder of the race.

JINGO (S Toolooa) - Raced wide without cover throughout.

JILDI JILDI (A Balloo) - Hung inwards in the run home.

MAMBA (T Moseley) - Lay in under pressure having to be straightened near the 250 metres.

METASEQUOIA (C Johnson) - Rider reported that the mare failed to handle the heavy nature of the track in a fresh condition today.

A Balloo (JILDI JILDI) was spoken to regarding his whip use.

K Asano (HILLERSDEN) was spoken to regarding his whip use.

Race 5 HORORATA SPONSORS MAIDEN (1400m)

NONS THE NAME (T Comignaghi) - Began awkwardly.

ROAD TO DIAMONDS (K Mudhoo) - Crowded shortly after the start with the left side winker becoming dislodged.

DONNATINA (T Moseley) - Slow to begin, lay inwards when placed under pressure in the home straight.

TANTALEE (Z Bholah) - Raced wide throughout, hung inwards when racing ungenerously near the 1100 metres crowding RED MAGICIAN onto GLACIER POINT and IDEAL WARRIOR.

RED MAGICIAN (J Laking) - Crowded near the 1100 metres.

IDEAL WARRIOR (R Beeharry) - Crowded near the 1100 metres.

GLACIER POINT (S Macnab) - Crowded near the 1100 metres.

SHIRANUI (C Johnson) - Had to be restrained off heels when over racing near the 1000 metres.

YOUNEVERKNOW (K Williams) - Rider reported that the filly lost the right hind plate during the running.

S Wynne (THE SAINTLY ONE) - Issued with a warning for her whip use.

Race 6 CUP WEEK HOSPITALITY ON SALE NOW RATING 92 (1000m)

NELLIE BLY (K Chowdhoory) - Slow to begin.

SELFIE (C Johnson) - Slow to begin.

MONTREUX MISS (S Wynne) - Crowded at the start losing ground.

NELLIE BLY (K Chowdhoory) - Crowded at the start.

OPERATOR (B Murray) - Lay outwards near the 900 metres inconveniencing BOYSLIGHTUP.

BOYSLIGHTUP (T Comignaghi) - Inconvenienced near the 900 metres.

BB Hong (ADMIRAL ROUS) - Issued with a warning after directing his mount outwards near the 600 metres forcing HOLY LOCH wider on the track.

HOLY LOCH (S Macnab) - Hampered when forced over extra ground near the 600 metres.

ADMIRAL ROUS (BB Hong) - Lay in under pressure in the straight having to be corrected on a number of occasions.

T Jonker (SABER) - Admitted a charge of excessive use of the whip prior to the 100 metres, with the Judicial Committee suspending her licence to ride at race meetings for 5 national days effective from the conclusion of racing today Saturday 11 July up to and including racing on Wednesday 22 July.

BB Hong (ADMIRAL ROUS) - Issued with a warning for his whip use prior to the 100 metres.

Race 7 SPEIGHT'S RATING 65 (1200m)

DEVIL'S STAIRCASE (W Papier) - Hampered leaving the barriers when LEIGHTON WARRIOR jumped outwards.

K Chowdhoory (GOLDEN HARVEST) - Issued with a warning for his whip use prior to the 100 metres.

Race 8 NORWOOD FARM MACHINERY RATING 95 (1200m)

CELINE (T Comignaghi) - Very slow to begin losing considerable ground in the initial stages. A barrier manners warning was placed against the mare.

FINAL SAVINGS (K Mudhoo) - Slow to begin.

CARSON RIVER (K Chowdhoory) - Crowded shortly after the start having to be steadied, held up approaching the 400 metres.

TURNCOAT (W Papier) - Hung inwards in the early to middle stages.

WHALE SONG (L Allpress) - Eased down by its rider over the concluding stages who reported she felt something to be amiss. A post race veterinary inspection did not reveal any obvious abnormality.

Race 9 DAVID LYTTLE FAREWELL RATING 62 (1400m)

TOP GHIA (C Barnes) - Slow to begin.

QWERTY (K Mudhoo) - Slow to begin.

B Murray (EFFERVESCENT) - Admitted a charge of careless riding in that he permitted his mount to shift outwards passing the 450 metres forcing TOP GHIA outwards onto RELIABLE GLOW which had to be checked, with the Judicial Committee suspending B Murray's licence to ride at race meetings for 4 national days effective from the conclusion of racing on Friday 17 July up to and including Friday 24 July.

TOP GHIA (C Barnes) - Hampered and forced wider passing the 450 metres.

RELIABLE GLOW (K Chowdhoory) - Checked passing the 450 metres, again having to be steadied away from the heels of TOP GHIA approaching the 350 metres.

SANCTIFY (K Asano) - Over raced near the 1100 metres for a distance then being caught four wide without cover. When questioned, the rider confirmed that over racing and being caught wide had been factors in the performance and was also of the opinion the filly would be better suited to improved and/or looser footing.

RICKY BAKER (S Macnab) - Held up for a distance passing the 300 metres.

S Macnab (RICKY BAKER) - Spoken to regarding her use of the whip in consecutive strides.

Race 10 CHRISTCHURCH CASINO RATING 77 (1400m)n

JIN LU (B Murray) - Slow to begin.

UPPERHAND (K Asano) - Raced ungenerously in the early stages when being restrained. When questioned regarding performance, rider advised that the gelding raced fiercely early and failed to handle the track conditions.

O'GUY (D Prastiyou) - Raced wide throughout.

B Murray (JIN LU) - Admitted a charge of excessive use of the whip prior to the 100 metres, with the Judicial Committee suspending his licence to ride at race meetings for 6 national days effective from the conclusion of racing on Friday 24 July up to and including Friday 7 August.

L Allpress (TRYFAN) - When questioned regarding performance, rider advised that the gelding failed to handle todays track conditions.

Race 11 RACECOURSE HOTEL & MOTOR LODGE RATING 74 (1600m)

CHOOKIE'S GIRL (C Campbell) - Refused to leave the barriers on terms with the remainder of the field taking no effective part in the race. Co-trainer S Anderton was advised that the mare is required to barrier trial to the satisfaction of Stewards prior to racing next.

DANTE FIRE (R Beeharry) - Slow to begin.

TUILANA (S Wynne) - Raced wide throughout.

COUP DREAMWOOD (K Chowdhoory) - Blundered near the 1100 metres. When questioned regarding performance rider advised that the gelding had travelled comfortably enough but had been unable to quicken in today's track conditions once placed under pressure.

B Murray (WHISKEY IN THE JAR) - Admitted a charge of excessive use of the whip prior to the 100 metres, with the Judicial Committee further suspending his licence to ride at race meetings for 7 national days effective from the conclusion of racing on Friday 7 August up to and including Sunday 23 August. B Murray was directed to meet with the NZTR rider skills review panel to assist in rectifying issues with his riding in relation to his use of the whip.
