Race 1 BRIAN PETA MEMORIAL/FOXPINE LOGGING/MAKOWHAI CONTRACTING 2YO (1000 Metres)				
SHARE POWER (D Hirini) - Began awkwardly and then was tightened for several strides when runners either side				
shifted ground. Had to be heavily restrained when improving on to heels rounding the turn.				
PRINCE OF DOON (J Parkes) - Shifted out near the 600 metres forcing VALHALLA RISING wider.				
VALHALLA RISING (R Myers) - Raced greenly throughout.				
K ASANO (PLATINUM STAR) - Dropped his whip shortly after entering the home straight.				
Race 2 TRC TOYOTA/HARRIS CONTRACTING 1100 (1100 Metres)				
CASAQUINMAN (D Turner) - Got back at the start.				
<b>ARMAGUARD</b> (T Taiaroa) - When questioned regarding the performance T Taiaroa advised the gelding never travelled comfortably throughout. A subsequent veterinary inspection displayed a delayed recovery.				
Race 3         PTS LOGISTIC LTD/WENHAM GRAIN & SEED 1200 (1200 Metres)				
CHILLAX 'N'CHASE (T Allan) – Slow away.				
<b>RONI</b> (R Myers) - Lay inwards shortly after the start and bumped with LINCOLN'S KRUZ. Dictated wide near the 800 metres and continued to race wide throughout.				
LINCOLN'S KRUZ (T Taiaroa) - Bumped and settled back.				
<b>EMPIRE OF PATCH</b> (L Hemi) -Had to be steadied shortly after the start when THATZ DAVID shifted in when not fully clear. R Bishop was shown footage and advised to take more care.				
<b>ZYTHEPSARY</b> (D Hirini) - Raced keenly into the first bend and when being steadied went back onto ALMERAKI.				
ALMERAKI (S MacNab) - Had to steady near the 800 metres. Had to be angled inwards to improve near the 50 metres after being momentarily held up.				
Race 4AB EQUIPMENT/WHISKER FORESTRY 1200 (1200 Metres)FLYINGFLYNN (T Allan) - Attempted to buck for several stride after the start before settling into stride. Connections were advised that the gelding must trial to steward's satisfaction prior to next starting.				
MASTER LINCOLN (L Allpress) - Tightened at the start and got back.				
MEILA REI (R Myers) - Slow away.				
CHEEKY AZZ (M Hudson) – Was checked going into the first turn when TOTAL SASS shifted inwards when not clear.				
<b>HYDROEXPRESS</b> (S MacNab) – Shifted out under pressure in the home straight resulting in MY FATHER'S GUN having to change ground inside to improve.				
MY FATHER'S GUN (R Bishop) Changed ground near the 150 metres.				
T TAIAROA (TOTAL SASS) - Admitted a breach of [Rule 638(1)(d)] in that she allowed her mount to shift ground inward				

near the 800 metres when not sufficiently clear of CHEEKY AZZ which was checked. After viewing films and hearing

submissions the JCA suspended Miss Taiaroa's licence from the close of racing 24<sup>th</sup> July up to and including 29<sup>th</sup> July. (2 days.)

# Race 5 SOUTH RANGITIKEI VETS SERVICE/THE RAT HOLE/TIM HARRIS TYRES & AUTO 1400 (1400 Metres) WITH JOY (J Parkes) - Slow away.

The following runners were tightened shortly after the start when MISS YELRACM lay out.

HIT THE DIFF (R Bishop) - Tightened at the start.

JUGADOR (D Hirini) - Tightened at the start. Raced keenly in the early stages.

PIRI PIRI PETE (D Bradley) - Tightened at the start.

**J BAILLIE** (SMOKEY AFFAIR) – Admitted a breach of Rule [638(3)(b)(ii)] regarding whip use prior to the 100 metres. After viewing films and hearing submissions the JCA imposed a fine of \$350.

MISS YELRACM (L Allpress) – Rider L Allpress reported that her mount was not suited to the Heavy 11.

#### Race 6 WATERFORCE 1400 (1400 Metres)

**FLORAL ART** (R Myers) - Late scratched by the veterinary surgeon after hitting the barrier prior to the start which resulted in bleeding to the nose.

**DURHAM** (D Bradley) - Hung outwards at the crossing in the back straight dictating DOLCETTO outwards onto FACE TIME.

FACETIME (S MacNab) - Hampered near the 1300 metres. Then commenced to over-race for a short distance.

HAPPY STAR (L Allpress) and ROCK ISLAND LINE (K Asano) - Came together near the 100 metres when both runners shifted ground.

Race 7SAM TURKINGTON 1550 (1550 Metres)DOUBLE ACT (J Baillie) - Slow away. When guestioned, rider advised the gelding was unsuited to the Heavy 11.

NIKAU SPUR (M Hudson) - Slow away.

**SPARKLING LADY** (R Myers) - Over-raced in the early and middle stages.

**DENALI** (L Allpress) – When questioned regarding the performance rider L Allpress reported the gelding failed to run on but would take natural improvement from the run. A subsequent veterinary inspection failed to reveal any abnormality.

#### Race 8 JOHN TURKINGTON FORESTRY LTD RANGITIKEI GOLD CUP (2100 Metres)

M KAREEM (MY GIFT) - Lost his whip approaching the 100 metres.

**SOUTHERN COOL** (M Sanson) – Slow away.

**SPEED CALL** (L Hemi) – Slow away. When questioned regarding the performance L Hemi advised her instructions were to ride the gelding back and improve over the latter stages. L Hemi advised the gelding was never comfortable in the going she described as holding and did not finish off the race as expected.

SLYVESTER (D Hirini) - Attempted to jump a plastic bag which had blown onto the track near the 800 metres.

**D** MONTES DE OCA (RICHARD OF YORKE) - Was issued with a warning for the manner in which he used his whip in the home straight.

**KARAKIA** (R Bishop) - Finished some distance last and when questioned regarding the performance, rider R Bishop could offer no excuse. A subsequent veterinary inspection failed to reveal any abnormality.

## Race 9 FLIPP TRANSPORT/TRANSAG CENTRE LTD 1550 (1550 Metres)

**TIRO** (M Sanson) - Slow away.

EM KAY POPS (B Ansell) - Began awkwardly and got back.

BELLISSIMO (T Taiaroa) – Over-raced for some distance early and had to be steadied in the back straight.

**THAT'S FUNNY** (D Bradley) - When questioned regarding performance rider D Bradley was of the opinion the mare may have held it's breath during the running.

**LINCOLN DREAMER** (K Asano) – When questioned regarding performance rider K Asano reported the gelding was not comfortable in the Heavy 11.

**JOHNNIE REDMOND** (D Montes De Oca) - When questioned regarding performance rider D Montes de Oca reported the gelding was not comfortable in the Heavy 11.

**B** Ansell (EM KAY POPS) - Was issued with a warning for the use of her whip on a horse out of contention.
