**RACE COMMENTS:**

<b>Race 1</b>	<b>Savvy Racing Syndications 1100</b>
<p><b>KOOL POWER</b> (D Johnson) – Began awkwardly losing ground.</p> <p><b>NOW IS NOW</b> (C Jones) – Began awkwardly.</p> <p><b>LIGHTNING WARRIOR</b> (S Collett) – Restrained from a wide barrier.</p> <p><b>HAERE UP</b> (C Dell) – Restrained from a wide barrier.</p> <p><b>RISING RISK</b> (S Spratt) – Steadied when racing in restricted room passing the 1000 metres to the inside of SUSSEX which had shifted in and away from HAPPY EGO with RISING RISK then being further restrained off the heels of SNAKEYE which shifted out slightly. As a result LUSTFUL LADY which was following was hampered.</p> <p><b>LUSTFUL LADY</b> (L Satherley) – Hampered 1000 metres.</p> <p><b>S McKay</b> (HAPPY EGO) – Issued with a warning for permitting HAPPY EGO to shift in passing the 1000 metres when insufficiently clear of SUSSEX which shifted away from that runner crowding RISING RISK which was steadied. Contributing was outward movement from SNAKEYE.</p> <p><b>LADY DE WINTER</b> (T Thornton) – Raced wide without cover.</p> <p><b>HAPPY EGO</b> (S McKay) – Inconvenienced for a distance from near the 300 metres until being crowded and checked near the 100 metres.</p> <p><b>J Fawcett</b> (SUSSEX) – Admitted a breach of careless riding in that she allowed SUSSEX to shift out near the 100 metres when insufficiently clear of HAPPY EGO which was crowded and checked. After hearing submissions the Judicial Committee suspended her licence to ride in races from the conclusion of racing on Saturday 1 August up to and including racing on 8 August, 3 national riding days.</p> <p><b>SNAKEYE</b> (R Elliot) – Shifted ground inwards passing the 150 metres to obtain clear running.</p>	
<b>Race 2</b>	<b>Madsen Lawrie Surveyors Ltd 2100</b>
<p><b>TWIN SPINNER</b> (C Jones) – Slow away. Commenced to over-race in the early stages placing Apprentice Rider C Jones in difficulty for a distance before shifting out passing the 1300 metres and improving forward to lead.</p> <p><b>RAAJ</b> (S Collett) – Crowded and checked near the 1800 metres to the inside of TWIN SPINNER which shifted in when over-racing and improving inside KEEPELLA HEIGHTS which shifted in.</p> <p><b>VAN BLANC</b> (D Johnson) – Began awkwardly then restrained from its wide barrier.</p> <p><b>BLANCO BAY</b> (J Fawcett) – Raced keenly in the early to middle stages.</p> <p><b>EL CORBY</b> (R Elliot) – Raced wide without cover throughout.</p>	
<b>Race 3</b>	<b>Mount Shop 2100</b>
<p><b>TIPICAL</b> (M Hashizume) – A little slow to begin. Improved into a marginal run approaching the 400 metres and then was hampered when making contact with the hind quarters of AL HARAM. M Hashizume was reprimanded and advised to exercise greater care in a similar circumstance. TIPICAL was then held up until shifting out to obtain clear running approaching the 200 metres.</p>	

**LAEKEEPER** (M Kareem) – Began awkwardly.

**MAESTRO BLU** (L Satherley) – Began awkwardly.

**HUNTER VILLAIN** (S Collett) – Raced wide without cover for the majority of the race. Crowded and steadied near the 175 metres to the inside of **MAGNANIMOUS MAN** which was dictated inwards by **AL HARAM** (J Kamaruddin) which shifted in under pressure.

**J Kamaruddin** – Issued with a warning after allowing **AL HARAM** to shift in near the 175 metres when insufficiently clear of **MAGNANIMOUS MAN** which was dictated into the line of **HUNTER VILLAIN** which was steadied.

**AL HARAM** (J Kamaruddin) – Contacted 400 metres becoming unbalanced. Shifted in under pressure in the final straight making contact near the 100 metres and again over the concluding stages.

**WINDY HEIGHT** (C Grylls) – Briefly contacted passing the 100 metres and dictated inwards over the final 100 metres before being contacted over the concluding stages.

**J Kamaruddin** – Admitted a charge of careless riding in that he permitted **AL HARAM** to shift in over the final 100 metres making contact with **WINDY HEIGHT** which was impeded for a distance. After hearing submissions the Judicial Committee suspended his license to ride in races from the conclusion of racing on 25 July up to and including racing on 1 August, 3 national riding days.

**J Kamaruddin** (**AL HARAM**) – Issued with a warning for raising his arm above shoulder height when using the whip.

Following the race the connections of the 2<sup>nd</sup> place horse **WINDY HEIGHT** lodged a protest against the 1<sup>st</sup> placed horse **AL HARAM**. After considering submissions the Judicial Committee dismissed the protest.

<b>Race 4</b>	<b>Mitchell Family 1200</b>

**PUSHKA** (J Fawcett) – Slow away.

**LORD VALENTINE** (T Thornton) – Slow away. Raced in restricted room near the 200 metres then shifted inwards to obtain clear running.

**BULLYBROOK** (C Grylls) – Steadied approaching the 1100 metres when in restricted room and raced keenly for a distance.

**MACUSHLA** (C Jones) – Raced wide without cover for the majority of the race.

**T Yanagida** (**NUTTEE**) – Admitted a charge in that he used his whip on a runner which was out of contention with his arm above shoulder height. After considering submissions the Judicial Committee imposed a fine of \$450.

<b>Race 5</b>	<b>Counties Agri 1200</b>

**LUPELANI** (M Hashizume) – Crowded when leaving the barriers. Lost a near front plate during the running.

**DELUXE EDITION** (M Kareem) – Slow to begin.

**BRANSOME** (N Alam) – Raced in restricted room soon after leaving the barriers.

**DEMONETIZATION** (L Innes) – Restrained from a wide barrier.

**MEDALZA** (S Collett) – Restrained from a wide barrier.

**MONACO** (T Newman) – Became awkwardly placed on heels for a distance passing the 900 metres.

**T Newman** (MONACO) – Admitted a charge in that she used her whip excessively prior to the 100 metres with the Judicial Committee imposing a fine of \$300.

**GORGEOUS GEISHA** (C Jones) – Underwent a post-race veterinary examination which could find no obvious abnormalities.

**Race 6** | **Haunui Farm 1400**

**MAJOR TOM** (M Kareem) – Restrained from its wide barrier.

**MY SUPERIOR GIRL** (A Calder) – Restrained from its wide barrier.

**DIOGENES** (C Jones) – Raced keenly when leading.

**BLUE BREEZE** (C Dell) – Raced wide without cover.

**A Calder** (MY SUPERIOR GIRL) – Issued with a warning for whip use.

**Race 7** | **NZB Insurance Pearl Series Race 1400**

**SWISS REGAL** (L Satherley) – Began awkwardly.

**RAPID FALLS** (R Oliver) – Crowded shortly after the start.

**NOMOREFIBS** (S McKay) – Crowded shortly after the start losing ground.

**LETZ'AV BUBBLES** (D Johnson) – Commenced to over-race when being restrained in the early and middle stages.

**ACE OF SPADES** (T Newman) – Steadied when in restricted room passing the 450 metres.

**CAMPING** (R Elliot) – Had to change ground inwards passing the 200 metres to obtain clear running.

**RAIL QUEEN** (A Calder) – Inconvenienced 150 metres by **RAPID FALLS** (R Oliver) which shifted out under pressure. R Oliver was advised to exercise greater care.

**R Oliver** (RAPID FALLS) – Issued with a warning for his whip use.

**N Alam** (RED RUSHIN) – Issued with a warning for his whip use.

**Race 8** | **Rogers Racing 1600**

**D Sweeney** (OUR BEESKEES) – Issued with a warning after presenting OUR BEESKEES to race in gear which had not been notified (blinkers).

**TUNZAGUTZ** (T Newman) – Began awkwardly losing ground.

**CAPTAIN ORANGE** (C Jones) – Raced keenly through the middle stages.

**Race 9** | **Event Essentials 1600**

**CAPE GEM** (C Grylls) – Underwent a veterinary examination after becoming fractious in the barriers and was cleared fit to race. Shifted in approaching the 200 metres to obtain clear running making contact.

**SIR ZACK** (C Jones) – Slow to begin.

**MOKELE MBEMBE** (C Lammas) – Slow to begin.

**BANKS ROAD** (L Satherley) – Slow to begin.

**CASSIO** (N Alam) – Raced keenly in the early and middle stages. Inconvenienced when contacted approaching the 200 metres by CAPE GEM which shifted in to obtain clear running. C Grylls was reprimanded and advised that he must exercise greater care in a similar circumstance.
