Race 2 LODGE RENTALS 1200

APPELLANT (D Johnson) - Trainer S Marsh advised Stewards, he was satisfied with the post-race condition of the mare, however, APPELLANT will now go back to racing on right hand tracks.

QUIZZY LIZZY (R Elliot) - Trainer S Marsh confirmed that QUIZZY LIZZY has now been retired from racing.

Race 4 WROTE @ HIGHVIEW MILE (1600 metres)

SIGLO (M Cameron) - Co-trainer A Forsman advised that the stable was satisfied with the post-race condition of the gelding, however, has now been sent for a spell.

Race 8 SUPER SETH @ WAIKATO STUD 1400

MARS BARS (S Collett) - Trainer A Sharrock confirmed that MARS BARS has now been retired from racing.

Race 10 SEE YOU @ VALACHI DOWNS FOXBRIDGE PLATE DAY 1400

TABATA (D Johnson) - Trainer S Marsh advised TABATA did not handle the heavy track conditions and it is his intention to carry on with the mare's current preparation.

RACE COMMENTS:

Race 1 RIBCHESTER MDN 1300

FIGHTING FIRE (D Johnson) – Slow away.

SWEET LILLY (D Danis) – Slow away. Raced keenly for a distance passing the 1150 metres.

MANHATTAN GIRL (S Collett) – Slow away. Made the bend awkwardly entering the straight.

BELLE FOLIE (J Fawcett) – Began awkwardly.

AEGON (M Cameron) – Restrained behind runners shortly after the start.

SEMPER FI (A Goindasamy) – Raced wide without cover throughout.

BABY SHARK (S Weatherley) – Held up entering the final straight.

FREE THYME (J Bassett) – Had to shift in passing the 200 metres to obtain clear running.

FLYING OARSMAN (S Spratt) – Improved on to heels approaching the 100 metres having to be steadied.

FULL OF PROMISE (C Lammas) – Steadied to avoid the heels of FREE THYME passing the 150 metres.

J Bassett (FREE THYME) – Issued with a warning for allowing her mount to shift in when not fully clear of FULL OF PROMISE which had to be steadied passing the 150 metres. Contributing was slight inward movement from TUMBRIL.

MACROS (T Newman) – Improved on to heels approaching the 100 metres being held up for the remainder.

Race 2 MATAMATA VETERINARY SERVICES

RHAEGAR (J Riddell) – Slow away.

PENTEVEREST (S Collett) – Restrained from its wide barrier.

FELIX FAURE (C Lammas) – Raced keenly in the early and middle stages.

MATTER OF FACT (M Cameron) – Raced ungenerously in the early and middle stages.

CRUZ RAMIREZ (S Weatherley) – Held up entering the final straight before improving into an incomplete run to the inside of VALETTI. VALETTI then shifted in slightly passing the 50 metres making contact with CRUZ RAMIREZ which was forced inwards making contact with the running rail becoming unbalanced and dislodging its rider. S Weatherley was attended to by on course ambulance personnel and cleared to fulfil his remaining rides. When questioned S Weatherly agreed with Stewards in that he had improved into a run that had not fully developed with S Weatherly being advised that he would be expected to show better judgement in future.

AKOYA PEARL (S Spratt) – Hampered by fallen rider just prior to the winning post.

RAZ (R Myers) – Hampered just prior to the winning post.

D Johnson (MARKUS AURELIUS) – Issued with a warning for her whip use prior to the 100 metres.

Race 3 ASCOT FARM MDN 1100

MIND YOU (L Satherley) – Began awkwardly.

COUNTESS CONTI (S Collett) – Crowded shortly after the start losing ground.

DUBY (C Grylls) – Raced keenly for a distance in the middle stages making the bend near the 800 metres awkwardly. Hampered approaching the 700 metres.

LETHAL (J Riddell) – Improved on to heels approaching the 700 metres when over-racing and shifted out hampering DUBY.

LET ME TELL YA (M Cameron) – Raced wide without cover throughout.

SIZZLER (S Weatherley) – Had to be steadied passing the 1000 metres when placed in restricted room to the inside of DUBY which shifted in when racing ungenerously. Held up entering the final straight and again passing the 100 metres when runners on either side shifted ground slightly, then being held up for the remainder of the race.

D Johnson (FASHION SHOOT) – Spoken to regarding her whip use prior to the 100 metres.

 Race 4
 THE OAKS STUD MDN 1100

 LOGAN'S LOGIC (L Innes) – Began awkwardly. Raced greenly when placed in restricted room over the concluding stages.

SUFFUSED (M Cameron) – Raced ungenerously in the early stages and shifted out, then being obliged to race three wide without cover for the remainder of the race.

NO LIMITS (D Johnson) – Raced ungenerously in the middle stages.

AUTOBAHN (C Lammas) – Held up entering the final straight before shifting outwards approaching the 200 metres making contact with CHANDLER which was forced wider slightly.

CHANDLER (S Spratt) – Contacted approaching the 200 metres being forced outwards.

BETTE DAVIS EYES (T Thornton) – Inconvenienced passing the 100 metres when JAMIESON'S TIPPLE shifted out.

Race 5 PER INCANTO PROVEN MDN 1300

OVERSTAYER (S Collett) – Slow away. Steadied when placed in restricted room approaching the 1000 metres to the inside of ROSEY POSEY which was forced inwards by STONEHENGE (J Riddell). J Riddell was advised to exercise care. Held up rounding the final bend.

LAKEMAN (E McCall) – Crowded shortly after the start losing ground.

FIRST SEA LORD (S Spratt) – Began awkwardly making contact with ROSEY POSEY.

ROSEY POSEY (C Grylls) – Crowded at the start.

STONEHENGE (J Riddell) – Crowded at the start.

GREEDY (D Johnson) – Raced three wide without cover throughout.

SWEET ANNA (M Cameron) – Held up entering the final straight.

FABULOUS FLEET (S McKay) – Following the race rider reported that the mare had felt indifferent in its action during the running. Underwent a post-race veterinary examination which did not reveal any abnormality.

J Riddell (STONEHENGE) – Spoken to regarding whip use prior to the 100 metres.

S Weatherley (TANGODANZER) – Spoken to regarding whip use prior to the 100 metres.

Race 6 THE CAMBRIDGE STUD R65 1300

RUBY NEGRONI (S McKay) – Slow away.

SACROSANCT (S Collett) – Began awkwardly then hampered shortly after.

PLUTON (C Lammas) – Over-raced approaching the 800 metres having to be restrained then shifted out off the heels of HEZA LOOKER (A Goindasamy) which shifted in when marginally clear dictating DESERT MIRAGE wider on the track. A Goindasamy was advised to exercise care and advised that he must be fully clear prior to shifting ground.

DESERT MIRAGE (S Spratt) – Forced wider passing the 800 metres.

HEZA LOOKER (A Goindasamy) – When questioned regarding performance the rider advised that the gelding had been disappointing. Underwent a post-race veterinary examination which did not reveal any abnormality.

S McKay (RUBY NEGRONI) – Spoken to regarding his whip use prior to the 100 metres.

COME BACK TIGER (T Newman) – Rider advised Stewards that the gelding had lay out throughout the running. When questioned trainer P Huxtable advised Stewards that he would be experimenting with gear changes prior to the gelding racing next.

Race 7

TAUPO PAK'NSAVE FILLIES 1100

MOONLIGHT SHADOW (T Thornton) – Began awkwardly.

ATISHU (S Spratt) – Began awkwardly. Held up for a distance passing the 200 metres.

NAJAH (A Goindasamy) – Began awkwardly then hampered losing ground. Improved on to heels passing the 900 metres having to be firmly restrained. Held up passing the 400 metres having to shift in approaching the 250 metres to obtain clear running.

KALUANUI (S Collett) – Commenced to race ungenerously passing the 950 metres, then steadied when placed in restricted room passing the 850 metres losing ground.

MEGLIO DI FALCREST (R Myers) – Inconvenienced passing the 850 metres.

C Lammas (TAUPO MISSY) – Issued with a warning for allowing his mount to shift in when not clear of MEGLIO DI FALCREST which shifted in and away crowding ATISHU on to KALUANUI which were both racing keenly passing the 850 metres. Also inconvenienced as a result was MOANA.

MOANA (R Oliver) – Contacted and unbalanced passing the 850 metres.

NO ROCK NO POP (S McKay) – Lay out throughout the running. Trainer L Somervell was advised that a warning would be placed on the filly's racing manners.

C Grylls (TELEKINETIC) – Spoken to regarding consecutive strikes with his whip prior to the 100 metres.

T Thornton (MOONLIGHT SHADOW) – Issued with a warning for her whip use on a runner out of contention.

S Weatherley (ALCHEMIA) – Issued with a warning for his whip use prior to the 100 metres.

Race 8 WAIKATO STUD MDN 1100

OCEAN BELLE (S Weatherley) – Underwent a pre-race veterinary examination on arrival at the barriers and was cleared fit to race. Began awkwardly.

KURT (C Grylls) – Began awkwardly.

SUPER SID (J Riddell) – Slow away. When questioned regarding performance the rider advised that in his opinion the gelding would now benefit from a step-up in distance.

SHOW THE LOVE (E McCall) – Knuckled shortly after the start.

ROC MUSIC (S Collett) – Raced ungenerously in the early stages.

MINNALLINES (C Lammas) – Raced wide without cover throughout.

Race 9 TE AKAU 2019/20 NO. 1 STABLE R56 1100

CIN CIN (D Danis) – Slow away. When questioned regarding performance the rider advised that in his opinion the mare would be better suited to some easing of the ground.

PALM SPRINGS (R Myers) – Crowded shortly after the start losing ground.

SHE'S A GODDESS (M Cameron) – Raced ungenerously when making the bend near the 800 metres.

FONTS DE L'ALGAR (A Goindasamy) – Held up until shifting inwards passing the 200 metres.

MASQUE (C Lammas) – Had difficulty obtaining clear running entering the final straight.

COLLYS' FOLLY (S Spratt) - When questioned regarding performance the rider could offer no excuse.

Race 10 KIWIKONTRACTORS TAUPO MDN 1800

RIPPEDEEDOODAH (D Johnson) – Began awkwardly.

CYNDY WINK (T Thornton) – Slow away. Eased down in the final straight when well beaten. The connections were advised that a warning would be placed on the mare's racing performance.

STIRLING FALLS (R Oliver) – Began awkwardly then restrained behind runners.

BRAWLER (A Goindasamy) – Slow away.

ZINZAN (J Riddell) – Hampered shortly after the start losing ground. Raced in restricted room inside the final 30 metres.

CAPE GEM (C Grylls) – Raced in restricted room over the concluding stages.

SOUTHERN VOGUE (S Spratt) – Returned to the enclosure with blood present in the left nostril. Underwent a postrace veterinary examination which found the mare to have bled. The connections were advised that it would now be subject to the mandatory 3 month stand down from racing, 2 month stand down from training with a veterinary clearance being required prior to racing or trialing next.

T Newman (CRIMSON STAR) – Issued with a warning for her whip use prior to the 100 metres.
