#### RACE COMMENTS:

Race 1 NZ INSURANCE PEARL SERIES RACE MAIDEN (1200 Metres)

**KOKOMO** (C Grylls) – Slow away.

**OUTAGE** (A Goindasamy) – Checked when racing greenly near the end of the back straight and went back on to TENNESSEE ROSE, which was steadied and in turn went back onto RODENT, which was checked. After questioning riders and viewing video footage which proved inconclusive no further action was taken.

Shifted in under pressure in the home straight tightening RONI. A Goindasamy was shown footage of his ride and advised that he is to straighten his mount sooner than he did on this occasion.

TENNESSEE ROSE (S Macnab) – Steadied back straight.

**RODENT** (L Hemi) – Checked back straight.

**FAGIOLO MAGICO** (D Hirini) - Held up rounding the turn and early in the home straight and went to the line without being fully tested.

OUTA CASH (S O'Malley) – Held up briefly early in the home straight.

RONI (D Bradley) - Raced in restricted room in the home straight

Race 2 BOYS GET PAID (1200 Metres)

**FLASH WARRIOR** (A Goindasamy) - Jumped outwards at the start simultaneously as SWING THE TIDE shifted in, which resulted in MAHOE, SIR BEETS and RIP US OFF being tightened.

**MAHOE** (T Taiaroa) - Tightened start.

SIR BEETS (C Grylls) – Tightened start.

Race 3

**RIP US OFF** (H Schofer) – Tightened start.

**SORRIDA** (R Myers) - Began awkwardly, shifted out and tightened FLYING ZACK which was slow away. Inclined to lug out under pressure in the home straight.

FLYING ZACK (L Hemi) – Tightened and slow away.

GENTLEMAN JACK (R Bishop) - Over-raced in the back straight and had to be steadied for some distance.

SWING THE TIDE (D Hirini) - Had to steady off heels when racing keenly in the back straight.

**MOGADOR** (J Parkes) - Raced three wide throughout.

# CHRIS HAY/ULTRASCAN MAIDEN (1400 Metres)

**IRISH PRAYER** (D Hirini) – Slow away. Had to be steadied rounding the home turn when improving rapidly on to heels passing the 600 metres.

**SPIJKER** (R Myers) – Raced keenly in the back straight.

**RETZENA** (J Parkes) - When questioned into the disappointing run of RETZENA, J Parkes advised the gelding pulled up in a reasonable condition and was disappointing. Trainer F Auret advised the gelding's future would be reassessed.

# Race 4 WAVERLEY MOTORS MAIDEN (1400 Metres)

MARTINA ROSE (M Hudson) – Began awkwardly and got back.

**ZYTHEPSARY** (F Lazet) - Lugged outwards rounding the first turn.

**ELDER HALL** (A Goindasamy) - Over-raced into the first turn and had to be steadied.

**JUGADOR** (D Hirini) - Held up for a short distance prior to entering the home straight.

**GISZELLES DELIGHT** (J Parkes) – Steadied off heels near the 1000 metres when IF YOU DANCE (S O'Malley) had to steady off heels when racing keenly. S O'Malley was shown footage of his ride and advised to exercise greater care. When questioned into the run of GISZELLES DELIGHT, J Parkes said that despite having an interrupted run in the back straight, the mare was disappointing and had no excuse.

AMAZING TEAM (A Mudhoo) - Steadied for a distance near the 1000 metres when racing keenly.

**DAY LIGHT** (S Macnab) - Steadied off heels in the back straight when the pace ahead eased.

**ELDER HALL** (A Goindasamy) - When questioned into the run of ELDER Hall, A Goindasamy advised the gelding changed legs on the point of the turn, was disappointing but would take natural improvement with the run.

**S Macnab** (DAY LIGHT) - Spoken to regarding the use of her whip in the home straight.

# Race 5 BRUCE CLIFTON MAIDEN (1650 Metres)

**MAUNA LOA** (D Hirini) – Underwent and passed a pre-race veterinary examination after being kicked behind the barrier. Raced greenly in the home straight, having to be straightened.

GOVERNOR GREY (L Hemi) – Slow away.

**BRINGITONPET** (J Fawcett) – Slow away.

**THE BOUNDER** (A Goindasamy) –Held up around home turn. Angled inwards to obtain clear running near the 100 metres then raced in restricted room over the final stages.

#### Race 6 FOREST360 MAIDEN (1650 Metres)

IN DREAMLAND (B Ansell) – Slow away.

**MANHATTEN AFFAIR** (D Hirini) – Raced greenly throughout. Steadied for some distance in the back straight. Was inclined to shift out and away from SMOKEY AFFAIR in the home straight and over the final stages was tightened when SMOKEY AFFAIR shifted out under pressure.

Prior to the authorisation of dividends an objection was lodged by the connections of the second placed **MANHATTEN AFFAIR** (D Hirini) alleging interference over the final stages by the winner **SMOKEY AFFAIR** (S O'Malley). After deliberations the JCA dismissed the protest.

# Race 7 SANDFORDS MAIDEN (1650 Metres)

UAREASTAR (J Parkes) – Slow away.

**BEAR GRYLS** (A Goindasamy) - Had to be steadied for some distance going into the back straight when over-racing, due to the slow early pace.

**YOLO** (S Macnab) - Made the bend into the home straight awkwardly.

**GREYSTONE** (H Schofer) was denied a run to the outside of IRISH TRIX (T Taiaroa), which shifted out slightly near the 350 metres, forcing GREYSTONE onto the hind quarters of BELLA SORELLA, which became momentarily unbalanced. Both apprentices H Schofer and T Taiaroa were shown footage and advised to exercise greater care. Held up rounding the turn and for the majority of the home straight.

BELLA SORELLA (R Myers) - Contacted and unbalanced passing the 350 metres.

Race 8 MOORE MARKHAMS HANDICAP (2200 Metres)

**PRIOR ENGAGEMENT** (A Goindasamy) - Shifted sideways at the start and bumped LONDONDERRY AIR. Lay in and away from OVER THE RIVER approaching the winning post on the first occasion. Had to steady when improving onto the heels of OVER THE RIVER passing the winning post on the first occasion.

LONDONDERRY AIR (D Bradley) – Bumped start.

NITRO TED (H Schofer) - Slow away.

**AWATANE** (L Hemi) - Over-raced into the first bend. Had to steady when improving into a narrow run approaching the home turn.

**J Kamaruddin** (COCONUT) - Issued with a warning for allowing his mount to shift out near the 500 metres when not sufficiently clear of AWATANE which had to be steadied. Also hampered as a result was BAKELA. When assessing the interference, the lack of clear video footage was taken into account.

**BAKELA** (S Macnab) – Briefly tightened winning post first occasion. Hampered passing the 500 metres.

LONDONDERRY AIR (D Bradley) - Steadied into the first bend into the back straight.

**OVER THE RIVER** (S O'Malley) - Over-raced in the home straight on the first occasion and shifted in momentarily passing the winning post briefly tightening BAKELA, which was over-racing. OVER THE RIVER continued to over-race badly rounding the bottom turn.

**J Fawcett** (HAMILTONIAN) – Issued with a warning for the manner in which she used her whip prior to the 100 metres.

Race 9 MITAVITE HANDICAP (2200 Metres)

LOCHARBURN (S O'Malley) - Reared at the start and lost ground.

MASTER COURTSMAN (R Bishop) - Slow away.

FLYINGFLYNN (D Bradley) - Raced wide throughout.

KEEPIN HARMONEE (M Hudson) - Over raced near the winning post on the first round.

**WHOLETTHEFOXOUT** (L Hemi) - Raced three wide without cover throughout.

# Race 10 TREADWELL GORDON HANDICAP (1200 Metres)

**RUFUS RUFFCUT** (L Allpress) - Reared at the start and lost ground.

**GLAMOUR** (S Macnab) – Held up briefly passing the 400 metres so was angled inwards to improve.

**WOODCOTE LASS** (C Grylls) - Shifted out under pressure in the home straight dictating MIKJENE over a little extra ground.

**MIKJENE** (H Schofer) - Dictated over a little extra ground in the home straight.

Race 11	SPORTZ BAR HANDICAP (1650 Metres)

MY ZED (J Fawcett) - Slow away.

ESTEFANIA (J Bassett) - Inclined to over-race in the early and middle stages.

LADY VERAWOOD (R Bishop) - Held up over the final stages.

**BELLA NERO** (D Bradley) - Shifted in under hard riding over the final stages and bumped WAY ABOVE near the post. D Bradley was issued with a warning under Rule 638(1)(d) and advised that he is expected to straighten his mount sooner than he did on this occasion.

# Race 12 JUSTA CHARLIE – GOOD TIMES HANDICAP (1650 Metres)

**MR JIMMY POCKET** (B Ansell) – Slow away.

**POROTENE CHARM** (S Macnab) – Slow away.

**SHEBRINGSMERUBIES** (J Kamaruddin) – Lay in when placed under pressure throughout the final straight.

**TAVIRA** (R Bishop) - Finished last. When questioned R Bishop was of the opinion his mount had held its breath.
