J Riddell was issued with a minor infringement notice and fined \$100 by the Judicial Committee after being unable to make the contracted weight for PISTOLERO, CAN'T FIND ONE and MAKZABEEL.

The gear was incorrectly displayed on the NZTR website for JAKKI SPARROW due to an anomaly in the NZTR computer system.

Race 1	STEVE LUNJEVICH CONTRACTING MAIDEN HURDLE (3100 Metres)
<p>BULLITT (N Downs) – Hit the fourth fence. Pulled up prior to jumping the final three fences.</p> <p>KARAKIA (S Karnicnik) – Jumped indifferently throughout. Pulled up prior to jumping the final three fences.</p> <p>BUDDY PERFECT (B Donoghue) – Misjudged the sixth fence. Pulled up prior to jumping the final fence.</p> <p>ARGYLL (A Kuru) – Hit the seventh fence.</p> <p>RICHARD OF YORKE (M Roustoby) – Misjudged the eighth fence and blundered on landing. Lost the left front plate during the running.</p> <p>CURIOUS GEORGE (L Douglas) – Misjudged the final fence.</p>	
Race 2	VICTOR & FRANK MATIJASEVICH MAIDEN HURDLE (3100 Metres)
<p>There was a delay to the start of this race after the ear covers were mistakenly removed from JAKKI SPARROW prior to loading with them being re-fitted prior to the start of the race.</p> <p>FRANCONI (N Downs) – Slow away. Jumped indifferently throughout. Pulled up prior to jumping the seventh fence.</p> <p>SECRET RUNNER (S Fannin) – Misjudged the second fence. Hampered after jumping the sixth fence by BLANCO BAY which hit that fence and shifted in. Misjudged the eighth fence and knuckled on landing dislodging its rider who was uninjured. Also hampered as a result was PAVLICHENKO.</p> <p>IRISH CALL (J Seivwright) – Misjudged the second fence. Pulled up prior to jumping the seventh fence.</p> <p>BLANCO BAY (R Cole) – Hit the sixth fence.</p> <p>SOUTHERN COOL (S Karnicnik) – Hit the eighth fence losing ground.</p> <p>PAVLICHENKO (L Douglas) – The Stewards permitted L Douglas to claim 2kg of his 3kg claim as there was no other suitable replacement rider available. Hampered after jumping the eighth fence.</p> <p>LOTHBROK (B Donoghue) – Pulled up prior to jumping the final three fences.</p> <p>JAKKI SPARROW (G Walsh) – Put in a poor jump at the second to last fence. Pulled up prior to jumping the final fence.</p>	

AL HARAM (M Roustoby) – Inconvenienced approaching the second to last fence. Contacted near the 150 metres. Hampered just prior to the winning post. Collapsed following the race being immediately attended to by the horse ambulance, the on-course veterinarian and was humanely euthanised after suffering acute cardiac arrest.

BANKS ROAD (E Farr) – Lay out when placed under pressure in the final straight making contact with AL HARAM near the 150 metres, then continued to lay out over the concluding stages.

E Farr (BANKS ROAD) – Issued with a warning for allowing her mount to shift out over the concluding stages hampering AL HARAM.

L Douglas (PAVLICHENKO) – Issued with a Minor Infringement Notice for failing to claim his full 3 kg allowance when riding PAVLICHENKO, and was fined \$100.

N Downs (FRANCONI) – Spoken to regarding his use of the whip prior to the start.

Race 3	SPEEDY RECOVERY ANDREW HURDLE (3100 Metres)

EACH WAY (S Fannin) – Began awkwardly. Hit the final fence.

HENRY TUDOR (C Studd) – Pulled up prior to jumping the final three fences.

CAPTAIN ORANGE (S Karnicnik) – Misjudged the seventh fence. Pulled up prior to jumping the final three fences.

CASHEL (N Downs) – Pulled up prior to jumping the final three fences.

Race 4	FRANK & ANNIE MATIJASEVICH MEMORIAL STEEPLECHASE (3500 Metres)

DESERT STORM (E Farr) – Slow away.

CRACKTHEGOODSTUFF (R Cole) – Pulled up after jumping the third fence. When questioned the rider advised that the gelding had felt indifferent in its action and had not improved over the early stages of the race. Underwent a post-race veterinary examination which found the gelding to be showing signs of colic which it received treatment for.

WILIJONMCBRIDE (J Seivwright) – Pulled up prior to jumping the final two fences.

ZED CASE (C Studd) – Pulled up prior to jumping the fence near the 1200 metres.

THAT'S HOW IT GOES (B Lammas) – Lost its footing when entering the steeplechase course near the 1300 metres.

ZEDMAN (A Kuru) – Lost the right fore plate during the running. When questioned regarding performance the rider advised that the gelding had raced keenly throughout and believed it had contributed to ZEDMAN failing to respond when being placed under pressure.

EL DISPARO (B Donoghue) – Misjudged the second to last fence and knuckled on landing. Raced in restricted room re-entering the course proper near the 100 metres.

DAAD (L Douglas) – Misjudged the second to last fence dislodging its rider who was uninjured.

Race 5	YELAVICH TRANSPORT LTD MAIDEN 2200

HARDOUT (C Burdan) – Slow to begin. Rider dropped her whip passing the 350 metres.

PISTOLERO (L Satherley) – Lay out rounding the first bend and ran off being pulled up by its rider near the 1400 metres. The connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next.

MEANT TO BE (J Fawcett) – Improved on to the heels of the weakening SHACKELTONS EDGE entering the final straight.

RISING ROAD (S Spratt) – Raced greenly when placed under pressure in the final straight shifting outwards passing the 350 metres making contact with MR GHIBSON.

Race 6	WAIHOU TAVERN MAIDEN 1600

MOKELE MBEMBE (C Lammas) – Slow away.

LUCKY ESCAPE (T Thornton) – Began awkwardly. Lay out when placed under pressure in the final straight. When making the bend passing the winning post, lay out contacting the outside fence and fell dislodging its rider. T Thornton was attended to by the on-course Doctor and cleared to fulfill her remaining rides. Was immediately attended to by the horse ambulance, the on-course veterinarian and was found to have suffered a compound radial fracture to the left foreleg being humanely euthanised.

ALL MIGHT (C Burdan) – Slow to begin.

FLYING OARSMAN (A Calder) – Raced keenly in the early and middle stages.

JUST AL (S Collett) – Raced keenly in the middle stages.

L Satherley (IMA WONDER) – Spoken to regarding her whip use prior to the 100 metres.

Race 7	MLAADI LAURICH (YOUNG LAURICH'S) MAIDEN 3YO (1200 Metres)

EDGE OF WONDER (T Thornton) – Raced greenly when placed under pressure in the final straight. Inconvenienced passing the 75 metres by SWEET HUNTER (S Weatherley) which shifted out when not clear. S Weatherley was advised to exercise care. Improved on to heels just prior to the winning post having to be steadied.

T Thornton (EDGE OF WONDER) – Issued with a warning for her whip use prior to the 100 metres.

Payment was withheld while the connections of LORD PAINTON viewed video footage before electing not to proceed with a protest.

Race 8	RANGIORA EQUINE – JULIE LAURICH MEMORIAL 1400

LORD VALENTINE (T Thornton) – Slow away.

LETZ'AV BUBBLES (D Johnson) – Began awkwardly. Commenced to race keenly when being restrained in the early stages.

JUDY'S SONG (T Newman) – Had to be steadied approaching the 800 metres when JUTANUGARN (S Weatherley) shifted out and LORD VALENTINE (T Thornton) lay in forcing LETZ'AV BUBBLES inwards. Riders S Weatherley and T Thornton were both advised to exercise care.

THREADTHE NEEDLE (S Spratt) – Commenced to give ground inside the final 700 metres. When questioned regarding performance the rider advised that in her opinion the mare had failed to handle today's track conditions. Underwent a post-race veterinary examination which included an endoscopic examination which revealed the trachea was clear,

a wound on the nasal septum and the mare was lame in the right foreleg. The connections were advised that a veterinary clearance would be required prior to racing or trialing next.

MOET MOLLY (C Burdan) – Steadied when weakening passing the 100 metres.

T Newman (JUDY'S SONG) – Admitted a charge of excessive use of the whip. After hearing submissions the Judicial Committee suspended her licence to ride in races from the conclusion of racing today, 23 August, up to and including racing on 4 September, 6 national riding days.

T Newman (JUDY'S SONG) – Issued with a warning for allowing her mount to shift out passing the 100 metres forcing ATA RANGI out on to MOET MOLLY which had to be steadied when weakening.

GOODNIGHT IRENE (J Fawcett) – When questioned regarding the improved performance the connections advised that the mare had benefitted fitness-wise from recent racing.

Race 9	JADRAN BASKETBALL TEAM MAIDEN 1200

FINAL EXPRESS (A Calder) – Began awkwardly.

MAKZABEEL (C Ormsby) – Crowded at the start.

HAERE UP (C Burdan) – Crowded shortly after the start losing ground.

COTTON EYE JOE (L Satherley) – Crowded shortly after the start losing ground. When questioned regarding performance rider L Satherley advised that in her opinion the gelding was feeling the effects of recent racing.

ANJARDEN (S Spratt) – Held up for a distance passing the 200 metres and again passing the 100 metres.

MATTERHORN (T Yanagida) – Lost the right hind plate during the running.

LADY DE WINTER (T Thornton) – When questioned regarding performance the rider had been disappointed. Underwent a post-race veterinary examination which did not reveal any abnormality.

C Burdan (HAERE UP) – Spoken to regarding her whip use prior to the 100 metres.

Payment was withheld until the connections of the second placed MATTERHORN viewed video footage before electing not to proceed with a protest.

Race 10	NOTTINGHAM CASTLE HOTEL MAIDEN 1200

CATWALK GIRL (C Lammas) – Began awkwardly. Commenced to over-race in the early and middle stages.

PAPENHUYZEN (C Burdan) – Crowded shortly after the start losing ground. Lay out and away when racing greenly from C'EST LA GRIS passing the 400 metres, then raced greenly when placed under pressure for the remainder of the final straight.

WHO DAT DARE (S Spratt) – Hampered shortly after the start losing ground.

JESSE JAMES (C Grylls) – Raced ungenerously for a distance passing the 900 metres having to be steadied to avoid heels.

FLEURISSIMO (A Goindasamy) – Steadied when placed in restricted room to the inside of BLEW BY YOU which shifted in and away from THUNDER passing the 900 metres dropping back on to JESSE JAMES which had to be steadied to

avoid heels. Underwent a post-race veterinary examination which found the mare to be lame in the left foreleg. The connections were advised that FLEURISSIMO would require a veterinary clearance prior to racing next.

LUSTFUL LADY (L Satherley) – Made the junction on to the course proper awkwardly and lay out.

THUNDER (M Kareem) – Shifted out slightly passing the 150 metres inconveniencing GITCHE GUMEE.

GITCHE GUMEE (D Johnson) – Inconvenienced passing the 150 metres.

FOURCHOUX (S Collett) – Slow away.

A'NOOD DUDE (D Johnson) – Began awkwardly losing ground.

EL ZITA (M Kareem) – Rider dropped his whip passing the 400 metres.

A Goindasamy (PEERLESS WARRIOR) – Issued with a warning for his whip use prior to the 100 metres.
