### RACE COMMENTS:

<b>Race 1</b>	<b>DOBSON'S REFRIGERATION AND ELECTRICAL 3YO 1300</b>
<b>LAPEL</b> (C Lammas) – Began awkwardly losing ground.	

**CAPALDI** (B May) – Over-raced in the early stages when being restrained.

**SHEZA JAKKAL** (K Ramsamy) – Held up rounding the final bend before shifting out passing the 300 metres to obtain clear running placing **GOLDEN HUE** in restricted room.

**GOLDEN HUE** (T Thornton) – Raced keenly in the early stages. Shifted in passing the 300 metres making contact with **SHEZA JAKKAL** (K Ramsamy) which was shifting out in an attempt to obtain clear running with **GOLDEN HUE** having to be steadied. Also contributing was inward movement from **FRANCESCA** (M Cameron). Riders T Thornton, K Ramsamy and M Cameron were all advised to exercise greater care.

<b>Race 2</b>	<b>ZEST HANDICAP 1600</b>

**DELUXE EDITION** (M Kareem) – Slow away.

**STAR TREASURE** (S McKay) – Jumped away awkwardly losing ground. Raced wide without cover throughout.

**A Goindasamy** (INSCRIPTION) – Spoken to regarding his whip use prior to the 100 metres.

**RUKUHIA** (T Thornton) – Underwent a post-race veterinary examination which revealed the gelding to be lame in the right foreleg. The connections were advised that a veterinary clearance would be required prior to racing or trialing next.

<b>Race 3</b>	<b>SEEKA MAIDEN 1200</b>

**THE BELVOIR** (A Goindasamy) – Slow away, then crowded shortly after having to be steadied. Briefly held up passing the 400 metres.

**YOU WISH** (T Thornton) – Began awkwardly losing ground. Had difficulty obtaining clear running early in the final straight.

**MARLEY** (J Fawcett) – Began awkwardly.

**MARMELLOS** (C Lammas) – When questioned regarding performance the rider could offer no excuse.

**A Goindasamy** (THE BELVOIR) – Spoken to regarding his whip use prior to the 100 metres.

**HAPPY EGO** (S McKay) – When questioned regarding performance the rider advised that the gelding had been unsuited by today's track conditions.

<b>Race 4</b>	<b>AONGATETE AVOJET HANDICAP 1200</b>

**VEDO ROSSO** (M Kareem) – Began awkwardly. Contacted the running rail near the 850 metres.

**PACIFIC MASTER** (J Fawcett) – Began awkwardly shifting out making contact with **MANRICO** briefly unbalancing the rider. Commenced to over-race passing the 1000 metres having to be firmly restrained off the heels of **MAGNESS** near the 900 metres, then continued to over-race for a distance through the middle stages.

**MANRICO** (D Danis) – Crowded shortly after the start losing ground. Steadied when placed in restricted room near the 900 metres.

**C Grylls** (RAZ) – Issued with a warning for allowing his mount to shift in when not sufficiently clear of **MAGNESS** which was over-racing forcing that runner inwards crowding **PACIFIC MASTER** which had to be steadied near the 900 metres. Contributing was slight outward movement from **VEDO ROSSO**.

<b>CALL ME BOB</b> (S Collett) – When questioned regarding performance the rider advised that the slow early pace of the race and being caught wide during the middle stages had not benefitted the gelding.	
<b>Race 5</b>	<b>CLARK MAZEY BAYLEYS HANDICAP 1300</b>
<p>There was a delay to the race after <b>NASHA RIVA</b> (S Spratt) had been fractious in the barrier with <b>YORKSHIRE DALES</b> (C Grylls), <b>BATTLE TIME</b> (C Burdan) and <b>AIR CENTRE</b> (S McKay) contacting the front of the barrier. All these runners were removed from the barrier undergoing a veterinary check with <b>YORKSHIRE DALES</b>, <b>BATTLE TIME</b> and <b>NASHA RIVA</b> being cleared to start and <b>AIR CENTRE</b> being late scratched on veterinary advice.</p> <p><b>YORKSHIRE DALES</b> (C Grylls) – Slow away.</p> <p><b>WATCH THIS SPACE</b> (M Cameron) – Fractious just prior to the start being effected and as a result was slow to begin.</p> <p><b>BATTLE TIME</b> (C Burdan) – Returned to the enclosure with blood present in one nostril. Underwent a post-race veterinary examination which revealed superficial cuts in the nasal area.</p>	
<b>Race 6</b>	<b>OPAL KIWI PACKAGING KIWIFRUIT CUP 2100</b>
<p><b>GABRIEL</b> (A Calder) – Jumped away awkwardly losing ground.</p> <p><b>GRAND BOUQUET</b> (M Cameron) – Raced three wide with cover before commencing to give ground passing the 800 metres. Underwent a post-race veterinary examination which did not reveal any abnormality.</p> <p><b>MOTUMAN</b> (T Yanagida) – Improved on to the heels of the weakening <b>GRAND BOUQUET</b> passing the 750 metres having to be steadied.</p> <p><b>MY GIFT</b> (M Kareem) – Improved on to heels passing the 300 metres having to shift inwards to improve.</p> <p><b>EL LUCHADOR</b> (C Ormsby) – Raced in restricted room for a short distance passing the 350 metres to the outside of <b>MY GIFT</b> which shifted out and away from <b>JUNIOR</b>.</p> <p><b>PACORUS</b> (D Danis) – Lost the left front plate during the running.</p> <p><b>M Kareem</b> (<b>MY GIFT</b>) – Admitted a charge in that he used his whip excessively when riding <b>MY GIFT</b> prior to the 100 metres. After hearing submissions the Judicial Committee imposed a fine of \$500.</p> <p><b>S Collett</b> (<b>YOUWANTMORE</b>) – Issued with a warning for her whip use prior to the 100 metres.</p>	
<b>Race 7</b>	<b>BULK LINES LIMITED HANDICAP 1600</b>
<p><b>BOSTON STRONG BOY</b> (S Macnab) – Jumped away awkwardly losing ground.</p> <p><b>UNACCEPTABLE</b> (C Grylls) – Slow away. Firmly contacted and forced wider near the 1100 metres. Contacted near the 800 metres and again 750 metres.</p> <p><b>TUNZAGUTZ</b> (J Fawcett) – Crowded shortly after the start losing ground. Contacted near the 800 metres and again near the 750 metres.</p> <p><b>BOSTON STRONG BOY</b> (S MacNab) – Held up for a distance rounding the final bend.</p> <p><b>WOODEN EDGE</b> (M Kareem) – Had difficulty obtaining clear running entering the final straight.</p>	

**GARNET** (A Calder) – When questioned regarding the performance the rider advised that the mare had been unsuited by today's track conditions.

**J Fawcett** (TUNZAGUTZ) – Admitted a charge in that she allowed her mount TUNZAGUTZ to shift out when not sufficiently clear of UNACCEPTABLE near the 1100 metres making firm contact with UNACCEPTABLE becoming unbalanced. After hearing submissions the Judicial Committee found the charge to be above the mid-range and suspended Miss Fawcett's licence to ride in races from the conclusion of racing on 5 September up to and including racing on 18 September, 7 national riding days.
