RACE COMMENTS:

Race 1 SPORTZ BAR OPEN HURDLE 3000m

IT'S A WONDER (J Seivwright) – Slow away. Dictated out over extra ground after jumping the third fence.

LAKE SUPERIOR (H McNeill) - Jumped through the wing and running rail at the third fence dislodging H McNeill who was uninjured and cleared to ride by paramedics. As a result the field was directed around this fence on the final round to avoid debris from the shattered wing and running rail. LAKE SUPERIOR was uninjured.

SENASSY (D Parker) – D Parker had to take evasive action to avoid debris from the demolished wing and running rail and in doing so shifted out and forced **IT'S A WONDER** over extra ground.

MESMERIZE (I Lupton) - Put in a poor jump at the fence near the 1,200 metres.

KEYBOARD WARRIOR (B Donoghue) - Put in a poor jump at the second last fence and dislodged B Donoghue.

SO KEEP EM (N Downs) - Was retired from the race when well back and out of contention.

Race 2 WANGANUI CHRONICLE OPEN STEEPLE 3800m

CAPTAIN ORANGE (H McNeill) - Raced in restricted room passing the winning post on the second round. Was retired when well back and out of contention prior to jumping the last fence.

THE BIG OPAL (J Seivwright) – Put in a poor jump at the fence near the 1,100 metres.

DES DE JEU (A Kuru) - Held up and unable to improve for some distance rounding the home turn gaining clear running near the home straight entrance.

OLD COUNTESS (B Lammas) - Was inclined to run its fences down over the final stages.

Race 3 TAKE IT EASY TOURS MAIDEN 1200m

INDY FOX (M Hudson) - Made the first bend awkwardly and shifted out abruptly then commenced to hang out rounding the home turn.

D BRADLEY (MONGOLIAN PRINCESS) – Was issued with a warning under Rule 638 (1) (d) after allowing his mount to shift in at the end of the back straight when not clear of **TENNESSEE ROSE** which had to steady. Stewards took into account outward movement from **INDY FOX** when assessing the interference.

MONGOLIAN PRINCESS (D Bradley) - When questioned into the run D Bradley reported the filly had no excuse but may take natural improvement with the run.

A BOX OF TRICKS (R Myers) - Lost ground near the 700 metres when in restricted room.

R BISHOP (THATZ DAISY) – Admitted a charge under Rule (638) (3) (b) (ii) in that he used his whip excessively prior to the 100 metres and was fined the sum of \$300.

Race 4 BALANCE ACCOUNTANTS 1200m

JUSTA SMALL RANSOM (L Hemi) - Slow away

MAGNESS (S Macnab) – Bumped at the start.

OUTTHEGATE (R Bishop) – Steadied from a wide barrier.

SPIDERMAN (H Schofer) – Began awkwardly and then steadied. Dictated wide near the 700 metres when **SHADY GREY** was directed out to avoid the heels of the runner ahead.

SHADY GREY (C Burdan) - Raced keenly through the middle stages.

J Parkes (RACED EVENS) - Was spoken to regarding his whip use in the home straight.

Race 5 DAVE HOSKIN CARRIERS OPEN 1200m

CHOSEN PEAK (T Taiaroa) – Tightened at the start and was slow away.

CONOR O'CEIRIN (S Macnab) - Knuckled at the start.

T Tairoa (CHOSEN PEAK) - Was reminded of her obligations in that she must ride her mount out fully to the end of the race when circumstances permit her to do so.

Race 6 HS DYKE WANGANUI GUINEAS 1200m

LACED WITH GOLD (D Hirini) - slow to begin

TANNAHILL (R Aukett) - Began awkwardly making contact.

MISS DIXIE (H Schofer) - Slow to begin.

MOGADOR (J Parkes) - Began awkwardly losing ground. Hampered and steadied towards the end of the back straight when crowded for room between **AMOSIA** and **TANNAHILL** both of which shifted ground.

FLASH WARRIOR (C Dell) – Bumped and unbalanced near the 250 metres and checked a short distance further.

ALICE TINKER (T Taiaroa) - Bumped and became unbalanced when **FLASH WARRIOR** shifted outwards abruptly near the 250 metres. A short distance further checked and forced over extra ground when **ATISHU** which was held up and angled out in search of clear running.

C Dell (FLASH WARRIOR)- Admitted a charge under Rule 638 (1) (d) in that he allowed his mount to shift out when not clear of **ALICE TINKER** and after submissions had his licence to ride in races suspended from the conclusion of racing on 12 September through until the close of racing on 18 September (inclusive) – 3 riding days.

ATISHU (D Bradley) – Dictated inwards near the 250 metres when **FLASH WARRIOR** shifted in and was then held up for a short distance prior to being angled out into clear running near the 200 metres.

Darryl Bradley (ATISHU) - Admitted a breach of Rule 638 (1) (d)] in that he angled his mount outward near the 200 metres resulting in **FLASH WARRIOR** having to check and **ALICE TINKER** being bumped and forced over extra ground. After submissions D Bradley had his licence to ride in races suspended from the conclusion of racing on 11 September through until the close of racing on 17 September (inclusive) – 3 riding days.

POWER ON (C Burdan) - When questioned regarding the performance rider advised the gelding had never travelled comfortably throughout. Underwent a post-race veterinary examination which could find no obvious abnormalities.

Race 7 HERSTON ROBINSON MEMORIAL FOXTON CUP 2040m

DOLCETTO (H Schofer) - Shifted n abruptly at the start and bumped with **NITRO TED**.

HURRY CANE (S Macnab) - Slow away

HI I'M NIKKITA (D Bradley) – Slow away

HAPPY STAR (R Myers) - Shifted out at the start dictating **DEUCE COUPE** outwards.

HUNTA PENCE (D Hirini) - Began awkwardly and shifted out into the line of Italian lover which got back.

ITALIAN LOVER (S McKay) - Over-raced in the early and middle stages and had to be steadied for some distance.

CHARLIE HORSE (L Hemi) – Over-raced in the early and middle stages.

MAUNA KEA (B Ansell) - Raced in restricted room near the end of the back straight and was buffeted between runners.

Race 8 ST JOHNS CLUB 1600m

SEA STAR (M Hudson) - Slow away

C Dell (SASSENACH) - Was issued with a warning under Rule 638 (3) (b) (ii) for the manner in which he used his whip prior to the 100 metres.

T Taiaroa (BOTTI) - Was issued with a warning under Rule 638 (3) (b) (ii) for the manner in which he used his whip prior to the 100 metres.
