Race 4 - Barfoot & Thompson Steeplechase

ZED CASE – Trainer G Shaw reported to Stewards that ZED CASE has now been retired from racing.

Counties Racing Club - 15 July 2020

Race 5 - Haunui Farm 1300

J Waddell (YOU ARE SO VAIN) – Defended a breach in that he was unable to make the contracted weight for YOU ARE SO VAIN. After hearing submissions the Judicial Committee found the charge proven and imposed a fine of \$150.

RACE COMMENTS:

Race 1 MELEKA BELLE (1300 Metres)

SHAM ON TOAST (A Calder) – Slow to begin. Raced ungenerously for a distance approaching the 850 metres. Improved on to the heels of a weakening runner approaching the 200 metres having to be firmly restrained.

POSTCODE ENVY (R Beemud) – Began awkwardly losing ground.

SPARKLING LADY (B May) – Restrained from a wide barrier.

ALL THE RAGE (R Elliot) – Restrained shortly after leaving a wide barrier.

TUMBRIL (J Riddell) – Raced wide without cover.

L Satherley (IMPERIAL STAR) – Reminded of her obligations in regard to riding her mounts out fully to the end of a race when circumstances permit.

Race 2 DPA CHARTERED ACCOUNTANTS (1100 Metres)

SPLASH OF RED (S McKay) – Slow away. Raced ungenerously in the middle stages.

TAUPO MISSY (S Collett) – Began awkwardly.

QUEEN SARABI (R Myers) – Lay in when placed under pressure in the final straight and was not able to be ridden out to full advantage over the final 100 metres.

Race 3 INGLIS READY2RACE SALE OCTOBER 20TH (1100 Metres)

GEE CEE (S Spratt) – Began awkwardly losing ground. Raced ungenerously in the early to middle stages.

LE CHAMOSSAIRE (C Grylls) – Restrained shortly after leaving a wide barrier.

EDGE OF WONDER (R Elliot) – Raced ungenerously when the pace steadied passing the 800 metres. Had difficulty obtaining clear running early in the final straight.

VITESSE BO (S Collett) - Raced wide without cover.

MINI MINER (S Weatherley) – Had difficulty obtaining clear running early in the final straight.

ARCARIUS (M McNab) – Held up until passing the 100 metres.

Race 4 TAUPO VETERINARY CENTRE (1000 Metres)

EMBERS (S McKay) – Began awkwardly. Steadied when placed in restricted room passing the 850 metres after being contacted. Made the bend awkwardly near the 750 metres when racing ungenerously. Steadied passing the 150 metres.

ELLE AYE LADY (S Collett) – Began awkwardly losing ground.

KEKE STAR (D Johnson) – Steadied when placed in restricted room passing the 850 metres.

S Spratt (O'JESSICA) – Issued with a warning for allowing her mount to shift in when not clear of KEKE STAR which was forced inwards making contact with EMBERS with both those runners having to be steadied passing the 850 metres.

ROMAN BEAUTY (L Satherley) – Raced in restricted room to the inside of ADDICTED TO YOU which was laying in despite the efforts of its rider approaching the 800 metres.

HUCKLEBERRY HUSSIE (R Beemud) – Made the bend awkwardly near the 750 metres.

DRAGON EXPRESS (C Grylls) – Raced wide in the early stages commencing to hang out when making the bend, and continued to do so for the remainder of the race.

PATCH PRINCE (T Yanagida) – Held up entering the final straight when DRAGON EXPRESS lay out under pressure, continuing to be held up until passing the 200 metres. Forced inwards passing the 150 metres.

SHOW THE LOVE (E McCall) – Raced wide without cover throughout.

O'JESSICA (S Spratt) – Shifted in abruptly approaching the 150 metres forcing PATCH PRINCE in on to EMBERS which had to be steadied when placed in restricted room.

ADDICTED TO YOU (A Goindasamy) – Lay in throughout the running placing its rider at a disadvantage.

Payment was withheld until the connections of the fourth placed EMBERS viewed video footage before electing not to proceed with a protest.

Race 5 TOTAL TRANSPORT TAUPO (1200 Metres)

CAN I GET AN AMEN (R Myers) – Slow away. Held up until shifting out passing the 200 metres to obtain clear running.

SANTORI (S McKay) – Began awkwardly. Made the bend near the 750 metres awkwardly when laying out, then continued to lay out losing contact with the body of the field. Was eased down in the final straight when out of contention. Trainer M Murdoch was advised that the mare would be required to trial left handed prior to racing left handed again. Underwent a post-race veterinary examination which did not reveal any abnormality.

RUSAVY (T Yanagida) - Threw its head down as the start was effected losing considerable ground as a result.

Race 6 PITCH SPORTS BAR & LUCKY LIZARD (1200 Metres)

HIGH ACHIEVER (C Ormsby) – Began awkwardly then raced in restricted room.

DON DRAPER (M Cameron) – Began awkwardly then hampered.

MOET MOLLY (A Goindasamy) – Knuckled leaving the barrier then hampered.

MISS VALENCIA (T Yanagida) – Raced keenly in the middle stages.

OTTAVIO (R Elliot) – Raced ungenerously when placed in restricted room passing the 750 metres dropping back on to MUNSTER which had to be steadied.

MUNSTER (S Collett) – Steadied passing the 750 metres when the pace eased. Had difficulty obtaining clear running entering the final straight, then was held up for a distance passing the 200 metres.

SACRED CHARM (S Spratt) – Inconvenienced having to be steadied passing the 500 metres after improving on to the heels of MUNSTER which was steadying.

IMAREADY (D Johnson) – Contacted just prior to the winning post by PACKING NOBLESSE when both runners shifted ground.

PACKING NOBLESSE (J Waddell) – Contacted just prior to the winning post.

Race 7 PLACEMAKERS TAUPO (1400 Metres)

SAIGNON (B May) – Began awkwardly with the rider becoming unbalanced.

IRON EAGLE (S McKay) – Raced ungenerously in the early stages and was contacted and forced wider passing the 1200 metres by PENNY ROYAL which knuckled and shifted out.

PALAMEDES (A Goindasamy) – When questioned regarding performance A Goindasamy advised that the mare had not began as well as anticipated and had got further back than intended.

Race 8 GENERATION HOMES TAUPO (1800 Metres)

LANDGRAVE (C Lammas) – Began awkwardly then crowded. Crowded and hampered approaching the 1700 metres.

TE TUHI ROAD (S Collett) – Slow to begin.

LA CASA (M McNab) - Restrained soon after leaving the barrier. Raced wide for the majority of the race.

ZINZAN (J Waddell) – Restrained soon after leaving the barrier.

MISS WRIGLEY (D Johnson) – Restrained shortly after leaving a wide barrier.

R Elliot (CARAMEL POPCORN) – Issued with a warning after permitting CARAMEL POPCORN to shift in near the 1700 metres crowding LANDGRAVE which was hampered with Stewards taking into account the racing manners of LANDGRAVE which was racing ungenerously at the time.

BLACK TECH (A Calder) – Steadied when placed on heels passing the 350 metres.
