Race 10 MICHELLE PAYNE GOLD CUP HANDICAP 1600M

RUBY NEGRONI (S McKay) - Trainer J Price advised Stewards, RUBY NEGRONI pulled up slightly dehydrated after the race. J Price further advised the mare underwent a veterinary examination on Monday 14 September which revealed no abnormalities, it is now his intention to carry on with RUBY NEGRONI'S current preparation.

Race 5 Dunstan Feeds 2100

MY CALLISTO (A Calder) - Trainer R Collett advised, that upon return to the stable the gelding underwent a veterinary examination which revealed a tendon injury.

Race 6 Otakiri Reserve 1200

GORGEOUS GEISHA (C Jones) - Trainer N Tiley advised Stewards he was satisfied with the post-race condition and will continue on with the mare's current preparation. N Tiley further advised that he may apply blinkers to GORGEOUS GEISHA when doing track work.

Race 7 JRA Trophy (1400 metres)

SHERWOOD FOREST (M McNab) - Trainer T Pike advised Stewards, SHERWOOD FOREST will undergo a veterinary examination in the coming days. A further follow up will be done by Stewards next week.

RACE COMMENTS:

Race 1 XMAS @ TE RAPA 2100 MAIDEN

BEAU ARCHERS ROSE (S McKay) – Began awkwardly then crowded. Raced keenly in the early stages.

MOKELE MBEMBE (M Cameron) - Began awkwardly.

FOURCHOUX (L Satherley) – Restrained from a wide barrier.

CHARRED (T Thornton) – Crowded shortly after start losing ground.

WIND CHIMES (C Lammas) – Crowded shortly after start losing ground. Steadied to avoid heels passing the 600 metres.

BUDDY PERFECT (S Collett) – Crowded shortly after the start. Raced three wide in the early stages before improving to sit outside the leader.

PRINCE SOLARI (S Spratt) – Steadied when placed in restricted room passing the 600 metres.

TEE BONE BROWN (J Riddell) — Held up entering the final straight. Returned to the enclosure with blood present in the nasal area. Underwent a post-race veterinary examination which found the gelding to have bled. The connections were advised that TEE BONE BROWN would now be subject to the mandatory two month stand down from training, three month stand down from racing and a veterinary clearance would be required prior to racing or trialing next.

Race 2

NZB INSURANCE PEARL SERIES RACE HANDICAP (1400 Metres)

NOW IS NOW (S Collett) - Began awkwardly.

AKOYA PEARL (C Burdan) – Raced wide without cover for the majority of the race.

FRIDAY WOOLFE (A Goindasamy) - Had to change ground passing the 150 metres to obtain clear running.

Race 3 SKYCITY HAMILTON MILE MAIDEN

NIZONA (D Danis) – Slow to begin. Returned to the enclosure with blood present in the nasal area. Underwent a post-race veterinary examination which found the mare to have bled. The connections were advised that NIZONA would now be subject to the mandatory two month stand down from training, three month stand down from racing and a veterinary clearance would be required prior to racing or trialing next.

IRISH BOY (Y Coonee) - Slow to begin. Raced wide without cover.

OVERSTAYER (D Johnson) – Hampered shortly after the start.

RISING RISK (T Yanagida) – Commenced to buck for a short distance passing the 1550 metres losing considerable ground before settling quickly. The connections were advised that a warning would be placed on its racing manners. Held up passing the 300 metres.

BORDER LEICESTER (C Lammas) – Improved on to heels and steadied near the 500 metres.

MR GHIBSON (T Harris) – Held up early in the final straight.

Race 4

BCD GROUP 1400 HANDICAP

RANGITATA (M Kareem) – Began awkwardly.

GUS THE MAVERICK (C Ormsby) – Began awkwardly then crowded. Rider dropped his whip passing the 350 metres.

MR INCREDIBULL (S McKay) – Began awkwardly losing ground. Had to be firmly restrained approaching the 200 metres after improving on to heels.

HEAR MY VOICE (S Collett) – Raced wide without cover.

SNITZ OF TIME (D Johnson) – Had difficulty obtaining clear running early in the final straight before improving into a marginal run to the inside of HEAR MY VOICE before having to be steadied passing the 200 metres when HEAR MY VOICE shifted in and away from RANGITATA.

CALL ME BOB (C Jones) - Held up until passing the 150 metres.

PRINCESS ORIGAMI (M Cameron) – When questioned regarding performance the rider advised that the mare had travelled comfortably throughout, but had not responded in the final straight. Underwent a post-race veterinary examination which did not reveal any abnormality.

Race 5

SVS 3YO 1200 MAIDEN

ARANCIA (S Collett) - Slow to begin.

SPIRIT OF BAZ (M Cameron) - Began awkwardly.

CANADIAN MOUNTIE (R Elliot) – Restrained from a wide barrier.

LAPEL (C Ormsby) – Restrained from a wide barrier.

KELLY RENEE (C Grylls) – Raced wide without cover for the majority of the race. Contacted passing the 350 metres, then firmly contacted and forced wider passing the 100 metres.

HELSINKI (D Johnson) – Shifted out passing the 350 metres in an attempt to obtain clear running making contact with KELLY RENEE, then shifted out and away from REBEL RIOT (E Leighton) passing the 100 metres making firm contact with KELLY RENEE which was forced wider.

MEGA BOURBON (M McNab) – Held up passing the 200 metres for a brief distance.

E Leighton (REBEL RIOT) – Issued with a warning for allowing her mount to shift out passing the 100 metres forcing HELSINKI out on to KELLY RENEE.

Race 6 FIBER FRESH 3YO 1200 MAIDEN

FLAVIUS (M McNab) – Began awkwardly then restrained. Forced wider to avoid heels passing the 700 metres.

OCEAN POINT (L Innes) – Crowded leaving the barrier.

BURCHA (R Elliot) – Restrained from a wide barrier. Steadied after becoming awkwardly placed on heels passing the 600 metres.

CARAMELLA (M Cameron) – Became awkwardly placed near the heels of FASHION SHOOT (D Johnson) passing the 900 metres having to shift out, then raced three wide without cover. When questioned regarding performance rider M Cameron advised that the filly had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

D Johnson (FASHION SHOOT) – Issued with a warning for allowing her mount to shift in passing the 900 metres when not sufficiently clear of CARAMELLA which had to be steadied when awkwardly placed on heels.

RUN FOR COVER (C Lammas) – Steadied when placed in restricted room passing the 700 metres.

S Weatherley (EXTORTION) – Issued with a warning for allowing his mount to shift out passing the 700 metres when not sufficiently clear of RUN FOR COVER which shifted out hampering FLAVIUS which had to shift out abruptly to avoid heels.

Race 7 NZB INSURANCE PEARL SERIES RACE MAIDEN (1200 Metres)

YOU WISH (T Thornton) – Slow to begin.

RUUD AS (C Grylls) – Began awkwardly.

SWEET FIELDS (R Beemud) – Began awkwardly and then restrained.

BUY ME A ROSE (A Calder) – Raced wide without cover for the majority of the race.

ORIGINEEL (L Innes) – Had difficulty obtaining clear running early in the final straight, and then was held up approaching the 300 metres before shifting out to obtain clear running.

SHE SPEEDS (D Johnson) - Had difficulty obtaining clear running early in the final straight.

ARRIVEDERCI (A Goindasamy) – Had difficulty obtaining clear running early in the final straight.

R Beemud (SWEET FIELDS) – Issued with a warning for his whip use prior to the 100 metres.

D Montes de Oca (MAI TAI) – Admitted a charge in that he used his whip above shoulder height. After hearing submissions the Judicial Committee imposed a fine of \$500.

Race 8 FOSTER MILE HANDICAP

PIPING HOT (M McNab) – Slow to begin. Had to be checked passing the 1100 metres.

MIDNITE INVASION (C Lammas) – Slow to begin. Raced in restricted room passing the 1100 metres.

ANATOW (A Goindasamy) – Slow to begin.

WORDSWORTH (J Riddell) – Raced three wide without cover throughout.

EL COOLIO (T Thornton) – Held up entering the final straight.

GLENHOPE (T Yanagida) – Raced in restricted room passing the 1100 metres.

SYMBIO (S Spratt) – Over-raced early stages then crowded passing the 1100 metres then continued to over-race through the middle stages. Held up passing the 200 metres.

PENTEVEREST (C Ormsby) – Steadied when placed in restricted room passing the 200 metres.

C Ormsby (PENTEVEREST) – Admitted a charge of careless riding in that he permitted his mount to shift in near the 1100 metres when not clear of SYMBIO, GLENHOPE, MIDNITE INVASION and PIPING HOT which were all crowded with PIPING HOT being checked. After hearing all submissions, the Judicial Committee suspended his licence to ride in races from the conclusion of racing on Saturday 19 September, up to and including racing on Friday 25 September, 3 national riding days.
