## GENERAL:

Rider R Oliver advised he would not be attending today's meeting. R Oliver is to provide a medical clearance before riding next. An investigation is being conducted into the matter. Apprentice A Goindasamy replaced R Oliver in races 1 and 2 due to no suitable senior rider being available.

### **RACE COMMENTS:**

Race 1	United Security Northland Maiden (1400 metres)			
The race was delayed 4 minutes at the request of TAB Control.				
<b>RISING SEA</b> (C Jones) – Late scratched at 12.35 pm by order of Stewards after RISING SEA galloped a full circuit of the course after the saddle slipped during the preliminary. A veterinary examination found the gelding to be grade 4/5 lame in the right hind. Connections were advised a veterinary clearance would be required for RISING SEA before racing or trialling next.				
<b>MERSEY BEAT</b> (L Satherley) – Began awkwardly. Hampered 1300 metres. Had difficulty finding clear running early in the final straight and then again for a distance passing the 100 metres.				
KAPALKA (B May) – Began awkwardly.				
LORD POLONIUS (M Hashizume) – Knuckled shortly after the start and then was further hampered losing ground.				
SHIRAZELLE (A Calder) – Crowded shortly after the start losing ground.				

BAYEUX (N Alam) - Restrained from its wide barrier.

**MOLLYS GAME** (T Yanagida) – Hampered shortly after the start. Approaching the 1300 metres MOLLYS GAME was contacted heavily becoming unbalanced by KAPALKA which shifted in abruptly. As a result, MOLLYS GAME shifted in crowding MERSEY BEAT and INCY WINCY SPIDER which both lost ground.

**B May** (KAPALKA) – Admitted a breach of careless riding in that he allowed KAPALKA to shift in near the 1300 metres making substantial contact with MOLLYS GAME with that runner shifting in and away dictating MERSEY BEAT into the line of INCY WINCY SPIDER which was checked with the Judicial Committee suspending his license to ride in races from the conclusion of racing today 19 September up to and including racing on 26 September, 4 national riding days.

INCY WINCY SPIDER (E McCall) - Crowded shortly after the start. Checked 1300 metres. Restrained passing the 800 metres. Improved onto heels approaching the 100 metres and steadied.

**TRIGON LAD** (T Newman) – Over-raced early stages. Raced four wide without cover throughout.

#### Fell Engineering Maiden (1400 metres) Race 2

RISING SILVER (E McCall) – Slow away.

**SON OF SASANOF** (S Spratt) – Slow away.

ALWAYS ON TIME (C Dell) – Restrained from its wide barrier.

**TROPIC THUNDER** (A Goindasamy) – Restrained from its wide barrier.

FLASHDANCE (C Jones) – Shifted in and away from OCEANS OF STANIMA approaching the 1300 metres making contact with the running rail becoming unbalanced and losing ground. Became awkwardly placed on heels passing the 900 metres and was steadied losing ground.

**OCEANS OF STANIMA** (D Danis) – Held up early in the final straight.

**PARKER LEWIS** (L Satherley) – Raced greenly when placed under pressure in the final straight. Improved on to the heels of LAMPUS (M Hashizume) which shifted out slightly approaching the 100 metres with PARKER LEWIS being hampered. M Hashizume was advised that he must exercise care in a similar circumstance.

**EVER SO EASY** (T Thornton) – The rider reported that the gelding had felt indifferent in its action when pulling up. A subsequent veterinary examination which found skin off right fetlock consistent with having gone down on the bumper.

Race 3 Bay of Islands – Waipapa 2100

**REFLECTION** (A Goindasamy) – Crowded shortly after the start losing ground.

JUDY'S SONG (T Yanagida) – Restrained from its wide barrier.

**SHOTGUN SALLY** (T Thornton) – Began awkwardly. Over-raced in the early stages when being restrained.

**POKER QUEEN** (M Hashizume) – Held up rounding the final turn and early in the final straight.

BRAWLER (S Spratt) – Had difficulty obtaining clear running in the final straight until near the 150 metres.

# Race 4 ITM/GIB Whangarei Gold Cup (2200 metres)

**OCEAN BILLY** (C Jones) – Began awkwardly then crowded losing ground. Racing wide without cover from near the 1400 metres.

**TRANSFORMER** (M Hashizume) – Reared as the start was effected losing ground.

**PUSHKA** (C Burdan) – Commenced to hang out making the first bend near the 1700 metres continuing to hang, running wide from near the 1400 metres and then not being persevered with. PUSHKA returned to the enclosure and it was apparent the bit had become displaced. PUSHKA underwent a veterinary examination which could find no abnormalities. PUSHKA is to barrier trial to the satisfaction of Stewards before racing next.

**FINAL SUGGESTION** (T Thornton) – Became awkwardly placed distance passing the 1600 metres shifting out to avoid heels forcing ITELLYOUONETHING wider on the track.

ITELLYOUONETHING (T Newman) – Forced wide 1600 metres.

**K Knight** – The trainer of ITELLYOUONETHING admitted a breach in that she presented the incorrect horse to race. After considering submissions the Judicial Committee imposed a fine of \$500.

Race 5 Northland Business Systems 1200

**IGOTTADOITMYWAY** (E McCall) – Late scratched at 3.00 pm after refusing to enter the barriers. IGOTTADOITMYWAY is now required to barrier trial to the satisfaction of Stewards before racing next.

**THE DOM** (T Newman) – Made substantial contact with AWARENESS becoming unbalanced soon after leaving the barriers.

MAKABAR (R Beemud) – Began awkwardly losing ground.

**SYMPATHIQUE** (L Satherley) – Restrained from a wide barrier then making contact with the hindquarters of NEW DAWN.

**NEW DAWN** (B May) – Contacted soon after leaving the barriers becoming briefly unbalanced. Raced wide without cover and ran wide when making the final bend.

**AMAL ROSE** (T Yanagida) – Held up entering the final straight improving into a marginal run approaching the 250 metres to the inside of THE DOM which had shifted out slightly when struck with the whip. When being corrected by its rider THE DOM shifted in slightly with AMAL ROSE clipping a heel of that runner and blundering. Crowded 100 metres.

A PROPER LADY (A Goindasamy) – Held up near the 400 metres before shifting out to obtain clear running.

**SPOIL SPORT** (C Jones) – Held up for clear racing room soon after entering the final straight, shifting out approaching the 300 metres hampering RIPPED which was forced wider on the track. Lost the near hind plate during the running.

**C** Jones – Issued with a warning after permitting SPOIL SPORT to shift out near the 300 metres when not sufficiently clear of RIPPED which was hampered.

**MIGHT** (S Spratt) – Crowded 100 metres and briefly steadied.

**C Burdan** – Issued with a warning after allowing AWARENESS to shift in under pressure approaching the 100 metres crowding AMAL ROSE on to MIGHT which was briefly steadied.

Race 6Bay of Islands ITM – Haruru 1600

NOMOATHAJ (C Burdan) – Stumbled jumping away shifting out making contact.

**AMAZING AZ** (T Thornton) – Hampered leaving barriers.

**FLOMILINE** (A Calder) – Restrained from its wide barrier draw.

ALASKAN GOLD (A Goindasamy) - Raced ungenerously in the early to middle stages.

**YAMUNA** (T Newman) – Raced wide without cover. When questioned regarding the performance Rider T Newman advised the mare had been disadvantaged after travelling wide without cover.

**SONOFABUTCHER** (T Yanagida) – Held up early in the final straight before obtaining clear running near the 300 metres.

**KAARERAWAY** (L Satherley) – When questioned regarding the performance rider L Satherley advised that she had not intended to lead and the mare may be better suited when ridden off the pace.

Race 7 Harcourts Tai Tokerau Trophy (1200 metres)

**MIDNIGHT RUNNER** (A Goindasamy) – Restrained from a wide barrier.

**MONEY TRAIL** (M Hashizume) – Restrained from a wide barrier. Could not obtain clear running for the majority of the final straight.

**NEW YORK JAZZ** (T Newman) – Raced wide without cover for the majority of the race. Lay in under pressure in the final straight with the rider losing her whip near the 150 metres. Made contact over the concluding stages.

**DONNA ANNE BILLY** (D Danis) – Raced wide without cover from near the 1400 metres. Crowded and steadied 175 metres.

**LE CASTILE** (A Calder) – Had difficulty obtaining clear running for the majority of the final straight.

**FAMILIA** (C Burdan) – Shifted out abruptly when struck with the whip near the 350 metres making contact with DONNA ANNE BILLY. Shifted out abruptly over the concluding stages making contact with NEW YORK JAZZ which was shifting in.

**MELT** (C Jones) – Had some difficulty obtaining clear running early in the final straight then crowded near the 175 metres to the outside of LE CASTILE (A Calder) which shifted out slightly. Contributing was an inward movement from DONNA ANNE BILLY which had been crowded to the inside of RIKKI TIKKI TAVI which was taken in slightly by YEARN (S Spratt) which had raced in restricted room to the inside of NEW YORK JAZZ (T Newman). Riders A Calder, S Spratt and T Newman were advised to exercise care in a similar circumstance.

# Race 8 Whangarei ITM 1400

**ANNIE'S SONG** (M Hashizume) – Refused to leave the barriers when the start was effected taking no part in the race. The connections were advised that ANNIE'S SONG would be required to barrier trial to the satisfaction of Stewards before racing next.

PARISIAN (B May) – Knuckled when leaving the barriers and was slow away as a consequence.

**PULLYOURSOCKSUP** (S Spratt) – Began awkwardly making contact.

SILENT TRUTH (C Jones) – Began awkwardly, shifting in abruptly making contact.

MY WORLD (D Danis) – Steadied from a wide barrier.

**CIVILISED** (L Satherley) – Steadied from a wide barrier. Held up for a distance from near the 250 metres until approaching the 100 metres.

**REGENT STREET** (T Newman) – Raced keenly when being restrained in the early to middle stages. Steadied over the concluding stages when in restricted room.
