R Cole - Did not attend the meeting due to injury and is required to provide a medical clearance prior to riding next.

N Downs - Was unable to make the required weight for a number of runners today, being fined \$500 by the Judicial Committee.

Race 9 - Windsor Park Plate (Group 1)

JENNIFER ECCLES - Co-trainer S Ritchie reported that he had been very disappointed with the performance advising that blood tests would be taken and the mare would be sent for a short spell.

RACE COMMENTS:

	Race 1	Eastern Earthmovers Hurdle (2760 metres)
THE ROLLING STONE (D Parker) - Slow to begin.		

RAUCOUS (A Kuru) - Raced keenly when being restrained in the early stages going back on to BUDDY PERFECT near the 600 metres on the first occasion. Badly misjudged the third fence, putting in a poor jump.

BUDDY PERFECT (B Donoghue) - Had to be steadied off the heels of RAUCOUS near the 600 metres on the first occasion.

LONDONDERRY AIR (M Cropp) - Jumped the second fence awkwardly. Raced wide in the middle stages.

CLEAVER (E Farr) - Steadied when placed in restricted room approaching the 900 metres.

G Walsh (VINCENTIUS) - Reminded of his obligation to ride his mounts out fully to the finish.

CALL ME ROYAL (N Downs) - Returned to the enclosure with blood present in the nasal area, a subsequent veterinary examination confirming the gelding to have bled. CALL ME ROYAL is now subject to the mandatory stand down periods.

 Race 2
 Pakuranga Hunt Landowners Hurdle (2760 metres)

KEEPELLA HEIGHTS - T Moki was unable to make the weight and was replaced by S Karnicnik. Hampered by the fallen horse near the 150 metres.

T Moki - Fined \$100 under the Minor Infringement Schedule after being unable to make the weight for KEEPELLA HEIGHTS.

T Moki (KEEPELLA HEIGHTS) - Admitted a charge in that she attempted to weigh out without her body protector. After considering submissions her license to ride in races was suspended for 4 weeks from close of racing today up to and including racing on Sunday 1 November, and in addition was fined the sum of \$250.

TITTLETATTLE (H McNeill) - Slow to begin. Badly misjudged the fence near the 1300 metres almost dislodging its rider.

TRUEMAN (A Kuru) - Put in a poor jump at the first fence. Ran down the second fence and continued to run down its fences for the remainder of the race. Put in a poor jump at the final fence and fell. After being attended to by the Course Doctor and St Johns Ambulance personnel A Kuru was transferred to a local hospital for further evaluation.

PRIZED PINS (B Lammas) - Landed awkwardly after jumping the second fence then racing keenly for a distance. Inconvenienced when making contact with the fallen rider near the 150 metres.

MIZZENA (D Parker) - Inclined to over-race when wide in the early stages with the saddle then shifting forward passing the 1700 metres placing the rider in difficulty for the remainder of the race. Two light pads became detached from underneath the saddle during the running but upon weighing in D Parker was still within the allowed weight tolerance of 0.5kg with correct weight being declared.

AZABEAT (E Farr) - Misjudged the fence near the 1050 metres.

KION (I Lupton) - Put in a poor jump at the fence near the 700 metres. When questioned regarding the performance rider I Lupton advised that after putting in a couple of poor jumps including one at the fence near the 700 metres the gelding had then been a beaten runner and had not been persevered with from that point. I Lupton was reprimanded and advised that in those circumstances KION should have been retired from the race and not have jumped the final two fences.

BRAWLER (N Downs) - Lost the right front plate during the running.

Race 3 Corson Maize Pakuranga Hunt Hurdle (3350 metres)

IZYMYDAAD (N Downs) - Rider N Downs was permitted to ride 2kgs overweight due to no suitable replacement rider being available but fined as per summary above. Improved onto heels and was hampered near the 2400 metres. Put in a poor jump at the fence near the 1300 metres.

EACH WAY (H McNeill) - Began awkwardly.

GALLANTE (I Lupton) - Slow to begin.

BIGREDMOON (G Walsh) - Slow to begin.

REVOLUTION (M Cropp) - Inclined to lay out throughout the race.

DELEGATE (J Seivwright) - Misjudged the fence near the 1300 metres.

THE COSSACK (M Roustaby) - Raced in restricted room approaching the 600 metres.

Race 4 Veterinary Associates 2100

CASSIO (D Danis) - Jumped away awkwardly then being further hampered when crowded by WIND CHIMES.

BLACK EYED SUE (C Burdan) - Jumped away awkwardly.

L Innes - Defended a charge of careless riding in that he permitted CAUTIOUS APPROACH to shift inwards when not sufficiently clear of RELIABLE HUNTER which was crowded and checked near the 1900 metres. After considering evidence the Judicial Committee found the charge to be proven, imposing a suspension of his license to ride in races from the conclusion of racing on Wednesday 7 October until the conclusion of racing on Friday 16 October 2020, 5 national riding days.

RELIABLE HUNTER (S Weatherley) - Crowded and checked near the 1900 metres. Made the crossing near the 1700 metres awkwardly then being further hampered by WIND CHIMES. Contacted near the 100 metres.

WIND CHIMES (M McNab) - Made the crossing near the 1700 metres awkwardly, hampering RELIABLE HUNTER.

KNOCK ON WOOD (T Thornton) - Hampered when forced wider after negotiating the crossing near the 1700 metres. Raced three wide without cover. Unbalanced after making contact with RELIABLE HUNTER near the 100 metres.

M Hashizume - Admitted a charge of careless riding in that he permitted his mount COLOSSAL to shift outwards when not sufficiently clear of CAUTIOUS APPROACH which was crowded and checked near the 150 metres. After considering submissions the Judicial Committee imposed a suspension commencing after racing on Saturday 10 October until the conclusion of racing on Friday 23 October, 6 national riding days.

CAUTIOUS APPROACH (L Innes) - Crowded and checked passing the 150 metres.

Race 5 The Patron's Steeplechase (4150 metres)

GRANDISCOCCYMELUMS (B Lammas) - Jumped indifferently at the rear becoming tailed off in the middle stages before being retired from the race prior to jumping the first fence on top of the hill on the second occasion.

DONARDO (J Seivwright) - Raced ungenerously after jumping the final fence in the centre.

DAAD (S Karnicnik) - Badly misjudged the fence near the 1400 metres almost dislodging its rider. DAAD again put in a poor jump at the next fence then being retired from the race. A post-race veterinary inspection did not reveal any obvious abnormality.

RAAJ (N Downs) - Required veterinary treatment post-race for a laceration to the left fore pastern.

Race 6 CLC Pakuranga Hunt Cup (4900 metres)

Rider **N Downs** was permitted to ride ZAMORA 2kgs overweight due to no suitable replacement rider being available but was fined as per the summary above.

DES DE JUE (J Seivwright) - Jumped the first fence poorly. Poor jump at the second fence (water jump). Poor jump at the fence near the 1400 metres on the second occasion hampering SOUTHERN COOL.

SOUTHERN COOL - Hampered at the fence near the 1400 metres on the second occasion.

OLD COUNTESS (G Walsh) - Commenced to give ground going up the hill on the second occasion and was retired from the race prior to the fence near the 600 metres. A post-race veterinary examination found the mare to be grade 4 lame in the left hind leg having suffered a tendon injury and would require a veterinary certificate of fitness prior to racing again.

SHAMAL (B Lammas) - Poor jump at the second fence (water jump).

MAGIC WONDER (B Donoghue) - Poor jump at the second fence (water jump).

THAT'S HOW IT GOES (S Karnicnik) - Retired from the race prior to the final fence.

N Downs (ZAMORA) - Issued with a warning for his whip use prior to the 100 metres.

B Donoghue (MAGIC WONDER) - Fined \$200 by the Judicial Committee after making a celebratory gesture prior to the winning post.

Race 7	Pakuranga Hunt Supporters Group 2100
BORDER LEICESTER (A Goindasamy) - Slow to begin. Hampered 550 metres.	

PRINCE SOLARI (T Thornton) - Began awkwardly. Hampered 550 metres.

MONBEAU (C Burdan) - Crowded soon after leaving the barriers. Raced ungenerously through the middle stages.

C'EST UNE STAR (M Cameron) - Began awkwardly then crowded. Badly hampered 550 metres.

EL ZITA (T Yanagida) - Raced wide without cover.

GRACIES GOLD (S Spratt) - Crowded and checked near the 550 metres when racing to the inside of MONBEAU which after improving into a tight run between GRACIES GOLD and EL ZITA, was taken in by EL ZITA (T Yanagida) which lay away from BOARDER LEICESTER which was improving to its outside. Film footage of this incident proved inconclusive as to the culpability of any rider with apprentice T Yanagida being advised to exercise care. As a result C'EST UNE STAR was badly hampering along with BORDER LEICESTER and PRINCE SOLARI also being hampered. GRACIES GOLD was then not persevered with in the straight. A post-race veterinary inspection did not reveal any obvious abnormality.

Race 8 Fixine For Equine 1200

ADDICTED TO YOU (L Satherley) - Restrained when leaving the barriers then crowded. Over-raced in the early and middle stages and hung outwards shifting out near the 900 metres hampering SEVEN AAJES with LINOLEUM also being forced wider.

SEVEN AAJES (S Weatherley) - Steadied when leaving the barriers. Hampered by ADDICTED TO YOU near the 900 metres.

SHIBUYA KOSATEN (S Spratt) - Steadied when leaving the barriers. Made contact with the running rail near the 1100 metres. Over-raced in the middle stages having to be firmly restrained to avoid the heels of PRECISION SHOOTER near the 900 metres. Had some difficulty obtaining clear running rounding the final turn and early in the straight.

MI SKY (C Burdan) - Slow away.

LADY DE WINTER (T Thornton) - Raced three wide without cover.

EMBERS (D Johnson) - Got its head up when being restrained passing the 1000 metres and again near the 900 metres going back onto PRECISION SHOOTER which had to steady with SHIBUYA KOSATEN then having to be firmly restrained when improving on to the heels of PRECISION SHOOTER.

PRECISION SHOOTER (M Hashizume) - Steadied off heels near the 900 metres.

LINOLEUM (M McNab) - Hampered and forced wider by ADDICTED TO YOU near the 900 metres.

Race 9 Tiley Family 1400

LIVVY LASS (A Goindasamy) - Began awkwardly losing ground.

MONLULA (R Elliot) - Slow to begin. Inconvenienced near the 200 metres when forced wider on the track.

MY WORLD (T Yanagida) - Slow to begin.

SPELTERINI (T Thornton) - Raced wide without cover.

DARCEE QUE (M Cameron) - Briefly contacted becoming unbalanced approaching the 300 metres by MAKZABEEL which shifted in under pressure.

LORD POLONIUS (M Hashizume) - Had difficulty obtaining clear running until inside the final 100 metres.

CALL ME BOB (C Jones) - Steadied passing the 300 metres when awkwardly placed then had difficulty obtaining clear running until approaching the 200 metres inconveniencing CHILLAX which was dictated out inconveniencing MONLULA which was forced wider on the track.

DEELS DONE (M McNab) - Improved onto the heels of the weakening DARCEE QUE approaching the 100 metres and steadied.

Race 10 Bridges Insurances Services 1600

THE BUZZ (T Yanagida) - Crowded leaving the barriers.

CREATIVE GENIUS (R Elliot) - Lost the left front plate during the running.

Race 11Wade Equine Coaches 2100LA CASA (M McNab) - Jumped away awkwardly, losing ground.

TUNZAGUTZ (T Newman) - Contacted near the 1800 metres when JUDY'S SONG (T Yanagida) shifted in. T Yanagida was advised to exercise greater care.

TAHUROA HEIGHT (M Hashizume) - Raced three wide without cover. Crowded near the 350 metres.

SIR AGLOVALE (L Innes) - Held up rounding the final turn then again held up near the 250 metres when JUST TREASURE (A Goindasamy) lay out. A Goindasamy was advised to exercise care.

T Yanagida (JUDY'S SONG) - Issued with a warning after permitting his mount to shift outwards early in the straight near the 350 metres crowding TAHUROA HEIGHT.

L Innes (SIR AGLOVALE) - Spoken to regarding his whip use in consecutive strides early in the straight.

RAPIDZ (C Dell) - Held up near the 350 metres having to be firmly restrained to avoid heels.
