GENERAL:

<p>Rider J Riddell advised Stewards he would not be attending today's races due to illness. J Riddell is to provide a medical certificate before riding trackwork, trials or races.</p> <p>Before the running of Race 6 concerns were raised after rain had fallen on a track that had been described as a Good 2 and was firm. A delegation of Club Officials, Trainers, Jockeys and Stipendiary Stewards then inspected the track with a unanimous view that conditions were not suitable to continue racing.</p>

Race 1	Westbrook-Cellar Door Waimauku (800 Metres)
<p>BRIX (A Goindasamy) – Lost its footing jumping away dislodging rider A Goindasamy who was uninjured.</p> <p>SOPHISTICARDO (T Harris) – Slow away.</p> <p>LUCYBELLE (T Thornton) – Inconvenienced approaching the 200 metres when placed in restricted room.</p>	
Race 2	AJC Marshall Stand – Conference Centre (1600 Metres)
<p>ULTIMATE ANGEL (C Burdan) – Slow away. Raced ungenerously for a distance passing the 1300 metres.</p> <p>IVERSON (M Cameron) – Slow away.</p> <p>ALWAYS ON TIME (S Weatherley) – Jumped away awkwardly.</p> <p>RISING STEPS (S Spratt) – Shifted away from LORD PAINTON approaching the 1400 metres making contact with RUSALKA which shifted away from that runner, contacting and hampering IL AFFARE.</p> <p>IL AFFARE (A Goindasamy) – Contacted and hampered approaching the 1400 metres losing ground.</p> <p>RUSALKA (T Thornton) – Raced three wide without cover.</p> <p>SPARKLING LADY (B May) – Raced wide throughout.</p> <p>DROPS OF JUPITER (T Harris) – Raced in restricted room approaching the 350 metres when attempting a marginal run then going off stride.</p> <p>LORD PAINTON (M McNab) – Made brief contact with RISING STEPS passing the 350 metres when both runners shifted ground.</p> <p>INCY WINCY SPIDER (E McCall) – Had difficulty obtaining clear running early in the final straight.</p> <p>B May (SPARKLING LADY) – Issued with a warning for his whip use.</p>	
Race 3	Next Trials at AJC 15th October (1600 Metres)
<p>FOODIE KING (M Hashizume) – Jumped away awkwardly making contact with SUMMER NIGHT which was forced on to the hindquarters of BEAUTIFULNIGHTMARE with FOODIE KING then being buffeted between runners for a distance. Steadied when in restricted room passing the 900 metres.</p> <p>SUMMER NIGHT (S Weatherley) – Contacted at leaving the barriers.</p> <p>BEAUTIFULNIGHTMARE (L Satherley) – Contacted at leaving the barriers.</p> <p>SENZABEEL (A Goindasamy) – Hampered when leaving the barriers.</p> <p>OSO SAVVY (D Johnson) – When questioned regarding the performance Rider D Johnson stated she had received an unfavourable run. A post-race veterinary examination did not reveal any obvious abnormalities.</p> <p>OUR MODENA (M Cameron) – When questioned regarding the improved performance the connections advised that the addition of blinkers as well as being ridden more positively today had been of benefit.</p>	

Race 4	Avondale Sunday Markets (1600 Metres)
<p>DELLE QUARTZA (J Kamaruddin) – Began awkwardly losing ground.</p> <p>JUTANUGARN (S Weatherley) – Began awkwardly.</p> <p>LIMENTIS (D Johnson) – Restrained from a wide barrier.</p> <p>ALL THE RAGE (B May) – Began awkwardly. Attempted to improve into a marginal run approaching the 250 metres racing in restricted room and hampered for a distance.</p> <p>B May (ALL THE RAGE) – Issued with a warning after pursuing a tight run to the inside of PRINCESS ORIGAMI with ALL THE RAGE being hampered for a distance.</p> <p>SYMPATHIQUE (L Satherley) – Raced wide without cover.</p> <p>SATRIANI (M Hashizume) – Held up until near the 250 metres. Disqualified from 3rd (rider weighed in light).</p> <p>Following the race, the siren was sounded after Rider M Hashizume (SATRIANI) weighed in 1kg under-weight. A request for a ruling was then sought by Stewards with the Judicial Committee disqualifying SATRIANI from 3rd position with the result now reading - LIMENTIS 1st, YOU'RE WELCOME 2nd, JUTANUGARN 3rd, ALL THE RAGE 4th.</p> <p>K Reuelu (Stable Foreman) – Admitted a breach in that he had omitted a towel when saddling SATRIANI and was fined \$800 by the Judicial Committee.</p>	
Race 5	AJC.CO.NZ (1200 Metres)
<p>TE NGAERE FALLS (M Kareem) – Slow away.</p> <p>ASPIRING (A Goindasamy) - Raced three wide without cover.</p> <p>CASH ME OUSSIDE (D Danis) – Restrained to obtain cover from near the 1000 metres.</p>
