PRESTIGIOUS LAD (J Riddell) – Trainer I Kennedy advised Stewards, he was satisfied with the post-race condition of the gelding and will continue on with PRESTIGIOUS LAD'S current preparation.

Race 3 BCD GROUP 2100

WORDSWORTH (L Innes) – Trainer M Falconer advised Stewards, that upon return to the stable, the gelding underwent a veterinary examination which revealed no abnormalities. M Falconer further advised it is now her intention to continue on with WORDSWORTH'S current preparation.

Race 5 LODGE XMAS RACEDAY 19/12 3YO

NO LIMITS (D Johnson) – Trainer J Richards reported, he was satisfied with the post-race condition of NO LIMITS, however, will now be sent for a spell.

Race 6 SKYCITY HAMILTON 1200

SHOWOROSES (D Johnson) – Trainer J Surgenor reported, SHOWOROSES pulled up lame in the right hind leg and will undergo a veterinary examination on Friday 9 October. J Surgenor will report back to Stewards with an update at the completion of the examination.

J Surgenor advised Stewards on Friday 9 October, SHOWOROSES underwent a veterinary examination which revealed no other abnormalities. J Surgenor further advised, SHOWOROSES will now partake in light track work over the next seven days with a further veterinary examination being completed on the mare at the end of next week.

RACE COMMENTS:

Race 1 COLCHESTER ENGINEERING LTD 1600

ROLL THE GOLD (T Newman) – Began awkwardly losing ground. Raced ungenerously in the early and middle stages.

QUANTUM (C Jones) – Slow away. Raced keenly in the early and middle stages, making contact with the running rail on a number of occasions. Steadied when placed in restricted room passing the 100 metres to the inside of TAMMIE WYNETTE (T Yanagida) which shifted in slightly. T Yanagida was advised to exercise care.

ENDEAN LASS (S Weatherley) – Slow away.

LUBAYA (J Riddell) – Slow away. Had some difficulty obtaining clear running throughout the final straight.

JAKAMA KRYSTAL (T Thornton) – Raced three wide without cover throughout.

M Kareem (SUPER HOOF) – Issued with a warning for weighing in 0.4 kg lighter than the weight at which he weighed out at.

Race 2 FAIRVIEW MOTORS MATAMATA 1400

NOT AN OPTION (D Johnson) – Slow away. Contacted and unbalanced near the 250 metres.

ROCKET SPADE (O Bosson) – Had to be steadied off heels passing the 1000 metres when the pace steadied. Contacted and unbalanced passing the 550 metres. When questioned regarding performance the rider advised that the colt had been unsuited by the muddling pace of the race.

FASHION SHOOT (J Kamaruddin) – Shifted out passing the 550 metres making firm contact with ROCKET SPADE. Held up entering the final straight before shifting out passing the 250 metres making contact with NOT AN OPTION. Was then held up until approaching the 100 metres.

A Calder (NO FILTER) – Was reminded of his obligations in that he must not ease the pace in the manner that he did passing the 1000 metres to the extent that it causes interference to trailing runners.

Race 3

MITRE 10 MATAMATA 1400

JAYDEEAR (L Satherley) - Slow away.

LOVINGYOURWORK (M Cameron) – Slow to begin then crowded shortly after.

NOWANAGEN (D Danis) – Began awkwardly. Raced keenly through the middle stages.

SHE SPEEDS (D Johnson) – Held up entering the final straight and shifted out passing the 250 metres making contact with EXTORTION, then shifted in passing the 200 metres to obtain clear running.

EXTORTION (S Weatherley) – Contacted and unbalanced passing the 250 metres.

MI SKY (T Thornton) – Contacted and forced wider passing the 250 metres.

M Cameron (LOVINGYOURWORK) – Issued with a warning for allowing his mount to shift out passing the 250 metres making contact with MI SKY which was forced wider.

FIVE SCHILLINGS (A Calder) – Had to be firmly restrained after improving on to the heels of KATY POWER which shifted out passing the 150 metres. Also contributing to the incident was inward movement from MASTER OAKLEIGH.

S Weatherley (EXTORTION) – Was spoken to regarding his whip use prior to the 100 metres.

Race 4

LUMINATEONE 1200

SPLASH OF RED (A Goindasamy) – Slow away. Made the bend awkwardly near the 800 metres when racing ungenerously.

VALYRIAN (L Satherley) – Slow to begin.

BABY CHEESES (A Calder) – Hampered shortly after the start losing ground.

STELLA ECLIPSE (D Danis) – Raced keenly when being restrained in the early stages.

ONEROA (M Cameron) – Raced greenly through the middle stages.

HENRY JAMES (J Riddell) – Raced three wide without cover throughout.

CALLIOPE (D Johnson) – When questioned regarding performance the rider advised that in her opinion the filly would be better suited to a step-up in distance.

Race 5

COMAG LTD 1200

O Bosson (TOP BRASS) – Admitted a charge in that he attempted to weigh-out without wearing a body protector. After hearing submissions the Judicial Committee imposed a fine of \$500.

HIGH ACHIEVER (A Goindasamy) – Began awkwardly losing ground.

WOODCOTE LASS (M Kareem) – Began awkwardly losing ground.

TOP BRASS (O Bosson) – Crowded shortly after the start losing ground. Commenced to over-race passing the 1000 metres having to shift outwards off heels approaching the 900 metres, then raced three wide without cover. Lay out rounding the final bend and when placed under pressure entering the final straight ran wide. Then continued to lay out for the remainder of the race with the rider being unable to ride the gelding out for the remainder of the race.

Lost the left hind plate. A post-race veterinary examination could find no obvious abnormality. The connections were advised that the gelding would be required to barrier trial left-handed prior to racing left-handed again.

MANNIE'S POWER (T Thornton) – Raced wide throughout.

MANRICO (T Newman) – Raced wide without cover throughout.

RAPOSA RAPIDA (D Danis) – Held up until near the 200 metres.

Race 6 MATAMATA VETERINARY SERVICES LTD 1400

RUBY NEGRONI (J Kamaruddin) – Slow away.

THE HELIX (S Weatherley) – Slow away.

LIGHT BROCADE (A Calder) – Began awkwardly losing ground. Forced wider passing the 600 metres.

DRAKE BAY (J Riddell) – Restrained from its wide barrier.

LADY LIRA (M Cameron) – Steadied off heels passing the 950 metres. Forced wider passing the 600 metres.

HEAR MY VOICE (L Satherley) – Over-raced in the middle stages.

HEART OF THE OCEAN (O Bosson) – Raced three wide without cover throughout. Steadied to avoid heels approaching the 100 metres.

THUNDER (M Kareem) – Shifted outwards abruptly passing the 600 metres forcing LADY LIRA and LIGHT BROCADE wider.

CAITHNESS KID (T Yanagida) – Unable to obtain clear running throughout the final straight.

A Goindasamy (SHE'S APPLES) – Issued with a warning for allowing his mount to shift out approaching the 100 metres with HEART OF THE OCEAN having to be steadied.

Race 7 TEAM WEALLEANS MATAMATA CUP (1400 Metres)

HAY TIGER (D Danis) – Slow away.

CUTTING UP ROUGH (A Goindasamy) – Slow away.

NEW YORK JAZZ (T Newman) – Knuckled on jumping away.

OUR ALLEY CAT (T Thornton) – Checked passing the 1050 metres. Held up entering the final straight before improving into a marginal run passing the 200 metres.

POP STAR PRINCESS (L Satherley) – Steadied passing the 200 metres when placed in restricted room between OUR ALLEY CAT which improved into a marginal run to its inside and SUNBURST which was forced inwards slightly by NEW YORK JAZZ. Underwent a post-race veterinary examination which did not reveal any abnormality.

LAVAGLO (S Weatherley) – Had difficulty obtaining clear running early in the final straight.

CRAFTY JESS (M Cameron) – Improved on to heels approaching the 100 metres before shifting outwards in an attempt to improve.

M Hashizume (RONCHI) – Defended a charge of careless riding in that he permitted his mount to shift in near the 1050 metres when not sufficiently clear of BURGUNDY BELLE which was dictated into the line of OUR ALLEY CAT which was checked. After hearing submissions the Judicial Committee found the charge proven and suspended his license to ride in races from the conclusion of racing on the 23 October, up to and including racing on 1 November, 7 national riding days.

Race 8 RUSSELL & YVONNE GREEN MEMORIAL (2000 Metres)

FELAAR (M Cameron) – Began awkwardly.

OBSESSIVE (J Riddell) – Began awkwardly losing ground.

DE KONING (T Thornton) – Slow away. Raced wide in the early stages before improving forward to lead near the 1000 metres. Shifted outwards abruptly just prior to the winning post inconveniencing THE GOOD FIGHT.

LINCOLN KING (D Johnson) – Crowded shortly after the start losing ground.

LADY SHABEEL (A Goindasamy) – Crowded shortly after the start.

THE GOOD FIGHT (S Weatherley) – Inconvenienced just prior to the winning post.

STEVEN JAMES (L Satherley) – When questioned regarding performance the rider could offer no excuse. Underwent a post-race veterinary examination which did not reveal any abnormality.

Authorization of payment was withheld until the connections of THE GOOD FIGHT had viewed video footage before electing not to proceed with a protest.

Race 9 CELEBRATING MELODY BELLE (2000 Metres)

OUR CRAFTSMAN (A Goindasamy) – Slow away. When questioned regarding performance the rider advised that the gelding had been unsuited by the tempo of the race.

ZENNTARI (S Weatherley) – Slow away.

KAJINO (T Yanagida) - Contacted shortly after the start when OHTHOSERUSSIANS shifted out.

CAPELLANI (B May) – Raced wide without cover from near the 900 metres.

A Calder (CORUBA JAK) – Was spoken to regarding his whip use in consecutive strides.

REACT (T Newman) – Briefly held up entering the final straight.

CORUBA JACK (A Calder) - Briefly held up entering the final straight.
