Race 7 TEAM WEALLEANS MATAMATA CUP (1400 Metres)

**POP STAR PRINCESS** (L Satherley) – Trainer F Cornege advised Stewards POP STAR PRINCESS pulled up lame in the near fore hind and has now been sent for a spell.

#### **RACE COMMENTS:**

#### Race 1 CHRISTMAS AT THE RACES BOOK NOW 1200

**CHANDLER** (J Riddell) – Was fractious in the barrier rearing over backwards. Underwent a pre-race veterinary examination and was late scratched at 11.40 am. The connections were advised that the gelding would be required to barrier trial to the satisfaction of Stewards prior to racing next. J Riddell was examined by the on course Ambulance personnel and stood down from his ride in race two. Underwent a further medical examination being cleared to fulfil his remaining rides.

**CARLITO** (T Yanagida) – Began awkwardly. Underwent a post-race veterinary examination which revealed the gelding to have a delayed recovery rate.

ACQUITTAL (T Thornton) – Slow away.

**RED STAR** (B May) – Hampered shortly after the start losing ground.

**GOSPODIN** (C Grylls) – Raced greenly when placed under pressure in the final straight having a tendency to lay inwards.

LIONIZE (M McNab) – Improved on to heels passing the 200 metres having to be steadied.

#### Race 2 GARTSHORE CONSTRUCTION 1200

BRIAN LAMONT (D Danis) – Began awkwardly. Commenced to over-race in the early and middle stages.

MISTRESS MINX (C Burdan) - Began awkwardly losing ground.

**OCEAN CRUIZER** (C Grylls) – Hampered shortly after the start losing ground. Raced wide without cover throughout. Inconvenienced passing the 50 metres.

**CUTTING EDGE** (M McNab) – Raced three wide without cover. Hampered passing the 50 metres.

**CHOPPER REED** (S Spratt) – Shifted out abruptly before being corrected by its rider passing the 50 metres hampering CUTTING EDGE and inconveniencing OCEAN CRUIZER and SAINTE ELISABETH.

**SAINTE ELISABETH** (T Yanagida) – Inconvenienced passing the 50 metres.

## Race 3 WAIKATO BRANCH NZ FARRIERS ASSOCIATION 1400

**GRAND SPIRIT** (T Yanagida) – Began awkwardly losing ground.

**LOFTY** (C Burdan) – Slow to begin. Improved on to heels passing the 50 metres having to be firmly restrained.

**TONY BE** (S Weatherley) – Slow to begin.

**UNCLE TERRY** (J Riddell) – Slow to begin.

**RED HUSSAR** (C Ormsby) – Improved into a marginal run passing the 400 metres making contact with runners on either side. Hampered passing the 50 metres.

**STAR RISE** (T Thornton) – Held up for a distance passing the 200 metres.

**CHAMPAGNE PRINCESS** (L Satherley) – Inconvenienced passing the 50 metres.

A protest was lodged by the second placed RED HUSSAR alleging interference from the first placed SWEET HUNTER in the final straight near the 50 metres. After hearing submissions the Judicial Committee upheld the protest with the final placings now reading 1 RED HUSSAR first, 13 SWEET HUNTER second, 14 ZEE FALLS third and 8 CHAMPAGNE PRINCESS fourth.

The connections of the fourth placed CHAMPAGNE PRINCESS also viewed video footage alleging interference from the first placed SWEET HUNTER before electing not to proceed with a protest.

A Goindasamy (SWEET HUNTER) – Admitted a charge of careless riding in that he allowed his mount to shift out when not sufficiently clear passing the 50 metres hampering RED HUSSAR. After hearing submissions the Judicial Committee suspended A Goindasamy's licence to ride in races from the conclusion of racing on 21 October up to and including 29 October, 6 national riding days.

## Race 4 JEREMY PRYOR SOTHEBY'S 1400

**SAHALAINN** (T Harris) – Began awkwardly losing ground.

**PRIMO STELLA** (A Calder) – Slow away.

**SECRET AMOUR** (C Burdan) – Knuckled shortly after the start.

**ROCK HARD REX** (L Satherley) – Raced keenly in the early stages.

**SILVERSTREAM** (C Jones) – Raced in restricted room for a distance passing the 700 metres.

**C Ormsby** (EL BANDOLERO) – Issued with a warning for allowing his mount to shift in passing the 700 metres placing SILVERSTREAM in restricted room.

**C Burdan** (SECRET AMOUR) – Was questioned regarding her lack of vigour displayed between the 500 and 400 metres. Miss Burdan explained that passing the 600 metres SAHALAINN had improved from her inside to a position outside her and she had been reluctant to improve her mount given the positioning of that runner, however agreed with Stewards that once that runner had cleared her she had erred in her judgement not to attempt to improve her mount's position forward. Miss Burdan's explanation was noted.

**NOZI CYCLONE** (M Cameron) – When questioned regarding performance the rider advised that the colt had raced keenly and hung throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

#### Race 5 BETAVET 1300

MAKABAR (R Beemud) – Slow away.

**LUM REEK** (A Goindasamy) – Slow to begin, then crowded shortly after.

MIGHTY ASLAN (S Spratt) – Crowded shortly after the start losing ground when BOLT FROM THE BLUE shifted in.

**SO MUCH MOUR** (C Ormsby) – Clipped heels and blundered shortly after the start.

**BOLT FROM THE BLUE** (A Calder) – Raced three wide without cover throughout.

#### Race 6 AZTECH SIGNS 1200

**MELODIOUS** (A Goindasamy) – Slow away.

THE BELVOIR (C Ormsby) – Slow away. Improved on to heels passing the 200 metres having to be steadied.

**HUGH GLASS** (T Yanagida) – Slow away.

**EDIT** (S Weatherley) – Knuckled shortly after the start losing ground. Shifted out passing the 400 metres making contact with KATHIES CHOICE with EDIT then laying out forcing KATHIES CHOICE wider.

**THE BOOGEYMAN** (D Danis) – Steadied when placed in restricted room between I'M CAPABLE which shifted out slightly when making the bend and STREET CAT (M Kareem) which shifted in when not fully clear near the 900 metres. M Kareem was advised to exercise care.

I'M CAPABLE (C Grylls) – Had difficulty obtaining clear running early in the final straight.

KATHIES CHOICE (C Burdan) – Contacted and forced wider passing the 400 metres.

LA VELOCITA (T Thornton) – Held up until passing the 150 metres.

**S Weatherley** (EDIT) – Issued with a warning for allowing his mount to shift out passing the 400 metres making contact with KATHIES CHOICE which was forced wider.

## Race 7 BOP HOSPITALITY NZ 1200

**EXUBERANT** (T Harris) – Slow away.

VICENZA (J Kamaruddin) – Restrained from its wide barrier. Held up over the concluding stages.

**MEKELLE** (M Cameron) – Raced ungenerously in the early and middle stages.

**FABULOUS FLIGHT** (C Burdan) – Over-raced in the early stages when being restrained.

**SAIGNON** (B May) – Held up entering the final straight. Raced in restricted room over the concluding stages.

**AERO DE PARIS** (C Grylls) – Travelled wide without cover. When questioned regarding performance the rider advised that the gelding would benefit from a more rain affected track.

## Race 8 NZB INSURANCE PEARL SERIES RACE

**JENNY KRAIG** (C Jones) – Late scratched at 3.40 pm after becoming fractious in the barrier and escaping under the front of the gates. The connections were advised that the mare would be required to barrier trial to the satisfaction of Stewards prior to racing next.

**RAIL QUEEN** (M Cameron) – Began awkwardly losing ground.

**HIBERNIA SEA** (T Yanagida) – Slow away.

**PENNY JANE** (T Newman) – Steadied when placed in restricted room over the concluding stages to the outside of HIBERNIA SEA (T Yanagida) which shifted ground.

**LES CRAYERES** (D Johnson) – Underwent a post-race veterinary examination which revealed the mare to be mildly lame in the right foreleg.

**T Yanagida** (HIBERNIA SEA) – Issued with a warning for allowing his mount to shift out when not sufficiently clear of PENNY JANE which had to be steadied over the concluding stages.

**N Bishara** (RUBYSHOWOFF) – Admitted a charge in that he presented RUBYSHOWOFF to race with the incorrect saddle cloth. After hearing submissions the Judicial Committee imposed a fine of \$50.

## Race 9 TEAM PRYOR SOTHEBY'S 2100

CAN'T FIND ONE (J Riddell) - Began awkwardly.

**LADY GWENDOLYN** (C Grylls) – Began awkwardly then crowded losing ground. Improved on to heels passing the 500 metres having to be steadied, then had difficulty obtaining clear running until passing the 350 metres.

**ISOLA SACRA** (S Spratt) – Began awkwardly.

**PATSYS LAD** (A Calder) – Slow away.

**SPARTAN WARRIOR** (M Kareem) – Restrained from its wide barrier. Became tailed off rounding the final bend, and was not persevered with in the straight. Underwent a post-race veterinary examination which did not reveal any abnormality. A warning was be placed on the colt for its performance.

**THE BOUNDER** (C Burdan) – Hampered shortly after the start losing ground. Raced ungenerously in the early stages.

**ALTAR GIRL** (C Dell) – Commenced to over-race in the early stages making the bend passing the 1800 metres awkwardly.

**JUDAH** (D Danis) – Made the first bend awkwardly when racing ungenerously.

**BLACK TECH** (L Satherley) – Raced keenly in the early and middle stages. Returned to the enclosure with blood present in one nostril. Underwent a post-race veterinary examination which revealed a laceration in the nostril.

**JUST AL** (T Thornton) – Raced in restricted room passing the 600 metres.

**GONE WEST** (O Bosson) – Forced outwards passing the 600 metres when placed in restricted room making contact with the hind quarters of CUBA which became momentarily unbalanced.

**CUBA** (S Weatherley) – Contacted and unbalanced passing the 600 metres.

**O Bosson** (GONE WEST) – Admitted a charge in that he used his whip excessively prior to the 100 metres. After hearing submissions the Judicial Committee suspended O Bosson's license to ride in races from the conclusion of racing on 21 October up to and including racing on 28 October, 5 national riding days.

#### Race 10 ULTIMATE MAZDA 2100

**REFLECTION** (A Goindasamy) – Slow away.

MOTUMAN (T Yanagida) – Slow away. Raced three wide without cover throughout.

MR INCREDIBULL (D Johnson) – Began awkwardly losing ground.

SIR AGLOVALE (M McNab) – Slow away.

**RAPIDZ** (C Dell) – Raced wide rounding the first bend.

**IFFRAAJINATOR** (S Spratt) – Had some difficulty obtaining clear running entering the final straight.

## Race 11 TAURANGA EVENT CENTRE VENUE HIRE 1600

WHEN IN PARIS (J Kamaruddin) – Began awkwardly.

DOHA (M McNab) - Began awkwardly. Travelled three wide without cover throughout.

**ELLE MCMASSEY** (A Calder) – Slow away.

**CLIQUE** (D Johnson) – Commenced to over-race when being steadied approaching the 1200 metres.

**LEICALOT** (S Weatherley) – Travelled wide without cover throughout.

**C Grylls** (C'EST LA GRIS) – Was spoken to regarding his whip use on a runner out of contention.

## Race 12 FOOD 101 MAIDEN (1600 Metres)

**CASTLE BLACK** (C Ormsby) – Slow away then hampered losing ground. Held up in the early stages of the final straight before shifting into a marginal run passing the 300 metres between VENI VICI which shifted out and DAWNED ON ME which shifted in.

**EAGLE HUNTER** (M McNab) – Slow away. Held up entering the final straight having to be steadied passing the 350 metres when placed in restricted room to the outside of JEAN PIERRE (A Calder) which shifted out when making the bend. A Calder was advised to exercise care.

**ROCCO** (L Satherley) – Began awkwardly losing ground.

**STRIKING** (T Yanagida) – Lay out passing the 1300 metres despite the efforts of its rider hampering LOUIS LE GRAND. Shifted out abruptly approaching the 350 metres making contact with VENI VICI which was forced wider forcing DAWNED ON ME out on to HEAPS which became unbalanced.

LOUIS LE GRAND (C Jones) – Hampered passing the 1300 metres.

**CATWALK GIRL** (S Weatherley) – Raced keenly in the early and middle stages.

**VENI VICI** (T Thornton) – Contacted and forced wider approaching the 350 metres.

**HEAPS** (C Dell) – Contacted and unbalanced approaching the 350 metres.

**DAWNED ON ME** (A Goindasamy) – Inconvenienced passing the 350 metres.

**COLIN OSCOPY** (T Harris) – Had difficulty obtaining clear running early in the final straight.
