Race 7 - Barneswood Farm Stakes (1400m)

An inquiry into the reasons for ZOLTAN (J Laking) falling and SHOWEMHOWITSDONE (B Murray) dislodging its rider near the 450 metres was concluded. J Laking stated that when travelling keenly he had been attempting to improve at that point of the race when racing tight to the inside of SHOWEMHOWITSDONE and in doing so had improved near the heels of MATCHMAKER (T Comignaghi) before striking a heel of that runner. Film footage of the incident was somewhat inconclusive but MATCHMAKER did appear to be laying outwards at that point shifting ground marginally. In the circumstances it was not felt that any rider had ridden carelessly and no further action was taken.

In coming to this decision Stewards took into account the racing manners of both LETHAL and SACRED CAGA.</p> <p>SHELOB (T Moseley) - Checked when crowded passing the 1100 metres.</p> <p>SACRED CAGA (S Wynne) - Hampered and forced wider passing the 1000 metres, held up early in the straight having to steady and angle outwards across heels to obtain clear running near the 200 metres, placed in restricted room over the concluding stages.</p> <p>TUSSOCK COUNTY (K Asano) - Had difficulty obtaining clear running until near the 200 metres.</p> | |

Slow to begin.</p> <p>LUX CUM AMORE (S MacNab) - Slow to begin, lay outwards rounding the bend and raced wide in the straight.</p> <p>QUARANTINA (C Barnes) - Raced wide throughout, contacted approaching the 400 metres.</p> <p>BODYGUARD (R Cuneen) - Made contact with QUARANTINA when placed in restricted room approaching the 400 metres.</p> <p>Following the race S Wynne (MOZZARELLA) advised that she was feeling unwell and after being attended to by St John Paramedics was stood down from her ride in Race 5. S Wynne was again examined following Race 5 and stood down for the remainder of the day.</p> | |

MONDORANI (K Asano) - Slow to begin, had difficulty obtaining clear running until near the 100 metres.

MADAM DE SOIR (C Burdan) - Slow to begin.

KING OF THE DANCE (T Jonker) - Slow to begin, over raced for a distance from the 1200 metres.

BABY MENAKA (T Comignaghi) - Crowded on jumping, held up rounding the final turn until near the 350 metres.

OCEANS AWAY (L Hemi) - Shifted outwards on jumping making contact with outside runner, crowded when weakening near the 400 metres.

OREPUKI LAD (J Lowry) - Bumped on jumping.

RIVIERA ROCK (S Wynne) - Raced wide in the early stages.

HILLERSDEN (S Macnab) - Over raced getting its head up for a distance passing the 2500 metres.

FANTASY FLIGHT (T Moseley) - Raced wide from the 1000 metres.

Trainer **M House** - Issued with a warning after presenting VANILLA MOON with incorrect gear.

TOO FERLAXED (K Asano) - Bounded as the start was effected losing ground.

ANYTHINGCOULDHAPPN (R Mudhoo) - Began awkwardly.

MAZZURO (T Moseley) - Began awkwardly, raced wide throughout.

VANILLA MOON (T Jonker) - Raced wide in the early stages.

L Hemi (VAINGLORY) - Issued with a warning for her whip use prior to the 100 metres.

KEEP QUIET - Following the race the gelding was found to have bled from both nostrils and is now subject to the mandatory two month stand down from training and three month stand down from trialling and racing, with a veterinary clearance required prior to doing so.

MARINE (K Chowdhoo) - Over raced in the early and middle stages, dictated wider rounding the final turn then came together with UNITION on a number of occasions, shifted inwards under pressure over the final 100 metres making contact with UNITION.

VITESSE BO (T Moseley) - Raced wide in the early stages, ran wide near the 700 metres when steadied to avoid the heels of SHOW BAZZ when that runner was dictated outwards by MARINE which shifted away from the running rail.

ELIZABETH ROSE (C Grylls) - Over raced for a distance near the 1100 metres.

UNITION (K Asano) - Lay out rounding the final turn dictating MARINE wider with UNITION and MARINE then coming together on a number of occasions, contacted by MARINE and forced inwards approaching the 100 metres continuing to be dictated inwards over the final 100 metres. The rider of the 3rd placed UNITION lodged a protest against the 2nd placed MARINE alleging interference over the concluding stages. After viewing films and hearing submissions the Judicial Committee dismissed the protest.

K Chowdhoory (MARINE) - Issued with a warning after permitting his mount to shift inwards under pressure near the 100 metres making contact with UNITION. K Chowdhoory was also spoken to regarding his whip action over the concluding stages.

FASHION SHOOT (C Burdan) - Lay outwards abruptly shifting wider on the track near the 500 metres.

SHOW BAZZ (R Cuneen) - Required veterinary attention post race when found to be 2/5 lame in the right hind leg with a veterinary clearance now required prior to racing next.

BENEFICIAL (T Moseley) - Crowded at the start, held up in the early stages of the straight having to shift ground inwards passing the 250 metres to obtain clear running.

QUINTUPLE TWINS (T Comignaghi) - Crowded at the start, over raced in the early stages.

KARALINO (C Grylls) - Shifted ground inwards at the start crowding inside runners, when attempting a tight run near the 350 metres was crowded by I AM A ROCK which lay out, I AM A ROCK continued to lay out away from UPPER HAND further crowding KARALINO resulting in AUGUSTACE being hampered passing the 200 metres.

AGE OF FIRE (C Burdan) - Crowded shortly after the start.

CARSON RIVER (K Chowdhoory) - Raced wide throughout.

REMINGTON (R Mudhoo) - Raced three wide without cover throughout.

TOBILICIOUS (K Asano) - Raced wide throughout, raced in restricted room when REMINGTON lay out near the 200 metres.

AUGUSTACE (L Hemi) - Hampered passing the 200 metres.

WILLIAM WALLACE (S MacNab) - Restrained to obtain cover after jumping from the outside barrier.

DIORISSIMO (A Balloo) - Slow to begin.

THE GROWLER (R Mudhoo) - Crowded shortly after the start, over raced in the middle stages and hampered near the 1300 metres when becoming awkwardly placed inside the heels of FIVE PRINCES.

NOMEN LUDI (T Moseley) - Over raced in the early stages, had to be steadied when crossed by WHO DARES WINS shortly after the start and then commenced to race fiercely continuing to do so through the middle stages proving a difficult ride.

J Lowry (WHO DARES WINS) - Issued with a warning after permitting his mount to shift inwards shortly after the start when not fully clear of NOMEN LUDI.

RAISE YOU TEN (C Barnes) - Raced wide in the early stages.

FIVE PRINCES (G Jogoo) - Raced ungenerously when being restrained passing the 1400 metres going back onto THE GROWLER which was hampered.

ZENTESSA (B Murray) - Over raced passing the 1400 metres.

CAMINO ROCOSO (T Comignaghi) - Lay out in the final straight.

T Jonker (DEE AND GEE) - Questioned regarding her ride after allowing OWEN PATRICK and WHO DARES WINS to improve to her inside rounding the final turn which resulted in her mount being placed in restricted room along with her apparent lack of vigour at that point of the race and early in the straight. T Jonker advised that DEE AND GEE had not felt to be travelling well at the time and in her opinion would be better suited to some easing of the ground. The explanation of Miss Jonker was noted but she was reprimanded and advised that in future she would be expected to ride her mounts in a manner which is not left open to query.

SANCTIFY (K Asano) - Slow to begin.

JOJO ROXX (C Grylls) - Slow to begin.

QUEEN JETSUN (C Campbell) - Raced wide without cover throughout.

VERMONT (B Murray) - Raced wide with cover throughout, checked when crowded near the 400 metres.

K Mudhoo (BELINDABELLA) - Admitted a charge of careless riding in that he allowed his mount to shift outwards when not sufficiently clear of VERMONT which was checked approaching the 400 metres, with the Judicial Committee suspending his licence to ride at race meetings for 5 national days effective from the conclusion of racing on Monday 26 October up to and including Wednesday 4 November.

R Cuneen (CLOONEY) - Admitted a charge of careless riding in that he angled his mount outwards when not sufficiently clear crowding SULU SEA onto LEITRIM LAD and BLACKBOOK which were all buffeted and unbalanced approaching the 400 metres, with the Judicial Committee suspending his licence to ride at race meetings for 6 national days effective from the conclusion of racing on Monday 26 October up to and including Thursday 5 November.

SULU SEA (K Chowdoory) - Buffeted and unbalanced when crowded near the 400 metres.

LEITRIM LAD (L Callaway) - Buffeted and unbalanced when crowded near the 400 metres.

BLACKBOOK (J Lowry) - Buffeted and badly unbalanced when crowded near the 400 metres.

SURE IS (T Comignaghi) - Raced in restricted room near the 250 metres when having to shift ground to obtain clear running.
