RACE COMMENTS:

Race 1 FEILDING HOTEL 2YO (1000 Metres)

STORMCAST (J Parkes) - Slow to begin then commenced to over-race, having to be steadied for some distance going into and around the first turn .Shifted out near the 600 metres tightening BRIX.

STORMY (L Allpress) - Raced three wide without cover throughout.

MY TARNZ GIRL (R Bishop) - Raced wide throughout.

Race 2 POWER FARMING 1200 (1200 Metres)

CABOCHON (T Bau) - Began awkwardly and when being corrected shifted out simultaneously as TELLYAWHAT shifted in, resulting in CELTIC WONDER and EXCELLERATION being tightened.

CELTIC WONDER (B Ansell) – Tightened start. Held up throughout the home straight.

EXCELLERATION (H Schofer) – Tightened start.

TELLYAWHAT (A Mudhoo) - When questioned into the run, A Mudhoo advised that after racing keenly in a three-wide position the gelding had little left at the finish. A Mudhoo was shown footage of his ride in the presence of the riding master after he allowed his mount to shift in near the 1000 metres tightening FLORAL BELT and BOUNDTOBEHONORED. Stewards took into account outward movement from RHAPSODY IN BLUE when assessing the interference.

BOUNDTOBEHONORED (L Allpress) – Tightened 1000 metres.

FLORAL BELT (T Taiaroa) – Tightened 1000 metres.

CASAQUINMAN (C Johnson) - Held up rounding the turn.

B Ansell (CELTIC WONDER) – Was shown footage of her ride in the presence of the riding master and issued with a warning under Rule 638(1)(d) for attempting to improve into a run where there was insufficient room to do so on a number of occasions in the final straight.

BADEA (D Johnson) – When questioned into the run of BADEA, D Johnson had no excuse.

Race 3 COURTESY FORD RED CRAZE BOWL (1300 Metres)

LONDON EXPRESS (S O'Malley) - Began awkwardly shifting in bumping JUST FABULOUS.

JUST FABULOUS (T Taiaroa) - Bumped start.

SINARAHMA (H Schofer) – Slow away.

STAR OF BOMBAY (D Johnson) - Held up early in the home straight and unable to improve into a narrow run near the 250 metres.

Race 4 PROPERTY BROKERS FEILDING MAIDEN 1400 (1400 Metres)

LA STRATA – Late scratching at 1.23pm on veterinary advice after receiving a cut to a nostril in the tie up stall area.

ELEGANT CHARM (J Parkes) – Slow away.

INDY FOX (T Taiaroa) – Shifted out abruptly at the junction onto the course proper and tightened VICTOREM, KALUANUI and FAVOLOSO.

VICTOREM (L Allpress) – Tightened 1300 metres.

KALUANUI (L Hemi) – Tightened 1300 metres. Had difficulty obtaining a run early in the home straight.

FAVOLOSO – (R Bishop) - Tightened 1300 metres.

SASHA (S Macnab) - Slow away.

MISTEREX (S O'Malley) - Jumped inwards and bumped with FAVOLOSO at the start.

BUDDY MARVELLOUS (D Hirini) - Unable to obtain clear running for the majority of the home straight

THE BLIKSEM (A Mudhoo) - Raced in restricted room over the final 100 metres when there was insufficient room to improve.

CHARMS STAR (S Wynne) - Unable to obtain clear running early in the home straight until being angled outwards near the 100 metres in order to improve.

When questioned into the disappointing run of **ELEGANT CHARM**, J Parkes was of the opinion the mare may have tied up, which was subsequently confirmed by the trainer.

Race 5 RATANUI DEVELOPMENT COMPANY 1400 (1400 Metres)

FREE TO SHINE – Late scratching at 2.17pm on farrier advice after dislodging a plate and standing on a nail.

MY FATHERS GUN (S McKay) - Tailed off in the early stages. S McKay could offer no excuse other than suggesting the gelding may be suited to a better track.

DU'BLUES (M Sanson) - Raced wide without cover.

GLAMOUR (S Macnab) - Raced keenly near the 800 metres.

RED JAKKAL (D Bradley) - Had difficulty obtaining clear running in the home straight until over the final stages.

SOLA POWER (L Allpress) – When questioned into the run of SOLA POWER, L Allpress was of the opinion the gelding may be better suited to firmer track conditions.

S Weatherley (NAVAL FLEET) – Issued with a warning under Rule 638(3)(b)(ii) for the use of his whip prior to the 100 metres.

When questioned into the run of **ON SHOW**, R Bishop reported other than the mare racing keenly in the early and middle stages, had no excuse.

Race 6 PGG WRIGHTSON 1600 (1600 Metres)

NEVERSTOPLAUGHING (D Hirini) — Put its head down simultaneously as its gate opened and then reared becoming awkwardly away and settling well back.

DUBAI'S MOKO (R Bishop) - Had to be steadied near the 400 metres when HINEPARA (D Bradley) improved to its inside. Stewards took into account simultaneous outward movement from THE HELIX when assessing the interference. A short distance further HINEPARA (D Bradley) shifted out and away from THE HELIX and crowded BELLESGIRL and FATTORE OTTO.

BELLESGIRL (S Weatherley) – Crowded 350 metres. A post-race veterinary examination did not reveal any obvious abnormality. When questioned into the run of BELLESGIRL, S Weatherley was of the opinion his mount may now be better suited to a longer distance.

FATTORE OTTO (S O'Malley) – Crowded 350 metres.

Race 7 TRICKLEBANKS 2200 (2200 Metres)

Due to a miscommunication S McKay was mistakenly declared to ride DELUXE EDITION. DELUXE EDITION was ridden by R Aukett.

FINAL SUGGESTION (L Allpress) – Finished mid field. When questioned, L Allpress could offer no excuse.

OBRIGADO (S O'Malley) – When questioned into the run of OBRIGADO, trainer M Breslin was of the opinion the gelding may be feeling the effects of recent racing.

D Johnson (TIRO) – Issued with a warning under Rule 638(3)(b)(ii) for her whip use prior to the 100 metres.

S Wynne (LONDONDERRY AIR) - Issued with a warning under Rule 638(3)(b)(ii) for her whip use prior to the 100 metres.

AVE MARIA (S Macnab) - Briefly held up near the 200 metres.

Race 8 RICOH FEILDING GOLD CUP (2100 Metres)

HIGH QUALITY (S McKay) - Slow away from its wide draw.

HI I'M NIKKITA (T Allan) - Raced wide early.

C Johnson was given permission to ride LUBAYA 1kg overweight in the day's leading up to the meeting but managed to make book weight (53kg) on the day.

Race 9 IAN HUMPHREY MOTORS & HUMPHREY FAMILY 1600 (1600 Metres)

MERCY HILL (L Hemi) – Late scratching at 5.09pm on veterinary advice after being kicked behind the starting stalls.

MEILA REI (S McKay) – Tightened and buffeted shortly after the start when there was movement from runners either side.

WHATSUP (D Bradley) - Raced wide early.

UAREASTAR (L Allpress) – Tightened when attempting a narrow run near the 200 metres and bumped with ORIGINAL GANGSTER and BONNY EZRA for some distance.

Inconvenienced final stages and had to shift ground to the inside of AROMATIC to improve.

BONNY EZRA (J Parkes) – Bumped 200 metres. Hampered final stages.

D Johnson (AROMATIC) – Was issued with a warning under Rule 638(1)(d) for allowing her mount to shift out over the final stages inconveniencing UAREASTAR and hampering BONNY EZRA near the finish.

Connections of **UAREASTAR** (3rd) and **BONNY EZRA** (4th) viewed video footage of final stages but elected not to proceed with an objection against the winner.

ORIGINAL GANGSTER (S Wynne) – Bumped 200 metres.
