## GENERAL:

Rider **M Cameron** did not attend the meeting due to an injury and is to provide a medical certificate before racing next.

#### RACE COMMENTS:

Race 1 Blue Bubble Taxis 2100

**RENEGADE FIGHTER** (E McCall) – Slow away.

**JUST TREASURE** (S Weatherley) – Crowded shortly after the start having to be steadied.

**SIR AGLOVALE** (M McNab) – Crowded shortly after the start having to be steadied.

**OUR CRAFTSMAN** (S Collett) – Slow away. When questioned regarding the performance Rider S Collett advised that the gelding had become disinterested in a fast run race and may prefer some easing of the ground.

**MARBUZET** (T Thornton) – Had to steady when crowded for room passing the 250 metres.

**TURRET** (T Newman) – Shifted out under pressure from near the 300 metres with WHEAO (M Kareem) shifting away from that runner crowding MARBUZET near the 250 metres which had to steady. Apprentice Riders T Newman and M Kareem were both reprimanded and advised they must exercise greater care.

**WHEAO** (M Kareem) – Received veterinary attention following the race for a superficial laceration to the left hind fetlock.

Race 2 Auckland Co-op Taxis 1400

**VOLITIVO** (T Thornton) – Crowded shortly after the start having to be steadied.

SECRET AMOUR (O Bosson) - Crowded shortly after the start having to be steadied.

**BEAUNE** (L Allpress) – Steadied when placed in restricted room shortly after the start.

**DAWNTING** (T Harris) – Crowded shortly after the start having to be steadied. Shifted out to obtain clear running passing the 500 metres forcing SHIBUYA KOSATEN wider on the track.

SHIBUYA KOSATEN (C Grylls) – Forced wide 500 metres.

**IMPERIAL STAR** (V Colgan) – Raced keenly through the middle stages.

**THE GREEN GREMLIN** (M Hashizume) – Lost the off hind plate during the running.

Race 3 Dunstan Feeds 1400

**ZOULANDER** (A Goindasamy) – Slow to begin. Improved on to heels approaching the 200 metres and then held up shifting out gaining clear running near the 100 metres.

KYLO REN (S Weatherley) – Hampered shortly after the start.

**GEE CEE** (M McNab) – Hampered shortly after the start. Had difficulty obtaining clear running until approaching the 300 metres.

**SPLASH OF RED** (V Colgan) – Raced keenly in the early stages.

**ARANCIA** (T Thornton) – Raced keenly in the early and middle stages. Commenced to race ungenerously when being restrained passing the 800 metres improving on to heels and then being hampered as a result. Steadied when well back approaching the 100 metres when improving on to the heels of KYLO REN which shifted in.

**EVER SO EASY** (C Grylls) – Had difficulty obtaining clear running until approaching the 200 metres.

**FLAVIUS** (L Innes) – When questioned regarding the performance Rider L Innes advised that the gelding had felt a little indifferent in its action and would benefit from some easing of the ground, further explaining he believed that the gelding had got its tongue over the bit. A post-race veterinary examination could find no obvious abnormalities.

## Race 4 Carbine Club Trophy (1400 metres)

**MONGOLIANCONQUEROR** (D Johnson) – Restrained to obtain cover in the early stages.

DAWN PATROL (J Riddell) - Raced keenly in the early to middle stages.

**MONACO** (T Newman) – Raced wide without cover.

**JUSTACANTA** (A Goindasamy) – Had difficulty obtaining clear running until shifting out approaching the 200 metres making brief contact with ALIGNS WITH ME which was dictated wider on the track.

ALIGNS WITH ME (C Burdan) – Briefly contacted and dictated wider 200 metres.

**GINO SEVERINI** (M Hashizume) – Lost the right front plate during the running.

**YEARN** (T Harris) – When questioned regarding the performance the rider advised that the mare had hung around the bend and the weight it had to carry possibly contributed to the mare's performance.

# Race 5Powersafe Electrical Wholesalers 1200

MASQUE (R Elliot) – Restrained from its wide barrier.

A PROPER LADY (L Innes) – Began awkwardly.

LIVE FOR YOUR LOVE (S Collett) – Began awkwardly and then crowded and hampered.

**THREE SIXTY** (D Johnson) – Slow to begin. Hampered 1050 metres.

**POWERFUL MOSS** (O Bosson) – Crowded and checked 1050 metres losing ground when racing in restricted room to the inside of MANRICO which had PLUTON improving to its outside. With the reduction in judicial camera angles available and accordingly no head-on view of the 1200 metre start film footage was inconclusive.

MANRICO (Y Coonee) – Raced wide without cover for the majority of the race.

**THE DOM** (A Calder) – Raced three wide without cover throughout.

**CHEEKY BEE** (C Burdan) – Contacted approaching the 400 metres when forced wider by A PROPER LADY (L Innes) which shifted out when looking to obtain clear running. L Innes was advised to exercise greater care in a similar circumstance. As a result CHEEKY BEE then became awkwardly placed on heels approaching the 300 metres and was steadied.

**LOOKSEASY** (D Danis) – Shifted out under pressure approaching the 300 metres making contact with PLUTON near the 200 metres, continuing to shift out again making contact with PLUTON several times inside the final 100 metres impeding that runner for a distance. Relegated from 1<sup>st</sup> to 2<sup>nd</sup>.

**PLUTON** (C Ormsby) – Dictated out from near the 300 metres being contacted near the 200 metres and again several times inside the final 100 metres. Promoted from 2<sup>nd</sup> to 1<sup>st</sup>.

**D** Danis – Admitted a breach of careless riding in that he allowed LOOKSEASY to shift out from near the 300 metres when not sufficiently clear of PLUTON which was impeded for a distance. After considering submissions the Judicial Committee suspended his license to ride in races from the conclusion of racing on 10 November up to and including racing on 18 November, 6 national riding days.

Following the race, the connections of the 2<sup>nd</sup> placed horse PLUTON lodged a protest against the 1<sup>st</sup> placed horse LOOKSEASY alleging interference in the final straight. After considering submissions the Judicial Committee upheld the protest with placings now reading PLUTON 1<sup>st</sup>, LOOKSEASY 2<sup>nd</sup>, A PROPER LADY 3<sup>rd</sup> and HIGHLAND DANCER 4<sup>th</sup>.

**PROJECT** (E McCall) – Slow to begin.

**ACUTUS** (D Danis) – Restrained from its wide barrier.

PACKING ROCKSTAR (O Bosson) - Over-raced in the middle stages.

**MEGEVE** (A Goindasamy) – Contacted approaching the 350 metres becoming unbalanced by FAMILIA which shifted out when looking to obtain clear running.

JE SUIS TIGER (J Fawcett) – Had difficulty obtaining clear running until passing the 200 metres.

QUICK PREVIEW (C Grylls) – Steadied after improving on to heels passing the 100 metres.

VIRTUOSO LAD (T Harris) – Denied clear running over the concluding stages.

**MUMMS JEWEL** (M Hashizume) – Raced three wide without cover throughout.

# Race 7 Jarden Stakes (2000 metres)

**ORAKEI OVERLORD** (S Weatherley) – Knuckled soon after leaving the barriers.

**DE KONING** (L Satherley) – Slow to begin.

BLUE BREEZE (M McNab) – Slow to begin.

**POKER FACE** (T Harris) – Restrained from a wide barrier. Eased down from near the 300 metres. Returned to the weigh-in enclosure with blood present in both nostrils and after undergoing a veterinary examination was deemed to have bled and also found to have suffered cardiac arrhythmia. POKER FACE is now subject to a 3 month stand down from trialling or racing and a 2 month stand down from track work with a veterinary clearance also being required before racing or trialling again.

**MY GIFT** (T Thornton) – Raced in restricted room near the 1800 metres and steadied to the inside of ROGER THAT which was dictated in slightly by ON THE ROCKS (C Ormsby). C Ormsby was advised to exercise care in a similar circumstance. Raced wide until improving to sit outside the leader near the 1000 metres.

**ROGER THAT** (S Collett) – Raced in restricted room near the 1750 metres and steadied.

**VADAVAR** (O Bosson) – Held up early in the final straight then denied clear racing room near the 300 metres when shifting out and made contact with SULTAN OF SWING near the 300 metres. O Bosson was advised to exercise care in a similar circumstance. VADAVAR continued to be held up until shifting in abruptly near the 175 metres to obtain clear running.

SULTAN OF SWING (J Riddell) – Contacted and unbalanced 300 metres.

**CHARLES ROAD** (C Grylls) – Rider C Grylls was reminded of his obligations in that he must ride his horses out to the end of the race when circumstances permit him to do so.

Race 8 Platinum & Plug Digital 1600

**G Hennessy** – Trainer G Hennessy was issued with a warning after presenting ROLL THE GOLD to race without notified gear (side winkers).

**HASABRO** (L Innes) – Underwent a pre-race veterinary examination and was cleared to start after rearing over in the tie-up stalls. Received veterinary attention after being galloped on during the running.

**LE SABLIER** (S Weatherley) – Slow to begin. Held up when improving on to heels near the 200 metres. Crowded and steadied near the 100 metres.

A Goindasamy (MAKE TIME) – Issued with a warning after permitting MAKE time to shift in near the 100 metres when insufficiently clear of LE SABLIER which was crowded and steadied.

CHA SIU BAO (M Hashizume) - Slow to begin. Held up early in the final straight.

**COUTURIERE** (D Johnson) – Restrained from its wide barrier. Raced ungenerously through the middle stages. Rider D Johnson advised that the mare was not suited by the slow tempo of the race.

**MASTER PAINTON** (O Bosson – Commenced to hang in the early stages and raced ungenerously for the majority of the race being eased down in the final straight. A post-race veterinary examination could find no obvious abnormalities.

**CIVILISED** (L Allpress) – Raced wide in the early to middle stages.

**MAKZABEEL** (M McNab) – Attempted to improve into a marginal run approaching the 100 metres then being crowded and steadied.

MAKE TIME (A Goindasamy) – Lost the front plate during the running.

Race 9 Chevalier Produce 1600

**FOODIE KING** (M Hashizume) – Crowded shortly after the start having to be steadied. Held up until shifting out approaching the 250 metres. Lost the off fore plate during the running.

**ELLE MCMASSEY** (A Calder) – Crowded shortly after the start having to be steadied.

**CASTLE BLACK** (T Thornton) – Began awkwardly losing ground. Lost the near front plate during the running.

**CATWALK GIRL** (D Johnson) – Began awkwardly. Hampered 1100 metres. Improved on to heels passing the 150 metres and then again became awkwardly placed on heels passing the 100 metres, obtaining clear running near the 50 metres.

**SEVEN AAJES** (C Grylls) – Raced in restricted room approaching the 1200 metres to the inside of TRIGON LAD and SAM'S SONG which was taken in slightly by DAWNED ON ME which lay in and away from EXTORTION. Restrained approaching the 1000 metres when in restricted room.

**CHAMPAGNE PRINCESS** (L Satherley) – Became awkwardly placed on heels near the 1100 metres being hampered, shifting back on to CATWALK GIRL which was also hampered.

**TRIGON LAD** (J Riddell) – Raced in restricted room 1100 metres and then raced ungenerously for a distance.

**EXTORTION** (S Weatherley) – Held up until approaching the 250 metres.

**ABU DHABI** (C Ormsby) – Briefly raced in restricted room passing the 100 metres between OPTIMUM SWEET which shifted out and FOODIE KING which lay in.

**RELIABULL** (S Collett) – When questioned regarding the performance Rider S Collett advised that in her opinion the gelding would benefit from a step up in distance.

Race 10 Barfoot & Thompson 1400

**LORD PAINTON** (O Bosson) – Steadied away from heels approaching the 1300 metres. Hampered 1200 metres by WAIMOKU FALLS which raced ungenerously and shifted out abruptly. Inconvenienced 350 metres when forced wider by WAIMOKU FALLS.

**PETRABELLA** (R Elliot) – Raced in restricted room passing the 1300 metres.

FIGHTING FIRE (D Johnson) – Crowded passing the 1300 metres.

**L Innes** (WAIMOKU FALLS) – Issued with a warning for permitting WAIMOKU FALLS to shift in near the 1300 metres crowding LORD PAINTON, PETRABELLA and FIGHTING FIRE.

**ROYAL CHARM** (C Ormsby) – Raced ungenerously in the early stages.

L Innes (WAIMOKU FALLS) – Issued with a warning after weighing in 0.9kg over the weight he weighed out.
