Race 7 HAUNUI FARM KARAKA CLASSIC (1600 Metres)

IN A TWINKLING (O Bosson) – Trainer J Richards advised Stewards, he was satisfied with the post-race condition of the gelding and it is his intention to continue on with IN A TWINKLING'S current preparation.

Race 8 FRANKLIN AUCTIONS 1600

LIVVY LASS (V Colgan) – Co-trainer P Gerrard advised Stewards, the stable was satisfied with the post-race condition of the mare and will continue on with her current preparation.

RACE COMMENTS:

Race 1	Avondale Sunday Markets (2100 metres)
<p>ZION HILL (M Kareem) – Began awkwardly losing ground.</p> <p>HAND OVER (T Yanagida) – Slow away. Raced ungenerously for a distance passing the 1600 metres. Faltered passing the 600 metres and was quickly pulled up by its rider and was immediately attended to by the Veterinarian. HAND OVER was humanely euthanased after being found to have suffered a shoulder injury. The rider advised that HAND OVER had been racing free of interference at the time but due to the reduction of judicial cameras available, particularly the turn camera situated near the 400 metres the coverage of the incident was inconclusive. The area of the track was inspected by the Stipendiary Stewards without any significant findings.</p> <p>KNOCK ON WOOD (T Thornton) – Over-reacted when being steadied and dropped back on to NAUTICAL MILE. Unable to find clear racing room in the final straight.</p> <p>RISING ROAD (A Calder) – Hung out around the final bend and when being corrected shifted in placing SHOCKING PENNY in restricted room near the 350 metres.</p> <p>GO BOBBY (A Goindasamy) – Held up rounding the bend into the final straight.</p> <p>NAUTICAL MILE (S Collett) - Held up until shifting outwards to obtain clear running near the 200 metres.</p>	
Race 2	Westbrook Vine & Wine Club (2100 metres)
<p>LANDGRAVE (O Bosson) – Raced in restricted room shortly after the start and was steadied.</p> <p>SHEBRINGSMERUBIES (S Collett) – Restrained shortly after leaving the barriers in an attempt to obtain cover.</p> <p>KAJINO (C Jones) – Commenced to hang out soon after leaving the barriers and continued to do so for the remainder of the race, running wide around the final bend and was not persevered with in the final straight. Trainer was advised that the gelding would have a warning placed against KAJINO for its racing manners.</p> <p>ANATOW (A Calder) – Held up on at least three occasions in the final straight.</p>	
Race 3	Wingate 3YO Mdn (1200 metres)
<p>TINA AGAIN (C Dell) – Was fractious in its barrier becoming cast. KIKI and SILENT ZONE which were in the adjacent barrier stalls were removed as well as TINA AGAIN to undergo veterinary examinations with TINA AGAIN declared a</p>	

late scratching at 1.07pm. TINA AGAIN is now required to barrier trial to the satisfaction of Stewards prior to racing again. Jockey C Dell was uninjured.

JIMMY FIVE (L Innes) – Began awkwardly then crowded.

TANGO TIME (J Fawcett) – Slow to begin.

RED STAR (B May) – Began awkwardly then crowded.

BOOMER HILL (M McNab) – Made the bend awkwardly approaching the 800 metres shifting out forcing JIMMY FIVE wider on the track and when being corrected by its rider shifted in crowding EZDARA which had improved on to that runner's heels.

KIKI (A Goindasamy) – Held up when becoming awkwardly placed on heels and when shifting out inconvenienced IDYLLWILD near the 150 metres. A Goindasamy was advised to exercise care when shifting ground.

J Fawcett (TANGO TIME) – Issued with a warning for raising her whip arm above shoulder height.

Race 4	Westbrook Cellar Door Waimauku (1200 metres)

O'JESSICA (V Colgan) – Was fractious in its barrier becoming cast. WAIPIPI GAL which was in an adjacent barrier stall was also removed to undergo a veterinary examination with O'JESSICA being declared a late scratching at 1.42pm. O'JESSICA is now required to barrier trial to the satisfaction of Stewards prior to racing next.

POKURU GRACE (R Simpson) - Slow to begin. Had to be restrained off heels for a distance passing the 600 metres.

VISTOCK (L Innes) – Began awkwardly. Held up until shifting out across heels passing the 300 metres to obtain clear running.

YOUKNOWHATIMEAN (T Thornton) – Slow to begin. Had to be restrained away from heels approaching the 1000 metres.

FINN MCCOOL (M McNab) – Raced wide without cover for the majority of the race.

LAUREATE (C Grylls) – Raced wide for the majority of the race.

LIGHTNING FIELD (O Bosson) – Held up for clear running until passing the 150 metres, shifting out across heels to obtain clear running.

WAIPIPI GAL (M Hashizume) – Held up for clear running until near the 150 metres.

DREAMS OF HEAVEN (A Calder) and **LAUREATE** (C Grylls) – Made contact on at least two occasions early in the final straight.

MOUTON (J Kamaruddin) – Shifted out abruptly over the concluding stages.

Race 5	AJC.CO.NZ (1400 metres)

CANADIAN MOUNTIE (V Colgan) – Began awkwardly with Rider V Colgan becoming briefly unbalanced making firm contact with ALALTUN.

ARYA STARK (M McNab) – Slow away. Was not persevered with passing the 300 metres. When questioned the rider was unable to offer any reason for the mare's performance.

SECRET SHOW (R Elliot) – Over-raced for a distance when being restrained from a wide barrier. Badly hampered near the 700 metres and was not persevered with for the remainder of the race. When questioned the rider felt that after being badly hampered at the 700 metres he elected not to persevere with the gelding.

FORGETZ (C Burdan) - Faltered near the 700 metres and was quickly pulled up by its rider and immediately attended to by the Veterinarian and was humanely euthanized after being found to have suffered a significant leg injury. The rider advised that FORGETZ had been racing free of interference at the time but due to the reduction of Judicial cameras available, particularly the turn camera, the coverage of the incident was inconclusive. The area of the track was inspected by the Stipendiary Stewards without any significant findings.

ALALTUN (E McCall) – Had difficulty obtaining clear running early in the final straight.

Race 6	Auckland Alarms (1400 metres)

The start of this race was delayed 13 minutes due to a meeting between the Stipendiary Stewards, Jockeys, Trainers and Club Officials regarding the injuries sustained by two horses during the running of race one and five and it was of the opinion that it was not a track related issue and the meeting was to continue.

ENTRIVIERE (S Collett) – Began awkwardly and then restrained in the middle stages to obtain cover when racing keenly.

SYMPATHIQUE (M Hashizume) – Crowded shortly after the start and steadied.

LONDON BOUND (C Grylls) – Crowded shortly after the start and steadied. Improved into a marginal run making contact with SYMPATHIQUE which shifted out contacting ENTRIVIERE and raced in restricted room for a distance passing the 400 metres. **C Grylls** was issued with a warning. Placed in restricted room near the 300 metres when WILLIAM TELL shifted out under pressure.

IT'S DOABLE (T Yanagida) – Raced in restricted room to the inside of WILLIAM TELL passing the 400 metres.

Race 7	Tulloch Café (1400 metres)

RAIL QUEEN (T Newman) – Slow to begin. Had to be restrained off heels passing the 800 metres. When shifting out to obtain clear running made firm contact with FEELIN' FANCY passing the 300 metres. **T Newman** was issued with a warning.

VULTURE STREET (J Fawcett) – Slow to begin.

FEELIN' FANCY (O Bosson) – Hampered soon after leaving the barriers.

AZAFRAN (R Elliot) – Began awkwardly, losing ground.

SPIRIT OF GOLD (C Grylls) – Began awkwardly.

KASHFLO (S McKay) – Over-raced in the early and middle stages. Shifted in abruptly when struck with the whip passing the 300 metres placing LUSTFUL LADY in restricted room.

Race 8	Marshall Stand-AJC Conference Centre (1600 metres)

WASP (E McCall) – Became fractious in the barriers and was removed to undergo a veterinary examination and declared a late scratching at 4.06pm. WASP is now required to barrier trial to the satisfaction of Stewards prior to racing next.

<p>COLIN OSCOPY (M Hashizume) – Became fractious in the barriers and was removed to undergo a veterinary examination and declared a late scratching at 4.06pm.</p> <p>OAK (L Satherley) – Began awkwardly. Raced wide without cover throughout.</p> <p>PARKER LEWIS (V Colgan) – Improved on to heels passing the 150 metres and then was held up until inside the final 50 metres.</p>	
Race 9	NZB Insurance Pearl Series Race (1600 metres)
<p>The siren was sounded as the barrier gate for LOVINGYOURWORK (C Grylls) had failed to open on terms with the remainder of the starting gates but as LOVINGYOURWORK had finished in the first four placings (3rd) pursuant to Rule 632(1) LOVINGYOURWORK was declared a starter.</p> <p>TRUEFALLS (S Weatherley) – Slow to begin.</p> <p>M McNab – Issued with a warning in that he allowed ANZAC POWER to shift out over the concluding stages crowding LOVINGYOURWORK which had to be steadied.</p> <p>SWISS REGAL (L Satherley) – Underwent a post race veterinary examination after the rider reported that the mare had felt indifferent in its action, however could find no obvious abnormality.</p> <p>Trainer D Guy (DOHA) – Fined \$50 under the Minor Infringement Schedule for not supplying a barrier blanket which was declared.</p> <p>Trainer W Rutherford (GET THE TREATS) – Issued with a warning for not providing a barrier blanket which was declared for the horse.</p>	
Race 10	Nikau Grove Nursery (Kumeu) (1600 metres)
<p>MOIRAS TOWN (S Collett) – Crowded at start. Held up for the majority of the final straight gaining clear running approaching the 100 metres.</p> <p>SATRIANI (C Jones) – Raced wide without cover.</p> <p>GOLDEN AGE (O Bosson) – Had difficulty obtaining clear running early in the straight then improved into a marginal run near the 300 metres and raced in restricted room for a distance.</p> <p>BONJOUR (L Satherley) – Underwent a veterinary examination following the race which could find no obvious abnormality.</p> <p>CRAFTYEVA (C Grylls) – Underwent a veterinary examination following the race which could find no obvious abnormality.</p>
