<b>Race 1</b>	<b>NZB INSURANCE PEARL SERIES RACE (1000 metres)</b>
<b>TE POROPITI</b> (R Elliot) - Began awkwardly then clipped a heel shortly after losing ground. Underwent a post-race veterinary examination which did not reveal any abnormality.	
<b>CHEROKEE WARRIOR</b> (L Satherley) - Crowded shortly after the start. Had some difficulty obtaining clear running until passing the 300 metres.	
<b>QUATTRO QUINTA</b> (S Collett) - Began awkwardly then shifting inwards abruptly shortly after the start crowding CHEROKEE WARRIOR onto TE POROPITI which clipped a heel and blundered.	
<b>CALVETTO</b> (T Thornton) - Began awkwardly then crowded shortly after having to be steadied.	
<b>Race 2</b>	<b>MICO PLUMBING MILE (1600 metres)</b>
<b>BELLA BUTTON</b> (A Goindasamy) - Slow away.	
<b>ON ICE</b> (L Satherley) - Slow away.	
<b>LOWRY</b> (B May) - Began awkwardly then attempted to buck for a short distance. Over-raced when being steadied in the early stages.	
<b>Race 3</b>	<b>WRC THANKS DENNIS SEXTON MILE (1600 metres)</b>
<b>HAY TIGER</b> (J Fawcett) - Restrained from its wide barrier draw.	
<b>JUSTAMAIZ</b> (A Calder) - Slow away.	
<b>ARIDITY</b> (C Burdan) - Slow away.	
<b>RONCHI</b> (V Colgan) - Over raced in the early stages. Contacted passing the 400 metres.	
<b>MASETTO</b> (S McKay) - Commenced to over race for a distance when being restrained in the early stages.	
<b>CRAFTY JESS</b> (M Hashizume) - Raced three wide without cover for the majority of the race.	
<b>VICHY</b> (D Danis) - Shifted out passing the 400 metres to obtain clear running making contact with RONCHI.	
<b>Race 4</b>	<b>FAIRVIEW MOTORS 1400</b>
<b>SHENANIGANS</b> (V Colgan) - Slow away.	
<b>VICTORY GLORY</b> (D Danis) - Began awkwardly losing ground.	
<b>MEKELLE</b> (A Calder) - Over raced in the early stages when being restrained. Held up until near the 250 metres.	
<b>IRON EAGLE</b> (S McKay) - Commenced to over race when being restrained near the 1300 metres going back onto RUM which had to be steadied.	
<b>RUM</b> (S Collett) - Steadied near the 1300 metres then commenced to race fiercely for a distance, before being allowed to improve forward to sit outside the leader near the 800 metres. When questioned regarding performance the rider advised that after racing fiercely in the early and middle stages it had failed to finish the race off.	

**LANGKAWI** (T Thornton) - Raced three wide without cover for the majority of the race. Inconvenienced passing the 50 metres when JE SUIS TIGER (J Fawcett) shifted outwards. J Fawcett was advised to exercise care.

**JE SUIS TIGER** (J Fawcett) - Had difficulty obtaining clear running early in the final straight.

**JAKKALBOMB** (R Elliot) - Held up until passing the 200 metres.

**Race 5** | **BEEFEATER GARDEN BAR 1200**

**AALAALUNE** (R Elliot) - Slow away. Held up early in the final straight before improving into a marginal run which did not eventuate having to be firmly restrained, losing all chance.

**TRUE BLESSING** (S McKay) - Began awkwardly losing ground.

**ROC CHA** (T Thornton) - Raced three wide without cover throughout.

**KEKE STAR** (S Collett) - Crowded and checked near the 900 metres. Had difficulty obtaining clear running throughout the final straight.

**CALL ME BOB** (A Calder) - Held up for a distance passing the 200 metres.

**MASQUE** (J Fawcett) - Had difficulty obtaining clear running until approaching the 100 metres.

**C Ormsby** (VIKING) - Admitted a charge of careless riding in that he permitted his mount to shift in near the 900 metres when not sufficiently clear of KEKE STAR which was checked. After hearing submissions, the Judicial Committee suspended his licence to ride in races from the conclusion of racing on Saturday 7 November up to and including racing on Saturday 14 November, 5 national days.

**Race 6** | **LEGACY LODGE SPRINT (1200 metres)**

**COVENTINA BAY** (S Collett) - Hampered on jumping away losing ground.

**CAMPARI** (A Goindasamy) - Hampered on jumping away losing ground.

**SHORT FUSE** (D Danis) - Contacted becoming unbalanced losing ground.

**BURGUNDY BELLE** (C Burdan) - Crowded shortly after the start having to be steadied after ENDLESS DRAMA shifted out slightly. Unable to obtain clear running until passing the 150 metres.

**MASCARPONE** (S McKay) - Raced keenly in the early and middle stages.

**NEW YORK JAZZ** (T Newman) - Held up for the majority of the final straight.

**ENDLESS DRAMA** (C Ormsby) - Underwent a post-race veterinary examination which did not reveal any abnormality.

**IHU** (M Hashizume) - The rider advised that the gelding had felt indifferent in its action. Underwent a post-race veterinary examination which did not reveal any abnormality.

**C Ormsby** (ENDLESS DRAMA) - An enquiry was opened into the riding tactics adopted in the final straight.

**Race 7** | **NWM - YOUR LAWYERS 2100**

**LADY SHABEEL** (B May) - Began awkwardly losing ground. Had to steady when becoming awkwardly placed on the heels of INSCRIPTION which shifted out near the 1600 metres, forcing PAISLEY PARK wider.

**PAISLEY PARK** (D Danis) - Slow away. Forced wider near the 1600 metres. Steadied after being crowded approaching the 600 metres when runners either side shifted ground. When accessing the incident video footage proved inconclusive. Unable to obtain clear running throughout the final straight.

**VERRY FLASH** (C Burdan) - Raced wide without cover for the majority of the race.

**DAYTONA RED** (T Yanagida) - Held up until passing the 200 metres then improved onto heels over the concluding stages having to be steadied.

**TWO MADISON** (T Yanagida) - Raced three wide until improving forward to sit outside the leader passing the 1400 metres.

**ROYAL PRINCE** (D Danis) - Began awkwardly contacting JAMES BARRIE.

**RIP EM UP** (S Collett) - Slow away.

**VITTACHI** (T Thornton) - Held up early in the final straight.

**R Elliot** (PEARLESCENCE) - Issued with a warning for raising his arm above shoulder height when using the whip.

**DRAKE BAY** (V Colgan) - Slow away.

**EL NYMPH** (T Yanagida) - Had difficulty obtaining clear running until approaching the 100 metres.

**SPOIL SPORT** (S Collett) - When questioned regarding performance the rider advised that, in her opinion, the mare would benefit from some easing of the ground.

**OUR WONDERLAND** (R Elliot) - Underwent a post-race veterinary examination which revealed to gelding to have suffered from cardiac arrhythmia. Connections were advised that a veterinary clearance would be required prior to racing next.
