### SUPPLEMENTARY:

**CANTERBURY JOCKEY CLUB AT RICCARTON PARK - SATURDAY, 7 NOVEMBER 2020****Race 1 - Garrards Horse & Hound Premier**

**ANJARDEN** - Trainer P Harris advised that the lameness had been found to be related to a foot issue where the mare had been pricked with a nail and after the appropriate treatment had recovered quickly.

**Race 3 - Christchurch Casino Premier**

**WANNABE 'N' PARIS** - Trainer P Harris advised that the mare had pulled up well and he was of the belief that it had got its tongue over the bit, also adding gear for its next start at today's meeting of blinkers and a tongue tie.

**Race 5 - One Good Horse At Avonhead Tavern Premier**

**THE SWISS MAESTRO** - Co-trainer M Pitman advised that the gelding had recovered well and may have struck itself during the running with a further veterinary assessment to be made in coming days and he would report the outcome.

**Race 10 - Nautical Boat Insurance Metropolitan Trophy Handicap**

**VAINGLORY** - Trainer C Cole advised that the mare was still under veterinary care having suffered a severed tendon.

| <p><b>SHELBY DEVINE</b> (M Gestain) - Began awkwardly.</p> <p><b>NOT USUAL WINGS</b> (B Ansell) - Contacted when crowded between runners leaving the barriers, raced three wide without cover from the 1400 metres.</p> <p><b>MAZZONI</b> (T Comignaghi) - Crowded on jumping.</p> <p><b>ZAKUNDA</b> (M McNab) - Crowded shortly after the start, held up early stages of the run home until inside the 200 metres having to be angled wider to obtain clear racing room.</p> <p><b>OPEN RANGE</b> (K Mudhoo) - Raced wide in the early stages, weakened from the 500 metres. | <p><b>TREKOLURE</b> (T Moseley) - Slow to begin</p> <p><b>VINEYARD MCPHEE</b> (S Collett) - Began awkwardly. When questioned regarding performance, rider advised that after getting a long way back the gelding had been forced very wide when attempting to improve rounding the turn which had told over the concluding stages.</p> <p><b>GOODANYA</b> (D Bothamley) - Shifted outwards on jumping contacting SACRED CAGA.</p> <p><b>SACRED CAGA</b> (D Johnson) - Contacted start, held up early in the straight before obtaining clear running near the 250 metres.</p> <p><b>EISENHOWER</b> (G Jogoo) - Raced three wide without cover throughout.</p>   |  |

**LAST LETTER** (A Balloo) - Held up when attempting a marginal run near the 400 metres having to shift ground outwards to obtain clear racing room.

**VOLVIK** (S Wynne) - Held up near the 400 metres and could not obtain clear running until inside the final 200 metres.

**THE EMPRESS** (M McNab) - Bumped on two occasions near the 300 metres when IFITHAPPENSAGAIN lay out away from TREKOLURE with THE EMPRESS becoming unbalanced then shifting inwards making further contact with IFITHAPPENSAGAIN.

**D Bothamley** (GOODANYA) - Spoken to regarding his whip use in consecutive strides.

**TURN YOUR EYES** (T Comignaghi) - Rider advised that the mare had not felt comfortable in today's track conditions.

**Race 3 ROMANO'S PIZZAS PREMIER (1400m)**

**BARRETT** (S Collett) - Very slow to begin losing several lengths, held up near the 150 metres having to shift ground inwards to obtain clear running.

**EGO TRIPPER** (Z Bholah) - Jumped away awkwardly, had some difficulty obtaining clear running until inside the final 200 metres.

**SANTISSIMA** (L Allpress) - Made contact with KATCHIN FEELINGS shortly after the start then shifting outwards hampering PURPLE RAIN.

**PURPLE RAIN** (T Comignaghi) - Hampered shortly after the start.

**GLORY CHANCE** (R Mudhoo) - Raced ungenerously in the middle stages skying its head.

**LADY CAMORRA** (K Mudhoo) - Over raced in the middle stages, raced in restricted room near the 300 metres having to be steadied.

**ANJARDEN** (C Barnes) - Raced wide throughout.

**GLORY CHANCE** (R Mudhoo) - Raced three wide throughout, placed in restricted room when KATCHIN FEELINGS shifted outwards under pressure just short of the finish.

**Race 4 BIDFORD PROCESSING PREMIER (1400m)**

**HEY SOUL SISTER** (C Johnson) - Slow to begin.

**WANNABE 'N' PARIS** (D Bothamley) - Began awkwardly shifting outwards making contact with HENLEY, hampered near the 900 metres.

**HENLEY** (S Toolooa) - Contacted at the start, inclined to shift ground under pressure over the concluding stages.

**EASY ON THE EYE** (M Cameron) - Restrained to obtain cover shortly after the start, held up passing the 400 metres and continued to have difficulty obtaining clear running until near the 200 metres.

**SUTHERLAND** (K Mudhoo) - Raced three wide without cover throughout.

**BEAVERTOWN BOY** (T Harris) - Hampered near the 900 metres, shifted inwards under pressure over the concluding stages.

**LETHAL** (D Johnson) - Hampered near the 900 metres then being inclined to over race for a distance.

**R Cuneen** (RUSSIAN FABLE) - Issued with a warning after permitting RUSSIAN FABLE to shift inwards passing the 900 metres when restraining his mount and not fully clear of AGAINST ALL ODDS which had to be firmly restrained going back onto LETHAL which was hampered, also hampered as a result was BEAVERTOWN BOY and WANNABE 'N' PARIS.

**THE ACE** (K Asano) - Briefly held up early in the straight.

**AGAINST ALL ODDS** (C Campbell) - Lay in under pressure throughout the final straight.

**Race 5** | **CHAMPION FLOUR PREMIER (1000m)**

**TENNESSEE ROCK** (R Beeharry) - Shifted outwards abruptly at the start making contact with OKAY PAL and losing ground.

**OKAY PAL** (M McNab) - Contacted at the start.

**RAZOR** (R Mudhoo) - Blundered leaving the barriers.

**OHIO SHOWGIRL** (M Gestain) - Crowded shortly after the start making contact when runners to either side shifted ground, had some difficulty obtaining clear running early in the run home.

**LOVEBUG** (S Weatherley) - Raced wide without cover throughout, inconvenienced 50 metres.

**FORTUNE PATCH** (S Toolooa) - Shifted inwards under pressure passing the 50 metres inconveniencing LOVEBUG.

**Race 6** | **HALLS REFRIGERATED TRANSPORT PREMIER (2000m)**

Trainers **K & A Tyler** were issued with a warning after presenting DR VELOCIOUS with incorrect gear.

**WILLIAM WALLACE** (S Macnab) - Slow to begin.

**CAMINO ROCOSO** (C Johnson) - Over raced in the early and middle stages.

**WHO DARES WINS** (S Wynne) - Briefly held up early in the straight with the rider then dropping her right rein near the 300 metres having to regather.

**CITY SLICKER** (L Allpress) - Held up early in the straight before improving into a tight run near the 300 metres making contact with NOMOATHAJ.

**NOMOATHAJ** (C Grylls) - Contacted near the 300 metres.

**S Macnab** (WILLIAM WALLACE) - Issued with a warning for her whip use prior to the 100 metres.

**Race 7** | **VALACHI DOWNS CANTERBURY BREEDERS STAKES (1400m)**

**NELLIE BLY** (M McNab) - Jumped away awkwardly.

**AIMEE'S JEWEL** (L Allpress) - Crowded and buffeted shortly after the start losing ground.

**KIWI IDA** (C Johnson) - Commenced to over race shortly after the start continuing to do so through the middle stages, had difficulty obtaining clear running in the final straight until inside the final 200 metres then failing to run on. When questioned regarding performance rider advised that he had got further back than intended and although held up in the straight had not felt to be travelling well then once in the clear had failed to quicken being disappointing. C

Johnson added that in his opinion the mare may have been feeling the effects of its first day run. A post race veterinary inspection did not reveal any obvious abnormality.

**SEVERINE** (K Asano) - Raced three wide without cover throughout.

**ZABAY** (C Campbell) - Had some difficulty obtaining clear running early in the straight then being inclined to lay in when placed under pressure.

**Race 8** | **HAASE MARSHALL DRAINAGE PREMIER (1400m)**

**DA VINCI GIRL** (C Johnson) - Slow to begin.

**CEDDY SMITH** (M McNab) - Crowded on jumping, raced three wide without cover, lay inwards when placed under pressure near the 350 metres making contact with ELIZABETH ROSE.

**CHOUX IN** (G Jogoo) - Began awkwardly shifting outwards making contact with THE GIFT.

**THE GIFT** (K Asano) - Contacted on jumping.

**AVAQUINELLA** (T Comignaghi) - Crowded on jumping.

**ELIZABETH ROSE** (C Grylls) - Crowded onto the hindquarters of OCEAN POINT when contacted near the 350 metres. When questioned regarding performance rider advised that the filly had been inclined to over race early but had otherwise been disappointing.

**OCEAN POINT** (K Mudhoo) - Hindquarters contacted near the 350 metres.

**EVA JAMES** (S Wynne) - After leading was quickly beaten when entering the final straight dropping out to finish at the rear, with the rider reporting that the filly was making abnormal breathing noises. A post race veterinary inspection revealed a severely elevated heart rate and poor recovery, with a follow up examination recommended. The connections advised that the filly has had some breathing issues and is now likely to undergo a wind operation. A veterinary clearance is required prior to racing again.

**NO RIGMAROLE** (T Jonker) - Made contact with the running rail and steadied when attempting to improve to the inside of the weakening EVA JAMES when there was insufficient room to do so near the 175 metres. T Jonker was advised to exercise greater care.

**Race 9** | **LINDAUER STEWARDS STAKES HANDICAP (1200m)**

The start was delayed when **PUYSEGUR** proved difficult to load.

**ROCANTO** (K Asano) - Began awkwardly shifting out crowding SENSEI.

**SENSEI** (M McNab) - Crowded on jumping losing ground. Rider advised that the entire had travelled well enough but had been unable to quicken when placed under pressure in the prevailing track conditions.

**PRINCE OZ** (T Moseley) - Lay in shortly after the start making contact with ENZO'S LAD, crowded and had to be steadied near the 350 metres when ENZO'S LAD lay out.

**ENZO'S LAD** (S Weatherley) - Contacted shortly after the start.

**JOHNNY JONES** (T Comignaghi) - Raced ungenerously when making the crossing and had to be restrained away from the heels of the runner in front.

**TURNCOAT** (S Wynne) - Held up early in the run home and continued to have difficulty obtaining clear running until passing the 150 metres.

**MORWEKA** (M Cameron) - Steadied when becoming awkwardly placed near heels near the 250 metres.

**WEKAFORCE** (L Allpress) - When questioned regarding performance rider advised that the mare had to work early from its wide draw and had made some abnormal breathing noises during the running. A post race veterinary inspection did not reveal any obvious abnormality.

**PRINCESS AMELIE** (D Johnson) - When questioned regarding performance rider advised that the mare had felt a little indifferent in its action and did not feel entirely comfortable in today's track conditions. A post race veterinary inspection did not reveal any obvious abnormality.

**K Asano** (ROCANTO) - Issued with a warning for his whip use prior to the 100 metres.

**POP 'N' ROCK** (C Campbell) - Declared a late scratching at 4.42 pm after refusing to enter the barriers. The connections were advised that the gelding must barrier trial to the satisfaction of a Stipendiary Steward prior to racing next.

**PRODUCER** (A Balloo) - Slow to begin.

**PICKUP** (S Collett) - Slow to begin.

**ANYTHINGCOULDHAPPN** (C Johnson) - Raced three wide throughout.

**MONKEY SHOULDER** (T Comignaghi) - Awkwardly placed on heels near the 1400 metres having to be steadied going back onto QUEEN JETSUN which was hampered.

**QUEEN JETSUN** (S Wynne) - Hampered passing the 1400 metres.

**JIN LU** (B Murray) - Had to be steadied away from heels near the 1300 metres.

**ST ANDRE** (M McNab) - Lay in under pressure in the straight making contact with the hindquarters of ZELENSKI near the 125 metres.

**ZELENSKI** (T Moseley) - Hindquarters contacted near the 125 metres.

**PEARL DAVONE** (C Barnes) - Returned to the enclosure with blood present in both nostrils and after undergoing a post race veterinary inspection was confirmed to have bled now being stood down from training for the mandatory two month period, and from trialing or racing for the mandatory three month period with a veterinary clearance required prior to doing so. Trainer P Harris indicated PEARL DAVONE would now be retired from racing.

**THE GROWLER** (B Murray) - Slow to begin.

**TOBILICIOUS** (K Asano) - Restrained to obtain cover shortly after the start, shifted inwards over the concluding stages when placed under pressure.

**SHIRLEY MAUDE** (C Johnson) - Over raced when leading in the early to middle stages.

**BENEFICIAL** (T Moseley) - Over raced passing the 1200 metres, held up rounding the final turn and could not obtain clear running until approaching the 200 metres.

**GERMANICUS** (T Harris) - Improved three wide without cover from the 800 metres. When questioned regarding performance rider was unable to offer any tangible excuse other than the gelding not having raced for 5½ weeks and in his opinion may benefit from today's race.

**LIGHTNING JACK** (L Allpress) - Held up when attempting a marginal run near the 350 metres and could not obtain clear running until near the 250 metres.

**HYPNOS** (D Johnson) - Held up rounding the final turn until the 300 metres.

**PICTURE ME ROLLIN** (S Wynne) - Held up until near the 250 metres. A post race veterinary inspection found the mare to be lame in the left foreleg, with a veterinary clearance required prior to racing next.

**B Murray** (THE GROWLER) - Charged in that he weighed in 1kg in excess of the weight at which he had weighed out. With B Murray having left the course the matter was adjourned until Saturday, 14 November.

**WHERO** (D Bothamley) - Began awkwardly.

**RUMOUR HAS IT** (S Wynne) - Began awkwardly losing ground.

**MAGIC IVAN** (S Macnab) - Restrained early to obtain cover.

**MADAM DE SOIR** (T Comignaghi) - Raced wide in the early stages.

**OUR BOY RITCHIE** (R Mudhoo) - Improved wide from the 1200 metres.

**SHOCK AND AWE** (G Jogoo) - Over raced in the middle stages.

**EKSTREMEMISS** (D Johnson) - Steadied when crowded between runners near the 150 metres. When questioned regarding performance rider advised that the mare had received an interrupted run and in her opinion is better when racing in the clear.

**HILLERSDEN** (M Cameron) - When questioned regarding performance rider advised that the gelding had over raced outside the leader and had been unable to finish the race off.
