GENERAL:

Manawatu Racing Club was spoken to regarding the tight alignment of the inside bend between the 800 metres and 300 metres, which was acknowledged by administration who advised it would be addressed before the next meeting.

RACE COMMENTS:

Race 1 MCINTOSH CRANES/TEAM DH LTD/INTER BUILDING 2YO (1000 Metres)

MARTINA DIVA (A Mudhoo) - Began awkwardly. Raced wide without cover.

BRAZEN BLUE (L Hemi) - Tended to lay in under pressure in the final straight.

WAKARI (D Johnson) – Underwent a post-race veterinary examination after returning to scale showing signs of lameness and found the colt to be grade 2/5 lame in the off foreleg. Trainer R Bergerson was advised a veterinary clearance is required before WAKARI racies or trials next.

Race 2 BRAMCO GRANITE & MARBLE/FEILDING FLOORING XTRA 3YO (1200 Metres)

R Elliot (MEGLIO DI FALCREST) – Admitted a breach in that he attempted to weigh out without his stirrup irons and leathers. After considering submissions the Judicial Committee fined R Elliot \$500.

ELUSIVE JOULE (L Hemi) - Made heavy contact leaving the barriers.

PARISIAN POPPY (F Lazet) - Made heavy contact leaving the barriers.

LA QUERIDA (M Hudson) - Began awkwardly losing ground.

MEGLIO DI FALCREST (R Elliot) - Crowded leaving the barriers. Made the bend near the 800 metres awkwardly. Steadied when awkwardly placed passing the 500 metres.

SCYLLA (S McKay) - Began awkwardly losing ground.

LADY SUPERB (R Bishop) - Made the bend near the 800 metres awkwardly.

FLOOR SHOW (T Taiaroa) – Held up briefly entering the final straight.

Race 3 MANAWATU ITM/JAPAC HOMES/TOD SEEDS LTD 1400 (1400 Metres)

BELLISSIMO (J Fawcett) - Began awkwardly losing ground. Held up rounding the final bend.

JUST FABULOUS (T Taiaroa) - Slow to begin. Raced ungenerously in the early stages when being restrained.

LANGKAWI (S McKay) - Began awkwardly then steadied when in restricted room to the inside of MEHRTENS, which was taken in by STAND TALL, which lay in.

CAN I GET AN AMEN (D Johnson) - Restrained from a wide barrier. Held up rounding the final turn, shifting out to obtain clear running approaching the 100 metres.

KING COUGAR (F Lazet) - Restrained away from the heels of MEHRTENS (M Hudson) passing the 1300 metres. M Hudson was advised to exercise greater care when in similar circumstances. Returned to the enclosure with blood present in one nostril. Underwent a veterinary examination and was deemed to have bled. Trainer M Breslin requested the gelding undergo an endoscopic examination which did not find KING COUGAR to have bled from the lungs and, therefore, was not classified a bleeder.

HANDFUL (R Bishop) - Commenced to over-race passing the 1200 metres when being restrained away from the heels of FATHER LENIHAN (J Riddell). J Riddell was advised to exercise greater care when in similar circumstances.

THE RIPPA (L Hemi) - Held up entering the final straight and continued to be held up until shifting in passing the 200 metres. THE RIPPA then improved onto heels near the 100 metres and was held up for the remainder of the race.

STAND TALL (A Goindasamy) - Held up until near the 150 metres.

Race 4 CARTERS PALMERSTON NORTH/WENHAM GRAIN & SEED 1200 (1200 Metres)

DEERFIELD (L Hemi) – Make contact with the fence when leaving the parade ring, undergoing a subsequent veterinary examination when arriving at the barrier and was cleared fit to race.

SHE'S NOT BAD (D Johnson) - Began awkwardly making contact with the hindquarters of ROCK 'N' AFFAIR, which became unbalanced. Held up early in the final straight.

TAVIS COURT (S Wynne) – Began awkwardly losing ground.

WHAT A SMASHER (C Johnson) – Raced keenly in the early to middle stages. Held up entering the final straight.

RIKKI TIKKI TAVI (J Fawcett) - Raced wide without cover.

Race 5 CAFÉ CUBA/HARCOURTS TEAM MANAWATU REALTY LTD 2100 (2100 Metres)

SYLVESTER (S McKay) – Slow to begin. Raced keenly in the early to middle stages.

STORMY HABIT (E McCall) - Slow to begin. Raced wide without cover for the majority of the race.

PENELOPE CRUISE (L Allpress) - Hampered leaving the barriers then raced keenly when being restrained in the early to middle stages.

THIS LADY ROCKS (R Auckett) - Restrained from a wide barrier.

SIR NATE (K Asano) – Crowded for a distance and then hampered passing the 1800 metres, then over-raced for a distance when awkwardly placed near heels.

ARICINA (D Johnson) - Raced ungenerously for a distance passing the 1800 metres when awkwardly placed near heels. Briefly held up rounding the final turn.

OVERTHERIVER (D Hirini) - Raced keenly through the middle stages.

C Johnson (SKYPHYTA) – Admitted a breach of careless riding in that he permitted his mount to shift in near the 1800 metres when insufficiently clear of SIR NATE, which was hampered. After considering submissions the Judicial Committee suspended his licence to ride in races from the conclusion of racing on 14th November up to and including racing on 21st November (4 national riding days).

Race 6 COURTESY MOTORCYCLES/PLUMBING WORLD 1200 (1200 Metres)

REIKO (D Johnson) – Slow to begin.

GOBUYIT (J Fawcett) – Restrained soon after leaving the barrier. Held up entering the final straight before shifting wide to obtain clear running.

TRENDY BELT (T Taiaroa) - Steadied soon after leaving a wide barrier.

SHE'S A GODDESS (S Macnab) – Restrained to obtain cover in the early stages.

RAINBOW DUNDEE (L Hemi) - Raced wide without cover for the majority of the race.

DURHAM LAD (S McKay) – Raced wide without cover.

LADY LIRA (A Goindasamy) – When questioned regarding performance rider advised that the mare had a tendency to lay in and may be better suited to more rain-affected footing.

Race 7 ROBERTSON PRESTIGE/HUMPHRIES CONSTRUCTION 1550 (1550 Metres)

GUILLADA (D Bradley) - Knuckled on leaving the barriers. Raced in restricted room to the inside of BEEFEATER (T Taiaroa) for a distance passing the 1000 metres then steadied approaching the 800 metres.

T Taiaroa (BEEFEATER) – Severely reprimanded and referred to the Riders Skills Review Panel [Rule 343(1)] after allowing her mount to shift in from near the 1000 metres making contact with GUILLADA for a distance.

JACKSSTAR (C Johnson) Began awkwardly.

HUNTA PENCE (K Asano) - Began awkwardly.

DUPLICITY (M Sanson) - Crowded and steadied passing the 100 metres to the inside of MAUNA KEA, which had shifted in and away from GUILLADA, which had shifted in under pressure.

S Wynne (MAUNA KEA) - Issued with a warning for allowing her mount to shift in under pressure in the final straight crowding DUPLICITY, which was steadied near the 100 metres.

D Bradley (GUILLADA) – Issued with a warning for allowing his mount to shift in under pressure in the final straight crowding DUPLICITY, which was steadied over the concluding stages.

MAUNA KEA (S Wynne) - Steadied over the concluding stages when in restricted room.

Race 8 JA RUSSELL LTD/STRINGFELLOWS CIVIL ENGINEERING 1550 (1550 Metres)

WEE DRAM (J Fawcett) - Restrained from a wide barrier.

NEVERSTOPLAUGHING (K Asano) - Restrained from a wide barrier.

VENETO (A Mudhoo) – Began awkwardly.

AKELA BELLE (F Lazet) – Clipped a heel after improving onto heels passing the 300 metres and blundered. SAIGON HOT NIGHT which was following was hampered.

SAIGON HOT NIGHT (L Hemi) - Hampered 300 metres.

HINEPARA (D Bradley) – Denied clear racing room passing the 250 metres after improving to the inside of the tiring LORNA DOON, losing considerable ground.

LORNA DOON (C Johnson) – When questioned into the disappointing run of LORNA DOON, C Johnson advised the filly had made contact with the running rail near the 700 metres and had momentarily gone off stride but failed to see out the 1550 metres at this stage of its preparation.
