FIRE SHOW - Following its disappointing performance, co-trainer J Parsons advised that the mare was still showing signs of tying up and is being treated accordingly.

CANTERBURY JOCKEY CLUB - Wednesday 11 November 2020

Race 11 - 16th Coupland's Bakeries Mile (1600m)

B Murray (THE GROWLER) - Admitted a charge of weighing in 1kg in excess of his weighed out weight [Rule 648(5)], with the Judicial Committee imposing a fine of \$200.

RACE COMMENTS:

Race 1 RACECOURSRE HOTEL & MOTOR LODGE PREMIER (1400m)

OUR FRANKIE (R Bishop) - The tongue tie was permitted to be removed in the parade ring when the mare became fractious. Crowded near the 1100 metres.

REDFORD (R Beeharry) - Began awkwardly then raced very ungenerously in the early stages with the rider losing the use of the right stirrup iron for a distance and losing considerable ground.

HEARTOHEART (M Gestain) - Raced wide in the early stages, had to be steadied near the 1100 metres when OUR PROM KING shifted inwards.

S Collett (OUR PROM KING) - Issued with a warning after allowing her mount to shift inwards near the 1100 metres when not fully clear of HEARTOHEART which had to be steadied and made contact with VAN DIAMOND which then lay away from that runner crowding OUR FRANKIE.

M Gestain (HEARTOHEART) - Issued with a warning after allowing her mount to shift inwards placing VAN DIAMOND and DECEPTIO VISUS in restricted room for a distance from the 1000 metres.

SERIOUSLY (R Cuneen) - Over raced near the 1000 metres and raced wide thereafter.

VAN DIAMOND (C Johnson) - Over raced in the middle stages, contacted near the 1100 metres, crowded for a distance from the 1000 metres.

LARIPPA (C Barnes) - Held up throughout the home straight and went to the line untested by its rider.

DECEPTIO VISUS (S Weatherley) - Crowded for a distance from the 1000 metres, placed in restricted room when HEARTOHEART lay inwards near the 250 metres.

CANNOLI (M McNab) - Had some difficulty obtaining clear running in the straight, with the rider reporting that the mare had been doing its best work over the concluding stages.

BELINDABELLA (K Mudhoo) - Had to be steadied away from heels near the 300 metres shifting ground outwards to obtain clear running.

SHOCK PROSPECT (M Cameron) - Had difficulty obtaining clear running until inside the final 100 metres.

S Wynne (RUNNING MAN) - Spoken to regarding her whip use prior to the 100 metres.

ATOMIC KITTEN (C Grylls) - Underwent a post race veterinary inspection after being found to have blood present in both nostrils on return to the stabling area being confirmed as a bleeder following an endoscopic examination. ATOMIC KITTEN is now subject to the mandatory stand down periods of two months from training and three months from trialing or racing, with a veterinary clearance required prior to doing so.

Race 2 KNCOOLTAINER PREMIER (2000m)

A Carston - Issued with a warning after presenting SANCTIFY with incorrect gear.

LADY BYRON (K Asano) - Slow to begin.

LETSBRINGITON (K Asano) - Slow to begin.

VILLERET (S Wynne) - Began awkwardly, raced wide without cover throughout.

AQUATTACK (A Balloo) - Began awkwardly losing ground.

MAGIC IVAN (S Macnab) - Crowded on jumping.

DANCING CHOUX (T Moseley) - Raced ungenerously near the 1800 metres when being restrained, raced wide from the 800 metres.

NOT USUAL HEAVEN (G Jogoo) - Raced wide in the early stages when improving forward to lead near the 1500 metres.

HEY MICKEY (S Collett) - Held up rounding the final turn behind the weakening NOT USUAL HEAVEN then having to be steadied near the 450 metres when HOT TAP (C Johnson) shifted inwards to obtain clear running. C Johnson was advised to exercise greater care when shifting ground.

HOT TAP (C Johnson) - Held up rounding the turn having to shift ground near the 450 metres to obtain clear running. When questioned regarding performance rider was unable to offer any excuse other than possibly not backing up from its race on Wednesday.

SANCTIFY (M Cameron) - Over raced near the 600 metres, held up near the 250 metres.

SULU SEA (R Bishop) - Held up near the 400 metres having to shift ground inwards to obtain clear running.

C Johnson (HOT TAP) - Spoken to regarding his whip use.

Race 3 CASHMERE ESTATE - LIVE WITHOUT COMPROMISE PREMIER (1200m)

K Hampton - Issued with a warning after presenting MOREIRA with incorrect gear.

STRAIGHT SETS (S Wynne) - Bounded at the start losing ground, lay inwards in the run home having to be straightened on a number of occasions.

ARNAGE (M Gestain) - Began awkwardly.

RIPA RUBY (T Comignaghi) - Raced wide without cover throughout.

Race 4 AVON CITY FORD PREMIER (1400m)

UPPERHAND (C Barnes) - Underwent a pre race veterinary inspection after dislodging its rider and escaping during the preliminary being passed fit to race. Rider C Barnes was uninjured in this incident.

EL BEE DARCI (S Collett) - Slow to begin.

TOBILICIOUS (L Allpress) - Slow to begin, when questioned regarding performance rider reported that the gelding had failed to back up from its race on Wednesday.

ALL ABOUT MAGIC (T Comignaghi) - Jumped away awkwardly.

QUINTUPLE TWINS (C Johnson) - Crowded shortly after the start, held up entering the straight and continued having difficulty obtaining clear running until near the 100 metres.

C Barnes (UPPERHAND) - Issued with a warning after permitting her mount to shift inwards when not fully clear of AUGUSTACE which had to be steadied near the 1100 metres.

AUGUSTACE (S Toolooa) - Steadied near the 1100 metres, raced wide throughout.

Race 5 WUHAN JOCKEY CLUB TROPHY PREMIER (1200m)

SELFIE (S Wynne) - Slow to begin.

ROCK SENSATION (M McNab) - Slow to begin.

MAGIC CONDOR (R Beeharry) - Bounded at the start.

TEE CEE COUP (T Comignaghi) - Out paced in the early to middle stages. When questioned regarding performance rider advised that the mare had failed to hit out throughout the running. A post race veterinary inspection revealed lameness in the left foreleg (3/5) with a veterinary clearance required prior to racing next.

ELLE MAKFI (S Collett) - Rider reported that the mare had coughed on pulling up. A post race veterinary inspection did not reveal any significant abnormality.

D Johnson (SUMMER MONSOON) - Issued with a warning for her whip use prior to the 100 metres.

Race 6 FRANTIC BLOODSTOCK WELCOME STAKES (1000m)

MOZZARELLA (S Wynne) - Fractious in its barrier before beginning awkwardly shifting outwards crowding VECTOR.

FOLLOW YOUR DREAMS (L Callaway) - Shifted outwards abruptly at the start severely crowding BODYGUARD and QUARANTINA which both lost ground.

BODYGUARD (R Cuneen) - Severely crowded at the start losing ground.

QUARANTINA (C Barnes) - Severely crowded at the start losing ground.

GLOBAL BEAUTY (G Jogoo) - Inconvenienced near the 300 metres when LUX CUM AMORE (S Collett) shifted outwards under pressure.

R Cuneen (BODYGUARD) - Spoken to regarding his whip use.

Race 7 NZB RTR SALE 18-19 NOV PREMIER (2500m)

BAK DA MASTER (D Johnson) - Blundered on jumping, raced wide in the early stages.

PLUSHENKO (L Allpress) - Slow to begin.

ARE YOU CEREAL (T Jonker) - Raced wide in the early stages.

BABY MENAKA (C Johnson) - Over raced passing the 2000 metres.

BEAUTY STAR (K Asano) - Got its head up when being restrained rounding the bend approaching the 2000 metres, raced three wide without cover from the 1800 metres. Rider reported that the gelding had felt a little indifferent in its action. A post race veterinary inspection did not reveal any significant abnormality.

EKSTREMEMISS (S Collett) - Raced wide throughout.

ASATHOUGHT (C Campbell) - Lay inwards throughout the run home.

CINTO BAY (C Barnes) - A post race veterinary inspection revealed lameness due to a left foreleg tendon injury with a veterinary clearance required prior to racing next.

SULCIFERA (T Comignaghi) - A post race veterinary inspection revealed significant lameness in the right foreleg joint with a veterinary clearance required prior to racing again.

CHIEF SEQUOYAH - Lost the right front plate during the running.

C Johnson (BABY MENAKA) - Admitted a charge of using his whip excessively prior to the 100 metres, with the Judicial Committee imposing a fine of \$1,000.

C Campbell (ASATHOUGHT) - Issued with a warning for his whip use prior to the 100 metres.

Race 8 BARNESWOOD FARM 48TH NEW ZEALAND 1000 GUINEAS (1600m)

DA VINCI GIRL (T Comignaghi) - Slow to begin, had to be steadied off heels passing the 1100 metres.

BONHAM (L Allpress) - Began awkwardly.

O Bosson (KAHMA LASS) - Issued with a warning after angling his mount inwards shortly after the start when not fully clear of MISS TYCOON ROSE which had to steady.

WAIMOKU FALLS (L Innes) - Was inclined to over race in the early stages, raced three wide without cover.

MISS TYCOON ROSE (S Wynne) - Steadied when crowded near the 1500 metres, was inclined to lay in under pressure in the final 200 metres having to be corrected on a number of occasions, having to be briefly steadied near the 50 metres when becoming awkwardly placed on heels.

EMBERS (K Asano) - Got its head up when being restrained passing the 1100 metres going back onto CORNFLOWER BLUE. DA VINCI GIRL which was following also had to be steadied as a result with KAHMA LASS having to be heavily restrained off that runner's heels.

CORNFLOWER BLUE (D Johnson) - Had to be steadied off heels passing the 1100 metres.

KAHMA LASS (O Bosson) - Had to be heavily restrained off the heels of DA VINCI GIRL passing the 1100 metres then being further hampered when FASHION SHOOT which commenced to over race when the pace steadied improved inside the heels of VITESSE BO crowding KAHMA LASS.

FASHION SHOOT (C Johnson) - Commenced to over race when the pace steadied passing the 1100 metres then becoming awkwardly placed inside the heels of TINKER MCPHEE having to steady losing ground going back onto KELLY RENEE which was hampered.

KELLY RENEE (C Grylls) - Hampered passing the 1100 metres having to be steadied to avoid the heels of FASHION SHOOT and shifting outwards making contact with MATCHMAKER.

MATCHMAKER (M Cameron) - Contacted passing the 1100 metres.

TOKORANGI (M McNab) - Hampered near the 400 metres when KAHMA LASS shifted inwards after improving onto the heels of WAIMOKU FALLS.

Race 9 VERNON & VAZEY TRUCK PARTS PREMIER (1400m)

FORTUNE PATCH (S Toolooa) - Blundered badly jumping away losing ground. Underwent a veterinary inspection after returning to the birdcage with blood present in the right nostril which confirmed the gelding to be a bleeder and accordingly is stood down for the mandatory periods of two months from training, and three months from trialing or racing, with a veterinary clearance required prior to doing so.

GLORIOUS OCEAN (S Wynne) - Jumped away awkwardly after being fractious in the barriers, lay in under pressure in the final straight.

MISS CURIOUS (A Balloo) - Slow to begin.

VARDON ROAD (K Asano) - Slow to begin.

OPERATOR (M McNab) - Raced wide without cover.

GIFTED (T Jonker) - Raced wide without cover.

S Wynne (GLORIOUS OCEAN) - Issued with a warning after allowing her mount to shift inwards near the 350 metres crowding SORCERESS.

SORCERESS (M Cameron) - Crowded near the 350 metres.

AUTHENTIC CHARM (D Johnson) - Had to be steadied when crowded for room near the 250 metres when racing to the inside of DREAMING EASY which was improving into a tight run before being taken in slightly by BOOGIE EASY.

S Wynne (GLORIOUS OCEAN) - Admitted a charge of careless riding in that she permitted her mount to shift inwards when not sufficiently clear crowding PONIARD inwards onto BOOGIE EASY which was checked near the 100 metres, with the Judicial Committee suspending her licence to ride at race meetings for 6 national days effective from the conclusion of racing on Saturday 21 November up to and including Wednesday 2 December.

PONIARD (S Weatherley) - Crowded near the 100 metres.

BOOGIE EASY (S Collett) - Checked near the 100 metres.

Race 10 CHRISTCHURCH CASINO 157TH NEW ZEALAND CUP (3200m)

DIORISSIMO (S Wynne) - Crowded at the start losing ground.

FIVE PRINCES (G Jogoo) - Restrained from a wide draw to obtain cover, contacted near the 700 metres when THE GOOD FIGHT shifted outwards to improve forward.

OWEN PATRICK (S Collett) - Over raced early stages.

DEE AND GEE (L Hemi) - Raced wide through the early stages.

RIVIERA ROCK (K Asano) - When racing keenly had to be restrained away from the heels of the runner in front passing the 2000 metres.

DIVINE DUKE (R Mudhoo) - Came under pressure and gave ground from the 1000 metres with the rider advising that the gelding had failed to respond to his riding and felt disinterested.

DR VELOCIOUS (L Allpress) - Raced in restricted room when improving into a tight run rounding the final turn, hampered near the 350 metres when RIVIERA ROCK shifted inwards to avoid the heels of ROBUSTO which lay in.

SPLENDIOR (C Campbell) - When questioned rider advised that the mare had failed to see out the distance of today's race.

MAJOR TOM (R Elliot) - When questioned regarding performance rider was of the opinion that the gelding had failed to see out the distance of today's race.

Race 11 TELTRAC PREMIER (2000m)

OUR BOY RITCHIE (R Mudhoo) - Restrained after jumping from a wide barrier to obtain cover.

SUCCOSO SEGRETO (L Allpress) - Raced wide without cover throughout.

CLOONEY (O Bosson) - Raced three wide without cover throughout.

L Callaway (YING RESOLUTE) - Admitted a charge of careless riding after permitting his mount to shift inwards passing the 350 metres crowding WHERO onto SHAKER, with the Judicial Committee suspending his licence to ride at race meetings for 7 national days effective from the conclusion of racing on Tuesday 18 November up to and including Sunday 29 November.

WHERO (D Bothamley) - Hampered when crowded 350 metres.

SHAKER (J Lowry) - Unbalanced when contacted by WHERO 350 metres shifting inwards forcing WHERO back in onto YING RESOLUTE.

YING RESOLUTE (L Callaway) - Steadied when becoming awkwardly placed near heels 300 metres.

ZAREEBA (S Collett) - A post race veterinary inspection revealed the mare to have suffered from cardiac arrhythmia with the appropriate veterinary clearance required prior to racing again.

Race 12 SPEIGHT'S PREMIER (1600m)

BLUEY'S CHANCE (A Balloo) was a late scratching at 5.08 pm on veterinary advice, with a veterinary clearance required prior to racing next.

NOPELE (C Johnson) - Slow to begin.

ST ANDRE (M Gestain) - Knuckled start, held up near the 200 metres having to shift ground outwards to obtain clear running.

AIR MAX (T Moseley) - Over raced badly in the early and middle stages, lay inwards throughout the run home.

THE BUFFER (L Callaway) - Commenced to over race near the 1400 metres and continued to race fiercely through the middle stages, held up in the early stages of the run home having to shift ground wider to obtain clear running.

HEE'S OUR SECRET (S Collett) - Raced three wide without cover throughout.

EL BEE JACK (S Wynne) - Raced wide from the 800 metres, inconvenienced 300 metres.

RITANI (D Bothamley) - Raced in season. Placed in restricted room rounding the turn approaching the 400 metres when ST ANDRE (M Gestain) shifted outwards. M Gestain was advised to exercise greater care.

AOTEA LAD (R Mudhoo) - Held up in the early stages of the run home until the 300 metres and when shifting out to obtain clear running made contact with BRONTE BEACH.

BRONTE BEACH (C Grylls) - Contacted near the 300 metres inconveniencing EL BEE JACK as a result.

WHALE SONG (M McNab) - Held up until inside the 150 metres having to be shifted wider.
