GENERAL:

Following the running of Race 1 and in consultation with the riders, the track was upgraded to Dead 4.

RACE COMMENTS:

Race 1 POWERWORX 2200

BLACK EYED SUE (J Fawcett) – Began awkwardly and was slow away.

THE RATTLIN' BOG (S O'Malley) – Over-raced in the early stages.

PRINCESS JENNI (B Ansell) - Went off stride unbalancing the rider near the 1,600 metres.

CARPE DIEM (A Mudhoo) - Shortly after entering the home straight **CARPE DIEM** shifted out and away from **LEVON** dictating **IRISH FLARE** outwards which subsequently made contact with **YULONG LANSON** which was improving into a narrow run passing the 150 metres. **YULONG LANSON** then bumped with **THE RATTLIN' BOG** for a short distance.

YULONG LANSON (R Elliot) - Held up rounding the home turn and then hampered passing the 200 metres.

DAY LIGHT (S Macnab) - Was held up in the home straight gaining clear running near the 150 metres.

Race 2 WAVERLEY MOTORS/FOREST360 1400

MADE OF GOLD (R Bishop) - Was a late scratching after arriving at the start displaying blood present in a nostril. A subsequent veterinary examination revealed a cut to the inside of a nostril.

THE DEN KEEPER (R Elliot) - Slow away.

LINCOLN TOWN (J Riddell) - Raced keenly in the run along the back straight.

SENORITAS GIRL (M Kareem) - Finished some distance last. Rider M Kareen had no excuse. Stewards advised connections that the mare must trial satisfactorily prior to its next run. Connections advised the mare's future would be reassessed.

SHADOW WARRIOR (D Johnson) - When questioned regarding the gelding's performance, Rider D Johnson advised that working hard in the early stages to obtain a position one off the running rail, had been detrimental to the gelding's chances when asked for an effort in the home straight.

Race 3 MARKHAMS/TREADWELL GORDON 1400

ICONIC LASS (H Schofer) - Got back at the start.

KATCHIT (S Collett) – Hampered soon after leaving the barriers when awkwardly placed.

Race 4 WAVERLEY HARVESTING/BIG BLADES 1400

MOGADOR (L Allpress) - Was declared a late scratching at 1.16pm after becoming very fractious in the enclosure.

RIO STAR (R Bishop) - Slow away

LINCOLN GREEN (J Riddell) - Underwent and passed a veterinary examination prior to the start. Trapped wide without cover throughout.

LA LANDONNE (S Collett) - Was inclined to lug out under pressure in the home straight.

BOUTONNIERE – (D Johnson) - When questioned into the run D Johnson had no excuse.

Race 5 R&L FREIGHT/TOTAL LOGS HAULAGE 1400

COOGA MOON (F Lazet) - Began awkwardly and got back, then over-raced into the first bend.

PLAY THE FIELD (M Hudson) - Had to be steadied off heels for some distance in the run along the back straight and made the home turn awkwardly.

GLAMOUR (T Thornton) – Had to be steadied off the heels of **ROYAL PATCH** when laying in near the 100 metres Became awkwardly placed rounding the home turn when racing in restricted room.

GINGER TOO (C Burdan) – Became awkwardly placed rounding the turn gaining clear running when being angled wide near the 200 metres.

REGAL REWARD (H Schofer) - Was held up rounding the home turn gaining clear running on entering the home straight.

Race 6 WANGANUI MOTORS 1200

VINCERE (R Elliot) - Became awkwardly placed on heels shortly after the start. In restricted room entering the home straight prior to being angled out near the 250 metres.

MAHOE (T Taiaroa) – Held up early in the home straight gaining clear running near the 200 metres.

MONTY (J Fawcett) - Made the home turn awkwardly.

Race 7 TOM ANDREWS CONTRACTING/PGG WRIGHTSON 2200

DEEP BLUE (S Collett) – Commenced to race keenly shortly after the start and had to be steadied for some distance.

ALBARAON (R Elliot) - Raced keenly in the home straight on the first occasion.

BRIAN BORU (F Lazet) - Made the first bend awkwardly when over-racing.

WHATSUP (C Burdan) - Raced keenly early.

FATTORE OTTO (H Schofer) - Held up rounding the home turn.

CAGE PHYTA (D Johnson) - When questioned into the run of **CAGE PHYTA** D Johnson advised the gelding raced in a fresh state and would improve with the run.

CHELSEA BURDAN (WHATSUP) - Was issued with a warning regarding her whip use.

RYAN BISHOP (WHOLETTHEFOXOUT) - Was issued with a warning regarding his whip use.

Race 8 STEELFORM ROOFING GROUP WAVERLEY CUP 2200

SHADOW KING (S O'Malley) - Slow away

BONNY EZRA (J Riddell) - Raced three-wide without cover in the early stages. Was inclined to shift in over the final stages and had to be straightened.

DEUCE COUPE (M Hudson) - Raced wide without cover throughout.

YOSSARIAN (H Schofer) - Over-raced near the winning post on the first round and when being steadied shifted out and forced **FACETIME** over extra time. **YOSSARIAN** disappointed. H Schofer was of the opinion the gelding may be feeling the effects of recent racing.

ROCKONEVE (S Collett) – Had to be steadied near the 150 metres when there was outward movement from **PEARLESCENCE** and inward movement from **DESERT MIRAGE**.

Race 9 C R GRACE/TONY WILSON LIVESTOCK 1650

WAY ABOVE (S Macnab) - Had to steady off the heels of BRIDAL VEIL going in to the first turn.

BRIDAL VEIL (L Allpress) - Made the first bend awkwardly and skied its head for some distance.

CAST IN BRONZE (F Lazet) - Had to be steadied passing the 600 metres when in restricted room between **RANGITATA** (M Kareem) and **LINCOLN STAR** (J Riddell). Video footage was inconclusive due to the removal of the turn camera.

RANGITATA (M Kareem) – M Kareem admitted a breach of careless riding in that he allowed his mount to shift inwards near the 800 metres dictating ZENA BELLE inwards into the line of SASSENACH which was checked and lost ground (4L). After submissions M Kareem had his licence to ride in races suspended from the conclusion of racing on the 21 November 2020 up to and including racing on 2 December 2020 – six riding days. A short distance further M Kareem angled his mount inwards near the 600 metres when not fully clear of ZENA BELLE which was hampered. M Kareem was issued with a warning under Rule 638 (1) (d).

Race 10 SUMMIT ELECTRICAL 1650

MARTINA ROSE (D Johnson) - Slow to begin

SEQUOIA DAWN (D Bradley) - Crowded leaving the barrier.

RONI (M Hudson) – Raced wide early.

QUATROMOSA (S Macnab) - Inconvenienced 100 metres.

Passing the 600 metres **BEHIND BLUE EYES** (Chelsea Burdan) fell. **MARTINA ROSE** (Danielle Johnson) was unable to avoid the fallen runner and was brought down. C Burdan was attended to by paramedics and taken to Wanganui Base Hospital for further observation. D Johnson suffered minor abrasions and was cleared by the paramedics however stood down for her remaining engagement.

After questioning riders and viewing available footage which was inconclusive due to the absence of a home-turn camera near the 400 metres after recent reductions in coverage, stewards could only determine that **BEHIND BLUE EYES** had improved on to the heels of the runner ahead and clipped a heel and fell.

MARTINA ROSE (D Johnson) - Underwent a veterinary examination which could find no obvious abnormalities.

BEHIND BLUE EYES (C Burdan) - Underwent a veterinary examination which could find no abnormalities other than several superficial lacerations.

Race 11 WANGANUI INSURANCE BROKERS 1650

PRINCE OF DOON – D Bradley replaced D Johnson as a result of an injury in the previous race.

LINCOLN LANE (H Schofer) - Tightened at the start and got back.

HASLER LAD (S O'Malley) - Got back from its wide draw.

SMOOTH COGNAC (M Hudson) - Raced keenly throughout.

MR POROTENE (L Allpress) - Hung in the home straight placing the rider at a disadvantage.
