<b>Race 1 - MCINTOSH CRANES/TEAM DH LTD/INTER BUILDING 2YO (1000 Metres)</b>
<b>WAKARI</b> (D Johnson) – Found to have a chipped sesamoid in the near foreleg after undergoing further veterinary examination on return to the stable. WAKARI will now have box rest for a month.

### RACE COMMENTS:

<b>Race 1</b>	<b>LANCE LAWSON 1400 MAIDEN (1400 meters)</b>
<b>THE VILLAIN</b> (A Calder) - Underwent a pre-race veterinary inspection at the start after being kicked and was declared a late scratching at 11.40am and was found to have suffered a small laceration and bleeding medial cannon bone. Lameness 1/5.	
<b>FUR</b> (S McKay) – Slow to begin (4L).	

**BLIZZING AWAY** (J Fawcett) - Held up throughout the final straight.

**WAIPIPI GIRL** (M Hashizume) - Had difficulty obtaining clear running early in the final straight.

**Race 2** | **MACMILLAN ACCOUNTANTS 1400 HANDICAP (1400 meters)**

**T Thornton** (FELIX FAURE) was granted permission to ride FELIX FAURE as there was no suitable apprentice available due to M Kareem not arriving on course due to transport difficulties. Raced keenly in the middle stages before shifting out passing the 900 metres to race three wide without cover

**PRINCE ALBERT** (W Pinn) - Slow to begin.

**AMANO** (T Yanagida) - Slow to begin.

**HIGH ACHIEVER** (O Bosson) - Slow to begin.

**SAIGNON** (B May) - Had to shift out approaching the 200 metres to obtain clear running.

**HONNEUR NOIR** (D Johnson) – Over raced through the early and middle stages. When questioned regarding the mare's performance rider advised that when placed under pressure near the 600 metres the mare failed to respond. A post-race veterinary examination revealed no obvious abnormalities.

**Race 3** | **NZB INSURANCE PEARL SERIES RACE MAIDEN 1400 meters**

**CAPISTRANO ROCS** (S Weatherley) - Began awkwardly losing ground. Held up early in the final straight and when shifting out to obtain clear running inconvenienced LUSTFUL LADY near the 200 metres.

**MILLIE GEORGIA** (D Johnson) - Slow away.

**LUSTFUL LADY** (T Thornton) – Over raced through the early stages.

**PARIS RUBY** (A Calder) – Steadied near the 1200 metres when making the bend awkwardly having to steady off the heels of SECRET AMOUR.

**FREE SPIRIT** (V Colgan) - Had to be firmly restrained near the 300 metres when becoming awkwardly placed on the heels of LUSTFUL LADY which shifted in slightly.

**BOUFFANT** (C Grylls) – Shifted in under pressure near the 200 metres dictating TAAFFEITE inwards crowding MILLIE GEORGIA which was steadied. Also contributing was outward movement from LUSTFUL LADY. C Grylls was advised to exercise care.

**Race 4** | **NOVARA PARK 1400 MAIDEN (1400 meters)**

**RAKUTEN** (O Bosson) – Slow to begin.

**NORTH OF HAVANA** (S Weatherley) – Slow to begin.

**TRAVELLING KATE** (C Grylls) – Became fractions in its barrier stall, and when the gates were released, began very awkwardly losing approximately 10 lengths. After viewing the video coverage, it was felt no further action was required apart from advising the trainers that the filly would be required to barrier trial before racing again. After improving to catch the tail of the field near the 800 metres, continued to improve wide, then was not preserved with from the 400 metres. C Grylls was checked by the St John Paramedics and was cleared to fulfill his riding engagements.

**SO SURREAL** (A Calder) - Had to be firmly restrained off heels passing the 1150 metres.

**OCEANA LAD** (R Elliot) - Held up rounding the bend until obtaining clear running passing the 200 metres.

**Race 5** | **ARAWA PARK FUNCTION ROOMS 1230 MAIDEN (1230 meters)**

**LOOK UP** (S Collett) - Began awkwardly losing ground.

**HASSTOBEYOU** (S McKay) – Began awkwardly.

**WISHING WELL** (D Johnson) – Commenced to over race when being steadied near the 1000 metres making the 900 metre bend awkwardly.

**CIVIL UNREST** (L Satherley) - Made the 800 metre bend awkwardly running wide.

**CATHAY NOVA** (A Goindasamy) – Had some difficulty obtaining clear running in the final straight and then was inconvenienced when attempting a marginal run passing the 50 metres.

**RAKUTEN** (O Bosson) - When questioned into the performance of RAKUTEN O Bosson was unable to offer any reason for the gelding's performance apart from it may prefer some easing of the ground.

**Race 6** | **CAMPBELLS INFRASTRUCTURE 1560 MAIDEN (1560 meters)**

**VULTURE STREET** (J Fawcett) – Slow to begin.

**VELARDE** (S Weatherley) - Began awkwardly losing ground. Held up for a distance rounding the final bend before shifting out to obtain clear running.

**PLUCKY MISS** (V Colgan) – Had to steady off heels passing the 1100 metres.

**COLIN OSCOPY** (S Collett) – Raced wide without cover throughout.

**THE GREEN GREMLIN** (M Hashizume) – Hung out under pressure in the final straight making contact with SHE SPEEDS on at least three occasions. M Hashizume was advised that he must make a greater effort to straighten his mount.

**Race 7** | **HOLIDAY INN 1560 MAIDEN 1560 meters**

**CASTLE BLACK** (R Beemud) – Slow to begin. Held up throughout the final straight. Apprentice jockey R Beemud was shown a video along with Riding Mentor, where he attempted a marginal run in which the gelding was reluctant to improve into, to the inside of GOLDEN EAGLE. R Beemud was advised that he would be expected to show better judgement than on this occasion.

**FLYINGWITHOUTWINGS** (S Weatherley) – Commenced to give ground passing the 500 meters and was not preserved with in the final straight. Rider was unable to offer any explanation. A post race veterinary examination revealed no obvious abnormalities.

**SUGAR LOAF** (A Calder) - Held up early in the final straight until shifting out near the 150 metres to obtain clear running.

**Race 8** | **LASER ELECTRICAL 1560 HANDICAP 1560 meters**

**PEPPERELLO** (M Hashizume) - Slow to begin. Held up for a distance passing the 400 metres.

**PRINCE ORIGAMI** (L Satherley) – Slow to begin. Held up rounding the bend into the final straight.

**HEART OF THE OCEAN** (M McNab) - Slow to begin. Steadied off heels shortly after the start when OSTASIO shifted in when not fully clear. Held up until passing the 100 meters.

**ASPIRING** (S Collett) - Raced three wide without cover throughout. When questioned into the performance, rider felt the mare would benefit with some easing of the track.

**Race 9** | **ATKINSON AND DONALDSON PLUMBING 1560 HANDICAP (1560 meters)**

**SACRED DELIGHT** (J Kamaruddin) – Slow away. Had to be steadied passing the 600 metres when attempting a marginal run to the outside of GREEN BRAVO. Then had to be firmly restrained when becoming awkwardly placed on the heels of the weakening SPEECHMAKER approaching the 250 metres.

**MAKABAR** (B May) – Briefly held up entering the final straight.

**Race 10** | **WAITOMO FUELS 1230 HANDICAP 1230 meters**

**S Weatherley** the rider of TANGODANZER was showing on the TAB website to be claiming 0.5kg, as this was a breakdown in the system, S Weatherley is a Class A jockey and not an apprentice.

**APPELLANT** (A Goindasamy) -Slow to begin. Raced keenly in the early to middle stages.

**HOT SPRING PROJECT** (V Colgan) - Restrained from its wide barrier draw.

**TANGODANZER** (S Weatherley) - Slow to begin.

**CASTANI** (W Pinn) - Raced ungenerously in the middle stages.

**ERIDANI** (T Yanagida) – Shifted out to obtain clear running passing the 200 meters.

**LA TARDIGRADA** (L Innes)- Shifted in when not fully clear of OTTAVIO near the 900 metres. L Innes was advised he must ride his mounts out to the finish when circumstances permit.

**Race 11** | **LIME CAFÉ 1950 MAIDEN 1950 meters**

There was a delay to the start of this race at the request of the TAB.

**TRUEFALLS** (S Collett) - Began awkwardly losing ground.

**ISTINA** (T Yanagida) - Crowded shortly after the start having to be steadied.

**GO BOBBY** (A Goindasamy) – Slow to begin.

**DIAMOND HEIST** (J Kamaruddin) - Slow to begin.

**ELDER HALL** (S McKay) - Began awkwardly. Lay in rounding the final bend with the rider being unable to ride the gelding to full advantage.

**CHAMPAGNE PRINCESS** (L Satherley) – Began awkwardly. Steadied passing the 500 metres when becoming awkwardly placed on the heels of the weakening MACROS. Pulled up in a distressed condition and underwent a post race veterinary examination which found the mare to have an elevated respiratory rate with an endoscopic examination showing moderate mucopus in the trachea.

**RUIZ** (S Weatherley) - Began awkwardly.

**MACROS** (T Newman) – Hung out throughout the race.

**RELIABLE HUNTER** (V Colgan) – When questioned regarding performance, rider V Colgan advised that the gelding had been reluctant to improve between runners, and also felt the gelding had been disappointing.
