## Race 11 - TELTRAC PREMIER 2000m

Apprentice **S Toolooa** was fined \$400 by the Judicial Committee after admitting a charge in that he used the whip excessively on his mount GREEN DISPATCH prior to the 100 metres.

#### **RACE COMMENTS:**

OCEAN'S SEVEN (	C Barnes) – Slow to begin.			

**COMMASSIE** (B Murray) – Slow to begin and tailed the field throughout. When questioned regarding the performance rider advised the mare had failed to hit out freely and had felt indifferent in its action. A post-race Veterinary examination did not reveal any significant abnormalities.

THE GOOD SHEPHERD (A Bohorun) – Began awkwardly hampering PURE VINTAGE.

**PURE VINTAGE** (L Callaway) – Hampered on jumping and forced outwards onto BELLA EVE which in turn was crowded. Raced wide throughout.

BELLA EVE (G Jogoo) – Crowded at the start.

**SORRIDA** (S Wynne) – Began awkwardly. Lost the off hind plate during the running.

**ORAKA PLAYBOY** (K Kwo) – Raced in restricted room over the concluding stages.

## Race 2 LONE STAR CAFÉ & BAR MAIDEN (1200m)

THE FABULOUS PEARL (S Wynne) – Slow to begin.

LET ME TELL YA (R Mudhoo) – Began awkwardly.

HE'S TUNZA GRUNT (R Beeharry) – Began awkwardly. Raced wide without cover throughout.

MARMADUKE (S Toolooa) – Raced wide without cover throughout.

**THE SELECTION** (J Lowry) – Crowded leaving the barriers. Inclined to over-race in the early and middle stages. When questioned regarding the performance rider advised that the mare had not helped its chances by over-racing.

**B Murray** (MAXIMUM SECURITY) was spoken to regarding his whip use on consecutive strides.

#### Race 3 KELVIN HOTEL HANDICAP (1200m)

**FASTELLIE** (S Toolooa) – Slow to begin.

**ONCE A WEEK** (T Jonker) – Slow to begin.

**KITTY POWER** (R Mudhoo) – Slow to begin.

**LOUIS LUCK** (S Wynne) – Commenced to over-race shortly after the start, continuing to do so into the middle stages, having to be further restrained near the 900 metres when briefly placed in restricted room to the inside of SILENT BATTLER which lay in at this point. Had to be firmly restrained when improving onto heels near the 600 metres. Unable to obtain clear running throughout the final straight.

**ROCKIN ROBIN** (T Moseley) – Steadied when laying out becoming awkwardly placed near the heels of OPHELIA ROSE passing the 800 metres. Made contact with PETTY'S LEGACY when shifting outwards to obtain clear running passing the 200 metres. Had to be steadied when crowded passing the 100 metres when ACEKINGSUITED lay out under pressure and PETTY'S LEGACY was taken in slightly by SILENT BATTLER with ROCKIN ROBIN not persevered with thereafter.

**SILENT BATTLER** (D Bothamley) – Raced three-wide without cover throughout.

Trainer **J Gordon** (MOTHER GOOSE) - Admitted a charge pursuant to Rule 614(2) being fined \$100 by the Judicial Committee after omitting the surcingle while saddling this runner.

Race 4

#### ASCOT SPORTS BAR HANDICAP (2215m)

**SURE HE CAN** (R Beeharry) – Got back shortly after the start.

**OLAF** (B Murray) – Raced wide in the early stages until improving forward to sit outside the leader near the 1400 metres.

**PERFECTO** (C Campbell) – Got back shortly after the start. Raced wide in the middle stages before being allowed to improve forward to the lead near the 800 metres.

C Campbell was spoken to regarding his whip use prior to the 100 metres.

**COLOUR ME RED** (R Mudhoo) - Held up for a distance rounding the bend from the 500 metres until near the 250 metres.

**R Mudhoo** was spoken to regarding his whip use.

**CHOICE DU JEU** (S Wynne) – Steadied away from the heels of the weakening ODYSSEUS passing the 400 metres.

**KNUTQUACKER** (K Mudhoo) – Held up passing the 100 metres, having to shift outwards across the heels of BEAM ME UP SCOTTY to obtain clear running.

Race 5 ILT CENTREPOINT & SOUTHCITY LIQUORLAND MAIDEN (1400m)

SHE'S GOT THE LOOK (G Jogoo) - Slow to begin.

**FINAL CHANCE** (D Bothamley) – Restrained to the rear from a wide barrier draw and tailed the field throughout finishing in a distant last placing. When questioned regarding the performance rider D Bothamley could offer no excuse. A post-race Veterinary examination did not reveal any abnormality. Trainer J Dalton advised that the gelding would now be retired as a racing proposition from her stable.

**CAROLINE MARGARET** (A Bohorun) – Raced wide in the early stages.

EMMA'S CHANCE (L Callaway) - Over-raced when being restrained near the 1000 metres.

**CHEYENNE DREAMS** (C Campbell) – Improved wide from the 600 metres and lay in under pressure in the final straight.

**RUBY ROYALE** (R Mudhoo) – Had to be steadied when improving onto the heels of HENLEY near the 500 metres.

IT'S GUCCI (T Moseley) – Raced ungenerously when being steadied near the 500 metres.

**AVINO** (J Lowry) – When questioned regarding the performance rider advised the mare had travelled well but had failed to let down when placed under pressure and may be better suited by some further cut in the ground.

## Race 6 WAIKIWI TAVERN & THE FOUNDRY RESTAURANT HANDICAP (1400m)

**LOVE TO DREAM** (S Wynne) – Slow to begin.

HE'S GOT POWER (R Mudhoo) – Began awkwardly contacting EASY HABIT.

**EASY HABIT** (C Campbell) – Contacted on jumping.

FIRE KATYUSHA (S Khetoo) – Began awkwardly hampering IRISH EXPRESS.

**IRISH EXPRESS** (T Moseley) – Hampered at the start.

**OUR TEDDY BOY** (R Beeharry) – When questioned regarding the performance rider advised the gelding had been outpaced and is better suited to more rain affected footing. Co-trainer S Anderton confirmed OUR TEDDY BOY is best suited by softer footing advising that **OUR TEDDY BOY** is now likely to be spelled.

#### Race 7 NORTHERN SPORTS BAR MAIDEN (1600m)

**OPHIR GOLD** (L Callaway) – Slow to begin.

BORN TO BE BAD (S Toolooa) – Slow to begin.

**MOTORBOAT CEE JAY** (C Barnes) - Reared and bounded as the start was effected, striking the rider in the face and losing ground. Dropped out to finish a distant last placing with trainer L Beck advising the mare will no longer be persevered with as a racing proposition from her stable.

**LAST TRY** (T Moseley) – Crowded at the start losing ground.

**SABOTEUR** (B Murray) – Got back shortly after the start.

AYAPPAN (G Jogoo) – Had to be steadied away from heels near the 250 metres.

**MISS PENVOSE** (R Beeharry) – Raced three-wide without cover.

**J Lowry** (THE ACE) - Defended a charge pursuant to Rule 340 misconduct, the particulars being that he struck his mount with the whip in an unacceptable manner behind the barriers prior to loading. After viewing replays and hearing evidence from Mr Lowry and the Stewards the Judicial Committee found the charge proved and imposed a fine of \$500.

## Race 8 CHRISTMAS at the RACES @ ASCOT PARK - DEC 12 (1600m)

**DANTE FIRE** (R Beeharry) – Slow to begin.

**GOLDEN VALKYRIE** (K Mudhoo) – Got back shortly after the start.

**RED MAJOR** (G Jogoo) – Ran wide rounding the final bend with the rider reporting the gelding had hung throughout and in his opinion would be better suited to rain affected footing. A post-race Veterinary examination did not reveal any abnormality.

Race 9 24 DAYS TO GO - SEE YA THERE - DON'T BE LATE (1600m)

**ROSIE MAE** (R Mudhoo) – Rider reported that the mare had felt indifferent in its action on the way around to barrier with a subsequent Veterinary examination revealing ROSIE MAE to be lame in the right foreleg and as such was declared a late scratching at 5.14pm.

SECRETARIA (R Beeharry) – Underwent a pre-race Veterinary examination and was cleared to start.

**DONTPUTYAFOOTINIT** (S Toolooa) – Slow to begin.

**RELIABLE BELLE** (C Barnes) – Slow to begin.

**ZED LEPPELIN** (C Campbell) – Went off stride near the 400 metres with the rider advising that the gelding had attempted to buck. Trainer L Beck was advised that a warning had been placed on the racing manners of ZED LEPPELIN.
