<u>Racing Tauranga Saturday 14 November 2020</u> STEWART BROWNE MEMORIAL 3YO (1400 Metres) ROSE 'N' POWER (T Thornton) – Trainer F Cornege advised Stewards, ROSE 'N' POWER pulled a muscle to the off hind quarter and has now been sent for a brief spell.
GARTSHORE TAURANGA STAKES (1600 Metres)

TRUE ENOUGH (J Riddell) – Co-trainer A Forsman advised Stewards, TRUE ENOUGH is to undergo a veterinary examination in the coming days. A further follow up with A Forsman will be completed by Stewards in the coming days.

A Forsman reported to Stewards on Friday 20 November, TRUE ENOUGH underwent a veterinary examination on Thursday 19 November which revealed no abnormalities. A Forsman further advised TRUE ENOUGH has now been sent for a spell.

Race 1	PRIMO WIRELESS MDN 1800
<p>MONGOLIAN PRINCESS (B Ansell) - Jumped away awkwardly.</p> <p>SHEZAWINKLE (L Allpress) - Jumped away awkwardly.</p> <p>OUR FAIR TRADE (S Collett) - Slow to begin.</p> <p>SAVEZAR (V Colgan) - Began awkwardly losing ground. Held up for a distance passing the 400 metres then had difficulty obtaining clear running early in the final straight.</p> <p>BEAR GRYLS (M Hudson) - Raced three wide without cover from near the 1000 metres.</p> <p>LOVINGYOURWORK (D Johnson) - When questioned regarding performance the rider advised that the filly had raced greenly throughout and had been reluctant to improve between runners when placed under pressure. Underwent a post-race veterinary examination which revealed the filly to be mildly lame in the right foreleg. Connections were advised a veterinary clearance would be required prior to the filly racing next.</p> <p>PEERLESS WARRIOR (A Goindasamy) - Had to be steadied when placed in restricted room passing the 1600 metres to the inside of LOVINGYOURWORK which shifted in when racing ungenerously.</p> <p>LA FAVORITA (T Yanagida) - Steadied when placed in restricted room passing the 800 metres. Had difficulty obtaining clear running early in the final straight.</p>	
Race 2	TELFER YOUNG MDN 1100
<p>SIR BALDRICK (S Collett) - Slow to begin.</p> <p>QUE PRET (A Goindasamy) - Slow to begin.</p> <p>DROP THE BEAT (L Hemi) - Restrained from a wide barrier draw, raced ungenerously for a short distance.</p> <p>KEEN TO RUN (S Weatherley) - Raced three wide without cover throughout.</p>	
Race 3	WAIKATO EQUINE CENTRE MDN 1100
<p>SEE THE LION (L Hemi) - Jumped away awkwardly shifting out making firm contact with SACRED OPTION which became unbalanced.</p> <p>SACRED OPTION (L Allpress) - Contacted near the start becoming unbalanced. When questioned regarding performance the rider advised that the filly had raced greenly throughout.</p> <p>SHOWCAT (S Weatherley) - Crowded losing ground passing 1050 metres when runners either side shifted ground. Held up until passing the 150 metres.</p>	

NUN HISSING (M Hudson) - Held up for a short distance passing the 400 metres.

Race 4 **NZB INSURANCE PEARL SERIES RACE 1400**

RELIABLE MISS (A Goindasamy) - Crowded shortly after the start having to be steadied. Had to be firmly restrained after improving onto heels passing the 700 metres.

FEELIN' FANCY (D Johnson) - Over raced in the early and middle stages, clipped a heel near the 700 metres and again near the 650 metres when over racing.

MISS DIXIE (H Schofer) - Held up until passing the 100 metres.

REGAL RUBY (M Hudson) - Over raced in the middle stages when being restrained.

Following the running of the race Stewards interviewed riders in relation to the pace of the race. As a result, S Collett, M Hudson, and L Allpress were all reminded of their obligations under Rule 638(4) in that a rider shall not reduce the speed of their horse to a degree that interferes with any other horse in the race.

Race 5 **BUNNINGS MDN 1400**

LOIS LANE (S MacNab) - Slow to begin.

PUNTURA (M Hudson) - Slow to begin. Improved on to heels near 700 metres having to be steadied. Made the bend near the 350 metres awkwardly.

DEE DEE SMASH (A Goindasamy) - Forced wider passing the 500 metres when SUMI shifted out when not clear. H Schofer was advised to exercise care.

BOLD BETTE (S Collett) - Held up early in the final straight.

ENCANTADOR (V Colgan) - When questioned regarding performance the rider could offer no excuse.

H Schofer (SUMI) - Was spoken to regarding the manner in which she used her whip raising her arm above shoulder height.

Race 6 **MASON APPLIANCES 1200**

SACRED PALACE (D Johnson) - Jumped away awkwardly losing ground. Over raced in the early and middle stages. Held up rounding the final bend. Raced greenly when placed under pressure in the final straight.

KLAASEN (S Collett) - Raced ungenerously for a distance shortly after the start. Raced three wide without cover for the majority of the race.

GOBUYIT (B Ansell) - Had to shift out to avoid heels approaching the 600 metres.

CATE BLANCO (H Schofer) - Held up rounding the final bend.

Race 7 **LA NUOVA DRYCLEANING 1100**

TELLYAWHAT (H Schofer) - Restrained in the early stages from an outside barrier. Made the bend near the 800 metres awkwardly.

STAR TREASURE (T Yanagida) - Made the bend near the 800 metres awkwardly. Improved on to heels over the concluding stages.

B Revell - Was issued with a warning for presenting MEILA REI to race without the notified gear (blinkers)

CHEEKY BEE (T Yanagida) - Slow to begin.

THE HELIX (S Collett) - Slow to begin.

LA LANDONNE (L Hemi) - Over raced in early and middle stages.

GOLDEN AGE (D Johnson) - When questioned regarding performance the rider advised that the gelding had felt flat throughout and failed to respond when placed under pressure. A post-race veterinary examination did not reveal abnormality.

BRIAN BORU (J Fawcett) - Slow to begin. Raced wide throughout.

MISS SHER NAN (D Bradley) - When questioned regarding performance the rider could offer no excuse.

REGAL ROCK (S Collett) - Shifted out passing the 150 metres when attempting to improve into a marginal run making contact with NITRO TED, then had to be steadied when held up before shifting out passing the 100 metres to obtain clear running.

NITRO TED (L Hemi) - Contacted near the 150 metres.
