SUMMER PASSAGE (C Grylls) – Co-trainer A Scott reported to Stewards, that on arrival back to the stables, SUMMER PASSAGE had pulled up lame. On Monday 23 November, SUMMER PASSAGE was seen to by the chiropractor, which revealed mild lameness to the croup area. A Scott further advised it is the stables intention to continue on with the gelding's current preparation.

RACE COMMENTS:

Race 1 | **BEEFEATER GARDEN BAR 12/12 (2100 m)**

ABU DHABI (C Ormsby) - Knuckled leaving the barrier. Had difficulty obtaining clear running in the final straight.

SEVEN AAJES (J Riddell) - Began awkwardly then restrained.

TRUTH BEKNOWN (S Weatherley) - Began awkwardly then restrained.

BLUE ICE (T Newman) - Began awkwardly then restrained from a wide barrier.

BEAU ARCHERS ROSE (L Satherley) - Raced ungenerously after becoming awkwardly placed on the heels of LADY GWENDOLYN (C Grylls) approaching the 1800 metres. C Grylls was advised to exercise care. Commenced to lay in when placed under pressure early in the final straight and was unable to be fully ridden out by its rider over the concluding stages. A warning was placed on the gelding's racing manners. Trainer B Pomare advised that he would be experimenting with gear changes.

GET THE TREATS (A Goindasamy) - Raced wide without cover in the early stages before improving forward to lead passing the 1200 metres.

LADY GWENDOLYN (C Grylls) - Raced three-wide without cover for the majority of the race.

S Weatherley (TRUTH BEKNOWN) - Admitted a charge in that he used his whip excessively prior to the 100 metres. After considering submissions the Judicial Committee suspended his licence to ride in races from the conclusion of racing on the 2 December up to and including racing on the 12 December, 7 National riding days.

Race 2 | **ADASHIKO FASHION STAKES 12/12/ (2100 m)**

BORDER LEICESTER (J Riddell) - Slow to begin.

RISING RANSOM (A Calder) - Began awkwardly then raced in restricted room.

OUR CRAFTSMAN (M Cameron) - Began awkwardly.

DELLE QUARTZA (L Satherley) - Began awkwardly. Was treated by the veterinarian after a slow recovery following the race.

NOWANAGEN (R Elliot) - Commenced to race ungenerously soon after leaving the barrier becoming awkwardly placed near heels for a distance approaching the 1800 metres. NOWANAGEN then shifted out to avoid heels hampering DELLE QUARTZA and HUSK, then continued to race ungenerously throughout the middle stages when racing wide without cover. Raced in restricted room when weakening passing the 350 metres.

MARBUZET (T Thornton) - Raced wide in the early stages.

HUSK (D Danis) - Raced ungenerously passing the 1800 metres when improving onto heels.

TURRET (T Newman) - Raced in restricted room for the majority of the final straight.

C Ormsby (OUR BEESKEES) - Admitted a breach in that he used his whip excessively prior to the 100 metres. After considering submissions the Judicial Committee suspended his licence to ride in races from the conclusion of racing on the 28th November up to and including racing on the 10th December. 6 National riding days.

T Harris (MILITARY STEP) - Admitted a breach in that he used his whip excessively prior to the 100 metres. After considering submissions the Judicial Committee suspended his licence to ride in races from the conclusion of racing on the 28th November up to and including racing on the 10th December. 6 National riding days.

KOOL POWER (J Kamaruddin) - Hampered leaving the barrier by FELICIENNE which had begun awkwardly.

FELICIENNE (C Grylls) - Began awkwardly. Lay out and away from O'JESSICA which shifted out slightly before being corrected by its rider making contact with ALEX MY MAN which was forced outwards crowding SIDE EYE, BANKERS CHOICE and SILENT ZONE near the 250 metres.

SIDE EYE (D Danis) - Crowded and hampered passing the 250 metres.

SILENT ZONE (T Yanagida) - Hampered passing the 250 metres.

BANKERS CHOICE (D Johnson) - Slow to begin then further hampered. Hampered passing the 250 metres.

LEGAL LADY (J Fawcett) - Began awkwardly losing ground.

ALEX MY MAN (T Thornton) - Raced three wide without cover. Hampered passing the 250 metres.

PENNY JANE (T Yanagida) - Began awkwardly.

HE'S THE MAN (M McNab) - Began awkwardly.

COPY ME IN (S Collett) - Began awkwardly then raced in restricted room and steadied.

ZAFFIRE BAY (M Hashizume) - Began awkwardly then steadied from a wide barrier.

ITSY BITSY (L Innes) - Raced ungenerously in the early and middle stages making the bend near the 800 metres awkwardly and shifted out forcing PARADING wider, then was obliged to race wide without cover for the remainder of the race.

PARADING (D Johnson) - Forced wider near the 800 metres.

GREGORY (V Colgan) - Raced ungenerously in the early and middle stages.

CAMAROSA (S Weatherley) - Held up until passing the 300 metres then improved onto heels passing the 100 metres having to be steadied.

RAPID RECALL (A Calder) - Had to shift out to obtain clear running passing the 350 metres.

NO QUARTER ASKED (J Fawcett) - Had difficulty obtaining clear running early in the final straight.

L Innes (ITSY BITSY) - Was spoken to regarding his whip use.

Race 5

FOSTER MAINTAIN 1200

ON DEMAND (T Thornton) - Removed from the barrier after becoming fractious to undergo a veterinary examination and was passed fit to race. Raced wide without cover.

SAIGNON (B May) - Removed from the barrier after becoming fractious to undergo a veterinary examination and was passed fit to race.

TIA CELESTE (L Satherley) - Began awkwardly then hampered. When questioned regarding the performance the rider advised that the mare had been unsuited to today's track conditions.

B May (SAIGNON) - Was reminded of his obligation in that he must ride his mount out fully to the end of the race when circumstances permit.

Race 6

BCD GROUP 3YO (1400m)

The start was delayed due to a gear failure with the bridle being replaced on LARGERFELD.

ULAANBAATAR (J Riddell) - Began awkwardly losing ground. Held up rounding the final bend then had difficulty obtaining clear running early in the final straight.

LARGERFELD (A Calder) - Began awkwardly losing ground. Hampered shortly after the start losing ground.

CANUHANDLEAJANDAL (C Grylls) - Crowded shortly after the start and forced out onto LARGERFELD which was hampered losing ground.

NO LIMITS (D Johnson) - Steadied when racing in restricted room approaching the 1300 metres.

DUNHILL (M McNab) - Raced fiercely when attempting to be restrained passing the 1000 metres.

TONYA (S Collett) - When questioned regarding performance the rider advised that in her opinion the filly would be better suited to the right-handed way of going.

C Jones (RISING DREAM) - Issued with a warning for his whip use on a runner out of contention.

J Riddell (ULAANBAATAR) - Reminded of his obligations in that he must ride his mount out to the end of the race when circumstances permit.

Race 7 | **SVS 1400**

TINA AGAIN (C Dell) - Declared a late scratching on veterinary advice after becoming fractious in the barrier. Trainer R Liefting was advised that TINA AGAIN would be required to barrier trial to the satisfaction of Stewards prior to racing again,

WHILE YOU'RE THERE (A Calder) - Slow to begin.

MANEKI NEKO (R Elliot) - When questioned regarding performance the rider advised that the gelding had raced greenly throughout. Underwent a post-race veterinary examination which did not reveal any abnormality.

EZDARA (S Collett) - Lay in when placed under pressure in the final straight having to be straightened by its rider approaching the 100 metres then was unable to be ridden out fully to the end of the race.

MISS INTERPRET (A Goindasamy) - Steadied when placed in restricted room passing the 100 metres to the inside of RUBYSHOWOFF which shifted in and away from EZDARA which was laying in.

Race 8 | **WAIKATO DRAUGHT MILE (1600m)**

SAM'S SONG (J Riddell) - Began awkwardly. Held up for a distance passing the 400 metres.

HIBERNIA SEA (S Collett) - Began awkwardly. Briefly held up passing the 400 metres.

CATWALK GIRL (S Weatherley) - Restrained from a wide barrier.

FUNNY GAME (M Hashizume) - Crowded passing the 1400 metres by KING ZAZU which lay out despite the efforts of its rider, also crowded as a result was KATHIES CHOICE and CIAMBELLA.

CIAMBELLA (C Grylls) - Crowded passing the 1400 metres.

KATHIES CHOICE (D Johnson) - Crowded passing the 1400 metres.

DUNTAYAR (M Cameron) - Raced ungenerously passing the 1400 metres making contact with BANCOMAT D'ORO. Raced wide without cover throughout.

DARK HORSE (V Colgan) - Raced three wide without cover throughout.

SHEEZ LEICA (T Newman) - Raced wide without cover throughout. Had to be steadied when weakening when runners either side shifted ground passing the 350 metres.

Race 9 | **\$400k HERBIE DYKE STAKES NOMS 8/12 (1400m)**

LAKEMAN (D Danis) - Began awkwardly losing ground. Underwent a veterinary examination after becoming tailed off which could find no significant abnormality. Trainer J McGrath was advised that warning would be placed on the geldings racing performance.

SPERENZA (W Pinn) - Began awkwardly losing ground.

CELEBRE (C Grylls) - Crowded shortly after leaving the barrier becoming unbalanced. Raced ungenerously in the early stages. Made the bend near the 800 metres awkwardly.

DOHA (J Fawcett) - Crowded shortly after leaving the barrier then steadied.

NANNY ANDY (V Colgan) - Made contact with LAUREATE when making the bend near the 900 metres.

LAUREATE (T Harris) - Contacted 900 metres becoming briefly unbalanced.

ALAMODE (M McNab) - Raced wide without cover for the majority of the race.

O'JUDE (A Calder) - Had difficulty obtaining clear running early in the final straight then improved into a marginal run passing the 100 metres.

J Fawcett (DOHA) - Issued with a warning for her whip use prior to the 100 metres.

Race 10

DUNSTAN FEEDS 1400

M Baker & A Forsman (DEALTTO) - Issued with a warning for presenting DEALTTO to race with blinkers that were not notified.

RAIL QUEEN (T Newman) - Began awkwardly losing ground.

BREAK THRU (C Dell) - Began awkwardly. Commenced to over race shortly after the start having to be firmly restrained passing the 1000 metres.

RISING SILVER (C Jones) - Began awkwardly then crowded losing ground.

VISTOCK (L Innes) - Slow to begin.

FINEST WINE (J Fawcett) - Had to shift out passing the 200 metres after improving onto heels. Connections were advised that a warning would be placed on the filly's barrier manners.

VITANI (D Johnson) - Inconvenienced passing the 150 metres to the inside of SWEET FIELDS which shifted in slightly.

EXTERSEA (J Riddell) - When questioned regarding performance, the rider advised that the gelding had been unsuited by today's track conditions.

POWERFUL MOSS (M Cameron) - Permission was granted by Stewards for the gelding to race without the notified blinkers due to the track conditions.

LETZ'AV BUBBLES (C Grylls) - Hampered leaving the barriers.

AALAALUNE (R Elliot) - Crowded leaving the barriers.

FIRODEN (D Danis) - Began awkwardly losing ground.
